



THE STATE OF AFRICAN AMERICAN ENTREPRENEURS

How are African-American entrepreneurs doing? There are nearly 2.6 million African-American owned businesses in the U.S., and they employ nearly 1 million Americans, according to statistics from the Commerce Department's Minority Business Development Agency. The same study reports that minority-owned firms overall experienced significantly higher growth than the average business did between 2007-2012—especially impressive considering that this period of time included the Great Recession.

Here's a closer look at how the average African-American entrepreneur is faring, according to a recent survey

that Guidant Financial conducted of current and aspiring small business owners.

Education

African American entrepreneurs have varying degrees of educational attainment. About one-third (32%) of them have a high school diploma or GED. Some 26% have a bachelor's degree, 21% have an associate's degree, and 22% have a master's degree or higher.

Motivation

Why are most African American entrepreneurs initially motivated to launch their businesses? These entrepreneurs are more likely than the average business owner to

say they started a business because they were dissatisfied with working in corporate America (22%). However, the vast majority of African American entrepreneurs (62%) say they wanted to "pursue their passion," 53% say they were "ready to be my own boss," and 30% say that opportunity presented itself. Just 12% say that being laid off or having their job outsourced motivated their startup.

Despite the rapid growth of African American-owned firms in general, there are still many challenges facing these entrepreneurs.

For example, just 57% of African American business owners that Guidant surveyed say their business is profitable. That's significantly lower than the average for all survey residents (68%).

African American business owners also report being less likely than the average business owner to have employees. Nearly half (46%) are solo entrepreneurs, 41% have two to five employees; 7% have between six and 10 employees; and 6% have 11 or more workers.

The achievement gap is particularly stark when it comes to revenues. The average annual receipts for African American businesses is just \$58,119.

That's compared to an average of \$173,552 for minority-owned firms in general and \$552,079 for non-minority firms.

What's behind these issues? One problem is that many African-American business owners can't access the financial resources they need to grow their companies.

In fact, a whopping 80% of African Ameri-

Board of Supervisors Calls for Fair Deal to Avert County Funding Crisis

The Board of Supervisors voted unanimously (18-0) today to endorse an outline of potential solutions to avert a funding crisis facing Milwaukee County.

"Milwaukee County is facing a serious funding crisis. We need a new partnership with state leaders on solutions that are good for the county and the state. We all have a shared interest in solving this problem," said County Board Chairman Theodore Lipscomb, Sr.

Supervisors adopted a resolution from the Fair Deal for Milwaukee County Work-group that outlines several areas for possible action by the State Legislature.

The workgroup studied the impact of a rapidly growing imbalance between necessary expenditures and the ability to generate sufficient revenue.

The recommendations include:

- Allowing Milwaukee County local control to generate new revenue and reduce the current reliance on property taxes through a binding referendum process;
- Increased, fair contributions from the state toward the provision of current and any new state-mandated services;
- Fully reimbursing the County for the cost of patrolling state highways (Milwaukee County is the only Wisconsin county required by state law to patrol state highways);
- Equally sharing Circuit Court and Register of Deeds fees collected by the County (currently 80% goes to the state and 20% remains with the County);
- Adjusting state Shared Revenue payments and other state aids to align with any inflationary increases in the cost of adequately providing public programs and services;
- Accepting federal dollars to expand BadgerCare statewide, which would reduce the cost of private health insurance borne by the County;
- Adequately funding any youth justice facilities located in the County;
- Rejecting any reduction in existing funding below amounts received in the 2019 Adopted Budget;

Chairman Lipscomb and County Executive Abele signed the resolution immediately upon adoption by the Board of Supervisors.

Workforce Development Dislocated Worker Services Summary

The Wisconsin Department of Workforce Development (DWD) Dislocated Worker Program provides transition assistance to workers and companies affected by permanent worker layoffs.

The Program's local Rapid Response Teams help companies and worker representatives develop and implement a practical transition plan based on the size of the layoff event. Types of services include:

- pre-layoff workshops on a variety of topics such as resume writing and interviewing, job search strategies, and budgeting
- provision of information about programs and

resources through written materials and information sessions

- career and resource fairs.

Workers affected by permanent layoff may also access basic re-employment services at no charge through the state's Job Centers.

Some services, including training assistance, may be an option for some workers after enrolling in one or more of DWD's workforce development programs.

While all companies faced with permanent worker layoffs are encouraged to seek assistance from the local Rapid Response Teams, some companies may be required to give 60 days notice before a mass layoff or closing under federal and/or state law.

Gucci pulls \$890 'blackface sweater' from stores after complaints of racism



Gucci has apologized for a wool sweater after complaints that it resembled blackface makeup and said the item had been pulled from its online and physical stores.

It was the latest case of an Italian fashion house having to apologize for cultural or racial insensitivity.

In a statement posted on Twitter on Wednesday, Gucci said it was committed to diversity and considered it a "fundamental value to be fully upheld, respected and at the forefront of every decision we make."

The turtleneck black wool balaclava sweater covers the nose and includes a red cut-out for the mouth. It was ridiculed on social media as insensitive and racist, at a time when the U.S. is grappling with cases of old photos of politicians with their faces blackened.

In December, Prada said it was no longer selling a line of accessories that featured a character with brown skin and exaggerated red lips after complaints they resembled blackface.

And last year, Dolce & Gabbana canceled a Shanghai runway show and apologized after complaints that an advertising campaign featuring a Chinese model trying to eat pizza, spaghetti and a cannoli with chopsticks was culturally insensitive.—Article courtesy of Associated Press

New survey shows African American small business ownership up 400%

The number of African American small business owners in the United States has increased by a staggering 400% in just a year.

This was the finding of a survey from the small business financing company, Guidant Financial.

The State of a Small Business survey interviewed more than 2,600 small business owners and entrepreneurs, both male and female.

The survey found that in 2018, 45% of small business owners

were minority ethnic groups. This was already a dramatic increase from 2015, when the amount of minority business owners was just 15%.

The biggest increase among minority small business owners, however, has been the huge increase in the number of African American small business owners year over year 400% increase in a year-over-year period between 2007 and 2018.

Following African Americans, Hispanics were the next largest group of minority small business owners representing 14% of the business owners interviewed for

the survey.

Meanwhile, Asians made up 8% of the business owners surveyed while Native Americans made up 4%.

David Nilssen, CEO of Guidant Financial, shared his enthusiasm over the rise in minority small business owners in the United States in an announcement announcing the guidelines.

In the release, Nilssen said, "It is exciting to see the growth in minority-owned small businesses, a trend that has steadily been rising since we began our survey in 2015.

He added "Growth amongst all



minorities including women is promising in America as small business ownership becomes more favorable and easier to attain.

We anticipate and hope to see a continued increase as the impact of tax reform and economic growth shape small business ownership moving forward."

The research also showed some of the reasons behind the prolific growth of minority small business ownership. Specifically, 62% of African American small business owners cited their desire to pursue their passion as the reason for starting a business.

can entrepreneurs in the Guidant poll say that lack of capital is their biggest business challenge. This is 10% higher than the average small business owner in the survey. The next biggest challenges, marketing and advertising (31%) and time management (23%), are mentioned far less often than access to capital.

If they did manage to obtain additional capital for their businesses, half of African-American entrepreneurs say they would use the money for expansion; 61% would use it for equipment, 54% would use it for marketing/advertising, 36% would use it for staff, and 30% say they would spend the windfall on technology.

The challenges that African-American business owners face are reflected in their relatively low confidence in the political climate for small business. Their confidence level is seven out of 10, compared to eight out of 10 for business owners as a whole.


