### Census Bureau Statement on Coronavirus and the 2020 Census

The U.S. Census Bureau is carefully monitoring the coronavirus (COVID-19) situation and will follow the guidance of federal, state and local health authorities.

We have also established the Census Bureau COVID-19 Internal Task Force to continuously monitor the situation and update our Pandemic Addendum to the Census Bureau Continuity of Operations (COOP) Plan.

Our preparation and contingency planning centers on two key principles: The health and safety of our staff and the public is of the utmost consideration and importance. We must fulfill our constitutional obligation to deliver the 2020 Census counts to the President of the United States on schedule, and we must adhere to our core task of counting everyone once, only once, and in the right place.

The key message right now for anyone with questions about how COVID-19 will affect the 2020 Census: It has never been easier to respond on your own, whether online, over the phone or by mail—all without having to meet a census taker.

From March 12-20, households will receive the first of several invitations to participate in the 2020 Census.

We are encouraging everyone to respond online as soon as you receive your invitation with the provided instructions to go online. Instructions include the web address for the online questionnaire in English as well as where to respond online in 12 additional languages, ensuring over 99% of U.S. households can respond online in their preferred

The invitation will also include phone numbers for English and the 12 additional languages, ensuring over 99% of U.S. households can respond over the phone in their preferred language. Telephone assistance is available seven days a week from 7 am to 2 am EDT for those who prefer to respond by phone.

Some households—in areas less likely to respond online—will receive a paper questionnaire in the first mailing; all households that have not responded online or by phone will receive a paper questionnaire between April 8 and April 16. The paper questionnaire

# Census Bureau Statement on Coronavirus and the 2020 Census

includes a prepaid postage envelope to return it by mail.

Census takers plan to conduct the Nonresponse Followup operation in a handful of communities beginning as early as April 9, and across the country on May 13. Households can still respond on their own during this phase (online and phone response is available through July 31).

The Census Bureau will closely follow guidance from public health authorities when conducting this operation, as we do when conducting all field operations.

If we need to delay or discontinue nonresponse follow-up visits in a particular community, we will adapt our operation to ensure we get a complete and accurate count.

Currently, we are successfully conducting fieldwork for some of our non-decennial surveys by phone in areas where we are seeing an outbreak.

Similarly, partnership specialists are working with local partners and conducting meetings that may have been in person by phone and teleconference.

We designed our 2020 operations precisely so we could offer multiple ways to respond. In so doing, we are able to make necessary adaptations at the local level for special operations as well.

For instance, "group quarters," the operation which counts people in nursing homes, college dorms, prisons and other institutional living facilities, includes a myriad of ways to respond, such as via eResponse, paper listing or self-enumeration by the facility.

The same is true for "service-based enumeration" which counts people experiencing homelessness at the site where they receive services. The site administrators have multiple options for response.

In short, where a community, facility or service organization makes a change that would affect any field operation, we will adapt to make sure we are getting the same population counted another way.

We will work to share information about any change in operations with local authorities, community partners and the media. We will also work with community partners to continue to encourage self-response through the end of the nonresponse follow-up phase.

We also have significant contingency budget to address costs of operational changes. As needed, we will hire additional workers, manage operations out of different offices or mail additional reminders or questionnaires to areas affected by an outbreak.

We will continue to monitor the situation and take appropriate steps in consultation with public health authorities.

### Tax Deadline Extended to July 15 Amid Coronavirus Pandemic

THE DEADLINE FOR Americans to file their annual tax returns has been pushed from April 15 to July 15 as the coronavirus pandemic wreaks havoc on Americans' wallets.

Treasury Secretary Steve Mnuchin tweeted on Friday that he was acting at the direction of President Donald Trump, stating that "all taxpayers and businesses will have this additional time to file and make payments without interest or penalties."

He still urged all taxpayers who may have refunds to file their taxes now "to get your money."

The White House had previously said it was deferring tax payments for 90 days but that Americans would still be required to file by April 15.


Extending the tax deadline is just one action the Trump administration is taking to reduce the economic impact of the coronavirus, which has infected more than 14,250 people in the U.S. and killed more than 200.

The president has already signed legislation expanding paid sick leave for workers, and law-makers are considering a \$1 trillion stimulus package that includes sending Americans making less than \$75,000 a check for \$1,200.



### **How to Vote Amidst** Coronavirus **Precautionary** Measures

It's midway through March and soon it'll be time for the Spring General Election, which is scheduled for Tuesday, April 7. As of right now, the election is to continue as scheduled but in light of recent events a press conference was held earlier this week to address the public's concerns.

Mayor Tom Barrett said that the upcoming election is a critical one on both a local and statewide level. However, there is a growing concern for the health and safety of poll workers and voters.

"First and foremost, we want residents of Milwaukee to exercise their constitutional right to vote," Barrett said. "[But] this pandemic is serious, and we need to exercise caution."

In Milwaukee, there are currently three ways to vote. Residents have the option of early voting, voting absentee and voting in person. Early voting began on Monday, March 16 and is offered at three locations: Zeidler Municipal Building, 841 N. Broadway, Room 102, Midtown Center, 5700 W. Capitol Dr. and the Zablocki Library, 3501 W. Oklahoma Ave.

Early voting hours are from 8 a.m. to 7 p.m. Monday through Friday and 10 a.m. to 3 p.m. on Saturday, March 28, Sunday, March 29, Saturday, April 4 and Sunday, April 5. Early voting ends on Sunday, April 5.

Barrett stressed that polling places are being routinely cleaned and disinfected throughout early voting and on election day.

He said that residents can further exercise caution by bringing their own black ballpoint pen or voting at times that are less busy to maintain the recommended six-foot distance.

If possible, Barrett recommended absentee voting by mail. "I want residents to consider this very seriously," he said, especially those who are over 60 or who have underlying health conditions. Any person can request and receive an absentee ballot as long as he or she is registered at his or her current address.

To request an absentee ballot, residents can go to myvote.wi.gov. Absentee ballots can be requested the Thursday before Election Day, but they must be returned by Election Day.

Neil Albrecht, the executive director of the election commission for the City of Milwaukee, said that in the 2016 presidential election 10,000 people voted by mail, so far 12,000 absentee ballots have been requested for this election.

The commission receives about 1,000 requests a day for absentee ballots.

Absentee voting isn't the only concern Barrett discussed during the press conference. A majority of the Election Day workers are over the age of 70 and considered a part of the high-risk age group.

"We want those election workers to be able to sit out this election, but they won't do so if they are concerned about who is going to replace them at voting sites," Albrecht said, adding that about 50% of the staff is over the age of 60.

Milwaukee needs about 1,800 workers. According to Barrett this is a good opportunity for high school students and college students to get civically involved. To apply, individuals can go to city.milwaukee.gov/election and click on the Election Workers tab to find an appli-


Election site workers receive \$130 a day and start time is 6 a.m. and ends when the polls close. Training will be offered, and most residents will be able to work at a polling place close to their home.

George Christensen, the county clerk for Milwaukee County, said the county is working with municipalities to provide up-to-date information. The county recently set up a hotline, (414)-278-VOTE (8683) to help raise awareness and he encourages residents to call if they have concerns.

Due to the fluidity of the situation and how contagious coronavirus is, the city and county are looking at ways to process absentee ballots in a safe and healthy

Since, absentee ballots must be processed on Election Day, Christensen asked that the public and the media be patient as election results may not be available immediately.

Jeanette Kowalik, health commissioner for the City of Milwaukee, also spoke during the press conference. COVID-19 or coronavirus is very similar to the flu and very contagious, she said. Kowalik asked that people exercise precaution and responsibility to not expose other to illness.

### State Department of Children and Families coordinating efforts to find childcare for vital service workers

MADISON - The Department of Children and Families (DCF) is coordinating efforts to find child care for families of workers providing vital service to the state's COVID-19 response. Child care available remains one of the top concerns to keeping

health providers and essential employees at work. Last week, DCF worked with the Wisconsin Hospital Association (WHA) and the Department of Health Services (DHS) to administer a survey of health care employees to gauge need. At the same time, the Wisconsin Early Childhood Association

(WECA), Supporting Families Together Association (SFTA), and the Registry assessed the capacity of providers to take new kids during the time of crisis.

Over the past 48 hours, work began on matching supply and demand to make sure health care workers were able to find the child care they needed.

"In a short order, our partners and agency staff were able to come together around a solution to address the child care needs of health care workers across Wisconsin," said DCF Secretary Emilie Amundson. "Over the coming days, we will continue to work on ways we can help other essential workers

DCF continues to work with WHA and DHS to develop a model for on-site care at the state's hospital and health care

The initial guidance developed by the department is based on local examples of hospitals, child care providers, and the business and non-profit community coming together to create new, drop-in care for health care workers in a specified region. The department is working with the Boys and Girls Clubs and YMCAs to explore similar options throughout the state near hospitals and sites with large numbers of essential staff.

"I continue to be amazed by the generosity and good-will of the people in Wisconsin," continued Secretary Amundson. "As we identify needs, people are raising their hands to help. This is especially true for the many child care providers who stayed open, adapted to more rigid rules to keep kids healthy and safe, and agreed to take new kids during this challenging period."

Child care providers were asked to reduce their footprint to settings with no more than 10 staff and no more than 50 children present to reduce the risk of COVD-19 spread.

Child care providers and centers are small businesses that are impacted by many of the same economic pressures other industries are experiencing when practicing social distancing and limits on human interactions. Like many states, Wisconsin was already facing a shortage of child care availability in many parts of the state.

To address some of these gaps, DCF has sought hazard pay funding for child care workers remaining open and asked educators to volunteer in child care settings.

"I want to be clear: child care workers are essential staff themselves," said Amundson. "And we need to do whatever we can to support them. If you have the luxury of keeping your kids at home with you, I am asking that you strongly consider doing so," concluded Amundson.

### Ald. Coggs seeks changes to allow tax collection relief, hazardous duty pay

Legislation introduced by Alderwoman Milele A. Coggs urges a state law change to establish a moratorium on assessing interest and penalties on property tax accounts, as well as a look at allowing certain city positions to qualify for hazardous duty pay.



Alderwoman Coggs, chair of the Finance and Personnel Committee, said the coronavirus (COVID-19) pandemic has had a major negative financial impact on small businesses and individuals, with many Milwaukee businesses being required to close per official order and residents forced out of work because of stay-at-home and required closure orders across all sectors.

Currently, state statutes govern the billing and collecion of property taxes, as well as delinquent tax interest and penalties (and currently recognize no exceptions for their assessment).

Her legislation would authorize the city's Intergovern-

mental Relations Division to urge the Wisconsin Legislature and Governor Evers to pass legislation that would establish a set time period moratorium on assessing interest and penalties on property tax accounts.

The Alderwoman's effort would dovetail with that of City Treasurer Spencer Coggs, who on March 20 sent a letter to the Governor and state legislative leaders, urging the passage of legislation that would establish a set time period moratorium on assessing interest and penalties on property tax accounts.

"These are unprecedented times as workers find themselves furloughed and businesses and individuals being unable to meet their financial obligations, including paying their property taxes," Alderwoman Coggs said.

"With the devastating and sudden loss of income being felt across the board, I believe individual property taxpayers and beleaguered small businesses impacted by the pandemic would benefit from the relief of not having to pay interest and penalties on property tax accounts,"

A second legislative file introduced by Alderwoman Coggs would require the Department of Employee Relations to look at establishing hazardous duty pay for "essential" city workers.

Currently, "essential" city employees across the city workforce are required to report to their work locations during the COVID-19 pandemic, while "non-essential" city workers are asked to stay and (in some cases) work from home.

"I believe this is an issue of fairness and one that we need to look at closely, especially with the likelihood that the 'stay home' orders could be in effect for many weeks if not months to come," Alderwoman Coggs said.

The measure could come before the Finance and Personnel Committee when it meets on April 9 at City Hall.

### Residents urged to abide by "Stay-at-Home" order

The global pandemic brought about by COVID-19 has caused the city and state to issue "Stay-at-Home" orders to help slow the spread of the virus. Alderman Khalif J. Rainey is urging city residents, particularly those of the 7th District, to take this order seriously and remain at home.

"The orders issued by the city and state this week underscore how serious this health emergency is," said Alderman Rainey. "I implore all residents to stay at home unless it is absolutely necessary to leave. I particularly want to encourage residents near St. Joseph's and the Sherman Park area to abide by these orders, as those places have seen the greatest concentration of positive cases."

Beginning Tuesday, March 24th

All drive-thru tests are by appointment only. Individuals who wish to be tested must first be pre-screened by Ascension Medical Group provider by phone (1-833-981-0711), or virtually using Ascension Online Care (ascension.org/OnlineCare).

The "Stay-at-Home" order aims to ensure that the maximum number of people self-isolate in their places of residence to slow the spread of the virus.

Residents should only leave their home to perform or obtain vital services. Among the businesses that remain open are grocery and supply stores, health care facilities and pharmacies, restaurants (take-out only), child care facilities, auto shops and gas stations.

Should someone have to leave their home they should follow the appropriate precautions. Practice proper social distancing and remain six feet apart from other people, remember to regularly wash your hands with soap and water for at least 20 seconds, cover coughs and sneezes, avoid touching your face, and stay home if you feel sick.

The order went into effective at 12:01 a.m. on March 25, 2020 and will continue to be in effect until it is extended, rescinded, superseded, or amended in writing by the Health Commissioner.
