## BLACK ARTS FEST MKE

Announces Cancellation Amid COVID-19 Pandemic

Recently, Black Arts Fest MKE (BAFMKE) announced the cancellation of its Aug. 1, 2020 festival at the Henry Maier festival grounds.

The final decision to cancel comes after careful consideration of the mounting health concerns and community hardships arising from the COVID-19 pandemic.

Festival organizers recognize that the Safer at Home mandates may be removed by August but in the end, it is impossible to predict future mandates for large social gatherings in this time of health crisis and uncertainty.

Although our community enjoys attending the festival, given the disproportionate rate that COVID-19 has affected African Americans, the board has made the difficult but responsible decision to cancel the festival for this year.

"We appreciate the value of our annual gathering but prioritize our community's



health and safety above all else." says Derek Tyus, chairman of BAFMKE's board of directors.

Black Arts Fest MKE is an anchor in our community and a vital part of Milwaukee's summertime ethnic festivals.

Celebrating our heritage, culture, and unity is a must. The board of Black Arts Fest MKE looks forward to returning to Henry Maier Festival Park in August 2021.



## New citation option to help prevent spread of coronavirus in MKE

Action was taken recently by the Common Council will allow Milwaukee Police and the Health Department to issue a citation up to \$500 in rare instances where individuals are deliberately violating the Safer at Home order that is in place in the city to help prevent the spread of coronavirus (COVID-19).

Alderman José G. Pérez said the ordinance approved Tuesday by the full Common

Council relates to enforcement of "communicable disease orders" and authorizes the Commissioner of Health and police officers "to issue orders and citations to any persons who willfully violate or obstruct the execution of an order" issued under city or state jurisdiction.

"Quite simply, this action does not affect the range of options and discretion for law enforcement for enforcing the 'Safer At Home' orders related

to COVID-19," Alderman Pérez said. "What it does is it allows a middle ground for citations to be issued."

"If you are traveling to visit your parents or just heading to or from the store, or working in your yard, this will not impact you.

"But if you are attending a party or hanging out with a large group on the corner

(non-essential activities), a citation could become an option for officers as you are clearly not abiding by the stay home order,” the alderman said.

“We want to emphasize the importance of educating the public about the stay home order, but where it is needed (in rare instances) there also must be an option for arrest and pursuing criminal charges when individuals are willfully violating the order,” he said.

An amendment to the ordinance states, in part, that “the City of Milwaukee, in its efforts to ensure compliance with the State of Wisconsin’s ‘Safer At Home’ order, wishes to maintain a full range of enforcement options, from education to arrest.”

# MKE Common Council votes to send every registered voter absentee ballot application

The Milwaukee Common Council voted unanimously recently to approve a new plan that would mail every registered voter in the city an application for an absentee ballot.

The plan would authorize the executive director of the Milwaukee Election Commission to create what is called the "SafeVote program."

Along with mailing absentee ballot applications en masse, everyone in the City of Milwaukee would also receive a postage-paid envelope to return the application.

"The right to vote is sacred in our democracy, and I am grateful for the support of my colleagues on SafeVote," Alderwoman Marina Dimitrijevic, who authored the resolution, said. "The unprecedented COVID-19 pandemic has made congregating in groups a threat to public health, and we recognize that voting by mail must be seen as the best way to ensure the best possible participation in a vital election."

Alderman Khalif J. Rainey, the measure's primary co-sponsor, said the resolution will help prevent a repeat of this spring's election, in which nearly 20,000 Milwaukeeans braved the coronavirus pandemic to vote in person.

"The spectacle of thou-

sands of citizens gathering to vote on April 7, while in a way inspiring, was an unacceptable danger to their own well-being and that of others," Alderman Rainey said.

"Affording residents the opportunity to vote by mail in an efficient and safe manner is the right way to go this fall."

The resolution will need to be approved by Mayor Tom Barrett before it is put into practice.

### COMMITTS \$3 MILLION IN FUNDING TO SUPPORT COVID-19 RESPONSE

*First round of grants to support current grantees and immediate COVID-19 response efforts in Milwaukee and Hawaii.*

Zilber Family Foundation Board of Directors announced the allocation of \$3 million in emergency funding to address the effects of the COVID-19 pan-

demic.

The funds will support organizations in Milwaukee, where the Foundation invests the majority of its resources, as well as in Hawaii, where it makes more targeted grants.

The new grants will support general operating expenses for the Foundation’s current grantees and immediate response efforts to meet the urgent needs of those adversely affected by COVID-19. Funding will be awarded on a rolling basis and allocated across three categories:

- Grants of up to \$25,000 to help current grantee organizations meet emerging needs and sustain operations, with a priority on organizations that contribute to reducing the economic, social, and health effects of the pandemic.
- The Foundation’s support for its current grantees also includes added flexibility in meeting the requirements of existing grants.
- One-time emergency grants of up to \$100,000 to current grantees addressing basic human needs,

housing, public health, and small business, with a priority on organizations and activities that have a clear and direct role in limiting, shortening, or minimizing the economic, social, and health effects of the pandemic.

- Grants to support pooled community-based emergency response funds that address the effects of COVID-19 on high-need populations across the community.

To date, the Foundation has awarded \$100,000 grants to two organizations, the MKE Response Fund of the Greater Milwaukee Foundation and the Hawaii Resilience Fund of the Hawaii Community Foundation.

“Many of our nonprofit partners serve on the front lines of the pandemic and need a quick infusion of funding to help meet an increase in demand for services and programs, and to maintain financial stability during this crisis.

“We want to ensure that nonprofits and the communities they serve are able to respond to this crisis and

thrive in the future,” said Gina Stilp, executive director.

The Foundation is inspired by our community coming together at this unprecedented time, and we will continue to contribute critical and targeted resources as the situation evolves.”

In addition to the COVID-19 funding, Zilber Family Foundation recently awarded grants totaling \$1.5 million to 19 nonprofit organizations.

The grants support organizations that address affordable housing and community economic development in the Zilber Neighborhood Initiative’s three targeted Milwaukee neighborhoods of Lindsay Heights, Clarke Square, and Layton Boulevard West.

Additional grants support organizations focused on youth development and basic human needs in Milwaukee and Hawaii.

## WISCONSIN'S BADGER BOUNCE BACK PLAN

The plan requires a 14-day decline in the number of new cases of the virus before state health officials may move the state into a new phase of reviving the economy.

1. In the first phase, schools could resume classroom instruction, restaurants could re-open with restrictions and Wisconsin residents could gather in groups of up to 10 people.

2. The plan's second phase would allow gatherings of up to 50 people, restaurants to resume normal operations, bars to open with social distancing restrictions and non-essential businesses resuming operations with similar restrictions. Colleges and universities also could resume instruction.

3. In the third and last phase, all businesses may resume operations and gatherings will have no size limits. Minimal protective and preventative measures would be in place for people at high risk of becoming seriously ill by the virus.
