WITH STATE STAY AT HOME ORDER STRUCK DOWN, MAYOR BARRETT ANNOUNCES PROGRAM TO RESTART LOCAL BUSINESSES AND GET THEM UP AND RUNNING

Relief funds from the federal government will be used to assist established Milwaukee businesses as part of a recently unveiled city program to help them recover from COVID-19 related setbacks.

"From the outset, we've been fully aware that we are in the midst of more than a public health crisis; we face an enormous economic crisis, affecting workers and business owners," said Mayor Tom Barrett announcing the launch of the Milwaukee Business Restart Program.

"Our Business Restart program aims to help small Milwaukee employers get back on their feet as promptly as possible."

The program is targeted at small businesses significantly impacted by the COVID-19 crisis. The city will also support the restart of neighborhood businesses in all parts of Milwaukee.

The new city program comes on the heels of a new order created and issued by city of Milwaukee Health Department that prioritizes the health and safety of residents.

The order was created based on recommendations from public health officials. Health officials will

work with local business owners to establish guidelines and safety measures to build the trust of patrons and minimize the spread of COVID-19. "Everybody's goal is to reopen

the economy. But, we have seen what happened in other parts of this country and we have seen what has happened in other parts of the world, where you have had a rush to reopen things," Barrett said.

Despite COVID-19 related economic challenges, retailers joined the HOL SUNDAY" effort by agreeing not to sell menthol tobacco

In the midst of a pandemic that has jeopardized small businesses across the country, more than 40 tobacco retailers in Milwaukee risked a loss of sales by not selling menthol tobacco products Sunday, May 17, as part of "No Menthol Sunday."

"No Menthol Sunday," was a national day of observance led by the National African American Tobacco Prevention Network and supported locally by the Wisconsin African-American Tobacco Prevention Network (WAATPN), an interfaith and communityled effort to raise awareness about the impact of tobacco use on communities of color.

The day was marked this year through virtual sermons, on social media, and through other activities Faith leaders and others shared information on how menthol tobacco has been historically targeted to communities of color, how smoking and vaping can weaken your immune system and put you at higher risks of severe illness or death from COVID-19, and discuss other ways that flavored tobacco such as menthol threatens health.

Retailers, who have also supported the WAATPN's "No Singles/No Loosies" campaign to end the sale of single cigarettes in Milwaukee, jumped on board to this effort to raise awareness on tobacco's impact on health by posting signs in their storefronts warning residents about COVID-19 related dangers for smok-

more death and more suffering. And, that is exactly what we want to

COVID-19 is present in every municipality across Milwaukee County, and public health experts warn that additional surges in cases, hospitalizations and deaths are a reality moving forward.

Social distancing has been a necessary step in allowing health care systems to build capacity increase testing and tracing and develop a plan for moving forward.

In the order, city health officials have also fashioned a plan that will be the foundation of Restart Milwaukee, called "Moving Milwaukee Forward."

In developing "Moving Milwaukee Forward," health officials considered the following criteria:

- The rate of spread of COVID-19 in Wisconsin
- The health care capacity to meet the needs of the state
- The testing, contact tracing, and isolation capacity in the state

• The availability of personal protective equipment for health care workers, first responders, and other public servants that are required to perform face-to-face services; and the economic needs of Wisconsin and Wisconsinites.

The new city restart program and health plan comes almost a week after a Wisconsin Supreme Court ruling overturning the state's "Stayat-Home" order, which the court called "unlawful" and "unenforce-

The "Stay-at-Home" order was issued state-wide on March 24 by Gov. Tony Evers. The order shut down all economic, educational and social activity in the state accept for those businesses and government services deemed essential, such as doctors, nurses, police, firefighters, and food store employees working at stores still open during the shut-


But Republican state legislators filed a lawsuit against Evers' administration, claiming it overstepped its authority when the state Department of Health Services (DHS) extended the Stay-at-Home order to May 26.

At the time of the court decision, Evers said the ruling put Wisconsin in a state of chaos.

"Now we have no plan and no protections for the people of Wisconsin," he said.

Barrett's response to the court order was to reinforce to residents the city's commitment to continue the city's "stay-at-home" order that it issued the day before the state's, which also prohibited public gatherings, restaurants, and bar operations.

Since the court ruling, city government officials have been working collaboratively with the Milwaukee Economic Development Corporation (MEDC) and will provide city grants to businesses so they can restock perishable inven-

tory, purchase personal protective equipment (PPE), and accommodate social distancing guidance.

The city anticipates disbursing grants in the coming weeks, and, rather than a first-come-first-served application process, proposals from eligible businesses will be consid-

Barrett Shares Specifics on **Business** Restart

Small Businesses Eligible for Up to \$15,000 to Resume Operations

Grants

Milwaukee Mayor Tom Barrett announced Wednesday, specifics on how the Milwaukee Business Restart Program will assist small local businesses as they resume operations.

Applications for grants through this program will be available beginning Thursday, May 28th and those applications will be accepted over a two week period ending Friday, June 12th. Starting Thursday, businesses can apply at: Milwaukee.gov/restart

The Milwaukee Business Restart Program is designed to get City of Milwaukee small businesses up and running following setbacks associated with the current

COVID-19 pandemic.

Grants will be available to businesses established before the end of 2019 with annualized revenue of less than \$2-million and 20 or fewer full-time-equivalent employees.

At this stage, the Restart program will be funded with a total of \$2-million in federal CARES Act money allocated to the City of Milwaukee. In-

Details of the program are being finalized, including the application process, the size of the grants, and the total amount of founds available. Specifics of the restart program will be unveiled soon.

All residents are encouraged to remain diligent in following guidelines to decrease the spread of COVID-19: staying home with family, wash hands and surfaces often, keep six feet or more away from others in public spaces, not meet in groups of any size and cover your nose and mouth with a mask or

dividual Milwaukee small businesses will be eligible for up to \$15-thousand each for expenses in three categories:

 The purchase of personal protective equipment for employees

 Investments in modifications to business spaces and operations that reduce the spread of disease

 Restocking perishable inventory

There will be additional limitations of what business costs will be eligible for grant allocations.

"Small businesses play a vital role in creating jobs, in driving our economy, and in maintaining the character of neighborhoods all across Milwaukee," Mayor Barrett said.

"I want our local businesses to have a fighting chance to get back to profitability as we adapt to new public health requirements and expectations."

The Department of City Development, with the cooperation of the Milwaukee Economic Development Corporation, plans to start distributing grants as soon as possible after June 12th. All timely applications will be reviewed and not considered on a first-come-first-served basis.

All businesses in Milwaukee, including grant recipients, will be expected to follow directives from the Milwaukee Health Department to reduce exposure and transmission of COVID-19.







Muslims commemorate first Muslim centennial with nationwide virtual iftars

Events draw U.S. Senators, members of House of Representatives and law enforcement in over 50 U.S. cities

The nation's oldest Muslim organization recently hosted Virtual Interfaith Iftar events across the country in commemoration of its historical centennial year.

As the first Muslim organization to accomplish 100 years in America, Ahmadiyya Muslim Community USA invited Americans across the country to unite together in interfaith virtual iftar celebrations amid the pandemic stay-at-home orders.

More than 120 public officials attended the Iftars across more than 50 U.S. cities.

Among these officials included 14 members of the U.S. Congress, dozens of members of state and local governments (including state representatives, state senators, mayors, city council members and assembly members), as well as

members of law enforcement. Faith leaders from various religious traditions also joined the virtual gatherings.

The events began by celebrating the historic centennial of the Ahmadiyya Muslim Community with a 5-minute video highlighting the 100-year journey since the community was established in America in 1920.

Each guest speaker then spoke passionately about how prayer, empathy and togetherness are essential now more than even

U.S. Senator Tim Kaine (D-VA) joined the Iftar in Richmond, VA, and congratulated the Ahmadiyya Muslim Community centennial by highlighting its motto: "Congratulations on the Centennial of 100 years.

It must have seemed like a Herculean task to come to the United States and introduce the Ahmadiyya faith to the American public, but the value of 'Love for All, and Hatred for None' was not a value that was foreign to the shores

Even if we don't live that way, the equality principle that all are created equal is very close to the value expressed in the Ahmadiyya [Muslim] Community."

The Senator concluded his remarks with a prayer of his own: "In this time of great challenge, even when we can't exactly understand why it's all happening... just don't abandon your faith and your principles...That's my prayer for all of us – that we hold to our faith in our religious values and we hold to our faith in the values of this country."

"You have a 100-year experience here in the United States, and our country has had the good fortune to have you become such an integral part of our communities.

But there is no reason at all that in countries such as

Pakistan – which at times claims to be an American ally – that you should be subjected to any type of persecution, never mind the horrible kind of persecution that you are forced to deal with," remarked U.S. Representative Pete King (R-NY) while speaking at the Long Island Virtual Iftar about the persecution the Ahmadiyya Muslim Community has faced in different countries around the world.

"At a time when there are terrible disputes going on in the world and divisions between people, religions, countries and ethnic groups, no one has been more stalwart in the defense of the United States than the Ahmadiyya [Muslim] Community. So, I am proud to call you my friends. I look forward to continuing working with you."

U.S. Representative Suzanne Bonamici (D-OR) was among the many members of Congress to also join a virtual Iftar, this one in Portland, Oregon. "Ramadan under quarantine is very different but still very meaningful. It's important to distance ourselves physically, but we must not distance ourselves socially, culturally, or spiritually which is why I so appreciate this Interfaith Iftar...I know the Ahmadiyya Community has always worked for unity for peace, for equality...Love for all, and hate for none."

In the end, thousands of Americans of various faiths joined the Ahmadiyya Muslim Community for the Centennial Interfaith Iftars around the country.



The Quora Digest website and the tenticles of racist propaganda

Question: "Why do some people vilify Black people?"

Answer: "Because they have to!"

That caustic response, to what I assume was a legitimate question, only makes sense from the perspective of an ignorant, impotent, imbecile. Or, more likely, some rancid racist roach.

Believe it or not, this exchange represents one of the less incendiary dialogues you'll find if you scan one of my favorite websites, 'Quora Digest.'

I say favorite not because of similarly ridiculous Q&A's, but because you'll also find a miscellany of intriguing questions, answered by experts and laymen covering an array of topics. Including race.

Anyone can pose a question on the site, and apparently, anyone can answer. But I generally restrict my focus to those inquiries answered by scholars or individuals with qualifications and creditability. I ignore most hypothetical questions requiring a subjective response.

The website attracts a diverse readership, from radicals to racists, liberals and conservatives, the callous and the corny.

And there is little censorship, which explains why so many racists are allowed to taint the canvas with their rancid commentary disguised as 'exper-

In fact, I was surprised earlier this year when I responded to a question posed by someone who was as ignorant as he or she was xenophobic.

My response, including a sarcastic analysis, was published, inciting a slew of reactions from the left, right, and center.

But that's not what heightened my interest in the site.

Instead, it was my discovery that many similar racists questions, posed by equally obnoxious White provocateurs could be found in the website's dark alleys and intersections.

I'm not on a mission to educate the misinformed and prejudicial. Instead, I find it interesting to follow the tentacles of racist propaganda.

If you can gauge the extent and reach of racism and ethnic ignorance in America by the percentage of participants on legitimate websites like Quora you can assess the extent of racial polarization in America, and how far we have yet to travel to realize Dr. Martin Luther King's dream.

In fact, in some respects, racism is merely a complication of ignorance, a fact you'll discover when visiting sites like Quora.

Take for example a question posed by a seemingly intelligent White man





'Do different colors (races) confer advantages on those who have them?' I found that question intriguing until the following day when I ran across another question apparently written by a kindergarten dropout who asked: 'What are some things you can't do as a Black person?'

Had I felt the impulse to respond, I would have answered with a long list of prohibitions including: drive through a suburban area after dark, speak with authority to a police officer, or jog through an area where vigilantes are waiting to prove their manhood.'

If the site separated the ridiculous from well-intentioned racialized questions, I could more readily navigate the site, visiting one for information and the other for entertainment.

But since you don't know if an author is serious, ignorant, or stupid, you're forced to accept paradoxical responses, often with a grain of sarcasm.

For example, how would you respond to the question: 'Why do many Black people only befriend Black people?' Or: 'Who taught you to fear Black peo-

What about: 'Why do some people hate Black people (solely) because of

Then there's 'why are White people vilified for being white?'

And, one of my favorites: 'How do Black people discriminate against White

I've long hypothesized that ignorance is the absence of knowledge; stupidity is the abuse of it. Insanity is not knowing the difference.

Using that analogy, a lot of the questions are from people who are genuinely ignorant of and about African Americans, apartheid and even the existence of White privilege. Then again, I assume many individuals who submit such inane questions are 50 playing cards short of a full deck.

Then again, millions of Whites have never come in physical contact with 'a Hueman.' Their only knowledge of us is through movies, the media, and tainted/ distorted history. Excuse me, make that 'His-story.'

That's why I don't get mad when I read a question like: 'Is it okay for a White person to call an African American "Black"?' Or: 'Why is it so easy to differentiate African Blacks from African American

And then there's: 'Why are American Blacks—who are not immigrants from

Africa—called African Americans, but American Whites are not called European Americans?' Would you assume someone who asks, 'why are Black and Hispanic people the majority of occupants in public housing?' is ignorant of institutional

racism and its contribution to generational poverty? The site also hosts many dubious questions, those that straddle the fence between legitimate inquiries and duplicity.

For example, on Sunday I had to give pause when I saw the following question: "are television channels (BET) and other 'things' (HBCUs) restricted to Black people discriminatory?'

There are several ways to answer that question, or you could just flip the script and ask is the KKK discriminatory because it's members don't recruit in the Black community? Also, why is affirmative action necessary in Amer-

My bonus/bogus question, appropriately asked during the pandemic: 'Why don't Black Americans look like Africans?'

Had I chose to, I probably would have answered that question with my usual sarcasm. Or, I could 'Signify' by telling the truth: Because our ancestors were brought here to become your human chattel. Your ancestors, including the self-righteous founding fathers, raped our great grandmothers while wearing crosses and hypocritically declaring themselves to be Christians.

The racist history behind Ahmaud Arbery's body being posted on Snapchat

On May 17, 1916 a young racist white man sent his parents a ghastly postcard from Waco, Texas.

A sepia photograph on the face of the card centers the charred naked torso of 17year-old Jesse Washington who had been tortured and lynched in front of 50,000 spectators for allegedly raping and murdering a white

Just below his curled limbs, a mob of hard-faced white men and boys form a calm and proud half circle around their handiwork.

of the postcard reads: "This is the barbeque we had last night. My picture is to the left with a cross over it. Your son Joe."

A little over 100 years later, Lindsay McMichael, a 30-year-old white woman from Brunswick, Georgia, got her hands on an unedited photo of 25-year-old Ahmaud Arbery's lifeless blood-soaked body lying on the street after he was lynched in broad

Presumably, after her father Gregory McMichael and her brother Travis McMichael hunted down and shot the unarmed jogger while fearing for their lives, they snapped a photo of their kill and shared it with Lindsay and others who continued to

circulate it in the local community. Large cursive writing on the back News reports indicate that she then posted the photo on Snapchat to expand the audience of viewers.

> She tried to obfuscate her own perverse pleasure for Black death by claiming that she's supposedly a "true crime fan" who didn't realize that posting the dead body of the man her father and brother killed was in

She's now apologetic. "I had no nefarious intent when I posted that picture. It was more of a, 'Holy shit, I can't believe this happened.' It was absolutely poor judgment," she said.

She added that because her father and brother "always loved her nonwhite boyfriends," murdering Arbery was neither intentional nor racially motivated. "I just want people to realize that we're not monsters," she



This astute observation by Merritt not only applies to this individual southern white family, but to a broader national visual tradition of white racists who have celebrated Black death across generations. As historians have noted, taking photos of murdered Black people is an indelible part of the choreography of lynching.

In the late 19th and early 20th century, photographers quickly reproduced duplicates of lynching photos and sold them right at the scene of

Advancements in print technology transformed racial violence into a na-

The development of cheap post-



cards and the movement of mail through the US Postal System via the railways, along with the national media, turned these visuals into highly-sought-after, mass-produced consumer goods that got shared socially and stored in private family albums and homes.

Lynching photos were trophies regarded as objects of white heroism and they were intended to terrorize black communities.

By the 1920s, the NAACP's campaigns against lynching, along with persistent investigations by the Black press, turned these objects from trophies into evidence of white barbarism and civil rights activism.

Decades later, Mamie Till took control over her 14-year-old son's mutilated body by using a horrific photo of his battered and swollen face as an indictment against his

By allowing Emmett Till's image to be published on the cover of JET Magazine, Till reframed the national discourse on the Ku Klux Klan and showcased how degraded white supremacists were unapologetic about destroying black children.

Today, with electronic social media and camera phones, images of Black death at the hands of police and white vigilantes have reemerged and get zipped around the world in

These viral videos and images are similar to lynching photography and serve the same symbolic function as

At the same time, Black people have been engaged in citizen journalism by using camera phones to capture white-on-Black murders and daily terror, whether it is a truck driver or UPS delivery man being harassed on the job, or a man recording his own death-by-cop on Facebook

Though separated by time and place, both Joe and Lindsay and the respective photographers punctuated the lynchings of two debased young Black males by sharing deeply gratifying totemic relics of heroism, sadism, and the lawless privilege of whiteness in America.

In 1916 and 1920, these souvenirs not only offered unmediated access to racial horrors, but they also created a shared experience that united their families, and by extension, white nationalists across America.

Sending photos to sympathetic eyes allowed them to assuage perversely curious spectators who missed the thrill of intimately witnessing or participating in the killing of a Black man.

Unlike Joe who witnessed the lynching of Jesse Washington up

close and personal, got to pose with the corpse and sent a postcard home to make his ma and pa proud of him for his contribution to white supremacy, having a photo of Arbery's dead body provided Lindsay with a safe, removed glimpse of the kill while shoring up her sense of safety in her status as a protected white

If we reluctantly give her father and brother the benefit of the doubt they may have wanted photographic evidence to exonerate them at trial But once she shared the photo on social media, without subverting it into condemnation, it proves that she is in fact a monster. She is a savage who loves white men who kill black people and she is complicit in the terrorization of Black communities.

Make no mistake about it — Lindsay McMichael felt the emotive power and enjoyed the display of her father and brother's cruel work of brutal racist communal justice, just like Joe did in 1916.

The Quora website and the tenticles of racist propaganda

Fortunately, much of what you might find on the Quora website is educational and entertaining.

If you like history, there is much to appreciate. There are also theological questions posed by atheists and/or agnostics; questions that challenge your faith, or at least prompt additional biblical research.

There are also many historical questions that provide answers you won't learn in public schools where you are taught to conform and salute the flag. I've learned a lot about 12th-century hygiene, the reigns of obscure nations, and even about the genetic makeup of Hitler (who would have guessed he

had Jewish blood?). A question about the origins of man led me to research Kemetic antiquity while solidifying my appreciation of the blood that flows through my veins.

But it the racial inquires that usually attract my greatest interest. Not just because of the diversity of questions, but also because it provides you with a renewed awareness of the general lack of intelligence and education of the folks who elect presidents and support policies.

I learned a long time ago there are more pawns on the civil rights battlefield

than knights or bishops. And most of those pawns are blind, dumb, or impotent (or, all three).

Worse still, most pawns don't know that they are pawns. White privilege has them believing they are kings or queens.

That reality explains why so many people voted for Donald Trump, and continue to defend his lunacy and lies. It also explains why they can ask dumb or naïve questions on the Quora website.

If you learn nothing else navigating the site, its that a whole lot of otherwise observant White folks know so very little about us.

Which explains a lot, including why they continue asking what I can only assume are stupid or rhetorical questions, including: "Why are Black people called "black" and White people called "white" when the skin color of the vast majority of both groups isn't "black" or "white"?

And my favorite of the year, 'what would happen in the world if there were only White people?'

Hmmm, gotta think about that one...

Diverse Board of MKE Cnty Supervisors United in Urgent Appeal for Federal Aid

The Board of Supervisors unanimously (18-0) called on the U.S. Congress to pass and President Donald J. Trump to sign a \$500 billion emergency stabilization aid package for counties and cities across America today. In a remarkable show of unity among the diverse Board, thirteen supervisors asked to be added as co-sponsors of the measure introduced by Chairwoman Nicholson and Supervisors Czarnezki and Rolland.

"We are facing a massive budget gap next year as a result of the coronavirus. Without additional support from the federal government, we will not be able to adequately fund essential public services," said Chairwoman Marcelia Nicholson.

At today's Committee the Whole meeting, Supervisors learned that the County will lose at least \$105 million in expected revenue this year. Unless additional support is provided, the county could face a \$34 million shortfall for 2020, despite \$30 million in expenditure reductions that have already been implemented, and some federal aid. On top of the 2020 gap, analysts expect to start the 2021 budget process with a minimum \$40 million deficit.

"Now is the time for the federal government to step in and protect the public from the coronavirus's catastrophic effects on the fiscal health of the Mil-

Order #1 on Friday, May 15 and has already moved to the next phase of reopening.

In preparation for this next phase of the reopening beginning on Friday, May 22, local health departments are communicating with businesses throughout their communities to share best practices and guidance about how they can reopen and operate safely.

Many businesses will likely change the way they operate to provide physical distancing between patrons, increased attention to sanitation, and more changes designed to minimize the transmission of COVID-19.

Health departments are diligently working with business leaders to ensure they have what they need to reopen in a manner that is consistent with the recommended guidance.

Public health leaders have carefully tracked key indicators to guide the safe reopening across the city, county and state.
