



ing - that are facing our community.

We want everyone in our community to live without barriers to optimal health. But unfortunately, too many residents continue to experience health disparities daily, and they have only been further exasperated by COVID-19.

Across the country we've seen elected leaders invest in evidenced based strategies that can help meet today's challenges, while also building a foundation for long-term health. To that end, we are asking the Milwaukee Common Council to invest in the following initiatives in the City's 2021 budget:

- Complete Streets: Getting around by walking or biking continues to be too difficult and unsafe for far too many residents, particularly those in underserved communities. Complete Streets projects help improve health and safety for residents, while also benefitting the local economy. We must prioritize these projects so that all residents can safely walk, bike and be active in their neighborhood.
- SNAP fruit and vegetable incentive programs: Several states and communities across the country have created incentive programs, providing additional funding for SNAP participants to purchase healthy foods (oftentimes called Double Dollars or Market Match). These programs are a win for families, farmers and the local economy. With need at an all-time high, it's time for Milwaukee to create a similar program.
- · Water filling stations in schools: Water is a basic human need, and access to safe, clean water in schools must be a priority. As we think about how to safely send kids back to school, we should consider investing in sensor-activated bottle filling stations. These units help prevent transfer of germs, while filtering lead and other harmful substances out of the water.

We completely understand the difficult situation our elected leaders are in – revenues are down, and the need is greater than ever. We also understand budgets are about priorities, and we have the opportunity to invest in programs that not only will address today's immediate concerns but will also break down barriers and truly move us towards a more equitable Milwaukee.


MILWAUKEE REP WELCOMES NEW **GROUP OF EMERGING PROFESSIONAL RESIDENTS FOR RESET SEASON**



TORONTO, ON – Health experts the world over are in agreement: face masks and face coverings are the proven first line of defence against airborne viruses, bacteria, pollen and pollution.

That only tells part of the story, portion of one's face. That leaves though, because face masks (of

a LOT of exposed skin at risk the "surgical" variety) only cover a when we're up close & personal

It's an ingrained habit that's extremely difficult to break - we do it without a second thought. One might say, when it comes to spreading sickness we're our own worst enemies!"

Beauty industry professionals are intimately familiar with your Tzone: they work with that area day in and day out. You can trust these trained professionals to keep you - and your T-zone - covered.

Jeff Alford's 5 TIPS on HOW TO **AVOID TOUCHING YOUR FACE**

- 1. Love the Glove: There once was a time when silky shoulder-length gloves were worn by wealthy women looking to avoid contact with a world awash in incurable pathogens. The more things change, as the old cliché goes, the more they stay the same! Light, breathable gloves - many brands are touchscreen-friendly - can keep your hands virus-free while discouraging direct hand-to-face contact.
- 2. Making Scents: The nifty thing about scented hand creams, hand sanitizers and lotions is that once you've applied them, you won't typically smell them again unless you bring your hand close to your nose. When you do, you'll notice the scent and remember NOT to finish that particular hand motion with facial contact.
- 3. The Paper Chase: Facial tissues the name itself should give you a clue! A strategically-placed box of "Kleenex" (any brand will do, actually) should be your go-to when eyes water, noses run or your milk moustache has worn out its welcome. Paper things over – it's a smooth move!
- 4. Notes to Self: Since we often touch our faces unconsciously, we need to remind ourselves consciously - and constantly - to NOT do it. Those colorful little Post-It Notes can be ideal reminders! Stick one on your make-up mirror, another on your monitor screen, yet another on your car's rear-view mirror... you get the picture. Whoever thought brain-training could be so simple, so helpful, and so healthful?
- 5. Wear a T-ZONE MASK: Now that we've learned the value of keeping our hands to ourselves - or more to the point, from ourselves, the beauty industry is addressing the other side of the anti-viral coin: inadequate face masks. "Not touching your mucus membranes, an area known as the T-zone, is perhaps the most important step you can take to prevent an infection," explains Dr. William Sawyer, founder of the Henry the Hand Foundation (a Cincinnati-based non-profit organization that promotes hand hygiene). "It's the one behaviour that would be better than any vaccine ever created," adds Sawyer.

Landlords can resume eviction proceedings after the Centers for Disease Control and Prevention issued clarifications to a previous executive order from President Donald Trump.

The CDC's memo released this week noted that its order "isn't intended to prevent landlords from starting eviction proceedings, provided that the actual eviction of a covered person for non-payment of rent does NOT take place during the period of the Order."

Further, the memo states that "landlords are not required to make their tenants aware of" Trump's eviction moratorium and the CDC's declaration form that renters must fill out to qualify.

Following the coronavirus pandemic outbreak, Trump issued an executive order that forced the CDC to temporarily halt evictions through the end of the year.

Diane Yentel, the nonprofit National Low-Income Housing Coalition president, suggested that Trump's order should have been accompanied with legislation and substantial emergency assistance.

Yentel declared that monetary aid was necessary because of a "wave of homelessness" facing the country.

Many experts said the government should mimic Washington, DC Mayor Muriel Bowser and the DC City

In September, the DC City Council voted unanimously an extension to Bowser's state of emergency order, which prohibits evictions and ties them to the health emergency.

The Council's action allows Bowser to extend the city's moratorium on evictions as long as she opts for one.

The District's law also bans new eviction filings, a move that will last for an additional two months following the end of the pandemic.

Further, notices to vacate are legally unenforceable during the eviction ban.

"When ... my email box is flooded with resident outrage, we want to act quickly, and I agree," D.C. At-large Councilmember Elissa Silverman told reporters. "But we also need to act thoroughly. The entire eviction process needs to be, I think, examined, and all of these recommendations made in the story deserve our consideration."

A study conducted by Harvard University's Department of Housing Studies revealed that half of Americans who

rent are either severely rentburdened or moderately rentburdened.

For African Americans and

holds were "much more likely to contract COVID-19, suffer lost income, and face housing insecurity as a result of the pandemic," the researchers concluded.

"It's a good time for the United States to really re-look at our housing policies," Yentel told Yahoo! News. "And see what changes need to be made post-pandemic or even during the pandemic to help those who were already struggling."

The U.S. Census Bureau reported that about 30 percent of American adults face some form of eviction or foreclosure by December.

To help protect against eviction, tenants must show that their 2020 income is less than 2019, and they have to prove that the coronavirus caused them to lose employment or the ability to earn money.

The CDC memo did provide a steadier position for homeliest.

The CDC memo also reinforced cries for a new federal stimulus. However, the Trump administration and Democrats have remained apart in negotiations.

"If Trump walks away from passing a stimulus, we are staring down the barrel of one of largest mass evictions in American history," Congresswoman Alexandria Ocasio-Cortez said in a Twitter post.

Vermont Democratic Sen. Bernie Sanders also tweeted his concern.

"The tsunami of evictions we are about to see is unacceptable."

In a statement, the American Civil Liberties Union also called for a stimulus agreement to assist financially ailing Americans.




