Joe Biden wins Wisconsin and Michigan, Trump to ask for recount; several states still counting absentee ballots!

ne day after the November 3 election, Democratic Presidential candidate Joe Biden was declared the winner in Wisconsin, collecting 10 electorial votes.

As of this writing, the Wisconsin victory gives Biden 237 electorial votes to incumbent President Donald Trump's 213. Both candidates need 270 total electoral college votes to clinch the presidency. (Later in the day, it was announced Biden won Michigan, bringing his electoral college total to 253. He needs 17 electoral votes to clinch).

The Trump campaign says it will ask for a recount in Wisconsin, citing unsubstantiated claims of voter fraud. Votes are still being counted in Pennsylvania, Georgia, and Nevada.

The impasse-though expected-has put America in uncharted territory: the pillar of democracy, liberty and freedom around the world with no clear definite winner of the one office the world (despite Trump) still looks up to.

Below are the final results of races important to Milwaukee's Black community.

Unlike the presidential race, local and state races saw incumbents and first-time, front-runner candidates win as predicted, with two candidates running unopposed. -- The MCJ Editorial Staff



**Marc Lamont Hill on tight** presidential race:

## 'If racism isn't a deal-breaker for you, you are indeed racist'

It's the day after the 2020 election and America is still waiting to see who will be the next president.

The race between President Donald Trump (R) and presidential candidate Joe Biden (D) is very close.

According to NPR, Biden is currently leading with 248 electoral votes, compared to Trump's 214. A total of 270 electoral votes is needed to become presi-

The following states are still counting votes: Alaska, Arizona, Georgia, Michigan, Nevada, North Carolina and Pennsylvania.

In Marc Lamont Hill's latest opinion video, he discusses how Trump winning many states tells you everything you need to know

about America. "After four years of lies, four years of mismanagement, four years of incivility, four years of anti-Semitism, four years of anti-Black racism, four years of economic decline for the vulnerable—and after a year where 200,000plus people have died of COVID, people still went in the booth and pulled the lever for Trump," says Hill.



**Marc Lamont Hill:** 

"After four years of lies, four years of mismanagement, four years of incivility, four years of anti-Semitism, four years of anti-Black racism, four years of economic decline for the vulnerable—and after a year where 200,000plus people have died of **COVID**, people still went in the booth and pulled the lever for Trump!"

The professor and author also argued that if anti-semitism, white supremacy and white nationalism aren't big enough reasons for you to vote against Trump, even if you don't identify as those things, you still are racist.

"White workers in states like Ohio and Pennsylvania were uncertain who to vote for," says Hill.

"Latino communities have been stigmatized by Trump, voted for Trump because they also buy into the lie of America. The lie of America is that this is a country that is as good as its promised on paper."

Hill continues: "It has never been. Not for Black folk, not for brown folk, not for women, not for poor folk, not for immigrants who don't look a certain way.

"The lie of America is that anybody can just make it with hard work when in fact, their labor is being ex-

People keep buying into the lie, and white people every single time will close ranks around whiteness rather than their own well-being."

Hill concludes that white people will vote for Donald Trump to feel good about being white, even if it means they lose their houses, even if it means dying from COVID.—Article courtesy of the Grio.com-Nov. 4, 2020 receives nat'l



**Lorraine Lathen** 

BROOKFIELD, WI-The American Lung Association has selected Wisconsin's Lorraine Lathen as the recipient of the national 2020 C. Everett Koop Unsung Hero Award.

Lathen is the Director of the City of Milwaukee Tobacco Free Alliance, Wisconsin African American Tobacco Prevention Network (WAATPN) and Wisconsin Tobacco Prevention and Poverty Network (WTPPN).

She is president and founder of Jump at the Sun Consulting, LLC, an African American, womanowned firm established in 2007 to address health disparities.

The C. Everett Koop Award recognizes a tobacco control advocate who has made significant, but frequently unrecognized contributions to reduce the burden of tobacco use.

Lathen received the award at the October virtual meeting of the American Lung Association's Na-

tional Board of Directors. Among her many accomplishments earning her the recognition, she has:

• Partnered with the Housing Authority of the City of Milwaukee over a 12-year period to provide impactful programs such as the Lung Association's Freedom From Smoking cessation program on site to Milwaukee Public Housing resi-

• Developed and implemented a resident-led study on the impact of the US Housing and Urban Development (HUD) smokefree public housing rule.

The study involved the collection of 600 resident surveys; findings have been presented at national, state and local conferences. Plans are underway for the replication of this model in other public housing

• Implemented "No Menthol Sunday," an event that calls attention to the deliberate and intentional marketing of menthol tobacco products to the Black community.

Lathen leads "No Menthol Sunday" in the state of Wisconsin and serves on the national planning committee for this CDC-funded ef-

Thousands in the faith community and communities of color have been reached with tobacco advocacy, tobacco prevention and smoking cessation messages.

• Been responsible for engaging in strategic partnerships with comgrassroots organizations and tobacco retailers. She successfully collaborated with tobacco retailers and community residents to create the No Singles No Loosies Campaign to end the illegal sale of single cigarettes and restrict youth access to tobacco products.

• Served as an adult mentor to WAATPN FACT, a youth-led tobacco control movement whose members are widely recognized as state and national leaders in youth tobacco prevention.

Under her tenure these middle and high school leaders have presented to U.S. Surgeon Generals (current and past), Wisconsin Governor and Lieutenant Governor and

• Participated as 2019 co-chair of the core planning group responsible for creating the Wisconsin Tobacco Prevention and Control Movement 2020-2025 State Plan.

In accepting the award, Lathen said, "The award I'm graciously accepting today recognizes me as an Unsung Hero for my work to address tobacco related health disparities. But I'd like to tell you who my true heroes are.

"My heroes are the individuals who live and work, and whose chilcommunities I serve.

"They are individuals who, all too often are excluded from the 'room where it happens' yet live in com-

"The Wisconsin African American Tobacco Prevention Network (WAATPN) and Wisconsin Tobacco Prevention and Poverty Network (WTPPN) applaud Milwaukee Public Schools for joining a national law-

suit against electronic cigarette companies JUUL Labs Inc., and Altria Group Inc., for deliberately targeting minors. The WAATPN and WTPPN are also encouraged that the Common Council unanimously approved today a substitute resolution to retain outside counsel to pursue potential vaping litigation. The use of flavored e-cigarettes is a growing problem in Wisconsin and across the nation, especially in suburban and rural areas. Flavored products such as e-cigarettes and cigarillos are designed to appeal to young people. Menthol, the most popular flavor, makes using tobacco easier to start and harder to quit. The WAATPN and WTPPN will continue their efforts to raise awareness about the impact of menthol and other flavored products such as cigarillos on low-income communities of color in Milwaukee and across the state."

enter the month of November, it is the month the Thanksgiving holiday is celebrated. We've had a tough 2020, but there's still much we can be thankful for.

Take a moment to count

your blessings this Thanksgiving. Thank God for family, friends and loved ones. As I thought about a theme for this month,

I recall last November, an elderly woman (who professed to be a faithful reader of this column) stopped me in the grocery store and said I should consider offering recipes during Thanksgiving month. Since many people will miss gathering with family because of the virus to enjoy their favorite recipe,

I'm taking this kind woman's suggestion and will share recipes this month. I wish I had this woman's name and contact information, because I would have contacted her for her favorite recipe; but in absence of that information, I sent out the request to two friends.

I was certain I would get the response, 'Sorry, but I don't share my recipes!' But that didn't happen, instead my friends said: 'When do you need it?'

Since Thanksgiving is a Time to Eat, A Time to Feast and A Time to Share, please enjoy two recipes submitted by two of my friends, Lorraine from Maricopa, Arizona and Jessie from Irmo, South Carolina.

Lorraine's "Um Um Good" Potato Salad Ingredients: red potatoes (a potato for each person you intend to serve), use half of a small jar of salad dressing, 1- $\frac{1}{2}$  bell peppers (1 green ½ red) chopped very small, 1 large onion, sweet relish, 4 to 5 boiled eggs, and 2 stalks of celery chopped very small. Mash all together, use a very small amount of yellow mustard, salt and pepper, taste to see what

#### Mother's Goofy Butter Cake

needs to be added.

Ingredients: 1 stick of melted butter, 3 eggs, 1 box cake mix (Yellow), 1-8-ounce pack of cream cheese (at room temperature) and 1 lb. Domino Confectioners' Sugar Pure Cane. Mix melted butter with one egg, and the cake mix.



Combine the remaining two egg, cream cheese and nearly all of the powdered sugar. Reserve a small amount of the powdered sugar for dusting. Beat until well mixed, pour over cake batter. Bake at 350 degrees for 35 min. When Top is slightly golden brown, take out of the oven and sporadically sprinkle some powdered sugar on top.


As a church member explained, this is because each cook brings to the kitchen their own personality and preferences. Some like their dishes hot and spicy, while others prefer milder flavored food.



He's been publicly ostracized and left politically impotent for accepting an offer from the 'Trumpster Regime' to recommend a platform to improve the quality of life for Black Americans.

The Biden team also initially expressed a similar opportunity but decided to table all input—including Cube's "Contract for Black America"-- saying they would 'wait' until after the election before entertaining suggestions.

The Trump camp was obviously eager to accept the Cube's input in a last-ditch attempt to earn a few Black presidential votes.

Even still, I don't think there are more than three people on earth, Mars or Chicago, who actually believed '45IQ' would do anything to benefit the Black community.

Hell, he hasn't even agreed to support a symbolic anti-lynching bill that has lingered in Congress seemingly forever.

And his B.S. about doing more for African Americans ranks right up there with his statement that he would date his own daughter.

But there was always the possibility that God (Nyame) could

touch his heart. (Yeah, and the odds of that happening are greater than Trump having an affair with Nancy Pelosi.) However, that's not the real issue here. Was Ice Cube wrong to

make a sincere attempt to do something more than complain about Black stagnation? Does a drowning man ask the motivations of the man extending a hand? Even though the last time we found ourselves in that predicament,

the missionaries put chains around our wrists and led us to the hull of slave ships, there is always the hope mankind is inherently good, and Nyame

has authored a script we don't understand.

Before you condemn Cube, consider--as I frequently do--what Frederick Douglass once declared: "power concedes nothing without a demand."

Also, note something my late friend and mentor Polly Williams once said after working with Republicans to get the school choice legislation passed: "no permanent friends, no permanent enemies, just permanent issues."

Also, consider as you ponder this: what is the alternative? Form our own political party and advance the agenda of Black Nationalism, as I often suggest. Or, should we just continue spitting into the strong wind?

Most tribal members are conditioned into believing the 'white knights' and missionaries have our best interest at heart. And since we have accepted them as the 'Freedom Train' engineers, we should

just sit back and enjoy the ride and the rapidly passing scenery.

Ice Cube wasn't the first African American to be asked to dialogue with 45IQ on Black America's plight. Remember Steve Harvey? And what about the Black clerics, which included one of Milwaukee's better-known preachers, who is still in business.

In fact, I know of several prominent Black leaders who were offered positions in the Trump administration but either rejected the offer outright or declared, in no uncertain terms, they would rather walk through hell wearing a gasoline soaked tuxedo.

One of the latter was a prominent Black Milwaukee.

I can understand their positions. No doubt, I would have responded similarly. But there's a difference between serving as a 'House Negro' and walking the path of an abolitionist.

Frederick Douglass never believed Abe Lincoln would free our ancestors out of Christian compassion. History (not His-story) reveals Douglass thought Lincoln to be a racist and could point to comments 'Honest Abe' made in 1858 in which he said Africans were an inferior 'race' and should not be allowed to vote or miscegenate.

But he was also among those who believe a sound strategy is to fight from within the fortress, instead of throwing rocks at it the 'White Castle' walls. Moreover, despite what Joe Biden said about Trump being the

first racist president, we know differently. In fact, there have been several during Biden's lifetime, including

the infamous Richard 'Tricky Dick' Nixon. Black America looked at Nixon through the same prism we see Trump. But if my history is accurate, Nixon followed the advice of his Black confidante, Art Fletcher, and signed an executive order


that propelled the concepts of affirmative action. Trump's top 'House Negro,' Dr. Ben Carson, isn't likely to press his 'boss' to remove that confederate flag he uses as a bedspread much less restore the teeth to affirmative action that Bill Clinton (the Democrat) pulled out, but he might leave the White House service door open.

Whether Ice Cube slipped through the back door in the dead of night or walks through the front passed the demonstrators who surround the White House, you have to give him credit for a least making an attempt...can't you?

Nonetheless, I'm totally cognizant of the extent of political polarization today and the collective hatred of the Trumpster.

#### **COMMENTARY:** The Presidential Race Might be Too Close to Call, but the 'Projected Winner is Racism'

Perhaps a single sobering Twitter post best summed up the state of America on the morning following an Election Night that's far too close to call—and frustratingly so.

"This was a referendum on the potential for a fundamental shift in that perspective," Actress and writer Natasha Rothwell wrote. "The race might be too close to call, but the projected winner is racism."

Others agreed.

"Look at the cities the nation is depending on in order to not re-elect an incompetent, racist, misogynistic president who has killed 230,000 Americans in seven months... Philly, Atlanta, Milwaukee and realize America is always leaning on Black people to save the day," added Dr. Ebony Hilton, an associate professor of Anesthesiology and a critical care physician at the University of Virginia.

African Americans heavily populate each of those cities, and each are critical as the swing states of Pennsylvania, Georgia. and Milwaukee.

They hang in the balance as votes are tabulated to determine whether President Donald Trump retains office, or the U.S. begins to heal under a Joe Biden administration.

With Biden holding a slight electoral and popular vote edge early Wednesday, he called for patience.

To no one's surprise, Trump declared victory and has threatened legal action to stop the vote count in those critical states where he currently has a slight edge.

Hilton and others believe that slight edge could likely disappear in those large urban cities as counting continues there

Still, the stunningly close election and with the GOP likely retaining control of the Senate, many say they've come to understand a sobering fact: America's standing on race, women's rights, and equal opportunity hasn't been this obvious since

## The Presidential Race Might be Too Close to Call, but the 'Projected Winner is Racism'

"I wake up every day to the reality that I live in a country that thinks my life is less valuable than it would be if I were white," decried Rothwell.

With a large swath still left uncounted as of Wednesday morning, Biden maintains an electoral college lead of 238 to 213 – 270 is needed to win. The Democrat currently leads the popular vote by 50 percent to 48 percent.

Biden also flipped Arizona, making him the first Democrat to win that state since 1996 when Bill Clinton claimed victory. Winning Arizona means Biden could lose one of either Pennsylvania, Wisconsin and Michigan, but still capture the presidency.

Georgia, where a large swath of votes remain uncounted in predominately Black Atlanta and Fulton County, also remains in play for Biden.

Trump, who led Republicans in slamming through a Supreme Court Justice last month in record time for scenarios just like this, promised to ask the high court to intervene before the ballots are counted in those four swing states. At press time, Trump leads in all those important states ex-

cept Wisconsin. However, each of those states counts ballots cast on Election Day first. Trump wants the count to end before officials tally mail-in votes, which arrived in record numbers.

It's also why the President pulled out all of the stops this year to cripple the U.S. Postal Service, whose Postmaster General Louis DeJoy has openly defied federal court orders to refrain from slowing delivery of mail-in ballots.

"In the midst of a pandemic that he had time to manage and, he held super-spreader events to spread the virus. And, with racial unrest still rampant which he stokes daily, the race is too close," Actress Yvette Nicole Brown railed. "No need to

question whether systemic racism exists in America. Many proudly chose the inept racist ... again!" Hilton also provided a follow-up.

"The only demographic who's consistently shown up for America is Black people," she remarked. "We are the greatest patriots despite facing a nation set on disenfranchising us, a nation having rallies to cheer the number of us dying at disproportionate rates from COVID, and mandates we live in poverty."

Regardless of who wins, Author John Pavlovitz said America already knows that the country is "as fractured as we imagined."

"We're as afflicted with racism as we feared," Pavlovitz wrote. "We're as far from equity as we thought. Good people are needed now more than ever. The fight doesn't begin or end, it continues."

I didn't include myself in the 'ranting,' preferring to leave punishment in Nyame's hands, even though I probably would not have shed a tear had he tripped over his white klan hood.

Similarly, I will not provide the surgeon's scalpel to castrate Ice Cube, particularly given how both sides of the political bird have played Black America at different

Even before Trump, the Black community was caught up in this sociocultural abyss of partisan politics.

And while it was not as confusing today as, during the civil rights era, it morphed into an either-or scenario with penalties and reprimands for those of independent mind or advocates of Black self-determination.

During the last commercial break, the socalled progressive leaders of the state Democratic Party used the politics of polarization as cover to establish a foothold in the Black community.

Led by State Senator Chris Larson, they enforced their agenda with an iron fist, boldly asserting to Black Dems and voters that all Republicans--and independent African Americans who put people before the party--were pawns of Satan.

To work with, or even be on the same side of the street with a Black person who marched to his or her own ideological drumbeat, would incur the new puppeteer's

I'm not exaggerating, and I risked my mental health and sacrificed the last of my black hair when I first exposed this scripted reality show a decade ago.

But it wasn't as simple as declaring the GOP the evil empire and themselves as Jedi

Their penultimate goal and the political organization they created—Wisconsin Working Family Party (which I renamed the White Family Party) was not only to control state and local politics, but to benefit their constituency—missionaries 'poverty pimps.'

And those who saw through the fog or raised a hand in protest found themselves targets of the new world order.

State Senator Lena Taylor, for example, found herself the target of a smear campaign and a challenger to her senate seat in the person of Mandela Barnes.

Before that travesty, State Rep. Jason Fields was actually unseated by Barnes, who was endorsed by Larson and the White Family Party.

While Taylor's crime was refusing to bow down and kiss Larson's ring, Fields offense was working with Republicans to get several beneficial bills passed, including the financial literacy mandate.

And herein lies the dichotomy of the partisan polarization.

Yet for his 'sin,' Fields--who has had more bills passed than the combined Black state legislative fraternity--was ostracized, cruci-

fied, and politically castrated. And the sentences were carried out by the Democratic Party's white knights.

Who benefits from this polarization?

In fact, if all our representatives can and will do is complain and blame, do we really need 'representation'?

Ice Cube is from a similar school as Fields, and to a lesser degree, Douglass. He recognizes that hiding your head in the sand does nothing but exposes our butt to the

I'm sure Cube knew not to expect anything from 45IQ. In fact, I would assume the rapper/actor didn't expect either party to deliver on the critical points of his agenda, much less empower Black America.

While the Democratic Party is far better for us than their cousins on the other side of the political and legislative aisle, history shows little--if any--part of the Black agenda is forwarded by either party.
