Among the study's additional findings:

- 18% of Americans say they have had a delivered package stolen from their porch or doorstep in their lifetime.
- 14% say that all or most of their grocery shopping is done via online delivery.
- 36% say that since March, they have shifted away from inperson purchasing in favor of online purchasing.

"Fortunately for consumers, there are effective ways to protect themselves and their packages from porch pirates—from order tracking to installing a security system to arranging for a pickup location. There are even some cities volunteering their local police departments as a package pickup point," added Giusti. "In the short term, the porch pirates problem is likely to get worse before it gets better. But it will get better."

This year's report is a follow-up to insuranceQuote.com's porch pirate reports from 2019, 2018 and 2017.

The full 2020 Porch Pirates in the Age of COVID-19 Report—which includes in-depth data and analysis on porch pirates and online delivery trends, along with tips for consumers to protect their packages, as well as what steps to take after falling victim to package theft—is available at https://www.insurancequotes.com/porch-pirates-package-theft-statistics

This study was conducted for insuranceQuotes.com via telephone by SSRS. Interviews were conducted from October 27-November 1, 2020 among a sample of 1,007 respondents in English (972) and Spanish (35). ### Consortium **Issues Statement Calling for the Decriminalization** of Tobacco

Local organization has joined a broad coalition calling for reform of tobacco laws and regulations.

Jump at the Sun, a Black woman-owned agency working to address health disparities and advance health equity, supports a national demand for decriminalizing commercial tobacco and addressing systemic racism in the enforcement of commercial tobacco and control.

The Weekend Edition·December 11, 2020·Page 3 Jump at the Sun recently joined more than 40 other organizations, including the American Lung Association, Truth Initiative, the American Heart Association, the American Public Health Association, the Wisconsin Public Health Association and the Center for Black Health and Equity, in issuing a joint statement outlining principles to help local and state health departments, decisionmakers, advocates, and other stakeholders, advance equitable enforcement practices related to the purchase, possession, sale, and distribution of all tobacco products.

Among the groups suggestions:

- Vest enforcement authority for commercial tobacco control laws in public health or other non-police officials.
- Ensure revenues from commercial tobacco control laws, including tobacco taxes, are used to support public health objectives and advance health equity.
- Eliminate youth purchase, use, and possession penalties.
- Eliminate the use of physical force against people suspected or guilty of violating commercial tobacco control laws.
- Prohibit enforcement officials from initiating contact with an individual based on the individual's possession of a tobacco product.
- Ensure that if commercial tobacco control laws are enforced against individuals, as opposed to businesses, they should not include punitive measures such as criminal penalties, fines, or mandatory community service.

"These principles can also help address tobacco addiction and reduce tobacco-related harms while maintaining and improving the



efficacy of enforcement of
commercial tobacco laws
and policies," read part of
the group's statement.

Lorraine Lathen, founder and owner of Jump at the Sun recently co-authored with Dr. Danielle McCarthy of UW-Center for Tobacco Research and Intervention, an op-ed titled, "Tobacco presents a dual-risk to Black Lives," which discussed the threat of criminalizing tobacco.

Tobacco kills 45,000 African Americans a year.

The most commonly used tobacco product among African Students for a Democratic Society at UW-Milwaukee to deliver demands to get cops off campus and redirect resources to programs and services that support social well-being and community health.

Americans, heart disease, diabetes and cancer, according to the CDC.

In Wisconsin, the smoking rate for African-Americans is 26%, a much higher rate than the state's general adult population (16%). Menthol, a product used by 9 of 10 African-American adult smokers in Wisconsin, is a peppermint flavored anesthetic tobacco companies added to reduce the harshness of cigarettes and other tobacco products. The Menthol additive makes it easier to start and harder to quit. Although African Americans start smoking at a later age and smoke less, they are more likely to die from tobacco use, according to the CDC.


Jump at the Sun has led local efforts to increase awareness about the impact of menthol and to address tobacco as a social justice and health equity issue.

"We are humbled to have the opportunity to work tire-lessly with our community stakeholders to help pave the way for Wisconsin to be a state where everyone lives in dignity and has an equal opportunity to achieve optimal health," Lathen said. "If adopted, the recommendations outlined in the statement could have far reaching impacts for Black residents in Wisconsin and across the nation."


