*Marcus Center reaffirms its commitment to engaging diverse communities and developing programming that reflects the Milwaukee community*

Strengthening its commitment to racial equity, diversity and inclusion (REDI) on and off the stage, Marcus Performing Arts Center released its REDI Action Plan to create a more racially representative and equitable culture at the Marcus Center.

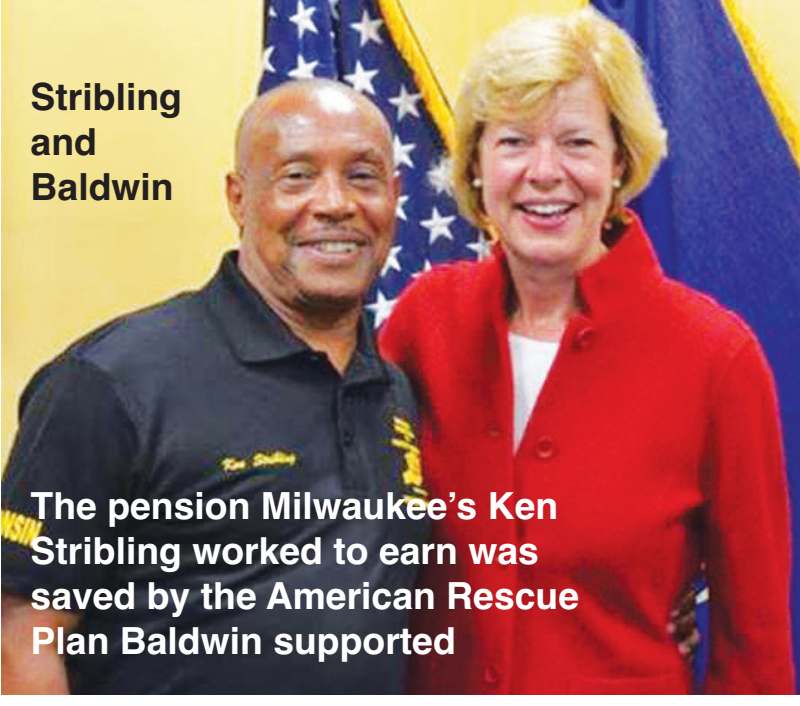
Focusing on building bridges be-

tween diverse members of the community through high-quality arts and entertainment that reflects the Milwaukee community, Marcus Center announced REDI goals in three key areas, including Representation, Inclusion and Investment.

The Marcus Center has been committed to REDI efforts for more than 17 years including the establishment of a Director of Community Engagement and Inclusion position in 2003. During this past nine months the organization spent time listening, learning and sharing, both inside and

## Retired Teamster is "Virtual Guest" of Sen. Baldwin during Presidential Address



Ken Stribling, a retired Teamster from Local 200 in Milwaukee was the 'Virtual Guest' of Sen. Tammy Baldwin during President Joe Biden's first Address to the Joint Session of Congress Wednesday night.

Members of Congress often invite constituents to join them as guests to such speeches. While COVID-19 safety protocols mean this year's in-person attendance will be limited, Baldwin said naming a virtual guest like Stribling is an important way to honor

## National News Briefs

A Texas court is now hearing arguments on overturning the conviction of Amber Guyger, the former Dallas police officer currently serving a 10-year sentence for fatally shooting **Botham Jean** in his own apartment in 2018. Guyger's attorney and prosecutors are before an appeals court to argue whether the evidence was sufficient to prove her killing of Jean was murder.

Guyger's appeal hangs on the contention her mistaking Jean's apartment for hers was reasonable and, therefore, so too was the shooting.

Her attorneys are asking to acquit her of murder or substitute it with criminally negligent homicide, which carries a lesser sentence. —TheGrio



Republican South Carolina U.S. Senator **Lindsey Graham** claimed recently that systemic racism doesn't exist in America because Barack Obama and Kamala Harris were elected president (twice) and vice president respectively. "America is not a racist country," said Graham during a Fox News interview. "Within every society, you have bad actors. The Chauvin trial was a just result." Graham decried attacks on police and policing, adding Democrats are calling all police racist. He also declared America the "best place on the planet" while also saying it's a "work in progress." His assertions aside, the election of two people of color in no way erases America's long history of enslavement, Jim Crow, or bias against Blacks in housing, employment or the legal system. —TheGrio



The U.S. Department of Homeland Security is launching an internal probe to identify White supremacists within its own ranks. "Domestic violent extremism represents the deadliest and most persistent terrorist threat to our country today," said DHS secretary **Alejandro Mayorkas** in a recent statement. "As we work to safeguard our nation, we must be vigilant in our efforts to identify and address domestic violent extremism within the wider community and within our own organization. Hateful acts and violent extremism will not be tolerated." This is the latest move by the feds to identify employees with extremist views, particularly after the Jan. 6 insurrection on Capitol Hill. —TheGrio

outside of the organization to create a strategic plan for REDI growth that is specific and measurable.

“We recognize that the process toward racial equity, diversity and inclusion is a marathon and not a sprint, and it’s our mission as an organization to always be thinking, acting and listening with a REDI lens,” said Marcus Center President and CEO Kendra Whitlock Ingram. “Creating and sharing these goals publicly is just another step to strengthen our commitment, and we look forward to tracking and reporting on our progress toward these goals regularly so the community can help hold us accountable.”

Marcus Performing Arts Center announced REDI goals in three key areas:

**REPRESENTATION** of artists, leadership, board, staff and volunteer members who reflect the racial and ethnic diversity of Milwaukee County, with action steps including:

- Achieve 50% BIPOC board membership by 2025 (currently 35%);
- Recruit, hire, and retain 40% BIPOC management by 2028 (currently 25%);
- Commit a minimum of 30% of Marcus Center Presents annual programming to the presentation of nationally and internationally celebrated BIPOC artists; and
- Increase racial and age diversity of volunteers to 30% BIPOC and 30% under age 50 by 2025.

**INCLUSION**-focused culture centered on creating, sustaining and promoting an environment

of belonging across the organization, with action steps including:

- Build process for inclusion-based decision making across the organization;
- Implement regular and consistent collection of audience perceptions;
- Continue to develop community-based programming that enhances sense of belonging; and
- Create a comprehensive communication plan.

**INVESTMENT** financially in REDI initiatives across the organization, with action steps including:

- Increase investment in minority, veteran, and women-owned suppliers and vendors;
- Establish annual budget for on-going REDI education for staff, volunteers, and board;
- Commission the creation of at least one new artistic work by a BIPOC artist annually; and
- Invest in new community access programs that remove barriers to participation.

“These short-term 12-month and long-term 3-year goals keep us focused on intentional actions to engage diverse communities and develop programming that fully reflects the Milwaukee community,” said Laura Gough, Marcus Center Board Chair and REDI Task Force Member. “The strategic decision to not only evaluate the Marcus Center’s current REDI initiatives and practices, but also deepen our REDI commitment across the organization was fully embraced by our board, management team, staff and community advocates.”

The REDI Action Plan and goals were

established through a collaborative process with community partner P3 Development. The organization convened a REDI Task Force, including 12 board and key staff members, to work with P3 on the effort. The group first reviewed research conducted prior to the development of the Marcus Center campus which examined community perceptions and provided recommendations for the organization. The REDI Taskforce assessed where the organization stands today against those recommendations and then developed new goals for the future.


“We recognize there are enormous societal issues surrounding systemic racism, and that our area of influence remains specifically focused on the live performing arts industry and those areas that we can most directly impact,” said Ray Wilson, Marcus Center Board Chair Elect.

Whitlock Ingram shared, “This is a journey for our organization and the community. We’ve begun intentional education efforts for our staff, including supporting those who are participating in YWCA Anti Racism Training, and setting aside time at staff meetings to discuss REDI initiatives to ensure our entire team is informed, understands essential REDI topics, and is using common language across the organization.”

The Marcus Center’s first update regarding progress on REDI goals will come later this spring - with the announcement of new diverse programming coming to the stage this summer and fall. hardworking men and women in Wisconsin.

Baldwin worked to successfully secure provisions in the American Rescue Plan that ensure workers and retirees – including Stribling and 22,500 in Wisconsin – can keep the retirement they have earned so their families and livelihoods are not put at risk. Baldwin voted for the legislation that President Joe Biden signed into law in early March.

“There are about 22,500 workers and retirees in Wisconsin who were facing massive cuts to their pensions, through no fault of their own.

“When Ken Stribling in Milwaukee was informed that his pension was getting cut by 55 percent, he was devastated.

“I worked for six years with Ken and many other Wisconsin workers and retirees to make sure they would get the pensions that they worked for and earned. Finally, we were able to get this done in the American Rescue Plan,” said Baldwin. “Now these workers and retirees have the peace of mind of knowing that the pensions they earned will be there for them and for their families when they need it. A pension is a promise and it should be kept.”

# BEWARE THE BOOGEYMAN!

**The Boogeyman is coming! The Boogeyman is coming!**  
Hide under your bed, in the attic, or if you live in one of the older areas of the central city, run to your bomb shelter 'cause the Boogeyman is coming!

OK, maybe I'm embellishing the script a little, and if you're younger than 60, you probably don't know what a bomb shelter is, anyway.

But my point should be taken with more than a grain of sodium (salt), which, if you're of African descent, will kill you just as certainly as those \$10 per pack (menthol) cigarettes.

In this reality show, the Boogeyman represents political propaganda, scare tactics, and manipulative tactics to take from the poor and give to the already rich under the guise of civil rights and 'Just-us.'

The Boogeyman utilizes modern solicitation vehicles to prey on our fears. Like his cousin, the Vampire, he sucks out our blood-stained money to advance its own welfare.

Last year we were inundated with campaign advertising supposedly to stop the 'slave owners' from reclaiming their property. We thought we won that battle, only to be told we are now but sharecroppers who must pay the new owners for grain and seed.

It's bad enough I'm 'mugged' by dozens of telemarketers every day, trying to convince me that unless I take a specific pill, buy another insurance policy or purchase their videos, I'm gonna die earlier, become impotent, or suffer through some as yet revealed consequence of the COVID-19 vaccination that will alter my genes and have me howling at the moon.

But this new wave of solicitations gets to the heart of why so many African Americans distrust politics.

Generally, I either ignore them (which is hard to do) or answer and tell them to remove me from their list. However, more and more frequently, an aggressive salesman will continue talking, trying to convince me that I will die or have a stroke if I hang up.

Plus, there are some calls I hesitate to hang-up on, like the various police assistance programs.

Particularly these days, given the tensions between people of color and the police, I hesitate to ignore those calls because my paranoia starts to kick in.

Last year, it was bad enough when my lines and email were jammed with solicitations from candidates seeking office.

But this year, we learn the myriad promises come with a caveat---we must pay to play.

Seconds after Biden was sworn in, groups like the Wisconsin (White) Workers Family Party and the DNC started lobbying for money to do what we thought we elected them to do.

Yesterday, I received an email from what I thought was Facebook, but instead was actually Move On, a Democratic Party front group. The solicitation concerned a pending decision by Facebook to lift its ban on Donald Trump.

Move On asked for a contribution to block his restoration, effectively severing his link to 35 million brainless followers.

How they will do that is never explained. Will the organization buy Facebook or lobby the board?

Give me a break!

I also received a surprising email from former presidential candidate Julian Castro (my favorite presidential candidate after Cory Booker) asking for money to stop a voter suppression bill in Texas.

He also said my contribution would be used to pass the 'John Lewis Voting Rights' and the 'For the People' Acts. Does that mean we have to pay for legislation now?

Last Friday, 'All on the Line,' another Democratic Party subsidiary (there are apparently hundreds, including some with ethnic names like the Colored Collection Collaborative), asked for a monthly commitment of \$250 to ensure Republicans didn't benefit from redistricting.

Apparently, unless I commit to paying them \$3,000 annually instead of my energy bill, the Boogeyman will sneak through the unlocked back door and usurp the process.

And you know what happens then: The GOP will invalidate the 13th and 14th Amendments, just as the Democrats on the U.S. Supreme Court tried to do following

the 1875 civil rights laws.

Two problems with that scare tactic: I don't know of any Black family that leaves their back door open. Secondly, those in power--the Democrats--determine the game's rules.

Sandwiched between those requests was another from--supposedly--Georgia Senator Raphael Warnock (actually, 'All on the Line'--Georgia division) asking for cash to 'mitigate the damages of voter suppression legislation in my home state of Georgia.'

I don't know precisely what that means. Still, as a public service, the AOL state director said if you sign up for the Act Blue Express, your contribution will go through immediately, instead of 24 hours later.

Wow, thanks for coming up with a way to take my money faster.

What additionally angers me about these disingenuous schemes to separate me from my limited income is when they use the race card.

Move On sent out a video, along with a request for still another donation, declaring that unless the filibuster rule is rescinded, the descendants of slave owners (most of whom ironically were Democrats at the time) will take over the White House.

Interestingly, the organization resorted to wrapping that request around a racist flagpole, claiming that the only thing blocking civil rights legislation over the centuries was the filibuster. Inappropriately, they used a white woman to do the voice-over for their appeal.

Couldn't they find a sister, huh?

Of course, they didn't mention the filibuster has been used over the years by both parties or that it is generally the party in power that wants to terminate its availability.

Nor, as I've repeatedly explained, do they explain how my contribution will stop the congressional rule. Will they pay-off Republicans who might use the filibuster?

Give me a break.

I can only assume, based on history and the Freedom of Information Act, most of it goes to unemployed White poverty pimps, connected consulting firms, or relatives on the public dole.

In fact, three times over the last 18 months, I have responded to these appeals for appropriations with questions that never get answered.

Don't get me wrong. My criticism and trepidation of the Democratic Party are not to imply I'm venturing across the political aisle. There is nothing attractive or compelling to prompt me to cross that street, even if I view the two major parties as different wings on the same bird. Neither party wants to empower Black America. To do so is to lose their power.

In fact, if the deceptive Boogeyman solicitations are a gauge of true intent, the bird is a goose who stops by your yard long enough to 'deposit' his 'do-do' and then fly away.

A recent GOP request came from a Black conservative group calling itself 'Every Black Life Matters.'

For a contribution of up to \$1,000, this group would initiate an advocacy campaign to 'educate Black America about the evils of border expansion, genocide through abortions, and put a muzzle on what they call the poverty pimp scam campaigns of Al Sharpton and Jesse Jackson

and others.'

This solicitation comes with another interesting slant. It posits Democrats want to give Black folks a "handout, instead of a hand up." The Dem agenda, the solicitation explains, has destroyed the Black nuclear family through government programs like welfare that forced men out of the household, and a school-to-prison pipeline through inadequate and inferior education.

They also note what they call 'Biden's true color.' It's not 'colored.' As a senator, the president has voted for oppressive legislation, has called young Black men thugs, and refused to support sanctions against racist nations.

I won't get into the merits of those accusations, but to the naïve and uninformed, they might hit a cord.

I received several requests from Trump loyalists of late asking for contributions for his 'take back America' campaign.' And another one asking me to purchase a Trump Flag (I assume he has started his own country) and, most recently, a Trump navy cap that asks the question: 'do you miss me yet?'

"HELL NAAAH!"

I never have and never will contribute to either of the 'major' political parties. Or to any of the missionary organizations that have taken over the engineering duties on the Freedom train. Hopefully, someday soon, Black folks will realize that we will be traveling in circles as long as they control the destination.

I have contributed to a few candidates over the years. Still, the only presidential aspirants have been African American or African American.

And of all the presidential candidates seeking support, I only gave to Barack Obama and Cory Booker. Barack opened the door, and Booker has shown he will put the people before the party.

That said, I'm not afraid of the Boogeyman.

But I am fearful of the right-wing militia preparing for a new civil war. I have bought up a record number of guns and ammunition in the last two years.

I'm more afraid of the brainwashed and enslaved Black thugs and thugettes who terrorize our community.

I'm afraid of those who maintain a system of educational apartheid for the sole benefit of maintaining job security for their relatives. And an economic system that ensures 98.5% of all wealth is in the hands of those who control the political system.

Thus, I want to advise you to watch out for the okey-doke. If you're going to make an investment in politics, do it at the local level, where you can see a return on your investment. Ask questions, and never assume. And don't believe the labels or lies.

Invest your limited dollars wisely. If you feel compelled to help make the world a better place, contribute to cancer, diabetes, or hypertension research.

Make a contribution to the Hunger Task Force, the homeless, or a 'go-fund-me' page to bury a victim of violence or help a family pay its rent. Send a few dollars to the Boys and Girls Club, YMCA, or an abolitionist committed to empowering versus playing partisan politics.

You can't pay the Boogeyman to stay away. That's called extortion.

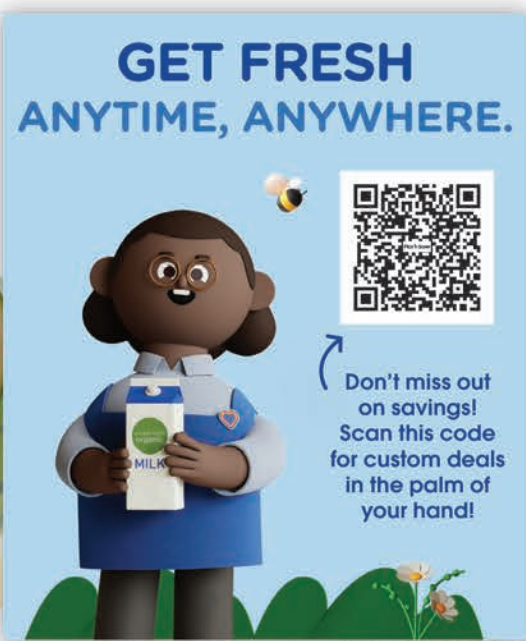
