WHEELIN' AT WESTLAWN FREE BICYCLE TUNE-UP EVENTS AND FAMILY RIDES SCHEDULED FOR 2021



The annual Wheelin' at Westlawn event is returning in 2021 with multiple dates and the addition of organized family bike rides for the Westlawn community and other area residents.

The bicycle tune-ups and repairs will take place on Friday, June 25 and Friday, July 23 from 3 – 6 p.m. at the Westlawn Gardens Playground Pavilion (located on N. 62nd St. and W. Custer Ave.).

The family bike rides will take place on the subsequent Saturdays, June 26 and July 24, starting at 10 a.m.

The rides will begin at the

Alderman Cavalier Johnson is encouraging those in the area to take advantage of this event.

"Biking is a cost-effective activity that allows the whole family to enjoy the outdoors, get some exercise and have fun," Alderman Johnson said.

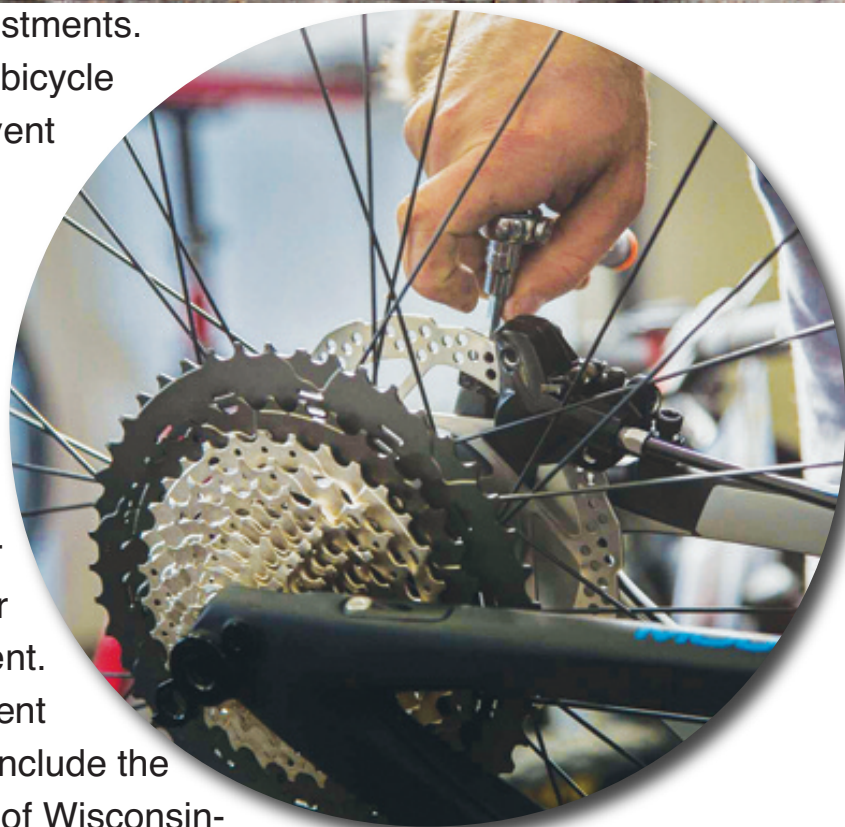
"Those who live in Westlawn and the surrounding area should mark their calendars now to utilize the free bike repair service and partake in a fun morning bike ride."

Rebuilding Small Businesses: VOLUNTEERS WANTED

Are you a successful corporate executive with deep business knowledge?

Or a social media maven who guided a corporate brand to big time success? Maybe, you're a public speaker and trainer that can inspire small business owners to climb to new heights of success. Or a savvy entrepreneur who has launched successful startups?

If so, then consider volunteering with SCORE, the nation's largest network of volunteer, expert business mentors and help small businesses recover from the

economic devastation wrought by the COVID-19 pandemic.

"Your skills are valuable, needed and appreciated by small business clients and entrepreneurs," according to SCORE CEO Bridget Weston. "Volunteer to join our community of more than 10,000 volunteers in 1,500 communities. You'll find a wealth of support and build back small business where you live."

Only about a third of small business owners reported turning a profit in 2020. Black and Hispanic-owned small businesses were particularly hard hit. Only 8.8% of Black business owners and 6.7% of Hispanic business owners reported profitability and growth last year, according to research conducted by SCORE.[1]

SCORE welcomes all volunteers and

offers a variety of ways to get involved based on the time you have to give and your interests and expertise. You don't have to be retired to volunteer with SCORE (which was formerly known as the Service Corps of Retired Executives), notes Weston. Today, half of SCORE's volunteers are actively employed or running their own businesses.

Volunteer roles include:

- **Subject matter expert** - Volunteer 2-10 hours per month and consult with mentors and business owners to answer questions in your area of expertise. Share your know-how and professional knowledge in e-commerce, accounting, human resources, social media or anything else and be an invaluable resource for small business owners.

- **Local workshop presenter** – Share your mastery of a business topic or strategy and deliver local business training for small business owners. The time required can be as little as 2-10 hours for each presentation.

- **Business mentor** – SCORE mentors provide hands-on assistance to local small business owners or aspiring entrepreneurs, helping develop business plans and a roadmap for growth. Mentors have excellent interpersonal and communication skills, as well as broad expertise as a business owner or upper-level manager. This role requires training and then 15-20 hours per month of volunteer time.

The benefits of volunteering with SCORE include networking with local and national business experts and building new community relationships

through the local SCORE chapter, notes Weston. Volunteers also expand their own skillsets through training, and receive local and national recognition. Helping others is extremely rewarding, and many SCORE volunteers value supporting the small business community where they live and knowing they are making a genuine difference.

Volunteering through SCORE creates a positive, tangible impact. In 2020, SCORE volunteers donated nearly four million hours of service and helped start 45,027 new businesses. They also supported the creation of 119,562 jobs and mentored 143,651 small business clients, many of whom reported higher revenues and business growth.

"My hard work is worth it when I read the emails saying how grateful people are for SCORE's help," said Toma Talpa, a volunteer with SCORE Chicago. "I chose SCORE because of its mission and because of the people who volunteer."

They are all passionate about helping entrepreneurs and business owners achieve their goals. It always amazes me that all of the resources and national workshops that SCORE provides are free to anyone."

Keeping state's restaurants open for business

Wisconsin restaurants, bars, bakeries, food trucks, breweries, wineries, distilleries and inns that prepare and serve food or beverages can now apply for funding equal to what was lost in the pandemic up to \$10 million per business. T

he federal Small Business Administration's Restaurant Revitalization Fund recipients do not have to repay the funding as long as it is used for eligible purposes by March 11, 2023.

"As Wisconsin bounces back from the COVID-19 pandemic, it is more important than ever for us all to support our local, small businesses," Governor Tony Evers said. "The Restaurant Revitalization Fund gives our

restaurants, brewpubs, caterers and more a chance to keep their staff paid and keep the lights on as our economy recovers."

Applications are now being accepted at <https://restaurants.sba.gov>. The exact amount businesses will be eligible for varies with awards starting at \$1,000 and going all the way up to \$10 million per business.

Businesses do not have to repay the funding as long as it's used for eligible reasons -- paying staff, rent or mortgages, utilities, constructing outdoor seating and more -- and is spent by March 11, 2023. Applications will remain open until funding runs out.

"During the pandemic, staff at the Wisconsin Economic Development Corporation (WEDC) and our partners at the state Department of Revenue (DOR) worked

to distribute more than \$240 million in We're All In grants to Wisconsin's small businesses," said Missy Hughes, WEDC secretary and CEO. "While the third phase of We're All In grants specifically targeted the food, beverage and amusement sector, we know that this part of our economy was one of the hardest hit in the pandemic. That's why I'm so grateful to see this federal funding available."

Businesses impacted by the COVID-19 pandemic can also expect more help to come from the state. Last month, Gov. Evers announced plans to create the \$420 million Wisconsin Tomorrow Small Business Recovery Grant program.

Details have not been finalized but the program will once again be run by WEDC and DOR. It is expected to offer grants of \$5,000 to businesses with annual gross revenues between \$10,000 and \$7 million with industries hit hardest by the pandemic being targeted.

"The Department of Revenue has seen what these funds can mean to our state's small businesses," said Peter Barca, DOR

secretary. "We will do everything we can to make sure dollars get to eligible businesses as quickly as possible. We also want businesses to take advantage of all funding sources available, both federal and state, including the

Restaurant Revitalization Fund and the Wisconsin Tomorrow Small Business Recovery Grant program and therefore you can always find information on these programs on our website, revenue.wi.gov."

the sino-Japanese word for skill or talent, and an East Asian influence is evident in our building's interior aesthetic as well. With Skyline Bar + Lounge, we're hoping to extend that cultural influence through the introduction of a curated selection of sakes."

To introduce the sake experience to Milwaukee, Skyline is hosting a series of tastings, discussions and events with experts and admirers of the beverage both in Milwaukee and across the country. As part of that effort, Milwaukee's own Tarik Moody has partnered with the organization as Nō Studios' resident sake scholar and enthusiast.

"I have always been fascinated by sake since I first tasted it during college at Howard University," said Moody. "Last year I decided I wanted to learn more about the culture of sake, so I took a Sake Professional Course, and now I'm a certified sake professional. This is the beginning of a three-year journey to learn all I can and hopefully one day brew my own sake. I'm excited to partner with Nō Studios to share my passion with others."

Upcoming events will cover the rich history of sake and include sampling of its many varieties and pairing possibilities, including Japanese inspired tapas. The first in-venue tasting on May 8 during the Nō Studios Makers Market has sold out. Additional in-venue tastings will take place June 12 and July 10 at 6 p.m. Register [here](#).

Skyline will feature a different sake each month and offer unique specials. Sake bottles to-go are also available for purchase online. Skyline is open to the public Thursday through Saturday from 5 – 11 p.m. Members have additional access Monday through Wednesday and Sunday from 8 – 11 p.m.; and Thursday through Saturday from 8 a.m. – 5 p.m.
