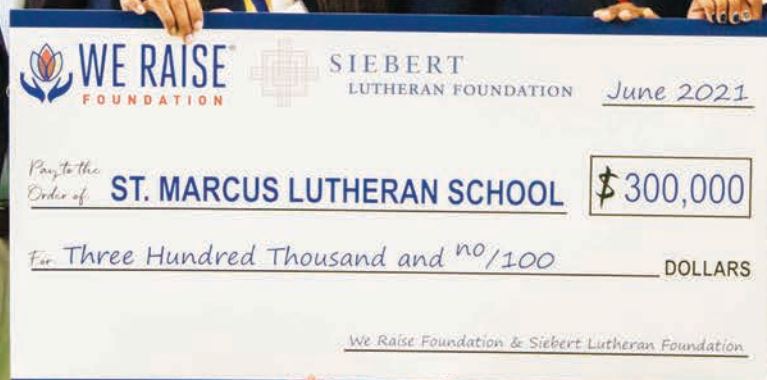

Project aims to build stable households that support productive learning environments

St. Marcus Lutheran School announced Thursday, June 10th, a \$300,000, three-year grant from Siebert Lutheran Foundation and We Raise Foundation for the school's "Building Stability and Prosperity for Community Transformation" project that will expand support services available to school families.

Support services launched by St. Marcus in 2017 are working to build a more diverse Harambee neighborhood, both racially and economically, allowing children and families to thrive.

The funding announced today will create one new staff position at the school and strengthen two existing positions that will provide services to school families that are designed to create

stable households and productive learning environments. These include:

- Financial literacy classes
- One-on-one financial coaching/accountability
- Homeownership workshops
- Job networking
- Peer-to-Peer Community Support
- Crisis Stabilization (healthy food, supplies, shelter)

The community engagement specialist will further engage leaders and organizations in the community to build effective collaborations and partnerships internally and externally for the good of the whole community.

These opportunities will give families the foundation for financial stability, independence, and prosperity and allow students to excel in the classroom.

With the planned opening of its third Harambee Campus in August, St. Marcus will be able to use its three geographically close campuses to serve more than 1,500 students as a platform to support families more broadly.

St. Marcus recognizes that an excellent education addresses social, emotional, spiritual, and academic needs of students and is critical for future success in life. Oftentimes, however, it is not enough.

Students' performance in the classroom can

be influenced by life events unrelated to school. A stable home, employment, and abundance of healthy food all affect a child's academics.

"We Raise Foundation is pleased to partner with Siebert Lutheran Foundation to invest in the work being done at St. Marcus Lutheran School," said Paul Miles, President and CEO of We Raise Foundation.

"Under the extraordinary leadership of Henry Tyson and his team, St. Marcus sets the highest standards of academic performance and then creates innovative solutions to help its students meet them.

We are proud to support their work and equally proud to be a leading voice for foundation partnerships like the one designed with Siebert.

We believe we are stronger when we work together to create healthy communities and encourage other funders to consider how they could do more through partnerships."

Since 2017, more than 650 individuals have received services through this project in collaboration with community partners such as Wisconsin Women's Business Initiative Corporation (WWBIC), ACTS Housing, Milwaukee Job-Work, The Joseph Project, and Habitat for Humanity.

Blazing a Trail for Women of Color in Hollywood: Director Ericka Nicole Malone

LOS ANGELES, CA— Ericka Nicole Malone continues to blaze a trail for women of color in the male-dominated entertainment industry with her combination of skills as an actress, writer, director and producer.

Malone is well known for building complex, relatable characters, whether she is writing a play for the stage or a script for a television series.

“As a writer, you don’t just want to tell a story; you don’t just want to tell an African American story; you want to tell a human story,” Malone said during a recent interview.

Her upcoming productions are a testament to her kaleidoscope of talent for telling human stories and connecting with audiences on multiple levels:

- Della is a one-hour television drama featuring a Black vigilante in urban Kentucky who protects women from abusive partners — often resorting to violence when she rises to their defense.

- Dreams from the Edge is a short film about a young girl auditioning in Hollywood. Her mother is a former actress and only has negative things to say about the industry. Ultimately, the tables turn, and the daughter must help her mother find her path in life again.

- Malone wrote the script and serves as an executive producer with Phillip Robinson on Remember Me: The Mahalia Jackson Story, which promises to honor Jackson’s legacy in Gospel Music, Civil Rights and as a shining example of a powerful Black woman. The movie features R&B recording artist Ledisi in the lead role.

- Malone also serves as executive producer for the animated feature and future TV series JG and the BC Kids, written and created by acclaimed actress Janet Hubert. The story follows Janet Granite, aka JG, a super intelligent, athletic scientist and inventor who travels the world to find special kids.

Ericka Nicole Malone is a “quadruple threat” as an actress, writer, director and producer. She has written, directed and produced 10 stage plays through her production company, Ericka Nicole Malone Entertainment, LLC, along with her business partner Phillip Robinson, including the smash touring musical stage play, In Love with Tyrone.

1 in 4 Wisconsinites would ignore their doctor's advice to cut down on drinking, reveals survey



43% ignore advice not to drink while on medications such as antibiotics.



It's a familiar feeling of dread experienced by anyone who smokes or drinks: as they sit down opposite their doctor for a routine medical examination or to discuss a problem that has arisen, the inevitable question is asked - “Do you drink or smoke?”

The patient knows that heavy drinking and smoking is bad for their health, yet their dependency on either substance overrides any willpower that would prompt them to quit.

Alcohol.org, a leading provider of addiction treatment resources and recovery information, conducted a survey of 3,000 drinkers and over and found that shockingly, more than 1 in 4 (26%) Wisconsinites admit they would ignore their doctor's advice to cut down on their alcohol consumption - this compares to a national average of 28%. Given that a recent study found that any amount of alcohol is damaging to the brain, it begs to question – is liquor more important than life?

When broken down across states, it was found those in Louisiana appear to be the most dismissive of their doctor's advice with 57% saying this was the case. Comparatively, only 13% of those in Wyoming admit to doing this.

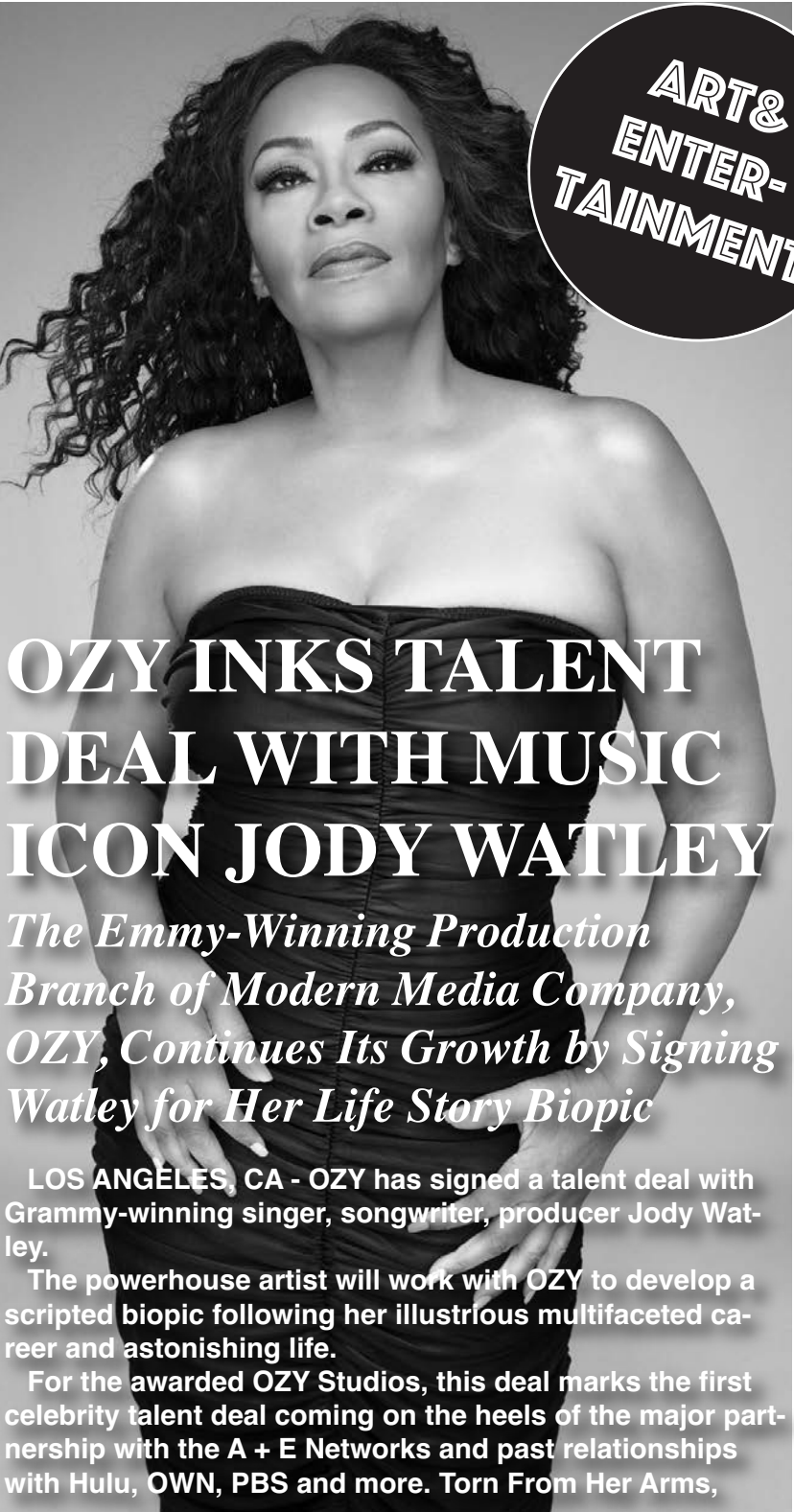

Worryingly, it was also found that more than 1 in 5 (21%) say they have lied to their doctor about how much alcohol they consume. Further analyzed, men (60%) were more likely to lie about their drinking habits to their doctor, as compared to women (40%).

Further, 31% of respon-

dents say they ignore medical advice to stop drinking while taking certain medications. With some treatment courses, such as antibiotics, the reason alcohol should be avoided is because its interaction with certain medication cause unpleasant side effects. If a patient is prescribed sleeping or anxiety medication, for example, alcohol can exacerbate side effects of drowsiness and may cause others, like dizziness or nausea.

for advanced participants, and exposure to career pathways in art and design.

Throughout the two- and three-week-long intensive courses, faculty encourage students to experiment with varied media, engage in collaborative projects, challenge themselves during problem-solving exercises, offer critiques of work with peers and teachers, and participate in special programming and field trips. Students experience personal growth by exploring their passion for the arts—a passion with the potential to become a career.

Students participating in Core Studio Concepts can choose two in-person classes, including: Graphic Design; Illustration; Screen Printing; Photography; Painting; Fiber Arts; and Basic Observational & Figure Drawing.

The Advanced Studio Concepts program is for high school juniors, seniors and graduates who are serious about pursuing art or design in college. Students must submit 10 images of original art to be considered for the program. The studios offered include: Product Design; Communication Design: Fashion Branding; Animation; Illustration; Advanced Photo & Film; Figure in Color; and Fine Arts.

While careers in design industries can be both personally and financially rewarding, they have historically lacked representative diversity. The reasons for this are myriad. In Milwaukee, students in underserved communities have limited access to arts and design education, knowledge of college requirements, and awareness of financial aid resources. Through outreach and scholarship opportunities, MIAD helps local young people overcome these significant barriers.

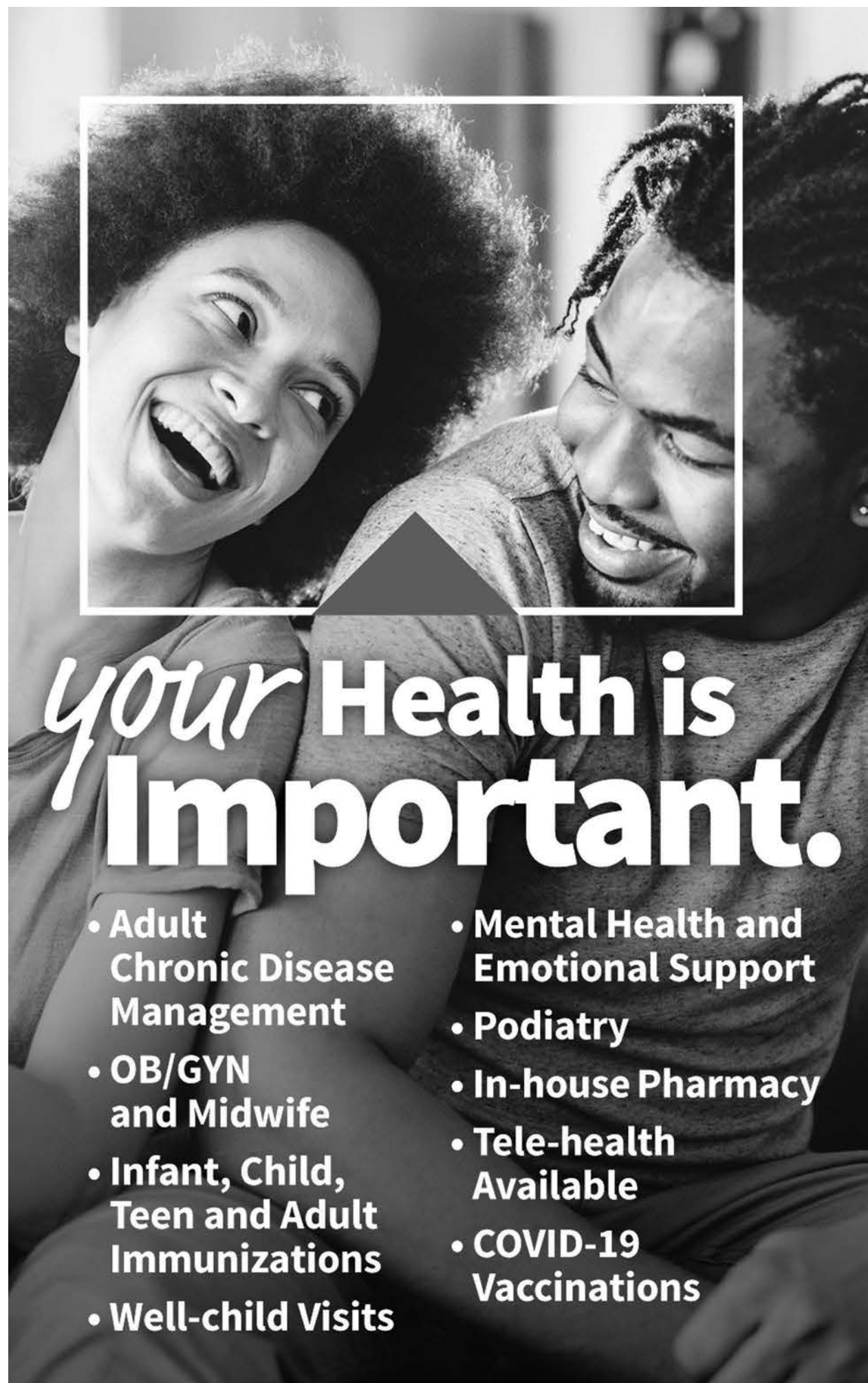
