

We as a people are in crisis.

The suppression and distortion of the truth as well as the miseducation of African American people has had a profound effect on the self-esteem and the psyche of Black people.

Self-hate and the incarceration rate are at an all-time high. In 2021, approximately 8600 Black Americans were killed by our own hands.

It is grievous to me that at the **Jean Jordan Nash** root of this dysfunctional behavior is a lack of knowledge of our his-

There are some people who choose to remain uninformed and would rather not discuss Africa, the history of Africans in the diaspora or colonization and the atrocities committed against Black people.


I've heard people say, "That happened a long time ago!", proclaiming, "I don't want to hear anything about Africa.

I am an American." That's true and sad because they don't realize they are the first Americans. Learning Black history is a liberating experience.

The problem is that many of us have little knowledge of our rich

past. The history of African people begins on the African continent. The first humans were discovered in Ethio-Homo sapien sa-

piens traveled out of Africa at least four times reached China and Europe simultaneously around 90,000 to 80,000 years ago. The Twa, an ancient people from Africa,




Head dedicated to the people of Ethiopia. -Photo by Runoko Rashidi

came to the Americas over 51,000 years ago.

According to David Imhotep in his book, The First Americans were African, the Twa were among the first Africans to populate the earth.

These short statured people, who were about four feet in height, were also known as Ta-Nehisi, Dwarfs, Elves and Brownies. In North America they were the Mound Builders. Only Africans built mounds and

The Twa built mounds that are prevalent along the Mississippi River from the Gulf coast to the Great lakes. The Mississippi river was like the Nile River. In ancient times the rivers were like the expressways



Over the years, I've interviewed James Beckum, "Mr. Baseball," several times. His life remains a treasure of achievements, faith and the ability to serve even when it was not necessary and there was nothing in the game for him. He is Black History.

Now, 90-years-old and weighing legacy versus physical ability. it was delightful to revisit "Mr. Baseball" and highlight his world during Black History Month 2022.

Born in Dilla Ridge, Illinois, near Collinsville, we laughed for I'd never known before this interview that our lives had begun in that region.

Places of interests became shared experiences combined with youthful reflections, for his Negro League teams had played at Lincoln Park in East St. Louis, Illinois, just blocks from my high school. "They loved our teams there; and we came often," Mr. Beckum declared.

"In high school, I was a pretty good player and my coach suggested that I consider joining the Negro Leagues. Now this was long before Blacks...Negroes (we were called then) were going into the National League (Major League Baseball). Jackie Robinson, you remember, was the first to make it into the big league. But

Taharqo, the most notable Kushite and fourth king of the 25th Dynasty in Egypt.

The largest mound in the U.S. is Monks Mound in Collinsville, Illinois, in which African artifacts were found. Arithmetic, geometry, numerology, astrology, astronomy, geology, philosophy, chemistry, medicine, and other physical, social and metaphysical sciences were their gifts to the world.

Dr. Imhotep: in The First Americans Were Africans: Documented Evidence, also documented that "Africans not only came before Columbus and Clovis but were in the Americans far before any other

The Olmec were the first great civilization in Mesoamerica. Some of the large stone heads in Mexico have full lips and broad noses. The heads bear helmets that match Egyptian military helmets of the era. The hair is depicted in stone braided in the Ethiopian style similar to cornrows.

The colossal Olmec heads weren't "formally" discovered until 1938, after Matthew Stirling found the

Tres Zapotes Colossal Head. However, this was due to a 75-yearold tip from an oil prospector, José Melgar, who first spotted this enormous stone head in Tabasco in 1862.

Archaeologists have tried to deny that they have negroid features and refuse to believe blacks were here in America so many years ago. One archeologist claimed that the noses and faces of these stone heads were flat because they had been in the ground.

Also telling, is that following this period of African contact, the people of this region of America began building pyramids.

No other group can claim this, not the Asians, European, nor the people known as Native Americans. Only insecurity and fear will drive a people to continue to deny reality.

Anthropologist and historian, Runoko Rashidi focused on the "Global African Presence", outside of Africa before and after enslavement. Rashidi's scholarship follows the work compiled by Dr. Yosef Ben-Jochannan, John Henrik Clarke, Asa Hilliard, Ivan Van Sertima and others who challenged Eurocentric narratives about Black inferiority.

In African Presence in Early Asia, co-edited with Ivan Van Sertima, Rashidi notes that "Blacks were...the first in the development of Asia's early civilizations. An international study has found that the Chinese people originated not from Peking Man in northern China, but from early humans in East Africa who moved through South Asia to China 100,000 years ago. It is now coming to light that our ancient human ancestors moved out of Africa, spreading to every corner of the planet.

Kushites and Ethiopians are the same people, just different cultures and languages from scattering across the continent and adapting to different environ-

Any original history or archaeology that highlights the accomplishments of Africans is gradually being revised by European historians who are biased against Africa and want to suppress African historical achievements and instead promote European accomplishments.



Diverse empires: such as ancient Ghana, mediaeval Mali and the Songhai Empire, thrived for thousands of years. They traded gold, ivory, salt and books with people from other regions. West Africa was one of the world's greatest producers of gold in the Middle Ages.

The most profitable trade items in Timbuktu were books. Scholars from around Africa, the Middle East and Europe traveled to Timbuktu to study. Greek scholars, Hippocrates, Pythagoras, Socrates, Plato and others all went to Africa, to learn at the Temple colleges of "Waset and Ipet Isut."

Because of King Mansa Musa, the Sankoré University had been converted into a fully staffed university with the largest collection of books in Africa since the Library of Alexandria. We have been taught that West Africans did not have a written history. Africans hid their books when invaders came. Approximately 1 million manuscripts have managed to survive from the northern edges of Guinea and Ghana to the shores of the Mediterranean. National Geographic predicts that 700,000 manuscripts in the city of Timbuktu alone have survived. The manuscripts detail how to live and treat each other. Education is key and knowledge of our past is the first step to self-discovery.

The Twenty-fifth Dynasty of Egypt, known as the Nubian Dynasty or the Kushite Empire, was the last dynasty of the Third Intermediate Period of Ancient Egypt. Taharqo, the most notable Kushite, is the only pharaoh mentioned in the Bible. The reunifica-

tion of Lower Egypt, Upper Egypt, also Kush (Nubia) created the largest Egyptian empire since the New Kingdom. A pharaonic dynasty in Nubia predates the first pharaonic period in Kemet (Egypt). They ushered in an age of renaissance by reestablishing Ancient Egyptian religious traditions, temples, and artistic forms, while introducing unique aspects of Ku-

although not the oldest, was the most advanced ancient civilization. They were highly ethical people and were referred to by some ancient civilizations as, "Those wonderful Ethiopians". Ethiopia was a region that included the present-day nations of South Sudan, Ethiopia, Eritrea, Djibouti, Somalia, Kenya, Uganda, Central African Republic, and Chad, so ancient Ethiopia was not just modern-day Ethiopia.

The 42 affirmations of Maat were the precursor to the 10 commandments. The Principles of Maat were the moral rules and beliefs that guided the behavior of Auset and all the people of Ancient Kemetic society. The ceremony of judgment of the dead; called the "Judgment of Osiris," focused on weighing the heart of the deceased in a scale balanced by Maat (or her hieroglyph, the ostrich feather), as a test of conformity to proper behavior. The Kemetic spiritual system promotes the seven cardinal virtues of Maat: truth, justice, balance, order, reciprocity, harmony and propriety. It was during the 25th dynasty that the Nile valley saw the first widespread construction of pyramids. There are more pyramids in Ethiopia than in Egypt.

In the majority of classrooms K-12 across the U.S., students learn about African American heritage starting with the enslavement of Africans in the U.S. colonies, a system that erased the identity of the people and treated them as property. We were considered the original "stock" on Wall Street. It is imperative that we teach our own history in order to correct what is being taught. Our children are suffering because they don't know who they are. This lack of knowledge of our history has led to self-de-

struction.

The question is often asked, 'After giving the world civilization what happened?" There were hundreds of tribal groups. Africans across the continent resisted colonial demands and took up arms against European colonizers. However, the spear, nor the bow and arrow were no competition


against gun powder and the Europeans unyielding violence. The African people had been welcoming to outsiders because of the principles they lived by. Many were captured in small groups. Millions were slaughtered and captured, and the continent was weakened. In 1787 upon seeing the evidence of African and ancient Kemet, Count Constantine DeVolney wrote: "Just think that this race of Black men, today our slave and the object of our scorn, is the very race to which we owe our arts, sciences, and

even the use of speech! Just imagine, finally, that it is in the midst of people who call themselves the greatest friends of liberty and humanity that one has approved the most barbarous slavery".

In 1884 the leaders of fourteen European countries came together to discuss control of Africa's resources. Known as The Berlin Conference, they sought to discuss partitioning Africa, and establishing rules to divide the resources among the Western countries at the expense of the African people. Of the fourteen nations at the Berlin Conference,



we had many good Black players throughout the country, and over time, we created regions of competition. And people looked forward to our arrivals because we brought fun and relaxation."

"We followed the big bands, in the Jim Crow South, of Kentucky, Tennessee and Mississippi. Of course, we all had jobs during the week so our games were on the weekend. It was grueling! You know, Hank Aaron started in the National Negro League.

"We all wanted to be as good as Hank, or Satchel Paige, the best pitcher I ever saw pitch. I worked and played ball until I was drafted into the U.S Marines. That was 1953. After my stint in the Marines, I came back to St. Louis and worked at Walgreens." Is this not living history?

"I came to Milwaukee for work. The place was booming. That was 1956. I worked at Ladish Steel for 35 years. We had good jobs, good

pay and neighborhoods were safe and strong. And everyone was sending their children to school, either the university or MATC. We knew we were creating better lives for them."

Blacks were being hired at Pfizer and Vogel, Allen Bradley, Harnischfeger. Ladish Steel and even American Motors. Yes, Milwaukee had an automotive manufacturing company right there on Richards Street, where Elige Johnson was doing the hiring. Milwaukee's Black community grew quickly between 1955 and 1965.

This was the Great Migration. With it came jobs and housing segregation and the demand for more schools, churches, and civic and social clubs and yes, more entertainment. So baseball quickly grew as a weekend past time sport.

"Dennis Biddle began the Milwaukee National Negro League, in Milwaukee. We had a strong team and over the years recognition finally came to the Negro League players. Only three are still alive today. Dustin Baker, who managed the Astros in the American (League). (The) National League remained close to Dennis Biddle and Bobby Barnes.

"Barnes never won a World Series but he kept hope alive. Each year, the Milwaukee Brewers hold ceremonies at the ballpark for the remaining players from the Negro league. We've had many superb players who made it to the National League, besides Hank and Jackie, who began as I did. The joy of the era is we understood sportsmanship.

"There was no cursing or rousing around, we often stayed in families' homes because there was no open hotels in the beginning; and we didn't have money anyway. None of us were paid, we played for the sport and the skills we knew we had to improve. We always hoped the best would be picked up by the National League."

Roy Campanella, Henry "Hank" Aaron, Joe Black, Jackie Robinson; the list goes on with the groundwork all coming from the Negro National League. James Beckum is applauded for his work with the Beckum Stapleton Little League that began from a request to serve. "Rev. E.B. Phillips witnessed what was happening to a lot of our Black males and began a ministry to get the boys involved with sports.

"He knew about my years with the National Negro League. So, out of obedience to the need and the request, I began to research the Little League of America."

"Thomas Cocroft, the District Attorney for Milwaukee, at the time, gave me a brochure about the National Little League World Series in Williamsport, Pennsylvania. The teams from Japan were winning. The kids were disciplined. They were good sportsmen, they knew and loved the game."

From fourteen boys and girls, at 9th and Brown Streets, the Beckum Stapleton Little League grew.

The competing teams were Greater Galilee Baptist Church, New Hope Baptist Church, St. Mark African Methodist Episcopal Church and Incarnation Lutheran Church. Each team had 15 players and two coaches, with boundaries set by the national office, so that teams could not go into other cities or counties to get the best players. That kept competition fair and all of the players working to get better.

"We developed some very good players over the years," Mr. Baseball recalled. "We should have won the National World Series in 1976. We'd worked so hard. The kids cried and I did too," he shared. We lost by one walk."

Mr. Beckum's beloved wife, Ruth, passed in 2016. "Her death took a lot out of me. She was my right hand. She never complained about

The Milwaukee Community Journal • February 9, 2022 • Page 3 was sendwas sendwe spending so much time with the kids. In fact, she helped me and even sacrificed to make certain we had equipment and snacks if the sponsorships were late or failed to materialize. I retired shortly after her death.

"I now have a real interest in science and medicine and changing our attitudes about health and clinical trials and making life better, especially for African Americans because we are the last treated and the fastest to go (death) because of distrust sometimes, and for lack of insurance, or not enough insurance.

"I'm learning about the 'All of Us' Research Program. I want to learn more. Whatever we can do to lengthen our days and shorten our pain, I'm for it."

James Beckum, "Mr. Baseball," still goes by the field to watch games from time to time. James Brey took over after Beckum retired; and he gives as much if not more to the game every year.

The kids love him and he's always looking for ways to keep the teams engaged, even during the winter. They sometimes go to the Southside for batting practice, donated by a former resident who grew up in the central city. Good has a way of multiplying good. and that certainly has been the case for the Beckum Stapleton Little League. While COVID-19 reduced the number of players last year, they played, and they are already getting ready for 2022.

Sign-Up begins the last weekend in March at Carver Park, the official home of Beckum Stapleton Little League. Practice begins the first Saturday in April.

And the first game is Saturday, May 7th, with a big Parade with con-

vertibles and the players riding in them. And the Milwaukee Community Journal has committed to report the PLAYER OF THE WEEK, chosen by the coaches of the North Central League. So watch for the Parade and the Player of the Weak, throughout the summer. Maybe we shall see a Little League World Championship team in 2022.



The Joe Rogan/Spotify controversy reignites the age old argument over the use (good or bad) of the 'N-word!'

If I understand the scenario correctly, several prominent Black 'leaders' are suggesting a national boycott of the music platform Spotify to protest the racist rants of a conservative podcaster.

The subject of the racist roach hunt is conservative podcaster Joe Rogan, whose Right-Wing views have spanned from the ridiculous to the racist. Since Black folks are not among his audience, his incendiary views were

generally unknown in our community. However, that changed last week when several podcasts highlighting his

repeated references to tribal members as 'niggers' (n-word) surfaced.

Obviously, Rogan uses the racist epithet as frequently as Snoop Doggy Dud does when praying to his god.

Fueling the flames of protest was an announcement by renowned singer India Arie who demanded Spotify remove her songs from rotation on the station in light of Rogan's racist rants.

Arie, who was also upset at Rogan's misinformed and ridiculous utterings about COVID-19, said she decided to have her catalog removed after learning he had used the epithet---'nigger,' (not n-word)--on 71 different podcast

I assume Arie, nor most angry African Americans, would not be upset if

Rogan had referred to us as 'n-words' instead of 'niggers. Or had he simply quoted a rapper or members of the Negrocracy—in-

cluding African American politicians, preachers, or poverty pimps.

In response to the growing backlash, Spotify CEO Daniel Elk issued the usual meaningless (PC) apology, saying Rogan's comments were 'hurtful and didn't reflect the company's 'values,' which essentially is about making

Elk refused, however, to give in to demands to have Rogan fired.

Said Elk, "While some might want us to pursue a different path, I believe that more speech on more issues can be highly effective in improving the status quo and enhancing the conversation altogether."

In a Twitter statement, he went on to say, "There are no words I can say to adequately convey how deeply sorry for the controversy (which) continues to impact us."

Hmmm. In other words, Spotify's hierarchy is sorry the podcasts are under public scrutiny.

But not sorry enough to remove the controversial podcast from the air because it is among the network's most profitable.

In fact, a rival network has offered Rogan \$100 million to leave Spotify and join them. I assume that the offer didn't come from BET or Disney. But then again, you never know. I had not intended to write about this controversy this week. I was half-

way through a column on the importance of Black History Month when I happened to tune into a discussion about Rogan on Tory Lowe's radio show I made an immediate U-turn, recalling my shock and disappointment

when his producer recently referred to Vice President Kamala Harris as a

The dichotomy of the two scenarios begged for a response.

Two quick points:

A 'boycott' against Spotify would end the same way as the one called by Mo'Nique against Netflix a few years ago.

If you recall, the foul-mouthed comedian, whose vocabulary consisted of two words---bitch (b-word) and nigger (n-word) ---called for a boycott because the platform was paying comedian Chris Rock more for a special than they offered her.

She said the network disrespected her.

I think four people joined her boycott. And they were relatives.

Or, to localize an example, remember our boycott of Beauty Island, the Asian-owned cosmetic (beauty) supply store on Fond du Lac Avenue?

The boycott was called after reports of a pregnant Black woman being assaulted by the Asian owner who accused her of stealing something--probably a wig or weave.

It should have been a commemorative example of Black Power, a situation in which tribal unity was exhibited.

Instead, it failed because some Neckbones felt stronger about Korean hair than Black empowerment or justice.

I remember being on the picket line in front of the store with Teju and other activists when a Black woman almost drove us over to get to the store. She made it known that horsehair was more important than righteousness.

By the way, the Neckbone called us a 'bunch of niggers' (not n-words) as she struggled to remove her two-ton butt outta her small, garbage-littered Despite our protestations, others followed the Neckbone's example. Even-

tually, the protest died a painful death, and the owners of Beauty Island laughed all of the way to their suburban bank. Boycotts are the most effective protest vehicle available to African Amer-

icans. But they must be well-coordinated and accepted throughout the village to be effective. The Montgomery Boycott is the clear-cut example of that paradigm.

Sadly, I can't remember any successful local effort.

My second point---in case you haven't figured it out yet—is about the

disingenuous, dichotomous word---'nigger' (not n-word).

Friends and followers of this column know of my disdain for the adjective/noun. I only use it to clarify or condemn—as is the case now.

And that goes for the ridiculous term 'n-word' as well.

A couple of years ago, the publisher revealed several of her peers were

disturbed that I didn't use the term 'n-word' as a substitute for nigger. So, I started using it sarcastically in conjunction with the epithet.

My subsequent disdain of the term 'n-word' is based on the phrase's hy-

And, like I said, had Rogan used the term 'n-word' instead of nigger. would you be upset?

But my bottom line is no one should use the epithet because that's precisely what it is.

Moreover, how many Black folks upset over Rogan's use of the offensive word use it themselves? I get it—there is a general consensus that only Black folks can use the

word, even though its origins are blatantly derogatory. It originally implied we were savages, illiterate, uncivilized animals.

Whites used it to justify slavery. 'Nigger' (n-word) was generally the last thing Black victims of lynchings and burnings heard before they died.

And ironically, it can still be used by tribal members as a denigrating ref-

Like the appellation bitch (b-word), it can be used affectionally and as an insult by its Hue-man source. Nonetheless, years ago, someone came up with the seemingly brilliant

idea of Black folks claiming ownership of the word. Under this paradigm (and when not used in a derogatory sense) nigger, or nigga, was redefined as a word of endearment, comradery, brotherhood.

Under this paradigm, Whites, even liberals, and spouses of Black men and women are forbidden from using the word. Or thinking about it. That tactic is beyond ridiculous. It has confused Whites on both sides of

the philosophical fence. Young, untainted Whites, the only hope for an end to racism, are told they

can't recite lyrics of rap songs or refer to their Black friends as 'niggers' even if it's spelled nigga. Moreover, as several Whites have informed me, it fuels their assumption

that we are a dysfunctional and confused people. Some Whites laugh at our self-defamation and denigration.

They recognize we are the only ethnicity on earth to refer to ourselves

with a term rooted in bigotry and oppression. No matter how you look at it, our acceptance of the word is our link to a slave mentality; inferiority and illiteracy.

Black South Africans don't call themselves Kaffas. Nigerians don't refer to their mothers as coons. Ghanaians don't call their ancestors spades. Have you ever heard an Asian refer to his brethren as a chink or slant

eye? Did Tonto call his tribal members 'injuns?'

In fact, Native Americans' disdain for racist epithets sparked their protest over the Washington NFL team calling itself 'Redskins.'

I hate to be the bearer of bad news, but our strategy has not worked.

We don't own the epithet, as illuminated by the fact that a county judge once said it was a 'fighting' word.

Whites can still motivate a response when they use it, implying they continue to control the word. And our reactions to it.

I can almost guarantee a fight if a White calls a Black man a nigger, versus the n-word. Hell, my column last week illuminated that fact.

As I noted, Theodore Edgecomb is facing 40 years in prison because he

punched a White attorney for calling him a nigger.

It's still an offensive word, as it will always be.

Equally important, I firmly believe as long as we look in the mirror and see a nigger, we will be chained to its origins, to slavery, racial hatred, and White Supremacy.

Imagine our future if we told our children that when they see their reflection, it is of a prince or princess, a descendent of greatness, creators of math, science, and medicine---of God's chosen.

I can't control your use of the word, but I don't allow tribal members to use it in my home.

My late mother, a reverend, taught me that the original Hebrews were Hue-men. Thus, Jesus/Yeshua was Black. Was (is) He a nigger? I rest my case.

Hotep.

hall." And it's the crime problem in Milwaukee that will surely take up most of Lucas' time if he survives a primary election February 15 and wins the special general election April 5 for the office to replace Tom Barrett, who is now the U.S. ambassador to Luxembourg.

"Crime is the most pressing challenge," Lucas said in a recent interview. "Solving the crime problem is key to prosperity and enhancing the quality of life in Milwau-

Not only does Lucas' anti-crime plan deal with the alarmingly high homicide rate, it also tackles the proliferation of guns, which Lucas says is responsible for

370 homicides in the city since April of 2020. And in a short period of time this year, 2022, Milwaukee has experienced over two dozen more.

"We must reduce the number of guns on our streets," says Lucas on his election website. "Enhance police presence in neighborhoods with the highest rates of gun violence and improve our homicide clearance rates by stepping up and investigate activity." Lucas notes the gang problem has been

exacerbated by the extreme number of car thefts in Milwaukee. In 2021, there were 9,700 auto thefts in the city. That averages almost 30 auto thefts per day. Milwaukee had 300 more auto thefts than Chicago.

believes the time is right to be mayor Lucas said he'd explore all avenues to not only treat symptoms that are causing the car thefts and reckless driving, but

identify the causes for this phenomenon. "I will bring automobile manufacturers, dealers, and insurance industry to the table to help us solve this problem. We will work to ensure that penalties are enforced.

"We'll also work towards the deployment of physical tools like speed bumps and roundabouts to make our streets safer."

Lucas noted the best solution to crime is a good education. "A community that doesn't educate its children will incarcerate its children."

He said he will work with MPS, the school board, teachers' union, business community and Charter and Parental Choice schools--as well as parents--to help students at all levels be successful.

Asked his thoughts on efforts around the nation to reform or 'defund' police departments, Lucas sees the challenge of reimagining law enforcement--and its practices--with keeping the city's streets

Lucas also reimagines how police departments can respond to 911 calls without having to send police. The MPD now utilizes mental health professionals in some calls dealing with a mental health crisis.

Notice of Special and Spring Primary Elections and Sample Ballot (February 15, 2022)

OFFICE OF THE MILWAUKEE COUNTY ELECTION COMMISSION

TO THE VOTERS OF THE CITY OF MILWAUKEE:

Notice is hereby given of special and spring primary elections to be held in the City of Milwaukee on February 15, 2022, at which the officers named below shall be nominated. The names of the candidates for each office, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, in the sample ballot below.

<u>Information to Voters</u>

- Upon entering the polling place and before being permitted to vote, a voter shall:
 - · state their name and address
 - · show an acceptable form of photo identification*
 - sign the poll book**

*If a voter does not have acceptable photo identification, the voter may obtain a free photo ID for voting from the Division of Motor Vehicles.

**If the voter is unable to sign the poll book due to disability, a poll worker may write the word "exempt."

If a voter is not registered to vote, they may register to vote at the polling place serving their residence if the voter provides proof of residence.

Where ballots are distributed to voters, the initials of two inspectors must appear on the ballot.

Upon being permitted to vote, the voter shall enter a voting booth or go to a machine and cast their ballot. The vote should not be cast in any manner other than specified here. Sample ballots or other materials to assist the voter in marking their ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

A voter who is a parent or guardian may be accompanied by the voter's minor child or minor ward.

An election official may inform the voter of the proper manner for casting a vote but the official may not advise or indicate a particular voting choice.

Assistance for Voting

A voter may select an individual to assist in casting their vote if the voter declares to the presiding official that they are unable to read, have difficulty reading, writing, or understanding English, or that due to disability are unable to cast their ballot. The selected individual rendering assistance may not be the voter's employer or an agent of that employer or an officer or agent of a labor organization which represents the voter.

Where Optical Scan Voting is Used

The voter shall fill in the oval or connect the arrow next to the name of the candidate of their choice for each office for which they intend to vote. To vote for a person whose name does not

appear on the ballot, the voter shall write in the name of the person of their choice in the space provided for a write-in vote and fill in the oval or connect the arrow next to the write-in line.

When using an *electronic ballot marking device* ("Automark" or "Express Vote") to mark an **optical scan ballot**, the voter shall touch the screen or use the tactile pad to select the name of the candidate of his or her choice for each office for which he or she intends to vote. To vote for a person whose name does not appear on the ballot, the voter shall type in the name of the person of his or her choice in the space provided for a write-in vote.

After Voting the Ballot

After an official **optical scan ballot** is marked, it shall be inserted in the security sleeve, so the marks do not show. The voter may insert the ballot in the voting device and discard the sleeve or deliver the ballot to an inspector for deposit. If a central count system is used, the voter shall insert the ballot in the ballot box and discard the sleeve or deliver the ballot to an inspector for deposit. The voter shall leave the polling place promptly.

Spoiling Ballots

If a voter spoils an **optical scan ballot**, they shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one voter. If the ballot has not been initialed by two inspectors or is defective in any other way, the voter shall return it to the election official who shall issue a proper ballot in its place.





France, Germany, Great Britain, and Portugal were the major players. Notably missing were any representatives from Africa. Europe, the U.S. and other western nations became wealthy off of our backs (slavery). They are still exploiting; supposedly underdeveloped, countries for cheap labor. The Portuguese, British, Arabs and Americans terrorized our ancestors. They stole our resources, religion, names, land language and culture.

During this time, King Leopold II of Belgium massacred 25 million Africans. Leopold's genocidal reign over the Congo Free State is infamous for its brutality. The people of the Congo were forced into labor for valued resources, including rubber and ivory, to personally enrich Leopold. Estimates vary, but about half the Congolese population died from abuse and malnutrition. Many more suffered from disease and torture. Among those who weren't killed, many were punished by having a hand or foot amputated for underperformance.

Ian Smith in South Africa proclaimed, "No African rule in my lifetime," he said, "The white man is master of Rhodesia. He has built it and he intends to keep it."

Cecil Rhodes thought of the English as a "master race". "I contend that we are the first race in the world, and that the more of the world we inhabit the better it is for the human race," he once said. His desired was to be able to draw a "red line" from Cairo to Cape Town, building a railway across the entire continent of Africa without ever leaving British territory. (Not to mention the millions who perished during the transatlantic slave trade.) Millions died, yet no one has been held accountable for this horrific holocaust.

Here in the United States, The Moors Sundry Act was a resolution passed by the South Carolina state legislature in 1790 relating to four Moroccan couples who were residents of the state. The resolution suggested that they were Moroccan nationals, and subjects of the Sultan of Morocco, not the government of South Carolina. The Act stated that the fact that they were Black should not subject them to state laws governing Blacks and slaves.

Morocco was one of the first countries to recognize the newly independent United States. From the Middle Ages to the 17th century, Europeans depicted Moors as black, "swarthy," or "tawny". The Moors were highly skilled craftsman and artisans and are responsible for bringing Europe out of the dark ages.

While Europeans in the 14th century were dying in large numbers of the Black Death, or plague; mainly due to living in unclean conditions, the Moors opened their first hospitals and understood that quarantining sick people had something to do with protection from

It was reported that George Washington summarized the debate on how to perpetuate slavery of the Moors in 1774 at the First Continental Congress in Philadelphia with this statement: "If we would agree to take the Fezzes and Turbans off the Moors' heads and remove the sandals from their feet and enforce severe punishments, and to also swear a death oath between ourselves to religiously and faithfully not to allow anyone to teach the Moorish children who they really were or who their forefathers were, and only allow the Moorish children to be taught that they are truly Negroes, Black people, and Colored folk. 200 years from today the Moorish people would not know their nationality nor the national name of their forefathers. Also, they would not know from which land or ancestors that they are descended from." This I believe is the original CRT (Critical Race Theory) response. This statement is as true today as it was then.

In the meantime, the right-hand man to John Hanson (also a Moor) was Benjamin Banneker. In 1789, U.S President George Washington appointed Banneker to the commission charged with planning the construction of Washington D.C. This exemplifies the hypocrisy of George Washington. The violence, suppression of our history and miseducation of African Americans began with the "founding fathers", many of whom were slave holders.

Anthony Browder said, "How can you expect the dominant culture to teach you right if they don't even treat you right." Tony Browder has devoted 30 years researching ancient Kemetic/Egyptian history. science, philosophy and culture. He is the director of the ASA Restoration Project; named for Asa Hilliard, which is funding the excavation and restoration of the 25th dynasty tomb of Karakhamun in Luxor. Egypt. Karakhamun was a priest of Amun at Karnak temple and served during the reign of Shabaka. Mr. Browder has conducted over 23 archeological missions to Egypt since 2009. He has traveled to Egypt 54 times since 1980 and is the first African American to fund and coordinate an archeological dig in Egypt. Mr. Browder's three decades of study have led him to the conclusion that, "Ancient Africans were the architects of civilization and developed the rudiments of what have become the scientific, religious, and philosophical backbone of mankind." None of this is taught in the American classroom.
