Wallace White

Wallace White, first African American Director of the Milwaukee Metropolitan Sewerage District and a long-standing community servantleader and entrepreneur, passed away recently after a long illness. He was 89.

Wallace White, first Black director of MKE Metropolitan Sewerage District, passes at 89

9 at 11 a.m. at New Testament Church, 10201 W. Bradley Road, where White was a member.

Wallace was born on May 28, 1933, to George Cornelius White and Janet White in Chicago.

Wallace spent his childhood in Chicago and later went on to further his education earning a BA in social psychology from Roosevelt University in Chicago, and a master's degree in public administration from the University of Southern California.

He was a proud American and served in the United States Army. He often wore a lapel pin of the United States flag. He told stories of how he had to fight his way up the ranks. Wallace began his early career as a sociologist,

Chicago and specializing in inner-city youth and gang violence reduction. He continued his work with the community as the

working as a community organizer in the city of

ment Program (CEP) in Gary, Indiana, where he worked as a cabinet member for Mayor Richard Hatcher developing programs for underserved communities.

He was also instrumental in securing federal funding to run those programs. White went on to serve as a cabinet member for other mayoral administrations and was a key part of several mayoral election campaigns.

His positions included Chief Administrative Officer for Mayor Kenneth A. Gibson in Newark, New Jersey, and Director of the Department of Public Works for Mayor Marion Barry in Washington, D.C. After his work in Washington, D.C., White was sought after internationally, from as far away as Japan, for his knowledge of then state-of-the-art wastewater treatment plant management. It was then that White moved to Milwaukee where he became

After his career as a senior-level public administrator and corporate executive, White used his entrepreneurial spirit to launch and run two local businesses.

During his 33 years in Milwaukee, White served as Board Member and Program Chair for the Milwaukee Area Workforce Investment Board (MAWIC), Chairman of the African American Chamber of Commerce of Greater Milwaukee, a member of the Executive Committee of the Community Brainstorming Conference, Captain of the Bradley Estates Neighborhood Organization, a member of the Bayshore Town Center Community Advisory Board, and was an adjunct professor at Cardinal Stritch Uni-

Tuckson has a master's degree in management and leadership and a master's degree in HR management from Webster University, as well as a bachelor of business administration degree from Fontbonne University.



Dear readers, as we rejoin the Baby Boomers, they have roared into a new decade, the 1960s.

The Baby Boomers marched off to the Vietnam War that began in November of 1955 and continued until April of 1975. An estimated two million-plus souls were deployed (sent) to war in that southeast Asian country.

In his book, "What It is like to Go to War," Karl Marlantes recalls his time as a Marine in that war:

"The Marine Corps taught me how to kill, but it didn't teach me how to deal with killing. Boot Camp can teach young soldiers many things. However, you can't teach consciousness or spiritual matur-


There are many differences between today's soldier and the Vietnam soldier. For example, in today's world—with the introduction of cell phones—a soldier can go on patrol and kill someone on the other side of the world, and afterwards call his girlfriend on his cell phone. In today's society we try to blur out the ugly as much as possible. When soldiers return home it brings joy, a missing piece of the community, isolation, mental health issues, and sometimes drug and

An alarming number of veterans have killed themselves at home after the war was over. The numbers are disturbingly large and

The acceptance of death by soldiers has been compared to women who learn to accept the danger involved in childbirth.

Ultimately, it's about accepting one's mortality. Some members of society do accept this outlook on life while others never reach that point of acceptance.

In his book, Marlantes, recalls a particular scary Drill Sergeant who he grew to respect and credited for making him a proud Marine.



Marlantes wrote that the Drill Sergeant helped him connect with something much larger than himself: his humanity. Soldiers returning home often need time, support, and encourage-

ment to rejoin their community, family, and a changed world.

Often times, it's the soldier's family that has changed. My family was one of those families. I will always recall with love and pride my first cousin who was a Marine during the Vietnam war; barely 19 years of age and preparing to go off to Marine boot camp.

His story was like so many others: a teenager forced to grow up quickly and face death so often that it became his familiar.

My favorite times were when my cousin came home on furloughs with so many stories to share about his travels.

As I look back, it is nothing short of a miracle that he could paint a picture that sounded as though he had just returned from a wonderful At the tender age of 12, I was not wise enough to know that I was

witnessing a survivor's best gift, the ability to paint the picture that best suits their needs for survival. A soldier's story speaks to many members of our community:

some veterans, some war widows, some children who never knew their fathers who died in that war.

We are all connected through memories, love, loss, and pride for our loved ones that are no longer with us, but who are always in our



Showing (or not showing) racism's true colors!

If you lined-up a dozen average-looking White men, could you tell which one was a White Supremacist?

Even if half were wearing dirty overalls, announced their names with a southern drawl and had chewing tobacco juice running through their dirty beards, could you ascertain which ones believed you were inferior, that the bible justified slavery or, as the Buffalo bigot feared, "Whites were on the endangered species list?"

Let me make this hypothetical quiz easier for you. If a dozen hillbillies were standing around a statue of Confederate General Stonewall Jackson--shining his boots and singing Dixie--could you assume they were Confederate sympathizers?

Obviously, this elementary school test would be easier to pass if the bigots draped themselves in Confederate flags or wore white hoods.

This is one reason I want to keep as many racist monuments in public view as possible.

I want to see who wants to take America back to the 'good old days' and believes America would be a better place if the 'tar babies were sent back to the jungles of Africa."

Call it guilt by association, but the tactic has worked in weeding out friend from foe. It has allowed us to look beyond the smiles and make assumptions that could save your life.

Conversely, the psychological orgasm you might get from seeing a statue of Robert E. Lee beheaded or the Confederate flag burned from its perch on southern state capitols buildings will incite temporary pleasure. Still, the truth is you've done little to change the hearts of haters. And that feeling will be short-lived once you find yourself driving through Mayberry.

Symbolism aside, you can't destroy cancer by placing a Band-Aid on a malignant growth.

I would rather see the herpes virus around your lips before I venture

I vividly recall attending a Nazi rally many years ago at a Milwaukee southside park. The scum bag bigots were adorned in khaki uniforms with swastika armbands positing their philosophy of Aryan superiority.

The small army of vanilla turds were in a roped-off area of the park surrounded by local police, some of whom were sympathetic to their

Anti-Nazi demonstrators shouted down the bigoted bastards, eventually pelting them with raw eggs.

Afterward, the followers of Adolph Hilter's ghost went home, took off their German uniforms, and prepared for their next day's work: at city hall, in government (public) schools, or behind the pulpit.

I assume you get my point.

Obviously, we can't force all bigots to identify themselves, and since most Caucasians are descent Hue-man beings---albeit prejudiced as are we all--how do you differentiate them?

That task is made more accessible if you photograph them at a Klan rally or pray before the altar of White Supremacy. Or marching around a monument to the Confederacy on the 4th of July.

I would jump at the opportunity to publish a photo of Granny Clampett (from the 60's TV sit-com show, 'The Beverly Hillbillies') as she cleans the bird do-do off the statute of the traitor southern general, Robert E. Lee.

Think of it another way: Would you buy a soda (diet) from a roadside merchant with a Confederate flag hanging from his window? Without the banner, you would be unwittingly subsidizing bigotry.

Several years ago, I authored a column on how my faith was questioned as I drove past a pickup truck in Menomonee Falls while heading to the House of Grace worship services held at a hotel on Main Street.

I readily admit I pondered an act of vandalism. Instead, I used the scenario to explain to a grandchild why I wanted to confront the seller

Had some suburban 'liberals' convinced the vehicle owner of his 'insensitivity' or set the truck on fire, I would never have known a White Supremacist lived 10 minutes from Milwaukee.

I often tell the story of my most frightening experience in while in Vietnam. I was sent as an escort/guard for an officer to a base deep, deep, deep in the south of that war-torn country. I was left alone as the officer went on a patrol. I felt uncomfortable because none of the soldiers would even talk to me, and several provided that look that sent chills up Black men's spines.

I didn't fully understand my danger until I saw the Confederate flag in their makeshift recreation shack.


For the next few days, I spent off-base with a Black troop. When forced to sleep at the camp,

I did so with a .45 under a pillow. I knew to keep a round in the chamber because they showed their 'true colors.'

Had I seen the flag at the on-set, I would have saved myself aggregvation instead of assuming my deodorant wasn't working.

I draw the line at subsidizing racist monuments with public dollars. Still, if the citizens of Cornbread, Mississippi, want to subsidize a racist monument with their private funds, that's on them.

It speaks volumes about the history of that community and the people who live there.



I know this may not convince most of you, so let me note my most significant concern. I think this movement to rid the country of racist images could lead to a new attempt to erase this country's racist past (and present) with revisionist history. Eventually, with no one to blame, we would again fall into the trap of self-denigration.

In other words, if there was nothing wrong with the system or the people running it, we must be the blame for our own predicament. Or maybe God-ordained American exploitation and provided the template for apartheid.

I assume most of you feel similar to how the brothers and sisters at Tuesday's Call to Action meeting. I revealed the topic of this column to North Division alumni as we were putting the final touches on a strategy to tear down the walls of apartheid that surround that pioneering school.

My position was met with concensus curiosity---to put it mildly.

As such, I didn't have the opportunity to elaborate on my secondary reasons, starting with my assertion that the quest to rid the country of racist memorabilia and monuments makes us complicit in a scheme to rewrite American history.

Indeed, I see a connection between the progressive-funded effort to remove monuments linked to the Confederacy under the same umbrella as the attacks on so-called Critical Race Theory.

It's bad enough that we're raising yet another generation of Black children with little knowledge of where they came from and how they got to this point. Children who can't relate to the Motherland and think Black History began with slavery.

The movement to remove symbols of hatred---His-story--- coincides with a national effort to sanitize or confuse references that justify our claims for reparations. At this current pace, the next generation will probably not know of the real reasons for the civil war, how the U.S. Supreme Court followed by stripping us of fundamental rights as they will do for women very soon (abortion rights/Roe v. Wade).

And I can guarantee that even

our Democratic Party 'pied pipers' will make sure the new 'His-story books won't mention the Confederacy and KKK grew out of their party.

Already most of America erroneously believes Abe Lincoln—himself an avowed racist---ended slavery with his Emancipation Proclamation. For the record, Lincoln only freed (probably illegally) slaves in Confederate states, and he didn't do it for humanitarian reasons because he felt our ancestors were inferior beings.

If you don't buy into my hypothesis, consider what so-called progressives are doing to sanitize His-story. The attacks against CRT which essentially posits that systemic racism has, and continues to exist, are rooted in accepting blame for America's authorities.

Several years ago, a Milwaukee suburban community school board decided to take several books off the student reading list because they said racist references were insensitive. To who?

One of the books was a Mark Twain 'classic' that repeatedly used the word 'nigger' (n-word). Daw?

I facetiously asked if it was replaced with the stupid substitute 'n-

The offensive term was used in a historical context by a racist in its property setting. It is how many Whites identified us in that era—and some believe today. It's what many of y'all see when you look in the mirror. (I said y'all cause I don't include myself in that dichotomous

My central point was the board's agenda to sanitize racism.

I can assume school boards will follow up by outlawing Lincoln's speech of September 1858. Or, for that matter, most public comments by LBJ, who some consider the architect of modern-day civil rights initiatives.

While the various monuments anger many people and give America a black...er white...eye, they serve a purpose. They are not only obvious examples of hatred and bigotry but reminders of where we came from and don't want to return.

Some believe the monuments make 'some' Whites uncomfortable or that it 'divides' people and fosters unnecessary animosities. So what. We need to pod and push, to confront and suspect. The only

way to address a problem—much less fix it---is to acknowledge that it exists. Remove the evidence, and you can't win the court battle. Racism, bigotry, and White Supremacy through, legal apartheid, are

as American as apple pie, baseball, and unfulfilled political promises. You can deny it, hide it or scrub off the graffiti with lye and lies, but that doesn't mean it has been exorcised. I understand the angst and emotionalism of those who want to ban

But we need to provide clear examples to support our justification

for reparations and, equally important, to measure how far we've come. And which obstacles remain to block our path to empowerment.

Black Holocaust Museum founder James Cameron once told me he created the museum to bring to the world's attention the evil that overwhelmed us and provide shocking exhibits to ensure we never forget.

Civil and human rights organizations tell the-Grio they have grown frustrated with the White House's lack of movement on what they say is no longer a fringe issue.

Civil and human rights groups are calling out the Biden administration for its apparent reluctance to take executive action to create a commission to study slavery and reparations in the United States.

Calls to address the socioeconomic harms caused by the country's "original sin" through reparative measures were recently renewed following the mass shooting of 10 African Americans at a supermarket in Buffalo, New York, last month.

Despite growing outside pressure from the movement for reparations, the White House will not commit to President Biden signing an executive order.

During a White House press briefing last week, theGrio asked Press Secretary Karine Jean-Pierre if the president would create the commission

through executive action.

reparations commission

In her response, Jean-Pierre reiterated what she had said earlier in June when asked about the executive order in response to a question about California releasing its own state task force report on proposals to develop

"The president's position hasn't changed," the presidential spokeswoman told theGrio.

On the record, President Biden supports a reparations commission and would sign H.R. 40 if passed by Congress.

The bill would create a reparations commission by law. However, it has yet to come to a vote in this session of Congress, and given the lack of support from Republicans, it is unlikely to pass in the current U.S. Sen-

Advocates say given the political reality of H.R. 40 in the House, some say they have legislative branch, Biden using the power of the executive administration's lack of movebranch is the only viable path to creating the commission.

"We know that we could get it passed in the House of Representatives, but it would only be a moral victory," Ron Daniels, convenor of the National Afri-Reparations can-American Commission (NAARC), told

theGrio. "We don't want a moral victory. We want an actual vic-

As previously reported, a source told the Grio that Democratic leadership is reluctant to bring H.R. 40 to a floor vote for fear that it could lead to blowback for the party in the months leading into the midterm elections in November.

However, Daniels said the decision to halt H.R. 40 was intentional and that Democratic leaders like House Speaker Nancy Pelosi, Majority Leader Steny Hoyer and Majority Whip James Clyburn are all in support of bringing the bill to a vote.

All sources contend that the best strategy on reparations is through executive order until more Democrats are elected into Congress. As advocates turn their attention to the White grown frustrated with the Biden ment on what they say is no longer a fringe issue.

"I think there's some fear that is rooted in [the idea that] we have to stay away from Black issues if we're going to win," said Andre Perry, a senior fellow at Brookings Institute. Perry, a respected scholar and author of

the book, "Know Your Price: Valuing Black Lives and Property in America's Black Cities," noted in an interview with the-Grio that public approval of reparations has "tripled" in opinion polls.

A recent Gallup Center on Black Voices survey found that a majority (57 percent) of Americans believe Black people have been affected by the history of slavery in the U.S. Most Americans (63 percent) also said the federal government has a responsibility to do something

Perry and other advocates also pointed out that despite the White House's inaction on creating a reparations commission, states, local municipalities and even the private sector are all engaging in work related to reparations for Black Americans. In addition to California's special task force, Maryland has also created a reparations commission.

In Illinois, Evanston became the first U.S. city to issue slavery reparations through a housing program to fund property repairs and other costs for Black homeowners and homebuyers.

Similarly, in Asheville, North Carolina, the city council voted to create a reparations commission and issued a formal apology for its involvement in slavery and racially discriminatory policies. The private secincluding banks, churches, and universities has also endorsed reparations or issued some form of reparative measures for Black Americans.

Perry said the growing state and local movement toward reparations is a signal that the rest of the country is already ahead of the federal government, and that "it's better to be in tune with what's happening across the country than ... signaling that reparations is going to bring down a president."

Dreisen Heath, a researcher at the Human Rights Watch, told theGrio that she sees the reluctance to move on creating a reparations commission as "rooted in gatekeeping white supremacy" and not the "shared power of the people.'

"This should be something that we are all taking as a serious measure for the well-being of our democracy, for the wellbeing of our country," said Heath.

She also noted that there's no "apology on the books" to Black Americans on behalf of the added, "the majority of the federal government's culpability in sanctioning torture and racial subjugation on Black people"

Perry said while action on reparations in Washington, D.C. have yet to materialize, it's only a matter of time given the grassroots movements percolating elsewhere. "If reparations won't come from D.C., it'll go to D.C.," he said. "At some point, Biden needs to take this up and treat it like a serious policy issue — as it is."

Perry noted that reparations could be implemented in a number of ways, especially when one looks at the myriad forms of reparations already being developed across the country. Regardless, he said, the repair should speak to the harm caused to Black people such as the inability to access and build

"It might be, you know, some type of savings bond, it might be cash payment, it might be various land rights," said Perry. "For instance, there's a housing gap and one of the ways to close that housing gap is to provide down-payment assistance." He said reparations could also come in the form of "various scholarships for higher education or free college" and eliminating student loan debt.

The movement for reparations is one that dates back decades. Daniels of NAARC is a longtime activist and political scientist. He also worked with the late U.S. Rep. John Conyers (D-Mich.), who introduced the first reparations bill in 1989. Daniels said NAARC's H.R. 40 strategy group has done a lot of the groundwork for the organized call to action for a reparations commission.

The organization has been closely working with U.S. Rep. Sheila Jackson Lee (D-Texas), who in this session of Congress introduced H.R. 40, a bill that builds on Conyers' legislation more than 30 years ago.

"She has been phenomenal in this pushing and scrapping," said Daniels, stressing that he is "honored" to be able to work alongside Congresswoman Jackson Lee. "I think that's because she sees John Conyers looking down, smiling on her as she has taken the torch from one of the great progressive leaders of our era to push this over the finish line."

"We know," she holiday that Biden signed into law last year that commemorates the date (June 19) in 1865 when a Union Army general informed enslaved people in Texas that they were free — activists held a press conference on the Ellipse in front of the White House. Daniels noted that an executive order from Biden would create a budget for a commission and would facilitate hearings to discuss what reparations would look like on the federal level. Ultimately, the commission would send those proposals to Congress.

Reparations, he said, are the "overarching policy prescription that will address the fundamental issue of white supremacy and structural institutional racism in this country." Referencing the current Jan. 6 committee hearings, Daniels said, "[it] needs to be addressed now in the same way that we're addressing the issues of the assault on democ-

He added, "They go hand-inhand to some degree because the forces who are trying to destroy democracy are the same forces who are harboring this strong sentiment in terms of white supremacy and structural institutional racism."

Heath of the Human Rights Watch told the Grio that there can be no racial reckoning in the United States without reparations. "You cannot reckon with the conditions without repairing them," she said.

Speaking to Biden and the need for him to unilaterally take up the issue of reparations. Heath said plainly, "There's really no sides here."

"There's right and there's wrong and there's destruction and there's repair ... which one will [he] choose?"
