

Editor's Note: This week, the MCJ continues its interview with Rev. Greg Lewis (pictured at left), founding president of Pastors United and 'Souls To The Polls,' an initiative created by Pastors United to mobilize resident and eligible voters of Milwaukee's Black community to vote in local and national elections and defend voting rights.

The one-on-one interview took place at the offices of the Community Journal and was taped by Souls To The Polls for use online. The MCJ will upload an edited version in the very near future.

This is the second of a three-part series the MCJ is running before the start of pre-election voting. In this segment, Rev. Lewis talks about the state of voter participation in Milwaukee and nationally, and the need to mobilize more than Black and Brown communities...

MCJ: Could you explain how—periodically with the Voting Rights Act. Explain why it's necessary to renew the Act every 20 years by the U.S. Congress for it to continue?

Rev. Lewis: Yeah. It's not even secure. So if we don't get another seat or two, that will never be secure.

So we'll be taking a huge step backwards and it'll be like Jim Crow. They'll be asking you to count the bubbles in the bowl or count the number of jaw-breakers in the jar.

Gerrymandering will keep this state in the control of Republicans for at least another decade...and probably (for) several decades, because I don't see why that would change if they (conservative Republicans) are still in power.

And we have these voter ID laws that started here in 2010. And you have all the nonsense with the drop boxes where you can't even help folks who are disabled or injured.

MCJ: In Georgia, you can't even give somebody a bottle of water.

Rev. Lewis: (As a matter of fact) you can't do it here (in Wisconsin) either. And all the changing of polling places, purging you off the voter registration rolls. All these things are

(continued from front page) happening right now. If we don't keep a person (like Gov. Evers) in place to veto these changes so they don't become law, all those (negative things) I noted will come to fruition.

Everything is at stake in this midterm election because the MAGA politicians want to keep minorities and the poor folks from voting. And they will succeed if we don't come out to vote on November 8.

MCJ: What are the issues that are make or break in the Black community as it relates to winning or losing on November 8?

**Rev. Lewis:** Again—and I hate to say this because I don't want people to think I'm saying we're not intelligent enough to make decisions about issues—we don't think about any issues because we're dealing with dayto-day mess all the time.

Plus, we're in a system that really doesn't seem to (want to) include us. As a matter of fact, it (the system) has dissolved our effectiveness in building our communities to the point where we're steadily going down into a valley of destruction...in our own communities: the murders, the (reckless) driving and all that kind of stuff.

But most of the people in our community are good, law abiding citizens who want a nice, safe place to live; who want to sit on their porches every day, and they want to enjoy the weather. But they can't do that because we have a few people who destroy all of that.

And it's on the (evening television) news. That's why I hardly watch the news, because it's never good news to me—about the things that happen in our community.

Issues are something we have to put in the faces of people...like, right now! Especially older adults. When someone comes along saying they want to eliminate Social Security and/or Medicaid, we have to let people know about what that means to and for them.

Because if you work all your life and you are once-amonth adding to that chest of money and the day comes for it to be your time to collect some retirement supplement, it's not there for you.

People need to understand and know that when you put money into that situation, it may not be there for you (when you're ready to retire) and some guy is going to

make that decision for you.

And that person is not going to be someone who you want to support. But, you have no one else to blame but yourself because right here in Wisconsin where 80 percent of the population is White and 20 percent is minority. However, that 80 percent is (itself) split right down the middle. We (minority/Black population) can make the difference. But we won't if we don't vote.

In America—as a whole it's 61 percent White and 39 percent minority. And THAT 61 percent is also split right

find a more simplistic way to deliver a message to our communities that can help them make step-by-step movement to power. (As I said) voting is pure power, right?

Black people have been bamboozled to think they don't have any power, and this is as wrong as two left shoes.

That's because our White brothers and sisters-I'm repeating it again—are split down the middle.

Most of those individuals are Democrat. And here's the other problem: not only do we

But! We don't think we have the power; we just don't believe we have the power! But we do. We can make the decisions if we vote. That's pure power! We're the most powerful people in the world right now. How America goes is how the world goes.

If our votes don't count, why do they (conservative Republican lawmakers) have all these suppression obstacles (laws) in our way? They (conservatives) are basically trying to convince our people that their vote doesn't count by putting rules in their path to discourage them.

MCJ: So, if we can convince people to vote based on that, do you think that they'll probably get out and vote feeling that they have a sense of power?

**Rev. Lewis:** That's what we're hoping for. We have to have to infuse energy into the Black and Brown, and other minority communities, we have to infuse energy into those White voters who are poor, who have given up; who don't think they matter, who don't think that they're important, who don't think their

That's what Black folks have felt for a long time. We knew the system was not built for us. But now, we have White folks who believe that. That's especially true of White Republicans. They believe that.

We have to get White Democratic voters energized to fight back. We have to teach these White brothers and sisters that they have to fight back...they have to fight with us (Black folks). This has to be a melting pot of people fighting together in order for us to put people in place who will look out for our interests. We can't miss that point.

## **Recognize World** Homeless Day

In recognition of-and solidarity with the World Homeless Day worldwide movement, Street Angels recently hosted a press conference to share information about their current outreach efforts in the Milwaukee area.

World Homeless Day educates communities about the needs of people experiencing homelessness.

On July 1, 2018, Street Angels began collecting data during outreach in order to track its success in helping people into permanent housing. With a focus on developing relationships, they do not require sharing information in order to receive meals, supplies, clothing and referrals

The system tracks gender, age, US military status, and chronic homelessness. Since then, Street Angels staff and vol-

The group suffered a heartbreaking setback in January when someone set fire to one of their two buses. With the community's support, they launched a new outreach bus at the end of March and have already put on approximately 3,800 miles in outreach since then. Street Angels run outreach on Sunday, Tuesday, and Thursday nights.

Dan Grellinger, Outreach Specialist and Substance Abuse Counselor – In Training states, "The county is on pace to set a record for overdoses this year. Unfortunately, we've also seen an increase in substance use disorders in some of the people we meet. Our friends also share evictions as a barrier to securing housing. Every person we help get into permanent housing feels like such a huge victory.

Wisconsin school districts encouraged to apply for Fab Labs **Grants** 

The Wisconsin Economic Development Corporation (WEDC) is now accepting applications for the seventh year of its Fabrication Laboratories (Fab Labs) Grant Program, which provides funding to help public schools build or expand fab labs.

The grant program supports hands-on science, technology, engineering, arts and math (STEAM) education by assisting public school districts with equip ment purchases for instructional and educational purposes in fab

Fab labs are high-tech workshops with the latest equipment, including computer-controlled manufacturing components such as 3D printers, laser engravers and computer numerical control routers.

WEDC's investment in the program puts fab labs within reach for schools that might otherwise not have the financial means to install such facilities.

WEDC will provide grants of up to \$25,000 to public school districts, or up to \$50,000 to consortiums of two or more districts, for the creation and/or expansion of fab labs.

For this year's funding cycle, applicants are being asked to match 50% of the amount of grant funds requested. For example, if your district is requesting a grant of \$25,000, the district must provide a match of at least \$12,500.

The funds may be used to purchase equipment used for instructional and educational purposes by elementary, middle, junior high, or high school stu-

Since the program's inception. WEDC has awarded over \$3.9 million in grants to 106 districts.

WEDC is allocating \$500,000 in this fiscal year and anticipates awarding 20 grants. Recipients will be announced in the spring.

For the first time, Fab Labs Grants will be awarded on a non-competitive process firstcome, first-served basis, with applicants evaluated on application completeness, evidence of readiness and long-range planning, curriculum, business and community partnerships, financial need and previous awards.

Applicants who have already received three grants will be ineligible this year for additional funds, except for Milwaukee Public Schools.

If a district previously received three Fab Labs Grants, they would still be eligible to apply for a one-time grant to establish a fab lab for use by K-8 students.

The announcement comes after Congress passed legislation in late 2020 requiring the military bases named after confederate soldiers be renamed.

The Department of Defense has approved the renaming of nine military bases that honor confederate officers, The Atlanta Journal-Constitution reports.

The announcement comes after Congress passed legislation in 2020 requiring military bases to rename camps currently named for confederate soldiers, including Fort Gordon and Fort Benning.

A taskforce was established last year to analyze the names of nine installations in former confederate states and change those names within three years, the Grio reported.

The Naming Commission submitted its recommendations to Congress in August, theGrio reported via The Associated Press. Secretary of Defense Lloyd J. Austin III stated in a recently released memo that the DoD accepted the recommendations, according to The AJC.

There is a 90-day waiting period until implementation, and Austin ordered the renaming and removals completed no later than Jan. 1,

The cost to rename the nine Army bases is \$21 million, according to the commission, 13 News Now reports.

RALEIGH, N.C. (AP) — The president of a historically Black university accused South Carolina law enforcement officers of racially profiling a busload of students from her school by stopping the vehicle for a minor traffic violation and using drug-sniffing dogs to search their luggage.

Noting that nothing illegal was found in the search, Shaw University President Paulette Dillard said she was outraged by the treatment, which also included questioning that she likened to an interrogation.

The traffic stop was done by

deputies and law enforcement officers in Spartanburg County on Oct. 5 as 18 students from her Raleigh, North Carolina, school were traveling to a conference in Atlanta, she said. Dillard wrote in a statement Monday that she has asked the school's general counsel to consider options for legal

"In a word, I am 'outraged," Dillard wrote. "This behavior of targeting Black students is unacceptable and will not be ignored nor tolerated.

"Had the students been White, I doubt this detention and search would have occurred."

She called the situation "reminiscent of the 1950s and 1960s — armed police, interrogating innocent Black students, conducting searches without probable cause, and blood-thirsty dogs" and the deputies' actions "unfair

and unjust.

The officers told the people aboard the bus that they stopped it because the vehicle was swerving and issued the driver a warning ticket for improper lane use, according to Dillard's statement. It was not clear if the bus, which Dillard referred to as a "contract bus," had university insignia on the outside.

The statement referred to deputies and officers conducting the search in Spartanburg County but does not specify which agencies were involved.

The university communications office didn't immediately respond to emails seeking further comment.

The stop occurred during the local sheriff's annual weeklong anti-drug campaign known as Operation Rolling Thunder, in which

## uncertainty amid furor over racist remarks

**Three current or former Council** members have been indicted or pleaded guilty to corruption charges, and it's possible resignations in coming days could create new vacancies.

LOS ANGELES (AP) — Where does the Los Angeles City Council go from here?

Three of its members – including the former Council president – are facing calls from President Joe Biden to resign after a recording surfaced of them participating in a closed-door

meeting in which racist language was used to mock colleagues while they schemed to protect Latino political strength in Council districts.

Three current or former Council members have been indicted or pleaded guilty to corruption charges, and it's possible resignations in coming days could create new vacancies.

The current mayor, Democrat Eric Garcetti, was named last year to become U.S. ambassador to India but the nomination appears stalled in the Senate because of sexual harassment allegations against one of his former top aides. Elections next month will bring a new mayor and several Council members.

In the short term, it's a looming question if the Council can assemble the required 10 members — out of 15 total — to conduct business on Wednesday, when coincidentally Biden will be in town.

"I have never seen anything like this," said Raphael Sonenshein, executive director of the Pat Brown Institute for Public Affairs at California State University, Los Angeles. "That's the real challenge now, to kind of get to where

they are going to conduct business on a regular basis," Sonenshein said. "This chaotic situation is going to be very visible ... both here and nationally."

The Council will attempt to reconvene Wednesday, possibly to censure the three members cited by Biden. A Tuesday meeting was nearly derailed when a raucous

crowd of protesters packed the chamber, calling for the resignation of those involved in the meeting — former City Council President Nury Martinez, who is taking a leave of absence, and Councilmen Kevin de Leon and Gil Cedillo, all Democrats.

The Council cannot expel the members — it can only suspend a member when criminal charges are pending. A censure does not result in suspension or removal from of-

The uproar was triggered by a leaked recording of crude, racist comments from a nearly year-old meeting, which also provided an unvarnished look into City Hall's racial rivalries. Those involved in the meeting were all Latinos.

Martinez said in the recorded conversation that white Councilmember Mike Bonin handled his young Black son as if he were an "accessory" and said of his son "Parece changuito," or "he's like a monkey," the Los Angeles Times reported Sunday. She also referred to Bonin as a "little bitch."

called indigenous immigrants from the Mexican state of Oaxaca "tan feos," or "so ugly."

The discussion — which also included a powerful La-

tino labor leader, who has since resigned — centered on

protecting Latino political power during the redrawing of council district boundaries, known as redistricting. The once-a-decade process can pit one group against another to gain political advantage in future elections. At the ornate Council chamber, an overflow crowd of

protesters delayed the start of Tuesday's meeting as they angrily shouted for de Leon and Cedillo to leave the room. Police officers scurried at the edge of the crowd.

De Leon sat impassively at his seat, his eyes cast downward, as protesters called on him by name to exit the chamber. Others on the 15-member Council urged the crowd to settle down and allow the meeting to begin.

Cedillo and de Leon left their seats early, leaving in doubt if they will appear Wednesday.

Martinez stepped down from the leadership job and apologized Monday, saying she was ashamed of her racially offensive language in the year-old recording. However, she did not resign her council seat. She announced Tuesday that "I need to take a leave of absence and take some time to have an honest and heartfelt conversation with my family, my constituents, and community



She did not appear at the Tuesday meeting.

In emotional remarks at the meeting, Bonin said he was deeply wounded by the taped discussion. He lamented the harm to his young son and the fact that the city was in international headlines spotlighting the racist language "I'm sickened by it," he said, calling again for his colleagues' resignations.

"Los Angeles is going to heal," he said at one point. "I want to lead with love."

Black and Latino constituents often build alliances in politics. But tensions and rivalries among groups separated by race, geography, partisanship or religion have a long history in Los Angeles and, indeed, the country The friction can cross into housing, education and jobs — even prisons — as well as the spoils of political power.

The California Legislative Black Caucus said the recording "reveals an appalling effort to decentralize Black voices during the critical redistricting

In one of the most diverse cities in the nation, a long line of public speakers at the meeting said the disclosure of the secretly taped meeting brought with it echoes of the Jim Crow era, and was a stark example of "anti-Blackness."

There were calls for investigations. and reforming redistricting policy.

Many of the critics also were Latino, who spoke of being betrayed by their own leaders.

Candido Marez, 70, a retired business owner, said he wasn't surprised by Martinez's language, who is known for being blunt

and outspoken. "Her words blew up this city. It is disgraceful," he said

"She must resign." The Los Angeles Times reported that the recording was

posted on Reddit by a now-suspended user. It is unclear who recorded the audio, who uploaded it to Reddit and whether anyone else was present. Biden press secretary Karine Jean-Pierre said Tuesday

that the president wanted Martinez, de Leon and Cedillo "The language that was used and tolerated during that

conversation was unacceptable, and it was appalling. They should all step down," Jean-Pierre said.

Other calls for the councilmembers to resign have come from across the Democratic establishment, including from U.S. Sen. Alex Padilla, Garcetti, mayoral candidates Karen Bass and Rick Caruso and members of

## **Bein' 'PO' versus** Being 'POOR'

I found a copy of a 1979 Social Development Commission Report on Poverty the other day and, within seconds, concluded little has changed in four decades.

In fact, the report could have been written yesterday, with the only observable difference being the boundaries of the central city.

Oh, yeah. Another significant omission: the report did not distinguish between the 'Po and the Poor.

And those categories had as much to do about income as culture. Like most of my neighborhood, I grew up 'Po, which didn't mean we couldn't afford the 'or,' but instead, within our culture, poverty was nothing more than a high hurdle; added weight we had to carry across the finish line. In fact, it could be said the added pounds helped to build muscles and fine-tune our strides.

Conversely, those caught up in the Culture of Poverty—'Poor' families---saw their lives through the prisms of contentment and containment. Chances are, if they crossed the finish line at all, it would be in

If I were to rewrite the SDC report, I would probably have included a footnote about how the conflicting categories impact Milwaukee's current status as the worst city for African Americans.

Unfortunately, neither policymakers, poverty pimps, nor politicians make that distinction, choosing to lump us all together, justifying police profiling and the lack of educational equity by positing that lowincome Black children can't learn.

In truth, it's not because of income but discipline, motivation, and the Culture of Poverty devaluing education.

Some would even go so far as to imply speaking English, or mastering algebra is 'acting white.'

Allow me to push the rewind button back to my childhood (a few days before the report) to elaborate:

Po' families moved from the deeper-than-deep south for opportunities, freedom from overt oppression, and an umbrella to deflect Confederate apartheid.

The North offered jobs and access to better schools. The weather was not as comfortable, but it was a lot warmer than the cold chill of apartheid in the Deep South.

Most 'Hue-men' family heads found good-paying factory jobs in Milwaukee. Many purchased homes within the confines of the segregated and separated Black community.

'Po families invested in businesses---as my grandparents did---and made our community self-sufficient, with a plethora of theaters, hotels, and grocery stores.

On the other hand, most 'Poor' families who followed the north star

as part of the third wave if the great migration did so to avail themselves of generous welfare programs.

Before President Bill Clinton ended 'welfare as we knew it,' Wisconsin had the second-highest benefits in the country (second only to Minnesota).

In fact, an additional bounty was paid for new slave labor—each new child brought an increase in financial assistance.

(A little-known fact of that era was that 'fornication' was against the law, meaning a woman could have been charged and jailed every time she picked up her welfare check.)

More disturbing was the fact that welfare required replacing the father as head of household with an uncle---Samuel.

Making matters worse was the reality that public assistance was barely enough to live on, and as such, leaving the fatherless family one mishap away from calamity. An unexpected bill or act of nature could leave children on the street.

'Po families maintained their property, even the rentals. It was about pride and livability.

was living in a two-bedroom log cabin. We were required to scrub the floors (not mop), dust, scour out tubs

My mother demanded cleanliness even when our family of seven

and toilets and keep the kitchen spotless. A roach would starve in our house, even though you didn't see many,

if any, in the homes of Po families. That paradigm extended to our lawns, nicely cut and manicured. We even had signs dictating people 'stay off the grass,' as that green carpet

was our welcome mat and was a reflection of the residents within. Poor families could care less, and the only grass you found on their property was rolled up in cigarette papers.

(I didn't know until my teen years that my grandfather was kidding when he said rural southerners grounded away the grass so they could see snakes approaching the house.)

Poor families covered their furniture with dirty bed sheets (we had ours encased in plastic), hid their mouse traps under an unread newspaper, and wiped-out dishes instead of washing them,

It was not unusual to be greeted at the door with the smell of urine, and that crackling sound under your feet was hopefully a peanut shell.

'Po children were raised with strong work ethics. They saw their parents working—albeit frequently low-paying jobs—to keep food on the table and clothes on our backs.

Everyone who could contribute to the household did so. I started a paper route upon my 12th birthday, a full year after I had spent summers working on my grandfather's scrap metal truck.

I also worked at Mary's Car Wash on 8th and Center Streets; she was a neighbor who provided extra income to families in need of extra

Most 'Po children had two pairs of shoes—sneakers for the week and 'dress shoes' (Buster Browns) for church and special events. I hated those 'dress shoes,' as they were made to last (some kind of pliable metal, it seemed) and were as ugly as Donald Trump's attitude.

My income allowed me to give to the household and buy outfits for myself.

Those subscribing to the Culture of Poverty used rent and food money to buy expensive clothes, to make themselves feel important, distinguish themselves from their peers.

They were the first on the block to purchase a color television (it was a rarity in my youth), even though there were more important pri-

While Po families generally ate simple---albeit nutritious---meals during the week, on the Sabbath, we would splurge or visit grandpar-

The

ents for family gatherings.

That's after we returned from church, which was generally crowded to overflowing. A family Bible was required reading, and my mother added another 30 commandments to God's original 10.

Violation of those aforementioned commandments could mean a 'whooping' as mentioned in the Bible.

Poor families slept in on 'The Lord's Day.' Some were just returning home from a night on the town. That's not to say we were prudish. We partied. As Lou Rawls once

sang, the 'Eagle flies on Friday, Saturday I go out to play. Sundays, I went to church and prayed.' My siblings and I attended quarter parties, generally hosted by a

classmate or a neighborhood friend. Otherwise, we reported in when the sun went down and generally stayed on the block afterward. The parents of 'Po children didn't worry about where they were; in

many cases didn't care. 'Po girls were told their virginity was a virtue and to keep themselves

for their husbands, as the Bible required. Those who did the nasty and got pregnant took a trip down south. Out-of-wedlock birth was taboo back in the day and often led to disrupted families and the welfare trap.

Strong values were the cornerstone of our cultural foundation back in the day. As a result, 70% of the Black families during my youth included two parents who were not only married but saw their primary responsibility being to 'raise' their children. A mother shouldered the responsibility of providing morals and maturation. A father's purpose was to take his children further than the preceding generation.

We were taught to navigate through apartheid, embrace and love our Blackness, and aspire to greatness despite bigotry.

Maybe it was because our ancestors fought against injustice in every form and were on a mission to improve their children's lives that we felt an obligation to them.

My mother joined with others in chaining themselves to bulldozers when the public (government) school system denied admission to Black students at a new northwest school. My parents, George and Sideena Holt, attended civil rights meetings. They did whatever was necessary to ensure our path to success was less burdensome than the generation before. We were shielded against apartheid with cultural and spiritual body armor.

Poor families always had something more important to do than protest or vote, like watch soap operas or spy on a wayward Neckbone

And their caustic and self-denigrating behavior was replicated by their 'Chillins,' who embraced their apathy and disregard with a passion that defied logic. 'Po families knew their neighbors. They were considered extended

'Po children were taught to respect their elders---any adult---and it

wasn't unusual to be disciplined by a village 'parent.' Poor mothers would fight a neighbor who attempted to correct the actions of a wayward child.

Trapped by the limitations of welfare, many poor families were transient; they didn't know their neighbors because they were generally

moving every other month to avoid rent collection. In some cases, they would leave a flat in disrepair ('ghettoized'). convincing White property owners to stereotype poor Black folks and to put less effort into maintaining the property.

The most glaring example of the difference between Po and Poor





approached in San Antonio by people pretending to offer humanitarian assistance. They were promised that jobs, housing, and other assistance were waiting for them if they were willing to get on a plane.

None of it was true. These vulnerable people were reportedly told lies about where they were going and given brochures with false information about help that would be waiting for them. Even worse, they may have unknowingly threatened their asylum claims by making it likely that they would miss court appointments scheduled far from where they

had been flown.

DeSantis and his henchmen hadn't contacted government officials or nonprofit organizations in Massachusetts. It was a photo op. It was definitely political. And it was possibly illegal. The sheriff in Bexar County, Texas, has opened a criminal investigation into the false pretenses under which people were lured onto the planes. A lawsuit has been filed on the migrants' behalf.

White House Press Secretary Karine Jean-Pierre slammed DeSantis for "alerting Fox

News and not city or state officials about a plan to abandon children fleeing communism," calling it "a cruel, premeditated political stunt."

Of course, it's not the first time that dishonorable politicians exploited vulnerable people. In fact, racist white southerners who were resisting segregation in the early 1960s did almost

the same thing to Black Americans 60 The Washington Post recently highlighted that history. A group of segregationists organ-

ized "Reverse Freedom Rides" in 1962 as retaliation for the Freedom Rides that carried civil rights activists throughout the South in 1961. According to the Post, "The plot was organized by white supremacist Citizens' Councils in Arkansas, who bought radio ads and made fliers advertising the 'opportunity' to African Americans." One Arkansas woman and nine of her children were dropped off on Cape Cod near the Kennedy family's compound because she had been falsely told that Kennedy was going to greet them. Sounds awfully familiar, doesn't it?

Last year, journalist Adam Serwer published

Democratic Gov. Gavin Newsom has stopped short of doing so, denouncing the racist language and saying he was "encouraged that those involved have apologized and begun to take responsibility for their actions." Democratic state Sen. Steven Bradford, who represents parts of Los Angeles County, said Newsom should call for the resignation of the three councilmembers.

"Every ethnic caucus in the Legislature has called for the resignations, so I would hope that the governor would ... ask for the resignation as well," Bradford said.

Councilmember Mitch O'Farrell, serving as acting president of the Council, said the city cannot heal if the three remain in office. He called it a "clear abuse of power" that was "profoundly unacceptable" of elected officials.

"Public opinion has rendered a verdict and the verdict is they all must resign," he said.

deputies and officers from agencies from around the state patrol the highways in Spartanburg County. Spartanburg County Sheriff's Lt. Kevin Bobo, an agency spokes-

person, said deputies need more information from the school, such as where the stop took place or the tag number of the bus, to fully investigate the school's complaint. About 900 traffic stops were made during the operation in Spar-

tanburg County, he said. Statistics from the sheriff's office show 39% of the drivers pulled over were white, while 38% were Black. Deputies said 233 of the stops were for improper lane change. The traffic stop follows a situation this year in which the president of Delaware State University, another historically Black college, ac-

cused sheriff's deputies in Georgia of intimidating and humiliating the school women's lacrosse team when they pulled over the athletes' bus and searched it for drugs. President Tony Allen said he was "incensed" by the April 20 traf-

fic stop along Interstate 95 south of Savannah as the team returned from a game in Florida. In a letter to students and faculty, Allen said nothing illegal was found.

Liberty County Sheriff William Bowman, who is Black, said in May that his office was conducting a formal review of the traffic stop. Deputies had stopped other commercial vehicles the same morning along I-95 and found drugs on a different bus, he said. The team's chartered bus was stopped because it was traveling in the left lane, a violation of Georgia law, he said. The sheriff said deputies decided to search the team's bus when a drug-sniffing dog "alerted" alongside it.

No one was arrested or charged. The sheriff said the bus driver was given a warning.
