The Milwaukee Common Council reently approved \$10.7 million in City of Milwaukee Housing Trust Fund (HTF) allocations for 14 projects that will construct new homes for those in need, create and foster thousands of construction jobs, rehabilitate existing housing stock that has fallen into disrepair, and provide much needed homebuyer counseling services.

The projects will leverage an investment of more than \$324 million in local construction and rehabilitation work over the next year, said Alderman Michael J. Murphy, chair of the HTF Advisory Board, which recommends the projects to be funded each year.

"Today is a special day as we have approved more than \$10 million worth of funding for affordable housing projects across the entire city.

"Not only will these dollars create permanent af-

fordable housing for our residents, but thousands of jobs will be created in the process," said Alderman Murphy.

"I want to thank my colleagues both for the initial allocation of funds to the Housing Trust Fund and supporting these 14 projects today, as well as the citizen-led review board for thoroughly and thoughtfully reviewing the applications received and making critical recommendations."

Alderman Murphy said one of the top 2023 projects would fund 93 apartments proposed by General Capital, as part of the mixed-use construction of a new MLK Library development at N. MLK Dr. and W. Locust), creating much-needed low-income apartment homes.

"This transformative project - along with the other selected projects - will help provide critical housing in Milwaukee to individuals who need it most," Alderman Murphy said.

The projects were recommended for approval by the Zoning, Neighborhoods and Development Committee during a special meeting prior to today's (continued on page 4)

Children's book again rejected by 'Tosa Library, Shon Lewis author claims **bias towards African American culture!**

For the second time in over a year, the Wauwatosa Library (WPL) Board rejected adding a book by a Black Milwaukee children's book author to its collection of books for children focusing on their developmental skills, mental health and diversity.

The library board claimed the book 'Coco's Courage: Meeting the Dentist,' written by Shon Lewis, was rejected again because it didn't adhere to their collection policy.

The book was originally rejected by the Wauwatosa library in May of 2021 because of "editing issues" according to WPL Children's Librarian Anne Kissinger.

Lewis claims the library was discriminating against African American culture, noting the book's subject matter was also questioned.

In a statement by Lewis to the MCJ, the author believes the library 'suspiciously' changed their book collection policy "to make it more difficult for Black and Brown books and faith-based books to be added to their library collection."

This past October, Lewis attended a Wauwatosa Library board meeting with a freshly edited hardcover version of her book. It was at that time she asked that the book be considered for use in improving developmental skills, mental health, and diversity.

Lewis was accompanied by a representative from the local NAACP.

MICAH (Milwaukee Innercity Congregations Allied for Hope), and two family members, who made statements during the meeting advocating for the revised book and its addition to the WPL collection.

That same month, the author said her Equal Employment Opportunity Commission (EEOC) appeal of discrimination was denied by that organization because the case was outside its jurisdiction, that it was a matter for the state of Wisconsin and/or federal government.

The library and Wauwatosa's city attorney denied it acted in a

discriminatory manner when the book was first rejected.

This time, Peter Loeffel, the director of the WPL, and City Attorney Hanna Kolberg-when asked by Lewis what in their policy justified a second rejection—would only refer her to a link to their policy.

According to the WPL's 'Collection Development Policy,' a book must meet these five criteria:

• The selectors must consider each type of material in terms of its own merits and the audience for whom it is intended.

No single standard can apply to all acquisition decisions. Some material may be selected primarily for artistic merit or scholarship, while others may be

chosen to satisfy the recreational and entertainment needs for the community.

• To build a collection of merit and significance, selectors acquire materials according to objective guidelines.

They evaluate acquisitions, whether purchased or donated to the library, primarily by examining reviews in one or more of the professional library review media and checking against the criteria listed below.

 WPL uses a website and social media in order to meet the information needs of patrons.

Professional librarians use the general criteria outlined in this

policy when linking to external content. • WPL is a member of the Milwaukee County Federated Library System and, as such, provides ac-

cess to materials from other libraries to our patrons. · Selectors will consider the availability of material at other local and regional libraries when making selection decisions.

Senator Baldwin Joins More Than 70 Total Signers in the Senate and House Urging Biden to Take Executive Action on Paid Sick Days for Rail Workers

WASHINGTON, D.C. – U.S. Senator Tammy Baldwin (D-WI) joined Senator Bernie Sanders (I-VT) on Friday on a letter with more than 70 total signers in the House and Senate urging President Biden to take executive action to guarantee rail workers paid sick days.

"While this agreement was much better than the disastrous proposals put forward by the rail industry, it still does not guarantee a single paid sick day to

rail workers who work dangerous and difficult jobs, have risked their lives during the pandemic to keep our economy moving and have not received a pay raise in over three years," the members wrote. "That is unacceptable and must be rectified."

The letter comes just a week after Congress passed legislation to avert a nationwide rail strike but failed to pass an amendment to guarantee paid sick days to rail workers.

The amendment, which passed the House but

Guaranteeing seven paid sick days to rail workers would cost the rail industry a grand total of \$321 million a year – less than 2% of its profits. Last year alone, the rail ndustry made a record-breaking \$20

billion in profits after cutting their workforce by 30% over the last 6 years. In the first three quarters of 2022, rail companies spent \$25.5 billion on stock buybacks and dividends. Rail workers across the U.S. currently are guaranteed

"The Housing Trust Fund has made a significant difference for Milwaukee families and neighborhoods, by making supportive housing, homeownership and rental housing more affordable for people who want to live here," Alderman Murphy said.

"I want to thank the city staff involved in handling and evaluating the proposals, as well as the members of the advisory board for their dedication and thoughtful deliberation."

Alderman Murphy said the selection process was made possible by a significant \$10 million investment in the HTF by the Common Council and Mayor Johnson, and the process was again driven by valuable input provided by residents and community groups.

The alderman said the 14 projects selected by the advisory board for funding would also create jobs and valuable opportunities for construction workers, carpenters, and those in the trades.

"The Housing Trust Fund Advisory Board takes its work very seriously and is cognizant that the projects selected are healthy investments for Milwaukee that bring critical economic activity and dollars into local businesses and into the lives of workers and their families," Alderman Murphy said.

Alderman Robert J. Bauman, a member of the Housing Trust Fund Advisory Board and a longtime advocate for affordable housing, said the projects approved today "represent the affordable housing investment and commitment that is needed each year across Milwaukee."

"This investment of \$10 million this year is part of the largest investment of city funds in affordable housing in the city's history, and I am so very pleased to see it," he said.

Alderwoman JoCasta Zamarripa, also a longtime affordable housing proponent, said

the creation of new affordable, supportive housing is critical in Milwaukee.

"On the near south side, in my district, and across our city, the need (for supportive, affordable housing) is great, and these Housing Trust Fund projects provide great help at the margins, where families and others can access secure and vital housing they can afford," she said.

This year, requestors proposed projects seeking nearly \$28 million in HTF funding. Of these recommendations, 14 were selected to receive funding.

The approved HTF awards include:

• \$1.5 million to General Capital – MLK Library, N. MLK Dr. and W. Locust St. – serving low-income renters. Amount leveraged - \$30.7 million. Estimated total project cost - \$32.2 million. New construction of apartments, with 93 housing units.

• \$1.25 million to Milwaukee Habitat for Humanity (owner-occupied, rehabbed structures/scattered site) – very low-income homeowners. Estimated total project cost - \$1.25 million.

Housing Trust Fund projects approved/ADD TWO

• \$1.25 million to Revitalize Milwaukee (owner-occupied, rehabbed structures/scattered site) – very low-income homeowners. Estimated total project cost - \$1.25 million. Rehab of existing homes.

I was working on a review of Patti Labelle's long-awaited Milwaukee show in my mind even as I was driving to the Riverside Theater Saturday night.

I had only seen 'Princess Patti' in person once before, two decades ago. The theme park was closed to the public, and the assembled media had its choice of three stage performances to attend at the conclusion of the celebration.

I don't know who the other performers were---country western and rock—but I vividly recalled that all African Americans (and other folks with good taste) were assembled within a stone's throw of the Patti stage.

We were greeted with one of the best performances of my long life.

In fact, one recollection that has transcended time was her hitting a note at the conclusion of a song, leaving the stage with the microphone in hand, continuing to hold that note as she changed clothes, shoes, drank a soda, and finished writing her recipe for sweet potato pie. She then returned to the stage as if nothing had happened.

Phenomenal doesn't fully describe it.

That night the sexy songstress hit notes that shook my ancestors in Sierra Leone and Kemet.

Patti's range, stage gyrations, and emotive interpretations put her in a class all by herself.

So, take that reminiscence as my Saturday review because, as you probably heard, Patti's show was terminated after three short songs because some forked-tongued fool called in a fictitious bomb threat.

Excuse my French, but damn!

One of the greatest singers of our time, defying time and evolving (or maybe that should be 'de-evolving') musical tastes, the 78 (couldn't convince any who saw her dancing across the stage with a dip in her hip and glide in her stride of her age), it was apparent Patti had lost nothing over the years.

Speaking of loss, I would have no problem if one of the pyramids built by the pharaohs fell down on the scum bag who called in the threat.

People traveled from Illinois and Indiana for the show which—we assumed—may be her last performance in the Midwest.

I had planned on attending since first hearing of the show last summer. And then some fool—bastard, turd, punk, or punkette—destroyed it for all of us.

Or should we be glad it was a false alarm? Or appreciative that the thug or 'thugette' opened our eyes to a new reality: that we are not safe

"We're Not Safe Anywhere Anymore!"

anywhere these days.

I mistakenly assumed there were some places we could still go to without fear of some young terrorist or gangsta wanna-be putting those of us who opened doors and fought for their freedom putting our lives in jeopardy.

And that's of particular interest to us seniors and elders.

Hey, first they took away our 'watering places' (bars)—even jazz venues and old-school joints---by shooting-up respectable establishments or, in confrontations, outside the clubs.

For that reason, most seniors and wise middle-aged folks stopped going to 'bars.'

And then these gangstas and thugs ('thugettes') showed up at schools, Bucks games, and even churches ('churches' for cryin'-out-loud!).

And now concerts that draw folk of my era. We're not talking about gangsta rap by the likes of 'Two Quarters,' or 'Snoop Doggy Dud,' but old-school R&B.

Isn't any old-school R&B event sacred anymore?

Has this city, which is losing residents as we break homicide records yearly, gone the way of East St. Louis or (parish the thought) Gary?

That was a rhetorical question because you know the answer. We've become Syria, Ukraine, or Burleigh Street after 10 p.m.

The last few years have witnessed a cultural transformation in America. Unfortunately, not for the better.

The COVID-19 pandemic played a role in this new negative social paradigm.

But you can't put all of the blame on the anxiety and depression that grew from that poisonous tree—or 'weed.'

In fact, you can place some of the blame on weed...and cocaine... and alcohol. Sugar and lead (as in lead paint and lead-lined water pipes) also contribute.

Add to those chemicals stress from unemployment, deterioration of values and mores, and even partisan politics.

And, as was noted on these pages recently, the abysmal state of education locks a generation out of the success equation and fuels dysfunctional families. It steers many of our tribe into the 'Culture of Poverty.' You have a diagnosis (as the television title) for murder.

Put some blame on the media, or at least social media.

The murder rate in Milwaukee is at an all-time high. One of the latest

sensationalistic murders was committed by an impressionable 10-yearold boy who killed his mother over a video game.

The end result is a community where no one feels safe, as terrorism, stupidity, and PTSD run rampant.

There are no more innocent bystanders, only collateral damage.

I do 96% of my grocery shopping at Pick n' Save because that store is the only local grocery that markets to the Black community. The others have intentionally built outside the community, almost as if they are afraid of Black people or don't want us to utilize their facilities for fear we bring herpes or COVID-19 to their establishments.

Recently, however, I took my mother-in-law to Woodman's because that 'employee-owned' establishment carries a more extensive assortment of greens.

I was shocked to be greeted at the store just south of Brown Deer by armed guards. Vested and in black.

They rotated from what appeared to be an armored vehicle. What message is the grocery owners sending?

I almost expect guards and security since there have been reports of chickens being freed and running north to freedom. But those men in black fatigues, armed and wearing vests, were not hunters.

A couple of weeks ago, I went to the Menomonee Falls Marcus Theater (on senior day---can't afford it otherwise). Again, armed security. Does the movie chain have armed guards at its other suburban theaters? That, too, is a rhetorical question.)

Public schools have metal detectors. Malls have machine gun towers, and Black Wauwatosa cops who will shoot you down.

I know of several large Black churches where the ushers carry more than bibles.

Pretty soon, even the police will have armed security.

Let's face it: this is the new norm.

So, I shouldn't have been shocked that there was a bomb threat at a Patti LaBelle concert.

In fact, even though I stood outside with hundreds of fans hoping against hope the police, who had blocked off Wisconsin Avenue, would announce it was safe to return, allowing us to partake of one of the few venues left to Black seniors. I should have remembered one of her top ten songs: 'I gotta new attitude." Yeah, we hard working, law abiding, tax paying citizens (and seniors) gotta get one too. **Hotep.**

through City Hall since at least 2015.

The problem, fueled by out-of-reach housing costs caused in part by flipping and speculating and by absentee real estate investors, is bigger than L.A. Squalid encampments can be found from the U.S.-Mexico border north to Sacramento and in every other big city across America.

But Bass, at least, has quickly zeroed in on new housing.

"We know our mission," Bass said. "We must build housing in every neighborhood."

On Sunday, she became the first woman to lead the city and the second Black American, after the 20-year tenure of Tom Bradley in the 1970s, '80s and '90s, to do so.

In November, she beat developer Rick Caruso, known for his successful shopping centers, including the ultrapopular Grove, and his impeccable suits, in a runoff to replace outgoing Democrat Eric Garcetti. Caruso is a former Republican in a heavily Democratic and labor-friendly city. He spent \$100 million of his own money on the run.

Bass, 69, spoke of shared vision Sunday.

"If we come together and focus on solutions rather than jurisdiction and on linking arms rather than pointing fingers, we will save lives in our city," she said in a video address after her inauguration.

"That is my mission as your mayor," she said.

Garcetti, a white man with Mexican, Italian and Jewish heritage, tried to please the city's important interest groups, which include Hollywood, homeowners associations and organizations that represent L.A.'s impossibly vast ethnic enclaves.

Bass is promising a new day and inspiring L.A.'s guardians to forget about the bickering, at least for a moment.

"In our city's 241-year history, we've never witnessed a day like today as Los Angeles came together to celebrate the swearing in of Mayor Karen Bass," Mark Gonzalez, the chair of the Los Angeles County Democratic Party, said in a statement.

Amanda Gorman, the country's first National Youth Poet Laureate, explained the moment during Sunday's ceremony and celebration.

"Where there's will, there's women," she said. "And where there's women, there's forever a way."

Though he admits he did not prevail at the ballot box, Rogers said he remains convinced that his campaign brought needed attention to the issues confronting the disrict and the nation, such as energy indpendence, universal school choice, criminal justice re-



form, clean drinking water and lower (and fair) taxes.

Bass is tasked with patching fissures in the social contract in a city rocked by racist remarks uttered by a few City Council members and witnessed by a labor leader in a secret recording revealed in October. All have resigned except Kevin De León who, under pressure to vacate his seat, got into a physical confrontation with an activist Thursday that is now under police investigation.

The city's homelessness crisis, both an incubator for street crime and a corollary to skyrocketing housing costs, touches almost every facet of life in L.A., even when it's just a backdrop.

Bass vowed Sunday to attack it head-on by declaring a citywide state of emergency, an idea that had been circulating

in an interview.
