Kwanzaa was created by Dr. Maulana Karenga, a professor of Black Studies, in 1966 during the time of profound social change for African Americans,

Karenga's vision of a celebration that would honor the values of African cultures and inspire African Americans who were working for/towards progress.

The celebration honors African culture in the diaspora and is observed from December 26 to January 1.

Each of the seven days observed for Kwanzaa is a mark of distinction of a different life principle. The Nguzo Saba, are principles that are believed to be the foundation of building resilient, prolific families and communities on the continent of Africa as well as in the Diaspora.

The Nguzo Saba are principles of Kwanzaa comes from the native language Swahili of the Bantu people in East Africa. During the observed time of Kwanzaa, celebrants greet each other using the Swahili

Christmas is less than a week away and I felt inclined to talk a little about other ways of celebrating this season. Traditions are cultural and can be adapted from anyone at any time, whether it is due to marriage or a blended family, knowing how others celebrate holidays can be a great learning experience.

Hanukkah is celebrated from December 18th – December 26th this year. Hanukkah which is Hebrew for "dedication" is the festival of lights. I'm going to share some information about this holiday and how it's celebrated.

The festival is observed by lighting the candles of a candelabrum with 9 branches called the menorah. Each night a candle is lit by the shammash (the ninth candle) until all eight candles are lit together on the last night of the festival.

Black Milwaukee MUST enlist in the war to win the last civil rights battle: EDUCATION!

The state of MKE education during and after the pandemic

The response to our series on the impact of the COVID-19 pandemic on Black Milwaukee students ran the gamut from shock to frustration to anger.

A retired African American educator said she shed tears upon learning our students were on the short end of the widest academic achievement gap in the country.

But anger and tears will do nothing to change the appalling status quo.

Unless you use those tears for motivation and your frustration turns into action, you may witness the painful and unnecessary transition from what was once a mecca for African American migrants to an urban desert.

Even the most optimistic pundit interviewed for our series could not visualize a sanguine future for Black students. Or our city.

Instead, the common assumption is we are witnessing the loss of another generation of innocent Black children. And with the handicap of illiteracy will come poverty, despair, poor health, and criminality in far too many cases.

This is not to say they were born with that handicap or are genetically predisposed to immortality. Instead, they are products of their environment, including being trapped in the Culture of Poverty and caught up in the paradigm of educational apartheid.

Moreover, don't make the mistake of blaming the current malaise --- the nation's worse academic performance---on

The pandemic only marginally worsened what was an abysmal reality for most Black students three years ago.

Before the pandemic, Black student performance was among the worst in the country. Only one in 10 could read at grade level, which was to be expected since we've had the lowest reading proficiency rates for African American fourth and eighth graders in the country since 2010.

Worse still, little to nothing has been done to remedy that affront.

The pandemic exacerbated existing negative paradigms

The Milwaukee School Board's decision to continue virtual learning protocols long after other local and suburban schools ended theirs, played a role in that paradigm.

As did various negative social indicators, which combined to earn Milwaukee the reputation as the worst city for Black Americans.

Our nation-leading poverty rate played a critical role. While many Black middle-class and specialty school students could adapt to virtual paradigms, their low-income

Other festival activities include spinning the "Dreidel" which is a four-sided spinning top, and each side is imprinted with a Hebrew letter, and it is used to play in children's games.

Holidays are defined by their food and Hanukkah is no different. Hanukkah is enjoyed by feasting on oil-based foods like latkes (potato pancake or fritter), sufganiyot (a round jelly donut) and dairy products. Check with your local grocer or specialty store to locate these delicious

The festival also includes Hanukkah Gelt (foil wrapped chocolate coins) that is used for the dreidel game winnings and can also be given as gifts. Music is also a staple like most holidays and its tradition is to sing a song after the nightly lighting of the candles.

I hope this helps you understand Hanukkah a little more and like always share this information with your family, so they can be aware or our differences, so we can embrace and respect other holiday traditions. Hunger persists in Wisconsin. Throughout the pandemic, a good deal of federal financial assistance streamed to states and communities to address the pandemic's impact on unemployment, supply chain interruptions and inflation.

Free food provided by charities won't solve lasting hunger. Hunger Task Force has distributed tens of millions of pounds of food each year since the start of the pandemic, yet the problem of hunger across Wisconsin persists.

Ending hunger in Wisconsin, a state that produces far more food than its citizenry can consume, shouldn't be that difficult. Still, in Milwaukee the incidence of poverty is 18.3%, and where there is poverty, hunger follows.

This is not just a Milwaukee problem. From far north in Ashland County where the poverty rate is 16.1%, or Grant County in the southwest where 15.1% of folks live in poverty, hunger affects every region of our state: urban, rural and remote.

There is an existing solution that can feed people today, tomorrow and next year. The solution is called the Supplemental Nutrition Assistance Program, or SNAP. SNAP provides low-income households struggling to make ends meet with food buying power each month until they are back on their feet. This 100% federally funded program has been around for decades—we used to call it "Food Stamps."

In Wisconsin, SNAP is called FoodShare. FoodShare has been criticized in the past as creating dependency. People who got FoodShare were suspected of drug use and work avoidance. But when the pandemic hit and record numbers of Wisconsinites lost their jobs, they turned to FoodShare to get help with food. Suddenly almost everyone knew someone who needed Food-Share—a brother, a friend, a co-worker.

FoodShare not only fed people during the pandemic, but it stimulated our agricultural and food producing economy. Farmers, food producers, grocery store workers and truck drivers became essential workers and people buying food helped them to continue working. FoodShare also has an economic multiplying effect. Did you know that every dollar in FoodShare spent multiplies to between \$1.22 and \$1.50, and over 95% of benefits are redeemed at stores

and markets? FoodShare creates jobs and supports the local food economy. It's time to re-think how people with limited cash reserves put food on the table and the impact this program has on our local economy. The time to act is now. Let's fully enroll the FoodShare program and end the stress of being hungry in the Dairy State.

The Seven Symbols of Kwanzaa: KIKOMBE CHA UMOJA

Meaning: the unity cup

Action: Celebrants drink from this cup in honor of their African ancestors.

KINARA

Meaning: the candleholder, which holds seven candles





counterparts were hindered by their economic plight, including access to computers and internet services.

Like health disparities and economic woes, the pandemic brought these academic realities to light---again. Indeed, educational apartheid has been a part of the local landscape for records.

So has political, cultural, and economic apathy.

As the series pointed out, Milwaukee now hosts the broadest academic achievement gap in the entire United States of America. The 'majority' of Milwaukee schools failed to meet state expectations, as the graduation rate dropped below 70%.

Less than 20% of Black children can read at grade level (rated as proficient), and math scores are second to last in the nation, only behind Detroit.

When the embarrassing reading status first came to light, a coalition created by former MPS Superintendent Howard Fuller responded with a unique and comprehensive reading project that remarkably improved

reading scores by one full grade during a summer of intensive tutoring. But two years later, the program died when funding dried up, and no government agency, including the public school system or the state, was willing to step up to the plate.

That was as close to a remedy to reversing our reading dilemma and thus closing the academic achievement gap as we've witnessed.

You can count on one hand the number of proposals to emerge from various governmental agencies since then. None, however, have seen the light of day.

The rationale for dismissing the proposals is as alarming as their rejection, marred in partisan bickering and union politicking.

Thus, it should not have come as a surprise when a state Republican plan to allow a local government agency to take over up to three failing schools was ostracized. It's proponents were labeled 'racists and traitors to public education.'

The absurdity of that assertion rests with the applicant being former Milwaukee County Executive Chris Abele, who enlisted the assistance of nationally regarded African American school superintendent Demond Means.

So vicious were the attacks by the teachers union and former MPS Superintendent Darienne Driver, that Means, who many felt would someday take on the challenge of MPS, literally left town. (Driver later apologized, reportedly suggesting she was 'forced' to undermine the proposal.)

And the wrap-around services that Abele brought to the table went unused, even though they would have positively impacted low-income families and students.

Making matters worse, Democrats offered nothing to replace it. Instead, DPI (state Department of Public Instruction) changed the criteria for a 'failing school!'

In other words, the schools were still underachieving, and the students continued to fail. But on paper, their plight was obscured by red

stacles or diversions, the most obvious being MPS Board Director Aisha Carr's innovative proposal to undertake a feasibility study of existing and new proposals to close the achievement gap.

Her proposal included a parent engagement project, isolating a day of the week for planning and analysis, and a renewed focus on mental health. The fifth day would also be used for career programs, tutoring, or college courses.

A board committee disingenuously rejected her proposal.

A state reading proposal that drew bi-partisan support and would focus on children handicapped by their inability to read at grade level, was rejected by the governor, who said his veto was because of a lack of appropriate funding for the proposal.

That 'excuse' flies in the face of logic, given the state is sitting on millions in unused federal stimulus funds and an additional \$6 billion in surplus revenues.

If there is one message you don't need a diploma to understand, it's that neither the educracy nor politicians are able or willing to provide our low-income children with the quality education they deserve; that other children automatically receive based on family income or color. That may be why the failing status quo has not raised an eyebrow

beyond the politically impotent Black community. That reality must change, which is fundamentality the reason for the

The series caught the attention of the state NAACP and several key

Black officials who are bringing voice to this problem. NAACP state president Wendell Harris has gone so far as to discuss

He is also lobbying to replicate the successful reading programs im-

plemented in Mississippi or the personalized student paradigm used in several charters and the Brown Deer School District (the only district in the entire state not hampered by a Black/White achievement

A recently formed organization of Black activists and North Division high school alums called 'Call to Action,' are exploring the possibility

of fundamental changes at that once respected school.

If successful (which means it will not be dismissed or corrupted by the educracy), it could provide a template for an educational rev-

Nearly 40,000 students are today enrolled in private (public) schools under the school choice program and charters. Another 6,000 have abandoned MPS for suburban districts under open enrollment. Collectively, they make up nearly 47% of local students. An educrat

In the interim, Black families are fleeing MPS by the thousands.

with a vested interest in MPS surviving as is, once posited, the district can only sustain itself with a minimum of 50% of the local student population. Both time and students are running short.

Respected researcher and Marquette University Fellow Alan Borsuk speculated that Milwaukee would suffer the consequences if the educational exodus continues down this track. Milwaukee is the state's economic engine. Without a workforce and a strong economy, the entire state will suffer.

If the loss of thousands of Black children who have been allowed to slip through the cracks is not enough to move the community, the loss of our state's economic engine may be motivation.

Mask it, ignore it, or put your head in the sand, but unless we address this concern, we are not only dooming a large segment of our community to second-class citizenship, but also our city.

As we have long said, education is the last battleground of the civil rights movement. Previous generations fought for our children to sit at the lunch counter. It is now this generation's turn to make sure they

The Community Journal is open to assuming whatever role necessary to arm, coordinate, and strategize on a battle plan. But without your help, it's a war we cannot win.

To lose this battle is to return to the era that sparked the desegregation lawsuit and a legislative proposal to carve out an autonomous and independent Black school district.

mean much to me, as I don't belong to a political party (like 92% of emancipated Black Americans), as I have long accepted the old adage of 'no permanent friends, no permanent enemies, just permanent issues. '

From that perspective, I've found conservative Republicans who have fought harder for Black children than ultra-liberals. And so-called liberals who are hypocrites of the first class.

Let us never forget it was a Democrat who blocked the schoolhouse door. And I'm not talking about late Alabama governor George Wallace. It was a racist Republican president who gave us affirmative action and a minority business enterprise pro-

Auntie Alberta opened my eyes to that dichotomy.

If memory serves me correctly, our last conversation was held at TMJ'4's studio following a taping of Sunday Insight.

Calls grow for DOJ to charge Trump as Jan. 6 committee releases report findings

"The Justice Department needs to step up and do what they're supposed to do," Capitol Police Officer Harry Dunn tells the Grio.





The Select Committee to Investigate the January 6th Attack on the United States is slated to release its final report to the public today.

The release comes just days after the committee recommended that the Department of Justice file criminal charges against former President Donald Trump, conservative lawyer John Eastman and other top officials.

On Monday, committee member U.S. Rep. Jamie Raskin, D-Md., revealed the proposed charges against the former president during the committee's final hearing. The charges include obstruction of an official proceeding, conspiracy to defraud the United States, conspiracy to make a false statement and "incite," "assist" or "aid or comfort" an insurrection.

U.S. Capitol Officer Harry Dunn, who stood guard outside of House Speaker Nancy Pelosi's office during the attack, told theGrio, "There's no way they could have followed the facts, as they stated, and not come to this conclusion" of suggesting criminal charges.

He continued, "I consider this a

After the final hearing on Monday, Michael Fanone, the former D.C. Metropolitan police officer who suffered a heart attack while defending the U.S. Capitol, told reporters that the committee, "did a good job assembling the facts in a way that is palatable for less educated people like myself." However, he noted that the committee's "criminal referrals are just a piece of paper."

During the hearing, U.S. Zoe Lofgren, D-Calif., said Trump not only violated several laws during the insurrection but he also infringed on the law when he took part in orchestrating the deadly attack in the weeks leading up to it.

On Jan. 6, 2021, Trump provoked his followers to storm the U.S. Capitol in an attempt to stop Congress from certifying then-President-Elect Joe Biden's victory.

Outgoing Republican Congresswoman Liz Cheney of Wyoming said, "Americans [were] persuaded by President Trump that the 2020 election was stolen by overwhelming fraud. We also knew this was false ... our president would not accept the outcome ... for hours he would not issue a public statement instructing his supporters to disperse or leave."

She continued, "During this time, law enforcement agents were attacked and seriously injured....this was an utter moral failure and a clear dereliction of duty."

Despite the violent attack on the legislative branch of the U.S. government, the officers who risked their lives to stop it have been lauded as heroes. Committee

Thompson, D-Miss., said, "Capitol Police, the Metropolitan Police and all the other law enforcement officers who fought to defend us that day saved lives and our democracy."

Dunn told the Grio, "It's still triggering for me. I still work in the Capitol, where the crime scene was. I work protecting the people some of whom downplay what we went through."

He continued, "It's difficult to deal with, but I got to keep on going. One thing that has helped me through is I've been able to reshape my narrative and my thought process about what happened, and what my job and what my position is, and why I'm in this moment. I have to look at the bigger picture."

Fanone told reporters that he isn't going to stop speaking up until there is "accountability for Jan. 6." He clarified, "not political accountability, [but] criminal accountability. Donald Trump needs to be in prison. His allies who orchestrated and participated in this coup need to be in prison." Activist April Reign told the Grio

that it's "unfortunate that it's taken so long, but I understand the wheels of justice turn slowly, but somebody needs to find the tin man's oil can and speed things up a little bit." Officer Dunn told the Grio that he

hopes the DOJ will file criminal charges against Trump.

"I can't look at the evidence of what happened and fathom or reasonably understand how [the Department of Justice] could not" file charges against the former president, he said.

The ball is now in the DOJ's court to decide whether justice will be served for the deadly tragedy that took place nearly two years

learn to bite your lip, pinch your nose or do the Ali 'rope-a- dope.'

Frequently, you must see beyond the political weeds and forget the motivation when a bill or program benefits us.

The tenure of Aunty Alberta is a testament to that strategy.

Obviously, she sponsored and supported dozens of bills most of us opposed, including what I call 'Old Testament legislation' that defined marriage, sexual orientation, and antiquated values and 'mores' more readily accepted when we used to hold open doors for women and stopped for funeral processions.

But the scales were balanced by her support of educational initiatives that revealed and opened cracks in the walls of educational apartheid. Alberta's work in that arena earned my respect.

Indeed, many of her bills, starting with her support and strengthening of school choice and charter legislation, generated accolades from progressives and Black Democrats like the late Polly Williams, who put her people before the party.

In fact, there is substance to the argument that had it not been for Auntie Al, Milwaukee would not be seen as the educational genesis it is today.

Most recently, Darling has come under attack for a bill that would break up MPS and another to provide additional testing and programs for students at risk of failing basic reading paradigms.

The latter bill was supported by the only African American Democrat

on the state education committee and critical members of the NAACP, a fact that gets to the heart of my argument.

I can understand the opposition to the former bill, even though it didn't get the same reaction when proposed by a Democrat or when Tom Barrett talked about a mayoral takeover.

When introduced by Darling, it was called racist by MPS board members.

The same ones who voted themselves an unprecedented raise even though the government school system hosts the broadest academic achievement gap this side of Cuba.

Darling was likewise cast with horns and a tail by the Shepherd Express, that beacon of liberal White Supremacy.

The fact that the Darling bill was in reaction to revelations that Black Milwaukee students have the lowest 4th and 8th-grade reading proficiency rates in the United States was somehow ignored.

You have to ask yourself what the educracy is afraid of? Truth? Does it set you free? The answer is no if the respondent is a Republican.

A defining bill by Aunt Alberta that would allow a local 'government' official to take over a failing school earned her a nomination for the Villainy Oscar Award.

Black Democrats, community leaders, and parents who supported the measure were traitors or escaped slaves caught without travel passes.

The Shepherd, published by a former Democratic Party state law-maker who views anyone outside the party, including Black independents, as spawns of 'Satan Claus,' referred to the bill as advancing 'privatization,' another catch-all phrase used to imply the penultimate evil---taking bricks out of the apartheid wall.

(I think allowing and ignoring Black educational failure is racist, but

The Shepherd, whose mission is to confuse and convince Black slaves that we will receive justice in the next life, has never questioned why so many Black children are failing in the government school system and who is responsible.

The editors (none of whom are Black, by-the-way) will blame 'poverty,' which is often an excuse for low expectations.

That's why they feed our children chitterlings while their children eat high-on-the hog.

Part of that agenda is to 'castigate' any rebellious slave, whether it be Polly, Howard Fuller, and Marvin Pratt among them- while simultaneously dictating who our leaders are and what agenda we should follow.

It's all a game. Unfortunately, while we're playing checkers, they are playing chess. And we (the community and Black parents and children) are the pawns.

None of this is to say I embrace the Republican platform or that Al-

berta Darling deserves the NAACP's Freedom Award (although if you turned the clock back 50 years ago, she would qualify).

But it does mean too many of us have been brainwashed into believ-

ing it is better to be shipwrecked by a Democratic or liberal captain than being given a leaky lifeboat from the GOP shipyard.

The bottom line is most White folks, regardless of political party or

economic status, think Jesus looks like Jeffrey Hunter. We know, however, He looked more like Idris Elba.

The question is if you closed your eyes, would the gospel be interpreted differently if it was channeled through thin or thick lips?
