Holiday returns aren't easy! And we don't mean the part where you explain to your mother why you returned the sweater she gave you.

Stores are not legally required to accept exchanges or give refunds, unless the merchandise was defective or misrepresented. While most retailers do offer refund and exchange programs, policies vary greatly from one store to another. Be sure to double-check policies this holiday season, even if you are familiar with the brand, as stores can change their policies whenever they want.

The following tips should help to make your holiday returns run more smoothly.

Get to know store policies. Before you make a purchase, find out if the store has a return policy and, if so, how it works. Understand that many retailers change their policies for the holiday season. If the store does allow returns or exchanges, find out if you will need to pay a restocking fee. Ask the seller if they offer cash refunds, exchanges, or only store credit. Store policies are usually posted at the check-out counter or printed on the back of

Understand online store return policies. If you are shopping online, search for the seller's return policy and read it through before clicking "buy." Find out if they accept returns or exchanges, and who pays the shipping when an item is returned. In some cases, you can save on shipping fees by returning an online purchase to the local brick-and-mortar store.

Get the details on a product's warranty. Most electronics and home appliances come with warranties that are to be fulfilled by the manufacturer, not the retailer. Find out how returns and repairs are handled if an item stops working or needs replacement parts. Will the retailer ship the item to the manufacturer for you? Or will you need to deal with the manufacturer directly? Knowing the answers will leave you well-prepared for any fu-

Keep your receipt and packaging. Most stores will only accept returns and exchanges if you can present the item with its receipt and original packaging. Always include a gift receipt with items you give, and hold on to any gift receipts you receive. Bring your ID. To avoid holiday return scams, many

stores ask to see your ID when you return an item. Sometimes retailers require you to bring your ID and the original form of payment. If this is the policy of the store where your gift is from, you may need the assistance of the gift giver in order to be reimbursed. Make returns in a timely fashion. Almost all return pol-



In general, there are no U.S. federal laws requiring airlines to provide passengers with compensation for a delayed flight. In Canada, see the flights and delays cancellations guide.

Airlines may have their own policies and may provide better benefits if a flight was canceled or significantly delayed within the airline's scope of control.

Consumers may have additional benefits if they purchased the flight with a credit card that offers additional travel protections. Check the cardholder agreement and with the airline.

Consumers should keep receipts for extra purchases, like a hotel room, so they can submit them to their airline or credit card company for reimbursement

As we enter into the thick of winter, I wanted to let you know about doxo's recently released report (U.S. Utilities Market Size and Household Spending Report for 2022) that ranks Milwaukee as the #1 most expensive major city for utility bills in the nation with Milwaukee residents paying \$521 a month on average for bills that include electric, gas, water & sewer, and waste & recycling. This compares to the Wisconsin average of \$361 and the national average of \$328 per month.

For example: Monthly bill amount in Milwaukee: The average household pays \$1,961 a month for the 10 most common household bills. Rank in Wisconsin: Milwaukee is the #41 most expensive city in Wisconsin for household expenses. Milwaukee's monthly bills compared to Wisconsin and national averages: The household expenses in Milwaukee, on average, are 2.1% lower than the national average of \$2,003, and 2.4% higher than the state average of \$1,915.



OPINION: THE HOUSTON RAPPER HAS BEEN THE FOCUS OF GOSSIP, RUMORS AND FLAT-OUT LIES ABOUT WHAT REALLY HAPPENED IN JULY 2020

TALK ABOUT IT.

On Friday December 23, Canadian rapper Tory Lanez was convicted of assault with a semiautomatic firearm, having a loaded, unregistered firearm in a vehicle and discharging a firearm with gross negligence — charges related to the July 12, 2020, shooting of fellow rapper Megan Thee Stallion.

Because the jury agreed that there were "aggravating factors" in the shooting, Lanez, whose real name is Daystar Peterson, faces up to 22 years in prison and deportation after he serves his sentence. He is scheduled to be sentenced on

In the two-and-a-half years since the shooting, Megan Thee Stallion, whose real name is Megan Pete, has faced online harassment and abuse from fans of Lanez, others in the hip-hop community and people in the general public who did not

believe her story. Friday's conviction of Lanez did not change that at all; people are still positing that she lied about the entire situation.

The entire situation stinks of misogynoir, and it serves as a reminder of how much Black women go unprotected in this world, even as many claim to love us and want to protect us.

Pete was subjected to a targeted campaign of weaponized misinformation and had her name dragged through the mud day after day. In her testimony during the trial, she tearfully related how this entire situation has impacted her life and made things harder for her, saying at one point, "Because I was shot, I've been turned into some kind of villain, and he's the victim. This has messed up my whole life.

"I wish he would have just shot and killed me (rather than) have to go through this torture," she said.

Victim blaming and shaming is nothing new; we see it

all the time.

What makes it especially egregious in this instance is that Pete did not initially tell police that Lanez had shot her, possibly saving Lanez from being yet another hash-

Read that last part again, because the fact that she didn't initially tell police she was shot has become a talking point folks have used to villainize her and say that she made up the entire shooting. Pete didn't tell police Lanez shot her because she was trying to prevent him from becoming yet another hashtag. Imagine if the police knew in that instance that he had shot her? How would that scenario have played out?

We will never know, because Pete kept it to herself and didn't speak publicly about it until rumors began spreading about what occurred that night after they left Kylie Jenner's party, forcing her to have to defend herself publicly.

Megan Thee Stallion was shot in the feet after an altercation occurred in the car she was riding in with her former friend Kelsey and Lanez. This is a fact. There is medical documentation as well as the testimony of the medical doctor to corroborate this.

Lanez went on trial for two weeks to face charges in

the shooting incident, and he was ultimately found guilty on all charges related to the shooting. This is also a fact. It is confusing to

me why there are people out there who still want to claim a) he didn't do it and b) she was never shot.

A Black woman was harmed by a Black man, yet the Black woman is the one who suffered the most umbrage from the general public, and that is telling about us both as a society and as a people and culture.

Black women are repeatedly disregarded in situations like this, and Pete is just the latest example — except for her, it went even deeper than that.

Pete was the victim of a targeted campaign of weaponized misinformation throughout her entire ordeal.

As reported by NBC News, "popular hip-hop bloggers, podcasters and social media accounts" --- who don't follow the same journalistic standards of ethics as the rest of us — have put forth unsubstantiated theories about what really happened that evening, and those theories have been read and spread by their millions of followers, whether they were true, based in fact, or not.

From NBC:

alities draw thousands to millions of viewers for celebrity-related news, and often share provocative, unverified rumors to their throngs of followers. The result is online fervor fueled by misogyny and misinformation that pits a highprofile woman, such as Megan Thee Stallion or Amber Heard, against a man accused of destructive behavior, such as Tory Lanez or Johnny Depp."

"These online person-

As Catherine Knight Steele a communications professor at the University of Maryland and the author of "Digital Black Feminism," told NBC in the same report, "This points to the way that misand disinformation, and misogynoir, is trafficked because of its profitability, even in the Black community. It's profitable for these sites to traffic in the most-vile stereotypes about Black women."

Milagro Gramz, a hip-hop news commentator, admitted to NBC that not everything she posts is meant to be factual and that at times she just posts things for "comedic effect."

Too bad Milagro Gramz is too goofy and drunk off internet clout to realize the damage she and others like her are doing when Black women are actually harmed.

Or, as Steele put it, "Whatever can garner the most controversy can go the most viral. It's profitable because being anti-Black woman, using Black women as scapegoats or villains, works for a variety of audiences, white audiences, Black men audiences and, most, unfortunately, in

spaces where Black women use misogynoir to distance themselves from the negative implications of being associated with other Black women."

A lot of people want to argue that the things they have said about Pete are just their "opinion," but here's the thing: Opinions need to be rooted in fact. If your opinion is not based

on facts or rooted in fact, then you have just made something up and are putting it out there as if it were facts, and that is harmful to us all. Improved and increased media literacy could have

gone a long way to prevent a lot of these rumors about Pete from spreading, but I'll save the media literacy lecture for another day.

Suffice it to say that Pete is the victim in this situation, not Lanez.

Dragging her through the mud, weaponizing her sexuality against her, and making her truth seem like a lie in favor of defending the man who shot her is the lowest form of "journalism" out there.

Everyone should be ashamed.

Tory Lanez was convicted on all three charges Friday, and while it may seem like Pete has gotten the justice she deserves, she really hasn't.

Justice won't be served until everyone who spread rumors about her during this ordeal has been dealt with accordingly.

Emancipation Proclamation is a reminder

of how far we've come as a country — and the work still to be done

Editor's note: The following article is an op-ed, and the views expressed are the author's own. There's more to celebrate on Jan. 1 than the start of a new year. It's the 160th anniversary of the Emancipation Proclamation, issued on Jan. 1, 1863, by President Abraham Lincoln to declare an end to slavery in the Confederate states at war with the United

In reality, the proclamation didn't bring immediate freedom for my own great-grandparents or for approximately 4 million other Black people living in enslavement at the time. That's because Confederate forces fighting in the Civil War didn't surrender until

the spring of 1865. And four states that sided with the North in the war — Delaware, Kentucky, Maryland and Missouri — still allowed slavery.

However, the proclamation had important effects.

First, it enabled Black men to officially join the Union Army. The idea of Black and white soldiers fighting side-by-side as equals was too radical for whites, so the War Department created the United States Colored Troops, led by white officers. Since it was impractical to have separate ships for Black and white sailors, both races served together in the Navy, but Blacks were barred from becoming officers and many

OPINION By Donna Brazile formerly enslaved men held the lowest rank, known as "boy."

Some 180,000 Black men served in the Union Army and 19,000 served in the Navy. More than 40,000 died in the Civil War. These heroic Black freedom fighters played a major role in saving the United States from breaking in two and in ending slavery.

Second, the Emancipation Proclamation helped persuade Britain and France not to enter the Civil War on the side of the Confederacy, which both European nations were considering as a way of expanding their influence in the Americas.

Because the proclamation cast

the Civil War as a righteous fight to end slavery — an institution many Europeans opposed — British and French leaders decided to stay out of the conflict. Had the two powerful nations intervened on behalf of the Confederacy, the South might have prevailed in the war and slavery might have continued for years.

And finally, the Emancipation Proclamation paved the way for the 13th Amendment to the Constitution, which was ratified by the states on Dec. 6, 1865, and at long last abolished slavery throughout the United States.

Of course, the 13th Amendment didn't end the systemic racism that has infected America with the virus of hatred since the first enslaved Africans were brought to this country in chains in 1619.

At the end of the Civil War, newly freed Black Americans had no money, owned no land, had been denied an education and faced legalized discrimination that barred them from many jobs, schools, public facilities and residential neighborhoods, as well as denying them the right to vote.

Much has changed for the better since 1865, of course. Rev. Dr. Martin Luther King Jr. and many heroes of the civil rights movement joined with white allies to win the enactment of laws outlawing racial discrimination, although in practice discrimination has stubbornly persisted. Tragically, Dr. King and too many others sacrificed their lives to give us our rights under the Constitution.

In my lifetime, Black people have reached the heights of power and achievement in government, business, academia, medicine, science, entertainment, sports and every other sector.

"The proclamation — issued Jan. 1, 1863, by President **Abraham Lincoln** — didn't bring immediate freedom for the approximately 4 million Black people living in enslavement at the time. But the document did lead to significant changes."

Just looking at government, Barack Obama served for eight years as the first Black president of the United States, Kamala Harris is now serving as our first Black vice president, two Black men and one Black woman have served on the Supreme Court, and Rep. Hakeem Jeffries (D-N.Y.) will become the first Black leader of a party in Congress when he becomes House minority leader in January.

Yet the legacy of slavery and centuries of racism remains with us today and is responsible for higher Black poverty, unemployment, imprisonment and rates of illness — and lower Black educational attainment, family income, homeownership and other benchmarks of attaining the American Dream.

Unfortunately, many lawmakers remain in vehement opposition to affirmative action, anti-poverty programs, aid targeted to Black businesses, and to even considering the possibility of reparations to right the wrongs of the past and make America a more just and

equitable nation. Obviously, we all know that no one alive today ever enslaved Black Americans. But that's no excuse to say America as a nation has no responsibility to help the descendants of the enslaved overcome the racism that was, as many have said, America's origi-

nal sin. On the 160th anniversary of the Emancipation Proclamation, we should reflect on the wise words Rev. Dr. Martin Luther King Jr. delivered in a 1962 speech about

the significance of the document. "If our nation had done nothing more in its whole history than to create just two documents, its contribution to civilization would be imperishable," Dr. King said. "The first of these documents is the Declaration of Independence and the other is ... the Emancipation Proclamation."

Explaining that the Emancipation Proclamation corrected the grave failure of the Declaration of Independence to extend the blessings of freedom and liberty to Black people by abolishing slavery, Dr. King said: "There is but one way to commemorate the **Emancipation Proclamation. That** is to make its declarations of freedom real; to reach back to the origins of our nation when our message of equality electrified an unfree world, and reaffirm democracy by deeds as bold and daring as the issuance of the Emancipation Proclamation." 
