Retired Los Angeles business woman and former Milwaukeean Terry Wells-Jones said her success as the first 'Negro' model for the old Milwaukee Sentinel newspaper, one of the first 'Negro' models for legendary Paris fashion houses, making television commercials, and being the first sales 'woman' for a Fortune 500 company, stems from her never saying: "I can't!"



"Faith is key...believing (in yourself)," Wells-Jones said during a recent MCJ interview, one day after a hugely successful book signing event at Boswell Books on Downer Avenue for her book, "Reflections!: Looking In The Mirror.'

"If you believe you can do something, you will create confidence in yourself and you will excel at whatever you do!"

Wells-Jones said "Reflections" is a memoir written for women based on her glass ceiling-breaking career in modeling and business.

It's also, she added, a road map to how women (and men) can succeed. "It's basic stuff."

Wells-Jones said people have

It was a mixed bag of results—good and bad—for Democrats in the recent Wisconsin general elections for local and state offices.

The most important state election—for Wisconsin Supreme Court—turned out to be 'good.' Milwaukee County Circuit Court Judge Janet Protasiewicz defeated former state high court judge Daniel Kelly.

Protasiewicz garnered 56% the state-wide (1,021,370) to Kelly's 44% (818,286).

With Protasiewicz (who was pro-reproductive freedoms, especially as it related to abortion rights) now on the state high court, control will rest in the hands of liberal leaning justices.

The new make-up of the court will now reposition the high court to the left as it eyes an anticipated ruling on the 1849 state law that bands abortion in nearly all circmstances.

The state's high court election was also a litmus test as to how the issue of abortion is

Three key steps for first-time home buyers

For those considering home ownership for the first time, it may seem as if there's a long list of details to tackle once the search begins. However, before potential buyers even start looking at homes, there are three important steps to take.

The first step is getting your finances in order. Checking your credit rating and getting pre-approved for a loan are crucial. A good credit rating is key to securing a mortgage at the best rate possible.

Starting at least a year (or even two) before you plan to buy will give you a chance to pay down or eliminate any credit card or other major debt that can affect a potential mort-

"I would suggest that a first-time buyer talk with a lender," says Angela Walters, a REALTOR with EXP Realty and chair of the Greater Milwaukee Association of REAL-TORS board of directors. "Sometimes buyers assume they cannot qualify, but they might be pleasantly surprised when they talk to a lender. I encourage people to reach out to a lender whether they think they're ready or not because an early conversation can help them do the right things. If you apply a year early and find out you're not ready, at least you'll know more specifically what you need to do. You might need to pay down or pay off certain debts to improve your debt-to-income ratio. You can also get advice on whether consolidating debt would be a good or bad thing, or whether to hire a credit repair company, etc."

What you don't want to do when planning to buy a home is make ratio may be too high. So, if you are

Another way to get ready for homeownership is to contact Housing Resources Inc. (HRI). HRI is a nonprofit organization in Milwaukee that works to support financial education and empowerment and prepares people for sustainable home ownership.

MCTS BUS SERVICE IS AT RISK OF FACING MAJOR CUTS





To Everyone Living and Working in Milwaukee County:

Great cities rely on great public transit. If you live or work in one of the 19 municipalities that make up Milwaukee County, I hope you'll help us save transit.

The Milwaukee County Transit System (MCTS) is facing a crisis whose ripple effects would touch the entire community. MCTS is confronting a projected \$26.5 million budget shortfall in 2025 after relief funds provided during the COVID-19 pandemic run out. Despite our ongoing efforts to control costs (which have us ranked second among our peer systems in cost-per-vehicle and third in cost-per-passenger) we are hurtling toward a fiscal cliff.

Without a sustainable funding solution, MCTS bus service will shrink by more than 20 percent which represents nearly one half of all routes in the system.

Failing to invest in transit will have cascading, cross-sectoral ramifications for all of us—setting back the regional economy, exacerbating labor shortages, and impacting education and health outcomes. And the harm done by such drastic reductions would fall on those least able to absorb additional burdens.

Most large cities invest in their transit systems with sustainable funding, like a local sales tax, that is indexed to grow year over year. MCTS receives local funding through a combination of property taxes and a vehicle registration fee—both of which don't match the scale of the gap we face. Without a reliable source of local funding, the proposed transit funding cuts would cripple Milwaukee County. We need allies like you to help position MCTS for growth.

Here's how you can help:

- Let the state legislature know that you support Milwaukee County Executive David Crowley and the Move Forward MKE coalition to create sustainable local funding for local priorities through at least a 1 percent local sales tax. I couldn't put it off any longer, so I had eye surgery last week.

For several days afterward, the world was a blur—no racism, self-hatred, or violence---but my hearing was 20/20, allowing me to listen to radio, podcasts, and television.

By week's end, I became sickened with one ty commercial that seemingly runs every 12 minutes on cable television: the insurance ad voiced by 'Jonathan,' selling a life (death) insurance policy for \$9 a month. No exception, no age limit, and no reality.

Jonathan (a former company employee) fails to reveal that the policy won't pay for the average African American home-going gathering, much less the funeral, as it is worth only \$1,000. Not a scam, but...

I mention that ad because it was still ringing in my head when my vision cleared, and I saw this week's 'plantation elections' through prisms that were previously a confus-And what I saw particularly in the most defining school

board elections in recent memory was a deceptive and disingenuous (maybe even racist) Democratic Party ruse that Jonathan could use as a similarly deceiving topic for an insurance commercial.

Through my new vision, there are no longer any delusionary shadows obscuring my sight, and what's in clear focus is another example of a betrayal of our community that will not only stagnate the Black Agenda but doom another generation of Black children to second-class cit-

Since most of the Black community has 40/40 vision and is forced to see through glasses produced in sweatshops using cheap materials, let me put this in focus:

Milwaukee has the worst-performing public school district in the entire United States. That paradigm partly exists because the teachers union---admittedly---has prioritized guaranteed employment, salary, and benefits over the education of students, 80% of whom are 'col-

precedented opportunity to elect a slate of candidates who would challenge that paradigm. But aside from historic Black apathy (another disgrace, particularly given the election

coincided with Martin Luther King, Jr.'s assassination anniversary), those 'Damn Dem's' interference swayed the election.

In these politically polarizing times, I assume I must clarify I am not a Republican, and aside from its support of school choice, I feel about them the way I do about Donald 'Trumpster' and hog maws: I can't stand them for the most part.

If Black folks take off their brand-name sunglasses and start our own party, I will be among the first to jump on board, as I've been advocating for that paradigm since Lot by stabbing former Common Council President and Acting Mayor Marvin Pratt in the back.

Pratt had been assured the Dems would stay out of the race, but after he convincingly won the primary, funds, and resources were provided to Tom Barrett.

That betrayal not only led to the election of Governor Scott Walker because of the Black backlash, but left us thinking where Milwaukee would be today had Marvin

We slept through similar betrayals since then in local races, but I went ballistic when the state party involved itself in the state superintendent race two years ago.

ited life choices. If I were a one-issue voter, my central concern would focus on education or, in the case of Milwaukee, a total restructuring of our city's abysmal government education system before a state takeover or it goes bankrupt.

In that case, I would totally abandon the Dem party.

The state and county branches put their support behind union-backed candidates, thus denying a slate of community activists a chance to address the Milwaukee Public School's nation-leading academic achievement deficit.

Despite its stated commitment not to favor any candidate in local non-partisan races, the Dems went so far as to deny access to essential election data to village-endorsed candidates and to reportedly provide resources to union-backed candidates.

Ask Jeff Spence, a former MPS director who found himself targeted and ousted by the MTEA during his term for the crime of questioning board apathy to Black failure. Despite being a Democrat, he was recently denied es-

sential data from the party whose officials told him they were supporting and endorsing Missy Zombor, a handpicked candidate of the union.

In fact, Zombor is a former employee of the MTEA and editor of the newsletter, 'Rethinking Schools.' That missionary publication has attacked Black leadership for questioning union opposition to reforms and supporting educational options.

In a nutshell, the Demo Party is undermining the Black community to benefit another special interest—the teachers union.

That puts us fifth---behind White folks, unions. women, and poverty pimps.

Obviously, the party's manipulation of 'non-partisan local elections would not be effective without the 'blind support of various special interests and the 'Negrocracy,' Black pawns willing to put their party before their people.

told her that "Reflections" has been an inspiring, motivating must-read about career and life.

"It's a 'how-to' book about pursuing life as a single mom raising two kids in the corporate jungle. It was tough, but I survived. I'm here!"

You can thank the COVID pandemic for giving her the push she needed to write the book, which originally was going to be just a collection of notes she wrote in order to have a recorded history of her family's legacy, which goes back 162 years.

"I just started writing a few paragraphs about myself. My friends saw what I was doing and said that I had a book.

Wells-Jones family's 'journey' starts with one of the early patriarchs learning to read and write (with his master's blessing no less) during the era of slavery in South Carolina when slaves were forbidden from doing either.

Her ancestor's ability to read and write gave him an advantage over other freed Blacks after slavery, such as owning land.

Wells-Jones' own journey started in Arkansas, where she was born. The family moved to Milwaukee several years later for better economic opportunities and to escape the oppressive Jim Crow

Her modeling career began when she was 'discovered' by a woman reporter with the old Sentinel on Wisconsin Avenue. Wells-Jones was home from college where she was pursuing a business degree (and pre-med courses), with dreams of ultimately becoming a doctor.

"She asked me if I was a model. I said 'no.' She said I had all the attributes to be a successful model."

The Sentinel reporter encouraged Wells-Jones to come to the newspaper's offices to do some test shots the next time she was in town.

Because "I Can't" wasn't in her vocabulary, Wells-Jones took the reporter up on her offer and did the test photo shoot. Those photos were used for a full page color advertisement in a Sentinel edition in

The result of the ad was that it was seen in the paper all over the world.

It was also seen by fashion design legend Oscar de la Renta, who contacted the newspaper inquiring about Wells-Jones. "They (de la Renta's company) contacted me to

model his dresses. My dad helped me make the decision as to stay in school or pursue fashion modeling. He felt I should take the modeling

"My dad was always behind me trying to fight to get into an all male world." Wells-Jones' dad told her if modeling didn't work out, she could always go back to school and pursue a medical de-

After Wells-Jones graduated with a business degree from UW-Platteville, she went to New York to pursue modeling, walking down fashion runways in the U.S. and Paris, the Mecca of the Fash-

Another 'I Can't' moment vanquished! Wells-Jones became one of the first Black models to be shown in newspaper ads.

Fashion modeling proved to be the launching pad to even loftier pursuits, such as television commercials for brewing companies, and banks that wanted to attract Black account holders.

Wells-Jones even dabbled in acting, co-starring with actor Sidney Poitier in the movie, "The Lost Man;" and in "The Landlord" with actor Beau Bridges.

"I wanted to break down barriers," Wells-Jones said during the interview. She attributed her success to not only rejecting 'I Can't,' but to her looks as well.

People thought I was French or Creole. Even after I got into modeling, they wanted to book 'the Creole model.""

Demonstrating her business savvy before shifting to the corporate world, Wells-Jones would tell



modeling agencies to not correct those seeking her availability as the 'Creole model.' She embraced the title as a way to break the glass-ceiling for other Black women pursuing modeling.

"I was opening doors for other models who came after me."

Timing also seemed a virtue for Wells-Jones. After years of being a modeling pioneer, she retired from the runway and photoshoots to put her business degree to use and pursue a position with a Fortune 500 company.

"The jobs I was interested in were in sales. But sales jobs were advertised in the men's classified section," recalled Wells-Jones. "I got an interview with Burlington Industries. I had sent my resume using 'Terry' so they would think I was a male."

Also helping her get the interview was her education and extracurricular activities. Her business degree and pursuit of male-oriented sports of basketball and track and field while in college also made the company think she was a 'he.'

Wells-Jones again credited her dad for guidance

and advice in helping her break some of that glass. "He said I had to learn the 'corporate game,'" she

recalled.

"He said I should learn as much as I can about a company before going into the interview so that once I was through the door, all I had to do was play the game.

"I took his advice and went for it! He always said, 'you can do anything you want to do. You just have to fight for it."

When 'she' showed up for the job interview and company officials saw that Wells-Jones wasn't a 'he,' they told her they had no intention of hiring

"I told them they were going to hire me." And they did.

Yes, Burlington took Wells-Jones through a rough interview period. And they didn't make it easy for her once she got the job.

"The first few years was a fight being the only woman in sales. But I built up the department I created. I was then promoted to assistant sales manager...then sales manager."

Another glass ceiling broken. Another barrier overcome. That's because Wells-Jones didn't quit. nor did she say, "I Can't." "I've always been a fighter, willing to fight to get what I want," she

"To succeed, you have to work as hard as possible to make it possible.

"I thought it was unfair—at the time—that women were only looked on as housewives and not educated women."

To do what she did in a 'man's world,' Wells-Jones said she depended on two skills: the ability to listen, and making eye-contact with the person she was selling to.

She attributed her skill as a listener to her grandmother, who never repeated herself. Once she made a statement, that was it. If you missed it, it was your loss. "As I brought in sales persons, I would encour-

age them to improve their listening and eye-contact skills; to learn to read a potential client's body language to enhance getting the sale." Asked about the state of women in business

today, Wells-Jones admitted she doesn't keep up with today's corporate world beyond what she watches on television news or reads in the papers. "There's been a lot of progress. I'm happy we

got to this point. But there's still a long way to go. A few younger women I've talked to say problems that I had still exist, they're just not as bla-

"It's still about breaking down barriers. Women are in (the corporate office), but they're still not being treated equally."

The exchange of court power from conservative to liberal will likely impact more than abortion rights. The court could take up the issue of union busting 'right-to-work' laws, and legislative districts drawn to effectively ensure GOP majorities.

The court might even play a critical role in determining how the 2024 election is conducted and settling disputes that arise.

The 'bad': Three-out-of four African American candidates vying for seats on Milwaukee Public School Board of Directors lost Tuesday.

Darryl Jackson was the lone school board winner from this group. He defeated Gabi Hart for the district three board seat. He collected 3,264 votes (60%) to Hart's 2,143 (39.4%).

Jackson, Pam Holmes (who was a write-in candidate), Dr. Shandowlyon Hendricks Reaves, and Jeff Spence represented a slate of school board candidates who wanted to turn around the dismal and failing paradigm of Milwaukee Public Schools.

A recent series by the Milwaukee Community Journal revealed, the city's school children of color disproportionately suffered during the COVID-19 pandemic.

According to a national report provided by the newspaper in its series, Milwaukee hosted the widest academic achievement gap

Hendricks Reaves lost to incumbent board member Marva Herndon for the district one director's seat. Herndon collected 3,648 votes (58.5%) to Hendricks Reaves' 2,523 (40.5%).

A former board director who sought to return to the board as an 'at-large' member to tackle the district's problems, Spence lost to Missy Zombor. Spence could only garner 24,757 votes (39.2%) to Zombor's 37,822 votes (59.9%).

Andrea Pratt will carry on the legacy of her father, former Alderman/Council President, and acting Milwaukee Mayor Marvin Pratt. She won the vacant first district Common Council seat that he once held, defeating former state legislator, David Bowen.

Pratt received 2,577 votes (50%) to Bowen's 2,560 votes (50%).

Other open council seats were won by Lamont Westmoreland (district five), defeating Annette Jackson, 5,936 (67%) to 2,973

Aldermanic district nine will be represented by Larresa Taylor, who garnered 3,087 votes (52%) to Odell Ball's 2,834 (48%).

Three statewide referendums passed on Tuesday. The first dealt with defining conditions of release from jail. The majority of voters voted yes (1,162,620 votes, 66.5%). About 584,343

The second referendum, focusing on cash bail considerations, passed by about 1,185,825 votes (67.6%). The no votes were 569,354 (32.4%).

The third referendum was a welfare benefit requirement. It passed by 1,416,125 votes (79.5%). There were 364,409 no votes.

The referendums came under criticism as the election approached, with many liberal groups questioning how the amendment's were worded to appeal to voters, unaware that—if passed—could have a disproportionately negative impact on Black and Brown people living in Milwaukee's economically and socially challenged areas.

In fact, in endorsing Marva Herndon (an African American incumbent) over the superiorly qualified Shandowlyon Hendricks-Reaves, the monthly 'Missionary' magazine could only note Herndon's interest in music and art.
