# Mayor Johnson lauds Common Council's passing of 2% city sales tax

Milwaukee Mayor Cavalier Johnson applauded the Common Council Tuesday for enacting a two percent city sales tax, stressing their action protects city residents from "unimaginable" cuts to library and public services.

"We have reached a turning point in the history of Milwaukee's municipal finances," Johnson said in a statement released following the council vote.

"This is certainly the most significant change in how city services are funded in more than a century."

The council's 12-3 vote will allow the city to avoid financial crisis in 2023 that would have forced cuts to services as costs surpass revenue and federal pandemic funds run out.

Council members Milele Coggs, Mark Chambers and Andrea Pratt were the three 'no' votes.

The tax increase is the center-piece of Wisconsin Act 12, which is legislation allowing the city to create a sales tax. For years Milwaukee political and civic leaders have been requesting the state legislature's approval for a new sales tax.

That permission was granted last month under a bipartisan plan to overhaul local government funding. But the agreement between Wisconsin Gov. Tony Evers and the GOP-led state legislature comes with (continued on page 2)

The law requires the city to maintain a minimum level of police and fire staffing, has taken away power from the city's police and fire commission and requires a return of armed police to Milwaukee Public Schools.

The city is also banned from using its sales tax revenue to hire people in charge of promoting diversity, equity and inclusion. The city's street car is also off limits.

Johnson admitted in a statement last week (reported in the July 5 MCJ) that he too was uneasy about the bill's associated non-fiscal policies.

"It's important to remember that whether we establish a sales tax or not, those policies are now state law. The only issue before us is the ability to generate additional necessary revenue via a sales tax."

In last week's statement, Johnson said without the new revenue the two percent sales tax would generate, the city would have had no other option than to lay off hundreds of police officers and firefighters "which would devastate our ability to respond promptly to emergencies."

The mayor added libraries across the city would've been closed and other city services greatly impacted by the loss of hundreds of city employees.

...And I'm not merely referring to the conservative intent to roll back civil rights gains, as everybody and their Mama's sister is positing, many for political reasons.

Nor am I focused on the asinine suggestion that ending affirmative action is a step toward a 'colorblind society,' as the court ridiculously suggested

I rank that proposition up there with the outcry that the city's new 2% sales tax is racist.

While the focus of discontent and fear-mongering over the court's decision reflects its negative impact at the college level, we wouldn't be having this conversation if the walls of educational apartheid were torn down at the K-12 'government' school level.

Simply put, most of our children never fill out a college application because they are unqualified---victims of a system of educational apartheid.

That irrefutable reality is grounded in the fact that the overwhelming majority of Black students are trapped in failing government schools, and neither the Democrats, missionaries, nor Negrocracy have done anything to reform it. Unless shifting the blame to Republicans or blocking access to systemic reforms and educational options is considered a remedial strategy.

# BBB Tip: Phishing emails may target shoppers with post-Prime Day offers

Once Prime Day ends, scammers may just be getting started. Con artists have been known to send phony emails and texts that look like messages from major retailers, instructing you to redeem the reward points accrued during your shopping days. Just hit delete on these phishing messages!

What to look out for

You receive an unsolicited email or text message that appears to be from a major retailer. (BBB has seen scammers use the names of Amazon, Kohls and Costco... but any company can be spoofed.) The subject line reads something like, "You Have a New Reward to Claim!"

You open the message, and it looks real. There's the company logo, colors, and a link to claim the reward points or gift from your recent holiday shopping.

As curious as you may be, don't fall for it. Scammers

hide malware in these email links or attachments. When you click, they can gain access to your computer and steal your sensitive personal information.

BBB has also seen these phishing scams pop up during

the winter holidays and other major shopping events. **Avoid falling for email phishing scams** 

Never click on links or download attachments from unknown emails. Out-of-the-blue emails are often an attempt to download malware to your computer and steal your personal information.

Don't take unsolicited emails at face value. Scammers often send out mass emails that contain little or no personal information. Be wary if the email doesn't mention you or include any personal information.

Hover on links to see their destination. Before clicking, place your mouse over links to discover their true destination.

Go to the source. Whenever possible, use the customer service information provided when you made your purchase, rather than searching online.



# Amid rising back-to-school expenses, Vice President Kamala Harris announces cap on childcare costs!


