Dr. Terence Thomas Scholarship recipient Jerrell Lovett is 26 years young He is a Milwaukee native and proud alumnus of Riverside University High School and Marquette University.

Between both of his parents, he has 15 siblings. Jerrell's father has ten other children, and his mother has five others. He says he feels blessed to have such a large

Most of Jerrell's life was spent with his mom in a house of six (at the time). His mother relied on pre-college and mentorship programs to keep Jerrell out of the troubled neighborhood where they lived.

His interest in science was fostered by the Marquette

of high school.

At the time, he had a general interest in the role that eating, and exercise habits had on physical health. He was inspired to attend college because his family had multiple diseases ranging from autoimmune diseases to cardiometabolic dis-

Although genetic factors play a role, he believes extrinsic factors like eating habits, physical activity, and lifestyle choices have a greater contribution to disease. This inspired Jerrell to study physiological science at Marquette to understand how sys-

tems work. While at Marquette, he gained a lot of research experience surrounding muscle biology. Jerrell's mentor, Robert Fitts had a great interest in studying muscle cells on a cross-bridge level in various context.

In other words, he was interested in looking at the molecular level where muscle contraction occurs. From his studies at Marquette, Jerrell earned a publication entitled "Contractility of Induced Pluripotent Stem Cells Cardiomyocytes with an MYH6 Head Domain Variant associated with Hypoplastic Left Heart Syndrome". In this study they collaborated with the Medical College of Wisconsin to study myofilament function in cardiomyocyte stem cells developed from skin cells isolated from infants

John Daniels III, President and Director of MKE Fellows, is committed to exposing young men to opportunities and instilling pride and self-respect in them to help set them on the path to success.

Apparently his efforts are paying off because the organization is growing in leaps and bounds and is reaping positive outcomes because of those efforts.

"As a young man growing up in Milwaukee and attending Milwaukee Public Schools, I had some amazing opportunities, including becoming the state debate

champion. "After graduating from the University of Michigan, I was not looking to return to Milwaukee

because there were so many op-

portunities away from here, but I

received an invite to return.

At that point, I began to understand and appreciate how much my community wanted to grow, so I wanted to become part of that growth by giving back," said

MKE Fellows is grooming cohorts of young men to become leaders through a comprehensive program that provides scholarships, mentors, community engagement, and internships from high school to college, and to their career path.

The MKE Fellows initiative

started in 2012 to encourage talented, young students from Milwaukee to pursue and complete their college education and serves as a vehicle to attract African American college graduates to return to the Greater Milwaukee

Over the years, MKE has received support and funding from several corporate sponsors and

late through the program and, at any given time, as many as 200 boys are engaged with MKE Fellows at some stage of their lives.

Each young man receives a mentor who is handpicked based on their career aspirations or life experiences.

"Sometimes rather than pair a youth with a similar career objective, we look at other connections.

For example, a student athlete may be paired with someone who played sports in college or profes-

That individual's experiences may help the young man navigate the challenges of playing sports while maintaining his academic standing.

We always use qualified mentors; in fact, we have some of the best mentors in Milwaukee who work at amazing companies and we are always looking for mentors," said Daniels.

Young men interested in applying for MKE Fellows can complete an application that is available online, which is followed by the student submitting a resume and an interview.

"We are looking for students with determination and grit. Their grade point average (GPA) or extracurricular activities may not reflect this but we want them to demonstrate that they have what it takes to excel.

"Our goal is to help get young men to the best place to help them

achieve their goals, to educate them, and then bring them back to Milwaukee.

"We understand that not everyone will return to Milwaukee after graduation.

"One young man advanced to Google in California and another to Wall Street but even those who no longer make Milwaukee their home, are paying it forward in some way or form. They are all committed to doing that," said Daniels.

As far as Milwaukee's future and messages of hope, Daniels calls Milwaukee home because of his staunch belief in the city and what it offers.

"There's not enough room in the newspapers to share all the bright glimmers of hope in our community.

"Some of our youth are or will

be entrepreneurs and others are business professionals. Seeing that glimmer and knowing we (MKE Fellows) can illuminate that is so exciting, especially when we take the time to develop and grow our own talent," said Daniels.

Family, friends remember beloved musician Jahmés Tony Finlayson

A prominent Black doctor and his family are grieving after the death of his son. The son of Dr. William Finlayson, 65-year-old Jahmés Tony Finlayson, died Monday after he was shot last month. He was a beloved musician, teacher and activist.

"Tony was a person who fed folks spirit and I think that's one of the reasons he has such love coming back," said Reggie Finlayson, his brother.

Finlayson is the youngest son of Dr. William Finlayson, a well-known OBGYN and trailblazer in Milwaukee.

Reggie describes his brother as someone who lit up any room he walked into, leaving a lasting impact anywhere he

On Monday, Finlayson lost the battle for his life after he was shot in the early morning hours of June 27 near 1st and Burleigh.

The family believe it was an attempted car theft. Police are still looking for the unknown suspect(s).

Friend Teresa Melbye of Life Center Milwaukee said Finlayson's loss

The long- term goal was to understand how MYH6 variant alters cardiac function which could lead to development of effective biological therapies.

During his final semester at Marquette, Jerrell continued with this line of inquiry and developed an independent project that examined the cardioprotective effects of regular exercise training on heart function using Langendroff perfusion system.

Jerrell continued to explore his interest in muscle biology when he joined Medical College of Wisconsin's Physiology Ph.D program.

He joined the lab of Caitlin O'Meara, who has a general interest in identifying novel mechanisms of cardiac regeneration after heart attack. Jerrell's project aims to look at the role of a protein called lethal giant larvae protein homologue 1 (Llgl1) in cardiac development and its role in mediating a regenerative response after cardiac in-

These studies have clinical significance because there

is a lack of knowledge of how newly regenerated heart muscle cells or transplanted cells reintegrate into the functional myocardium.

Jerrell's success in progressing the field's knowledge in heart regeneration has led him to present at multiple conferences. This past March, he was invited to present his research and give a talk in Long Beach California. He received a distinguished abstract in muscle biology award for my research.

After he finishes his Ph.D., he envisions being a Medical Scientist Liaison temporarily with the long-term goal of working in Healthcare Administration. He wants to have a say on how policy is being implemented on a larger scale, which will affect underrepresented groups. Beyond his career in Science, he has a long-term goal to educate, inspire, and empower other black youth to discover and achieve their purpose through a three-layered generational program. This program will consist of members from e.g baby-boomers, his own generation, and Gen Z.

The goal will be to create Black Professionals through mentorship and representation. There will be a constant flow of knowledge throughout these generational groups so that Black people are not starting at a disadvantage. They will have similar resources as their counterparts when it's time to attend post-secondary education for ex-

Diligently she sought out locations where she could have the most impact and discovered an orphanage in Kenya where dozens of homeless youngsters had no shelter

With support and encouragement from her friends, Davis-Frechette committed to the orphanage, solicited a few donors, and shared with them the incredible story of Sister P and her mission.

Support began in the form of food, supplies, and educational materials for the youngsters.

A small, limited grant was secured enabling them to increase and improve embeddable housing.

Davis-Frechette and four others traveled to Kenya to personally administer aid and assistance and solidify a transformative friendship

"It is hard to believe that from thousands of miles across the ocean, people as loving and caring as Nivia and her friends would find us and donate this help," remarked Sister P.

In answer to your question, I don't plan on taking my marching shoes outta mothballs to participate in Tory Lowe's march against violence this Saturday.

While I applaud his goal of bringing attention to the problem of violence in the Black community, I've long given up hope that symbolic gestures have much impact on the myriad of social ills, much less the epidemic of urban violence.

Simply put, I don't think there's that much gold in the pot at the end of

onstrations and boycotts—have accomplished much more than putting a dent in the walls of American apartheid.

That reality led to my appropriate several years ago that my marching.

However, history and 'His-story' have shown few marches—unlike dem-

That reality led to my announcement several years ago that my marching days were over.

In fact, starting with my first protest as a preteen in the Open Housing Marches during the late 1960s, I've worn out more shoes than Donald Trump lies. (Well, not that many, but you get my point.)

As a result, my feet are now flat and swollen and resemble Fred Flintstones' in shape, if not hue.

Indeed, I've sacrificed my entire adult life for the cause and am now paying for it physically, financially, and mentally. And sadly, only some of the miles traveled have ended at the hoped-for destinations.

I did take what was left of my shoes (worn down to the ankle) out of retirement to participate in the local marches following the 'public execution' of George Floyd three years ago.

But, in retrospect, that was a wasted effort, as I quickly realized the Freedom Train had been hijacked by 'missionaries' and liberal political activists who rerouted our trek from the halls of 'Just-Us' to the White House, where our struggle died on the same platform as dozens of other promises, starting with the '40 acres and a mule.'

Black American gullibility was once again tested, along with the hundreds of thousands of White millennials who believed foot power could fuel a national reform movement that would move us closer to an actual colorblind society where the only stereotypes centered on rhythm and sex drive.

I recognize that Saturday's march will not fall victim to a similar ploy since Lowe will lead it. However, if the destination differed, I would be more inclined to support the walk/march or run.

For example, I might be motivated to participate (by scooter, bike, or camelback) if Lowe led the marchers to the homes of drug dealers, wannabe gangsta/thugs—including the 'Kia Boys' and Girls---or politicians.

It was not so long ago that I enlisted the help of Muhammad Sabir (rest in peace) to join me and female members of the 49th Street block club to 'march on' a drug dealer's house to 'pray with him' about his soon-to-be one way trip to hell if he didn't vacate our block.

Without going into detail, our not-so-veiled threats made him reconsider his lifestyle.

Instead of walking to the radio studio, it would be more beneficial to march to aldermen's homes to demand additional funding for innovative prevention programs, crisis intervention programs, or tickets to Atlanta. (Naw, dismiss that location, Atlanta has similar crime concerns, and it's hot as hell to boot.)

Why not reschedule the march for the next full common council or committee meeting and provide our elected officials with tangible solutions.

Not the pie in the sky we gotta get together,' wishful thinking remedies; but realistic programs that Lowe alluded to have offered in the past.

Seems like every other day, I heard some 'radio revolutionary' referring to our city representatives as the 'uncommon council' and decrying Black politicians' unwillingness to follow our 'agenda.'

I've never heard anyone explain what that 'agenda' entails, although I assume it includes provisions only God can provide.

It would be a coup of historic proportions if marchers provided officials with a consensus agenda and then held them accountable (beyond complaints on the radio).

In fact, if participants are serious about putting a dent into crime and other social ills, they need to march down to the school administration building instead of the mall.

While we hate to admit or acknowledge it, much of the violence we encounter today can be traced to education and parenting (or lack thereof).

In fact, there's been almost as many headlines in recent years about the

academic failures of our children as there have been about violence.

Yet, even though Milwaukee hosts some of the worst test scores this side of Cuba, our 'government school' board hasn't seen more than a few dozen

Black faces in the last 25 years.

They do see a sea of Whites parents and (teachers) union members.

Maybe Black parents and activists are under the assumption that if you don't vote, you can't attend a board meeting. But even that excuse does not explain why they 'accept' a failing status-quo for their children, many of whom will turn to crime because they can't read, write or express their feelings.

Despite that reality, less than 10% of those who say they care so much about the community voted in the most important election of the 21st century---this spring's school board elections.

Now, that's a crime!

I don't know if Truth Radio's talk show host, Ken Harris, will participate in Saturday's march, but as a former policeman and current educator, I think he's uniquely qualified to add to the discussion.

Indeed, I was impressed with a list of five solutions he editorialized during his show last week, four of which addressed parenting.

Number five boldly recommended that women get married before having children.

For those who don't understand his focus, Harris recognizes that most

by single mothers. The absence of a father (not Uncle Sam) in the home dooms many of our children to academic failure, poverty, and culturally dysfunctional lifestyles.

And in Milwaukee, that means 72% of Black households, most of which are impoverished.

Harris also has repeatedly drawn a link between poor parenting, poverty immorality, and crime.

Unless and until we address those contributing factors, marching will be a symbolic gesture at best.

And to be sure, despite trillions 'awarded' to poverty organizations, there

And to be sure, despite trillions 'awarded' to poverty organizations, there is no viable solution to eradicating it other than a social revolution, which ain't gonna happen.

Aside from being led by a high-profile radio talk-jock and the self-pro-

claimed 'most requested advocate in Wisconsin,' this Saturday's march will be no different than two others scheduled for this weekend (one by a church group which I've been told has been endorsed by God), and dozens of others held so far this summer.

None of them resulted in any terrorist punk or punkette turning in their weapons so they can be turned into plowshares, nor did they deter any from

violating the sixth commandment against murder---misinterpreted as 'killing' by most theologians.

Marching, for the most part, is similar to praying/faith: without works beyond and in conjunction, it is meaningless—fruitless—or as the Bible

says: "faith, without works, is DEAD!"

If the aforementioned destinations don't intrigue you, maybe we should all parade down to the gun range. Citizen patrols (yeah, vigilantism) may prove more successful since nothing else seems to move you.

As an alternative, hire the Nation of Islam's 'Fruit of Islam,' those righteous brothers have the courage most of us lack, and even the gangstas give way to them.

Or, then again, some previously denounced laws and policies have proven successful in other communities. The problem is they come at a price "What price?" you might ask! Surrendering some of our civil liberties.

Through my prisms, every tribal member should serve in the civil and human rights army, repaying those who struggled before them; who cleared a path for our children.

From that perspective, participating in marches becomes a symbolic template for a 'rite of passage.'

I first introduced late son, Malik, when he was six-year-old, to his responsibility when we paraded back and forth in the frigid cold to protest a local bank's refusal to close in honor of the King holiday many years ago.

Over the years, he attended dozens of protests, culminating in our joint participation in the Million Man March. Unlike many marches, the MMM concluded with participants vowing to return to their communities to lead or pass on the baton.

My son became a mentor and educator. And I continued my work with

My son became a mentor and educator. And I continued my work with the Black Press, at the vanguard of the civil rights movement, and training a new generation of Black warriors.

If Lowe's march can have that sort of impact, there may be hope for significant change.

(continued from front page) that rate spiked to 6% in June.

The jump in unemployment for Black Americans raised questions as to whether the economy is as strong as the Biden-Harris White House is touting. Economic data shows that when an economy is on the upswing, Black workers are the first to be hired. But when an economy weakens, they are the first to be fired or laid off.

When the Grio asked whether the administration was concerned about the latter prospect, Joelle Gamble, deputy director of the White House National Economic Council, said the data is less worrisome when peeling back the

"This data is particularly volatile, so it's most useful to measure it on a quarterly basis," Gamble said during a White House press call last week. The former chief economist for the U.S. Department of Labor said she has "looked at this survey data fairly closely."

The White House official said it's better to compare job numbers on a quarterly basis versus month-to-month.

"That smooths out noise," Gamble said.

On a three-month quarterly average, the Biden economist said the jobless rate in the second quarter was tied with the previous quarter.

"That's an apples-to-apples comparison for the lowest on record," she noted.

While the White House is closely paying attention to this figure, Gamble said it can "jump around." However, she emphasized that reducing inequality and investing in Black communities and others that have been left behind is a "top priority" for the president.

During the same press call, Isabel Guzman, administrator of the Small Business Administration, said that another way the Biden-Harris administration is looking to boost employment opportunities for Black workers is by providing as much support to Black business owners as possible.

"Focusing on ensuring that our Black founders have access to capital [and] have access to revenue growth opportunities and contracts really helps them create



She added, "We know that they over-index in hiring folks in the Black community, and so ensuring that our Black entrepreneurs or founders continue to create jobs is important to the administration."

Harry Holzer, a senior fellow in economic studies at the Brookings Institution, told the Grio that there is "good news" in the data for Black workers as wages in the last three years have "more than

"Even though inflation has been pretty high, wage growth has been even higher," Holzer said.

Wage growth was reported highest in low-wage occupations, such as leisure and hospitality and some parts of retail. Holzer explained that employers "simply can't get workers to work at really low wages, so they feel like they have to offer workers more to try to entice them back."

The economic researcher

warned that chances of employment loss increase if wages hit a certain peak.

"That could hit Black workers more than white workers," he

However, with gradual and moderate increases in the minimum wage, for example, Holzer said employment losses are "pretty minimal."

There is also some modest good news as it relates to the cost of living for Black Americans and all Americans, based on the latest inflation numbers. According to the consumer price index, inflation fell to its lowest annual rate in more than two years in June.

Gamble noted that some products, such as everyday grocery times like eggs, have declined in price. She emphasized that the administration still has more progress to make on bringing prices down. However, she highlighted some of the White House's wins as it relates to Biden's economic agenda, including provisions secured under the Inflation Reduc-

"He already beat Big Pharma in trying to lower prescription drug costs and cap insulin for Medicare recipients at \$35 a month," said Gamble, who noted that Biden is also cracking down hidden fees like overdraft fees for bounced checks, which she claimed could save consumers up to \$5 billion a year.

She added that the Biden-Harris administration is also investing in clean energy to reduce overall

energy costs. The president "[recognizes] how important being able to get from home to work can be not just for getting to your job but also in terms of your budget," Gamble said.

Following last week's inflation report, Biden said it was a sign of "Bidenomics in action."

"Our progress creating jobs

while lowering costs for families is no accident," the president said. "I ran for office to grow the economy from the middle out and bottom up, not the top down," he

added. "That's exactly what we're

doing."

After 100 years, the descendants of Rosewood return to tour the Wright House, the only surviving structure in Rosewood following the 1923 massacre FLORIDA - Descendants of the Rosewood Foundation, Inc. announced a

significant milestone for the families of those lost during the historic 1923 Rosewood massacre. The descendants of the eight families have been invited to the former home of John Wright, the white store owner who hid residents during the week-long massacre that devastated an entire community of more than 300 Black residents.

The Wright house was the only structure left standing after the desecration of the once thriving town more than 100 years ago.


On Saturday, July 22, the descendants of Rosewood, in conjunction with their Annual Rosewood Family Reunion, will gather at Veterans Memorial Park in Gainesville to be escorted by the Florida Highway Patrol to Rosewood to tour this historic landmark and pay homage to those who fought and died protecting their families and property. This will be the first time members of the eight families have been granted access to view the property together.

The Wright's home was central to the survival of the residents who took refuge there while a vigilante mob of white men ravaged the town before burning it to the ground. Those who survived the massacre hid inside the house, in the water well in the yard, and in the woods before fleeing to Gaines-

This collective tour will perhaps provide some level of comfort or closure

to the families as they continue to grapple with this devastating loss. In the coming days, the Descendants of Rosewood Foundation, Inc. plans to announce another historic milestone as they continue to work to restore their family legacies and the wealth that was that was stolen a century ago. "We are so thankful for this opportunity! This will be the first time for many of us to view the inside of the Wright house, but more importantly, to experience this critical piece of our collective family history," said Gregory Doctor, the cousin of Arnett Doctor, the descendant who led the fight for

the families' historic reparations settlement.


