Piano Guys, Black Violin, composing two orchestral compositions and co-creating the Milwaukee Youth Arts Center Student Advisory Board.


Because of these experiences, it further solidified Autumn's passion for the arts, but also made her further aware of the lack of accessibility for the arts in her community.

The driving force behind Sheriff Ball's rise in rank has been her passion for improving the daily interactions people have with law enforcement.

She is also committed to ensuring that people, particularly those in crisis, are connected to resources that are available.

"One of the greatest challenges of this job is the county and state budgetary restraints. We could do so much more with more re-

"For example, if we don't have the ability to make people feel safe, they don't go out into the community, use our parks and experience or take advantage of other community services.

Oftentimes I see people at their worst. I would like for us to be able to do more for them, especially when they are in crisis," said Sheriff Ball.

Acknowledging that the covid-19 pandemic created unique challenges, Sheriff Ball commends her staff for overcoming unprecedented challenges.

"We only housed individuals that had committed felony or serious misdemeanors during the pandemic.

"To minimize the spread of covid-19, we used videoconferencing with judges so that people could have their day in court, but because people started committing more crimes, we still ended

Teaching my 'Fula Princess' the difference between **'need' and 'want'!**

I was a microsecond short of catching my granddaughter's insertion of 50 cents into the 'animal rescue' donation box at the checkout line.

Before I could tell her to 'stop,' her coins rattled on the container's bottom.

My attempt to convey my concerns about her charitable contribution caught the clerk's attention. He gave me a curious look similar to my Fula Princess, who responded as if she had done something wrong.

To Princess Alaiah, I explained animal shelters should not be your priority when you have limited re-

I like dogs too, sometimes better than people, I explained. But you can't weigh their welfare above people, particularly if you have limited funds to do-My point hit home a few minutes later when she dis-

covered she was 15 cents short of the price of a pack of (sugar-free) gum she had planned to purchase. To avoid paralleling her 'candy' purchase with a

charitable contribution, I amended the lesson to ex-

plain that before making donations, she should consider her personal needs and wants. My central message was about setting priorities. Needs should always overshadow wants, although

many people need clarification. You may want a new television, but you 'need' to pay

your rent. I recalled an acquaintance asking several friends for

contributors to pay her rent because she had fallen for the appeal of her pastor to prioritize tithes and offerings above personal, 'selfish' commitments.

After a stern lecture, I gave her a few dollars and suggested she find another church.

A well-dressed minister who arrives at church in a nice new car and has the nerve to pimp the poor should be drummed out of the ministry. So should those 'pastorally poverty pimps' who tell their congregations to suffer on earth for they will receive their reward in

If you think about it, that's exactly what the vicious and inhumane slave owners told our African ancestors.

Many of my charitable contributions have centered around personal tragedies and community interests.

Cancer stole away the lives of my mother and sister and redirected the energies of my younger sister and brother, so contributions to cancer research and supportive services have been a priority.

As a victim of heart disease—hypertension—I have invested in related educational programs and diabetes

Now that I'm more or less on a fixed income, I have

But, it wasn't an issue of money when I dropped the Democratic Party from my revised donations list. It was more about how I saw the party: it was nothing more than the other wing on the political bird.

Several years ago, I wrote the DNC asking for specifics on how the party would benefit Black Milwaukeeans, only to be dissed and treated like a pawn for

about slavery without upsetting anyone.

Who, other than a racist who believes Black people e subhuman, would not be upset to learn how en slaved Blacks were treated like farm animals, how human beings could be owned by other humans and considered property, how enslaved women were routinely raped by their owners, how enslaved children could be ripped from their weeping mothers' arms and sold, never to be seen again by their parents? How the enslaved could be murdered and no punishment be meted out to their murderers?

I understand that some issues involving Black Americans today can be debated. Does systemic racism still exist? Is race-based affirmative action good or bad? Are the descendants of enslaved people entitled to reparations?

But some things are so evil that they are beyond debate. Slavery is a prime example. So are Jim Crow laws that enforced racial segregation in the South, denied Black people voting rights and made us secondclass citizens in our own country for 100 years after slavery ended following the Civil War.

It's frightening to think what educational standards DeSantis might try to impose on schools across the nation if he becomes president.

Might schools be required to teach students that enslaved Black people happily sang Negro spirituals as they joyfully picked cotton and learned how to farm, grateful for the free passage they received from what then-President Donald Trump in 2018 called "shithole countries" in Africa?

Yes, I know that sounds crazy. But what Florida has done already to distort education and lie to students is

DeSantis says he is waging war on wokeness. In fact, he is waging war on the truth.

America is a wonderful country. I love our nation dearly, as do millions of Black Americans. But we all have an obligation to teach young people the truth about our country — the good, the bad and the ugly. Painting a fairy tale version of America for students

in public schools, as Florida is attempting to do, is not an act of patriotism. It is an act of child abuse.

Before the Democratic convention three years ago, I sent a column to party officials asking if they would focus on any of the myriad issues impacting our city, only to be told we were essentially irrelevant.

I stopped giving to presidential elections after Barack Obama. Thus I threw into the 'circular file' (that's trash can) a recent campaign contribution form from America's first Black president (with his signature no less) seeking contributions for President Joe Biden.

If Black folks organized an independent political party, I might reconsider. However, if it disagreed with reparations, like Obama did, or opposed educational options, like the Democratic party does, they can redirect that request to Hunter Biden, the racist son of the president who has yet to be rebuked by Black Dems for calling us 'niggers' (n-word).

Likewise, I dropped the NAACP from my charitable list after the local branch coordinated a press conference to denounce my support (and the support of the MCJ) for school choice. There was a time when I was a faithful member and

even served as the chair of the nominating committee. But I soured on the organization when it was used by special interests to sue to stop school choice. The NAACP's stance—at the time--reflected its

status as a subsidiary of special interests that benefit from Black dysfunction and dependency.

The organization's opposition to educational options for Black children failed by government schools

sharply contrasted with my personal cultural philosophy, as was illuminated when I asked the then-president of the local branch why the civil rights organization was suing to stop school choice.

His response still rings in my mind:

He said that the Black private schools—Harambee and Urban Day-- participating in the school choice program are exclusively "Afro American' and thus segregated. "

And, he added, "Anything all Black is all bad." I'm not making that up.

After the shock wore off, I asked him if I should take my savings out of the Black bank, tell my children not to consider attending a Black college or university, and no longer purchase from Lena's grocery store?

My questions were met with silence.

My additional lesson to my Fulani Princess (DNA testing revealed our family is Fulani and Mende) was not to invest in ventures counter to our culture and sociopolitical self interests.

As of this year, I've been forced to reassess donations





The Roberts Temple Church of God in Christ in Chicago, where Till's funeral took place, Graball Landing in Mississippi, thought to be the site of his body's discovery, and the Tallahatchie County Second District Courthouse, where an all-white jury found the white men responsible for his murder not guilty, make up the 5.7 acres of the newly designated national monument.

During the ceremony, Biden acknowledged the significant role played by the Black Press in shedding light on Till's tragic story and the broader struggle for civil rights.

He applauded the bravery and unwavering dedication of publications like JET Magazine, the Chicago Defender, and other newspapers and radio announcers who fearlessly reported on the events surrounding Till's murder, ensuring that the truth reached the American people.

"The reason the world saw what Mrs. Till-Mobley saw was because of another hero in this story: the Black Press," Biden remarked, receiving applause from the audience.

He emphasized the importance of shining a light of truth on the painful aspects of the nation's past, acknowledging that darkness and denialism cannot erase history.

Vice President Kamala Harris, also present at the event, echoed Biden's sentiments and emphasized the critical role that the story of Till and the courage of Mamie Till played in fueling the civil rights movement.

Overnight respite care is available not just to St. Ann Center's day program clients, but also to community members, who may join the Monday-Friday day program activities downstairs if they

"Many caregivers are unaware this kind of respite care exists, let alone in their own neighborhood," Lonergan said. "We want them to know St. Ann Center is here for them, that we understand the demands placed on them, and that we'll treat their loved ones with empathy and kindness."

The cost will vary, depending on the level of care needed. St. Ann Center accepts private pay and payment assistance from Family Care, Community Care, Care Wisconsin, IRIS, Department on Aging and more. There is no minimum stay required; a caregiver may need only a weekend morning or afternoon of care.
