



OP-ED: Building democracy 60 years after the March on Washington

Sixty years ago, more than 200,000 people descended upon the National Mall for the March on Washington for Jobs and Freedom, making a stand for freedom and equality.

Black people, women, and poor people had been treated like second-class citizens for too long, and it was time to demand justice.

The March led to unprecedented federal legislation addressing the systemic racism and economic injustices that had plagued Black people through slavery and the Jim Crow era.

Within a year, the Civil Rights Act of 1964 was signed, followed by the National Voting Rights Act of 1965 a year later.

Sit-ins, protests, and other demonstrations set the stage for change, but the March on Washington set a new standard for civic engagement and exemplified the impact that could be accomplished when we organize broad coalitions toward a common goal.

Those lessons will stand the test of time. The march remains a call to action for social justice advocates to continue the fight against discrimination, voter suppression, police brutality, and wage disparity.

It is also a platform to elevate the greater narrative on racial injustice.

Now, as we commemorate August 28, 1963, we understand that while progress has been made, we have so much more work to do. Our democracy is fragile, and we face new threats each day.

In Georgia, threats against democracy linger around every corner. Over the past five years alone, potential voters have faced a new wave of voter purges, the elimination of polling places, reductions in early voting options, limitations on the use of mail-in/absentee ballots, efforts to undermine poll workers and legislation that would subject citizens to a criminal investigation by the Georgia Bureau of Investigation for claimed suspicion of voting irregularity.

While in North Carolina, she taught first graders at Governor Morehead School for the Deaf.

Mrs. Dukes was a member of many organizations throughout the years, including a charter member of The Links, Incorporated - Cream City Chapter and former President; and Silver Life Member of Alpha Kappa Alpha Sorority, Incorporated - Epsilon Kappa Omega Chapter.

She was a dedicated member of St. Paul's Episcopal Church in Milwaukee serving as an active Vestry Member, Junior/Senior Warden, Chair of the Personnel Committee, as well as other outreach committees.

Mrs. Dukes is survived by her daughters Karlicia Dukes Gilbert (Martin) and Enica Dukes Russell (Jason), grandchildren, Madison, Logan, and Emory, and a host of cousins, godchildren, and friends.

She is preceded in death by her parents; Carl and Mizie Hanna of Miami Florida; husband, Enoch Dukes; and grandson, Cameron.

and social justice, but recent years have shown just how far some people will go to suppress the will of the people.

The needs of real people too often take a backseat to partisan jockeying, rampant mis- and disinformation, and wholesale agendas reversing decades of legal precedent promoting equity.

At this moment, we cannot afford to view the March as a thing of the past. The fight for our most basic civil rights never ended. We need urgent action and consistent civic engagement.

That's why for more than a decade, ProGeorgia has worked to help uphold the legacy of community organizing, civic engagement, and viable policy change set forth by the trailblazers behind the March on Washington.

Alongside our 61 partner organizations, we continue to employ smart, robust, and innovative strategies to rebuild democracy and magnify civic engagement.

While we organize for equity in our state, we also try to provide a framework for creating people-centered, positive change nationwide.

What we've found most effective is centering our work around three major premises: relational, rather than transactional engagement; elevating the values, views, voices and

leadership of women of color; and embracing, amplifying, and mobilizing young people.

"Change happens at the speed of trust," said Stephen M.R. Covey, and the Rev. Jennifer Bailey added that "relationships are built at the speed of trust, and social change happens at the speed of relationships."

Thus, longstanding, systemic, and generational change is built over time by creating meaningful relationships.

It's not enough to rally folks for a single election or campaign. You must give people a real reason to believe that their voice and vote matters.

Even more, you must show them how to engage in the democratic process regularly, beyond election cycles, and re-

mind them that our systems are only as strong as the people who run them. We must hold those elected and appointed officials accountable to the will of the people.

Beyond non-transactional relationships, it's important to center and elevate the voices, values, and leadership of people guiding this work every day, many of whom are Black women and women of color.

The face of civic engagement must reflect the communities being served. We need more brown, black, queer, and differently-abled people as activists, organizers, candidates, policy-makers, judges, district attorneys, and lawmakers.

Binge drinking and substance use spiked among adults 35 to 50 in 2022 — but not for Black folks

A new study finds that while cannabis, hallucinogens, and binge drinking have increased in recent years, racial gaps in drinking and drug use in the U.S. continue.

A recent study by the University of Michigan's Monitoring the Future (MTF) panel found the use of cannabis, hallucinogens, and binge drinking skyrocketed among adults 35 to 50 years old in 2022 to "historic highs." However, the data illustrates major gaps when broken down by race.

The MTF study, which has been following different cohorts of 8th, 10th, and 12th-grade students since 1975 to track their lifelong use of substances, illustrates through data collected over time how substance and alcohol use has fluctuated dramatically over the past several

decades across genders, age ranges, and race.

According to the study, white and Hispanic respondents have historically led in all categories. In the latest set of data for 2022 for binge drinking among midlife adults, Black respondents had the lowest rate (17.1%), compared to white respondents (31.4%), and respondents solely identified as Hispanic (30.6%).

"Among midlife adults ages 35 to 50, there have been significant increases in binge drinking over the past one year, five years, and [ten] years among white midlife adults only," re-

searchers wrote in the study.

The results are similar among young adults. Hispanic young adults had the highest prevalence of binge drinking at 35.2%, white young adult respondents were the second highest at 32.5%, and Black young adults were much lower at 20%.

Outside of binge drinking, in 2022, white young adult respondents had the highest prevalence of alcohol use in the past 30 days at 70.3%, followed by Hispanic young adults (66.2%) and Black young adults (60.7%).

While the stats for Black

young adult respondents remain lower, researchers highlight how there has nevertheless been a "significant" increase in alcohol use in the past 30 days over the last five years among Black young adults. In 2017, 51.7% of Black young adults reported having had a drink within the last 30 days.

"Differences in alcohol use have persisted over time," the researchers noted.

It would appear the same is true for cannabis use. In 2022, Black, white, and Hispanic young adults reported similarly high prevalences of cannabis use in both the past 12 months and past 30 days categories.

According to researchers, "this ranking has shifted over time."

Researchers added, "From the late 1980s through 2007, white young adults consistently had significantly higher prevalence of marijuana use than Black and Hispanic young adults."

Overall, the research indicates that in that time span, young adults and midlife adults have been turning to alcohol and substances, including cannabis and hallucinogens, at increased rates.

Regarding substances other

than cannabis, white and Hispanic respondents consistently have the highest rates across age ranges. According to MTF, Black respondents — who have been included in the survey since 1988 — have had the lowest rates of substance use outside of cannabis across age ranges.

In 2022, 20.7% of Hispanic respondents and 17.8% of white respondents reported using a substance other than cannabis within the last 12 months, while 8.3% of Black respondents reported the same. Looking at this category among midlife adults, 13.1% of white respondents and 12.0% of Hispanics reported using something other than cannabis within 12 months, while only 5.2% of Black respondents reported the same.

"Understanding these trends is a first step, and it is crucial that research continues to illuminate how substance use and related health impacts may change over time," the National Institute of Drug Abuse director Nora Volkow said in a release.

"We want to ensure that people from the earliest to the latest stages in adulthood are equipped with up-to-date knowledge to help inform decisions related to substance use."

is all that's left of the good side of the Kord dynasty. After haphazardly meeting Jaime, Jenny entrusts him with a blue scarab beetle, and he has no idea what it is. It is in fact, an ancient artifact with amazing powers. It enters Jaime's body, giving him the ability to fly, fight and create new weapons. The former pre-law college student is not sure how to handle his new skills. His evolution as a crime fighter fuels this story's momentum. Normally in a superhero movie the protagonist's powers are the lynchpin. However, as written by Gareth Dunnet-Alcocer, directed by Ángel Manuel Soto and with visual effects by Kelvin Mcllwain (The Suicide Squad), none of Jaime's new abilities are astounding.

ingly unique. They're generic. In fact, some of his superpower effects look cheesy, like a low-budget Robert Rodriguez film (Spy Kids). Also, the look of fight scenes, bomb blasts and rescues are ho-hum at best. The reason action scenes seem dire is because Jaime is so innocent, and the Reyes family is so loving you don't want anything bad to happen to them. So, it is a great relief when the Reyes family finds the will to battle Victoria and her henchmen. Soto doesn't establish a directing style that makes his footage distinctive. But fortunately, he has the presence of mind to let the grandmother Nana (Adriana Barraza, Rambo: Last Blood), mother (Elpidia Carrillo), father (Damián Alcázar, Narcos), sister Milagro and wacky Uncle Rudy (George Lopez) showboat. Once the relatives enter the picture and put their fate back in their hands the film takes off. Equally exhilarating is Jamie's ascension from innocent befuddled victim to superhero in charge of his destiny. Uncle Rudy: "The universe has sent you a gift, and you have to figure out what you are going to do with it." Jaime's new attitude as Blue Beetle comes in handy as he fights Victoria's killing machine, Carapax (Raoul Max Trujillo, Sicario). In fact, Maridueña may be the wide-eyed, photogenic lead, but Barraza and Tru-

jillo are the ones who leave a lasting impression. Production designer John Billington (Bad Boys for Life) authentically creates Palmera City and the Reyes' home. The surroundings are typical of places in Florida, Texas or California and the homes and interiors look very working class and lived in. Cinematographer Pawel Pogorzelski (Mid-sommar) deftly captures the action scenes and the simple times when the Reyes congregate around their dinner table. While Craig Albert's editing keeps everything crisp as it builds to the finale. Hints of reggaeton on the soundtrack (composer The Axon Cloak) make what's on view feel current. There is a crucial scene when Jaime looks like he won't make it. Stranded in a netherworld, he meets someone who helps him find his bearings. It's a very heady and mystical scene. Quite touching. More of these moments would have made this film stronger. Now that the premise and characters have been established, Blue Beetle has room to grow. Certainly, if it upgrades its visual effects (VFX) it could compete with the best superhero movies. The kind kids, tweens and young teens like. This is a nice start. The beginning of a Latino franchise that can only get better. Especially if it learns from its imperfections and builds on its strengths.

Exclusive: White House elevates Erica P. Loewe to new senior role

White House director of African-American media, Erica P. Loewe, is elevating to a new role within the Biden-Harris administration, becoming the latest Black woman to hold a senior role at 1600 Pennsylvania Avenue.

Loewe, who managed part of the White House's media and communications portfolio, will now serve as special assistant to the president and chief of staff for the White House Office of Public Engagement, theGrio exclusively reports.

The Florida native started her political career as a White House intern many years ago, working through various staff roles on Capitol Hill. In her last role before joining the Biden-Harris White House, Loewe served as deputy communications director for then-House Majority Whip Jim Clyburn, D-S.C. She worked in Clyburn's office during the Jan. 6, 2021, attack on the U.S. Capitol, where she and fellow Hill colleagues barricaded the doors to protect themselves from pro-Donald Trump insurrectionists.

Reflecting on her ascent in Washington, Loewe credits it all to hard work and navigating a world of D.C. politics without "any special connections."

"I didn't necessarily come from a life of privilege," she told theGrio. "I grew up in Liberty City, Florida, where the median income is around \$30,000."

Loewe, who is single, admits she has no work-life balance. Her typical day is filled with countless planned and unplanned projects. "You go to sleep reading the news, and you wake up reading the news," she shared.

Loewe is fiercely passionate about public service, particularly for Black Americans, who may feel little or no connection to the highest office in the land – also known as "The People's House."

"A lot of the people that I grew up with don't end up in the White House and are not expected to end up in rooms that I have been blessed to end up in," Loewe acknowledged.

As one of few staffers in the White House with an intimate and sophisticated understanding of Black America, Loewe has been a key player on issues related to Black communities.

"I don't know if it makes me special...but I know that does make me relatable," Loewe said of her success and built experience working in community and media strategic communications.

Anita Dunn, assistant to the president and senior advisor to President Biden, lauded Loewe for spearheading the White House's Black media engagement "since the early days of the Biden-Harris administration."

"She's smart, innovative, hard-working and has a passion that aligns with the President's mission of ensuring everyone has a seat at the table," Dunn said in a statement provided to theGrio. She added, "I'm confident she'll be a tremendous asset to the Public Engagement team as the President and Vice President continue working on behalf of communities across the country."

In her new role, Loewe will now engage with organizations and communities beyond her previous scope. She will be tasked with bringing people from all walks of life to the White House, taking the veil off what can oftentimes be seen as a mystery, despite being the most recognizable building in the world. The Biden official said she wants to expand her work to ensure that the White House is "inclusive and accessible," which is her "favorite part" of the job.

Loewe recalled the days before her life in public service when she and her family visited the White House during President Barack Obama's first inauguration. They stood outside the gates and took photographs on their phones.

"It was incomprehensible to us that we would be able to do anything else," she said. "Now that I am in and I realize how easy it is to bring folks behind me, I am not going to stop."

Stephen K. Benjamin, senior advisor to the president and director of the White House Office of Public Engagement, said he is excited to welcome Loewe in her new role.

"The Office of Public Engagement works tirelessly on behalf of the President to ensure direct dialogue between the Biden-Harris Administration and the American people," Benjamin said in a statement provided to theGrio.

Recognizing Loewe's professionalism, the former mayor of Columbia, South Carolina, said, "Her leadership, experience, and creativity will be invaluable as we continue to reach diverse communities across the nation."

As one can imagine, being a staffer at the White House often requires working around the clock. Many often experience burnout, and very few stay for an entire administration. Understanding that reality, Loewe said she still enjoys the job.

"They say that once you're no longer excited to walk through the gates and see the White House, it's time to go," she said. "I still catch myself taking pictures like a tourist."

For Loewe, rising in the ranks of the White House is personal, especially when she thinks about her family history. Her late grandmother, who did not have a high school education, "could not understand what I could possibly be doing there" back when she was just an intern.

"It was just unfathomable to [her] that I would go into a building like the White House or the Capitol, and people would be interested in what I think," shared Loewe. She added, "That's not lost on me."
