

The city of Milwaukee health department recently received a report of a confirmed case of measles in a Milwaukee resident employed in Wauke-

### **Sherrie Tussler: Feeding the** Masses, One Person at a Time **By Kathy Gaillard**

It's been said that if you love what you do, you never work a day in your life. Apparently that old adage rings true for Sherrie Tussler, executive director of Hunger Task Force.

She acknowledges that she enjoys going to work every day and that joy is evident when she talks about Hunger Task Force.

Her passion for serving food insecure families is heartwarming, contagious and has served the community well.

For the past 25 years Tussler has been the driving force behind Hunger Task Force, substantially raising the organization's profile, expanding its services and programs, securing corporate partners, engaging in statewide initiatives, and even operating a farm in Franklin, WI that provides healthy and nutritious food to residents.

Hunger Task Force, Inc. is a non-profit, anti-hunger public policy organization in Milwaukee.

The organization works to end hunger in Milwaukee County by providing direct food delivery services and works to end future hunger by advocating for fair and responsible administration of federal nutrition assistance programs.

When I was hired by Hunger Task Force, the organization was in a bit of trouble and did not have enough money or food to meet the needs of Milwaukee County. The budget was about \$1.5

million a year and now it's substantially more. We have also taken on statewide initiatives in 17 distinct locations across Wisconsin, where we serve food pantries and tribal nations.

"As I look back over my life and think about how much I love my job, I know that I am doing what I was supposed to do. I initially thought I would become an art teacher, but the world takes you in other places," said Tussler.

One of the projects Tussler is most proud of is Hunger Task Force's farm. In 2012, the organization signed a historic, 30-year lease with Milwaukee County Parks, which allows Hunger Task Force farmers to operate more than 200 acres of farmland in Franklin, Wisconsin and natural areas.

With the help of six employees and hundreds of volunteers, Hunger Task Force grows more than 25 different varieties of fruits and vegetables each season to feed children, seniors and

families in the community. The Farm infuses half a million pounds of fresh fruits and vegetables into food banks, enhancing the nutrition of those who normally rely on canned or nonperishable foods.

Produce grown on The Farm includes peppers, tomatoes, corn, watermelon, beans, spinach, greens, broccoli, cauliflower, apples, pears and more. Hydroponic produce is grown during the winter months.

"Very few food pantries exist that actually grow healthy foods. The minute we were able to get The Farm and grow one-half million

pounds of food annually, it changed the course of the kinds of foods that we give to people and improves public health, one person at a time.

"There's such a variety to the work that we do at Hunger Task Force. We have the farm, mobile market, and I have the opportunity to meet with leaders of tribal nations.

"I'm always meeting new people and influencing how they get access to healthy food," said Tussler.

Innovation and outside-the-box thinking have helped make Hunger Task Force a national model. For example during the covid-19 pandemic, Door Dash food delivery reached out to Tussler to support food delivery since senior centers and meal programs were closed.

"We continue to dash food to about 1,200 seniors who are unable to come out. Coming out of pandemic, there's a lot of hope.

"We are resilient people and we can figure stuff out. We can all make a difference in other people's lives if we just chip in and do our part,"

And while she didn't pursue a career as an art teacher, Tussler enjoys rehabbing houses and "painting them pretty colors because it makes me happy," she said.

The Milwaukee community is grateful and all the better that Tussler has found her niche serving this community through Hunger Task Force. Her efforts paint the picture of a true diamond.

#### COUNCIL **ADOPTS FILE** TO OPPOSE **WE ENERGIES** RATE HIKES

The Milwaukkee Council recently adopted a resolution reaffirming the city's opposition to Wisconsin Electric Power Company's (WEPCO) and Wisconsin Gas LLC's joint application to adjust electric, steam, and natural gas rates.

The file, introduced by Alderpersons Marina Dimitrijevic, JoCasta Zamarripa and Jonathan Brostoff, and unanimously co-sponsored by the entire council, comes at a time when the utilities are seeking a 3.1%

"We Energies has stated that this rate increase is to support new infrastructure expenditures, including renewable energy.

The city has an ambitious climate and equity plan and supports more renewable energy.



among the highest in the Midwest, it is ridiculous that they once again are working to shift the burden onto customers for something they should have been investing in years ago," said Alderwoman Dimitrije-

"I would urge the Public Service Commission to reject these efforts that seek to exploit working families who don't have affordable energy alternatives, and focus on instituting income-driven payment options to ensure greater equity."

The Common Council, via file #220612 adopted in September,

2022, expressed its opposition to the rate increase that went into effect

Should the rate increase be approved by the Public Service Commission without amendment, it would result in two-year electrical rate increase of 14.4% for residential customers.

The proposed 3.1% increase for 2024 would add approximately \$4 per month to a customer's monthly electric bill, and \$2-\$3 per month for natural gas.

The file adopted today allows the Office of the City Attorney to submit objections to the rate increase on behalf of the City of Milwaukee.

The first of several park signs were installed in early September. The new signage honors the Johnsons by listing their full names—Clarence and Cleopatra Johnson.

"I am grateful to the Milwaukee County Board, Chairperson Marcelia Nicholson and County Supervisor Johnson for facilitating this historic park renaming.

"It is not an easy task to rename a park, but it is important that Clarence and Cleopatra Johnson re-

ceive credit for their commitment to improving the quality of life in Milwaukee through recreation, baseball and a host of other activities," said Clayborn Benson, Executive Director of Wisconsin Black Historical Society/Museum.

The Johnsons owned Ideal Tailor shop, which was one of the few black businesses that survived the Great Depression Era.

They also helped found the North Central Branch of the YMCA — now the Northside YMCA at 1350 W. North Avenue and Columbia Savings and Loan Association, which has been operating on Fond du Lac Avenue since 1924.

The community is invited to attend this historic unveiling which will also include remarks from members of the Rod & Gun Club, a recreational organization founded by Clarence Johnson.

Individuals onsite during these dates/times need to check their MMR immunization status as soon as possible. Individuals can access their immunization records using the Wisconsin Immunization Registry (WIR). Instructions are available in English, Spanish, and Hmong. If you are unable to access your records, please contact your doctor's office or your local health department.

Measles is a highly contagious disease that can be spread from person to person through the air and can stay in the air for two hours after a sick person coughs or sneezes.

Measles is a vaccine-preventable disease. The best way to prevent getting measles is to get the measles vaccine (MMR) as a child beginning with the first dose at 12 to 15 months of age, and the second dose around age four. Even one dose is 93% effective against measles.

If you are pregnant, severely immune compromised, have children under the age of 12 months, or are otherwise ineligible to receive the MMR vaccine, contact your medical provider for guidance.

Adults who were born in or after 1957 and have never had the vaccine, should get at least one dose. If not previously vaccinated, college students, international travelers, and healthcare workers should get two doses at least 28 days apart.


"We are actively managing the situation and taking necessary steps to prevent further spread. Measles is a vaccine-preventable disease. The virus is a highly contagious disease that is spread through respiratory droplets and direct contact with contaminated surfaces." said Milwaukee Health Commissioner Mike Totoraitis. "We urge all potentially exposed individuals to check their immunization records and ensure they have received the MMR vaccine or make a plan to get the vaccine. Vaccination is not only crucial for your protection but also for the well-being of our entire community."

Immunizations are available at a doctor's office, some pharmacies, and City of Milwaukee Health Department Clinics.

This Saturday, October 14, the Milwaukee Health Department's Northwest Health Center Drive-Thru Clinic (7630 W Mill Rd) will be administering the measles (MMR) vaccination, in addition to COVID-19 (for eligible individuals) and flu vaccinations. The clinic will run from 10 a.m. to 3 p.m.

For questions or assistance with accessing immunization records, residents can call 414-286-6800.

If there are any additional measles cases, these will be included in the case count posted on the DHS website.




## Signs and symptoms of measles include:

- Runny nose
- High fever (may be greater than 104°F)
- Tiredness
- · Cough
- Red, watery eyes, or conjunctivitis ("pink eye")

A red rash with raised bumps starts at the hairline and moves to the arms and legs three to five days after first symptoms appear.


If you develop any of the symptoms of measles, you should stay home (do not go to work, school, shopping, or use public transportation) and call your doctor's office. Tell them you might have been exposed to measles and describe the symptoms you are experiencing.



SIGNIFY

I saw the smoke signals hovering over Menomonee Falls last week and immediately surmised they were part of a new warning system for 'outer ring suburbanites.'

The man-made cloud was one of several 'warning' devices utilized in the last few months in anticipation of an eventual 'foreign invasion.'

And I'm not talking about Chinese, Russians, or Trump's Toxic Troopers.

Instead, the alert signaled another arrest of a brown-skinned brother who thought he could sneak a television under his shirt at the Germantown Walmart.

In itself, that arrest signifies little. But when reports reveal that while the small G-town police force was escorting the punk to their station, a dozen other thugs and thugettes escaped the net, you begin to understand why suburbanites are concerned.

And it's not only because they know their property taxes will skyrocket to address the growing shoplifting tsunami.

It's more so a fear that the invasion of 'colored culprits' thievery may signal a pending incursion of the 'Milwaukee Mau Mau' (MMM)---crazed and impoverished 'Negriods' who have been incited by Critical Race Theory propaganda, intoxicated on drugs obtained from poverty pimp organizers, and inspired by liberation theology clerics who advocate the green grass and clean streets of the outer core suburbs could compensate as reparations for slavery and 150 years of second class citizenship.

OK, OK, I might be exaggerating...a tad! But you can't deny the irrefutable concern of White and Black suburbanites that their once safe communities are being devalued by a wave of 'nonviolent' crimes, most clearly illuminated by record shoplifting, 95% of which are being perpetrated by Milwaukee's Minions who apparently think they are in the export business.

Now, each of those 'alarms' is, in truth, part of a coordinated warning paradigm for suburbanites to practice procedures in which they lock their doors, load their guns, and put their daughters in chastity belts because, as Sidney Poitier once declared: 'guess who is coming to dinner?'

Today, it's unprecedented and resource-draining shoplifting. Tomorrow, it's carjackings. Next week, it's home invasions.

The 'Mau Mau'- the propaganda and conservative trouble makers are telling the suburbanites—is coming.

As a child of Black parents who

taught me the power of reading (a lost art), I can decipher the tea leaves. And they saw a growing

problem that is reaching its apex.

A couple of years ago, the Washington County publication isolated a small corner of the weekly publication to crime ---drunk driving, speeding, and occasional drug (one joint) arrests.

Today, that column has grown into an entire page with, sadly, most of the crimes reportedly committed by outsiders (Milwaukee Minority Minions).

So, I'm not recuperating from the contact high I received while entering the corner grocery across the street from the newspaper I write for (the one you're now holding). Nor am I exaggerating as I did when I told my blind date—now my wifethat I was 6'2" and had a washboard stomach.

The truth is, the outer core suburbanites are telling authorities that something must be done before this situation gets out of control. And they won't have to scream too loudly, as 'special interests' are using the scenario to create cultural chaos

and, indirectly, solidify the strong lock conservatives have on suburban politics.

You can call it fear-mongering. But you'd be hard-pressed to convince the retirees, including Black professionals, who left Milwaukee for the safety of the suburbs that their lifestyles and security are being jeopardized (again) by an onslaught of Black criminality.

The uptick in hiring of armed security at businesses outside Milwaukee is not merely the result of corporate decisions to lower unemployment figures. They are, in fact, a response to escalating shoplifting and other 'nonviolent' crimes, much of which are being perpetrated by members of our tribe (or a subset).

Several months ago, I relayed my confusion about the hiring of black-clad armed guards at Woodman's grocery store on the border of Milwaukee and Menomonee Falls, 104th Street, just south of Brown Deer Road. That's different from the other Woodman locations in Waukesha and Oak Creek.

Somewhat confused, I asked a Black employee about the hirings,

and she confirmed---sadly---that they were 'necessitated' by a tsunami of shoplifting, including punks running out of the store with carts full of groceries to waiting cars.

The employee brought some levity to the scenario, stating, 'The low riders (wearing pants below the thighs) want to impress the chicks with clean drawers.

As much as I tried, I couldn't hide

my laughter from the joke, although the disingenuous nature of the scenario was not lost on either of us. Even the Marcus Theater down



# GETTING TO KNOW... EZEKIEL GILLESPIE

I recently had a chance encounter at a restaurant with Rev. Greg Lewis, Executive Director of 'Souls to the Polls,' and his lovely wife, Annette.

During our conversation, I shared with him that this week I had attended a school renaming in Madison, Wisconsin.

The school changed its name from Thomas Jefferson Middle School to Ezekiel Gillespie Middle School.

Rev. Greg said that I should share this historic occasion with the greater community.

Many of you may have heard of

Ezekiel Gillespie but do not understand the important role he played in our state's history.

In 1869, Ezekiel Gillespie was one of several people who founded St. Mark AME Church in Milwaukee. He also participated in Joshua Glover's rescue in 1854 and, after a brief argument in a local barbershop, he partnered with Attorney Sherman Booth to sue the State of Wisconsin for Black people to have the right to vote.

In 1849, African American men took a bold stance that they lived in the state of Wisconsin and clearly had the right to vote, so they called for a statewide voting referendum asking the question, "Should African American men

have the right to vote as citizens of the State of Wisconsin?" At the heart of the question, many of this state's leaders questioned whether we should even be considered citizens of the United States.

This notion came on the heels of U.S. Supreme Court Chief Justice Roger B. Taney's opinion as it relates to the Dred Scott decision that Black Americans were clearly not citizens and not entitled to any rights that related to citizenship.

The outcome of the Wisconsin referendum vote of 1849 stated that Black Americans did not have the right to vote.

The question of voting was one of several items on the ballot and the State Board of Canvassers denied the right to vote.

The truth of the matter is for the

next 16 years, Black Americans were denied the right to vote until Ezekiel Gillespie had the courage to challenge the State.

After the Supreme Court reviewed the evidence put forth by Sherman Booth, they learned that the Board of Canvassers were wrong. Black Americans had the right to vote dating back to 1849.

Finally, the subject of Blacks having the right to vote and being cheated out of the right to vote for those 16 years has been muffled over, justified, misrepresented, and glossed over by educators, institutions, people who are supposed impart accurate and historical information.

It's no wonder why Black Americans are so slow to go to the polls. We were cheated more than 150 years ago. Currently the State Legislature and the Supreme Court are hearing the issue on voting maps and how they continue to suppress our right to vote.

Kudos to Ezekiel Gillespie Middle School for recognizing the importance of renaming the school after such an important historical figure in our state's history.



The Medical College of Wisconsin (MCW) was recently selected by the National Institutes of Health (NIH) to establish a Maternal Health Research Center of Excellence. These Centers of Excellence are a key part of the NIH's larger vision for the Implementing a Maternal Health and Pregnancy Outcomes Vision for Everyone (IMPROVE) initiative, which supports research to reduce pregnancy-related complications and deaths and to promote maternal health equity.

The Center's lead primary investigator is Anna Palatnik, MD, associate professor and the Patrick J. and Margaret G. McMahon Endowed Chair in Obstetrics and Gynecology. The focus of her research is reducing health disparities in birthing people experiencing preclampsia and gestational diabetes, as well as improving health outcomes both during and after pregnancy. Coleading the Center with Dr. Palatnik are the following MCW faculty: Joni S. Williams, MD, MPH, from the Center for Advancing Population Science; and Jessica Olson, PhD, MPH, and Julia Dickson-Gomez, PhD, from the Institute for Health & Equity.

"Wisconsin has the highest infant mortality rate in the nation for infants born to non-Hispanic Black birthing people. Further, Black birthing people in Wisconsin are nearly eight times more likely to die from pregnancy-related causes than Hispanic women and five times more than White women," said Dr. Palatnik. "Being selected as one of only 10 research institutions in the country to establish a Maternal Health Research Center of Excellence is a unique opportunity for the Medical College of Wisconsin to directly impact those statistics and improve maternal health outcomes in our area."

The primary goal of MCW's Maternal Health Research Center of Excellence is to address the main social structural risk factors for racial disparities to impact maternal morbidity in Southeast Wisconsin. The NIH funding will enable MCW to partner with community organizations that will help inform the Center's research projects; to develop and evaluate interventions to ad-

dress racial disparities in maternal health; share learnings to inform policy change; and train a diverse group of early career scientists in maternal health equity research. Funding is expected to last through August 2030.

"The Medical College of Wisconsin's selection as a Maternal Health Research Center of Excellence acknowledges our dedication to pioneering research and compassionate care, and underscores our unwavering commitment to health equity," said John R. Raymond, Sr., MD, president and CEO of the Medical College of Wisconsin. "As we continue to advance maternal health and wellness, we recognize the imperative of addressing health disparities that disproportionately affect marginalized communities. Every breakthrough, every partnership, and every solution we uncover, bring us closer to a future where every mother receives the highest quality of care, regardless of background or circumstance."

According to the most recent Wisconsin Maternal Mortality Report, Black, Non-Hispanic Asian, and Hispanic mothers made up only one fourth (24%) of Wisconsin births in 2016-2017, yet they represented nearly one half (42%) of all pregnancy-related deaths. In Milwaukee County, 78% of non-Hispanic White birthing people received early prenatal care in 2020 compared to 62% of Black and 63% of Hispanic birthing people. Prenatal care that starts early and lasts throughout a pregnancy can help prevent and address health problems in pregnant people and their infants.

"Where someone lives, learns, and works has a significant impact on length and quality of life, but not everyone lives in a place that affords them the opportunity to reach their full potential. By working with community partners and policymakers, we'll ensure that our efforts sustainably eradicate maternal health disparities in Southeast Wisconsin – and beyond," said Dr. Palatnik

#### **PASSAGES: HUGHES VAN** ELLIS, 102-Year-Old Tulsa Race Massacre Survivor, By Lauren Victoria Burke— NNPA Newswire Contributor Dies

One of only three known survivors of the Tulsa Race Massacre has died on October 9 at the age of 102 years old.

Hughes Van Ellis, 102, died in Denver, Colorado on the morning of October 9. Van Ellis was born on Jan.11, 1921.

The two last known survivors of the Tulles Race Massacre are now Viola Ford Fletcher, 109 and Lessie Benningfield Randle, 108.

The Greenwood District was a prosperous African American community in Tulsa, Oklahoma, often referred to as "Black Wall Street."

It was a thriving business district with a vibrant Black cultural and economic life, home to many Black-owned businesses and residences.

On May 31, 1921, a young Black man named Dick Rowland was falsely accused of as-

saulting a young white woman named Sarah Page in an el-

The allegation led to Rowland's arrest and tensions escalated as rumors spread about the incident.

At the time, Hughes Van Ellis was three months old. Over the years there have been several attempts to earn damage rewards for the destruction of life and property by the white community in Tulsa. None of the challenges have been successful so far.

A statement released by the family stated, "Mr. Hughes Van Ellis, 102, passed Mon. Oct. 9th at 11:30 am in Denver, Colorado. A loving family man, he was known as "Uncle Redd."

He was among the three last known survivors of the 1921 Tulsa Race Massacre, one of the most horrific acts of racist

terrorism on American soil. A WWII war veteran, Mr.

Ellis, bravely served America, even as he spent a lifetime awaiting atonement related to the Tulsa Race Massacre.

Mr. Ellis was aware, that survivors, his sister Mrs. Viola Ford Fletcher, 109, Mrs. Lessie Benningfield Randle, 108, and family descendants were recently at our state capitol as part of an interim study focused on 2001 state-commissioned reparation recommendations.

Two days ago, Mr. Ellis, urged us to keep fighting for justice. In the midst of his death, there remains an undying sense of right and wrong. Mr. Ellis was assured we would remain steadfast and we repeated to him his own words, "We Are One" and we lastly expressed our love.

"The scripture of Jeremiah 6

The Milwauukee Community Journal • October 11, 2023 • Page 5 reads 'This is what the Lord says: "Stand at the crossroads and look; ask for the ancient paths, ask where the good way is, and walk in it, and you will find rest for your souls.

We celebrate the rare life of Mr. Hughes Van Ellis who still inspires us!"

Funeral details are not yet known. Van Ellis' funeral ceremony is likely to be another touchpoint around the issue of reparations for the damage done to members of the Black community as a result of systemic racism.

## **Black America Divided Over** Hamas' Attack on Israel, **Raises Questions on Solidarity**

Black Americans have expressed a range of emotions regarding Hamas' recent and deadly attack on Israel, with many taking to social media to highlight what they perceive as a lack of support from Israel and some members of the Jewish community for the Black Lives Matter Movement.

The sentiment was especially after George pronounced Floyd's assassination in Minnesota in 2020.

Numerous posts on social media platforms feature hashtags like #BLM and #PLM, underscoring the perceived parallels between the struggles of Palestinians and African Americans in their fight against systemic racism.

One widely circulated message emphasized the cross-border nature of these movements,

Americans have been [creating] a social movement, without borders, to fight systemic racism.

As part of international protests, in Palestine/Israel signs read 'Justice for Eyad. Justice for George.', 'Black lives MATTER. Palestinian lives MATTER."

Former NBA star Amari Stoudemire, who previously announced his conversion to Judaism, took a contrary stance, denouncing African Americans who do not support Israel.

Stoudemire openly criticized the Black Lives Matter movement, asserting they were not contributing positively.

He stated, "For all y'all Black Lives Matter who ain't saying nothing or 'let me figure out exactly what happened before I say anything,' F. you. Figure out what? It ain't never been cool to kidnap kids."

stating, "Palestinians & African min F. Chavis Jr. unequivocally condemned the acts of violence committed against the Jewish people and the nation of Israel by Hamas. "The National Newspaper Publishers Association (NNPA), representing the Black Press of America, forthrightly condemns the brutal, fatal terrorist attacks today on the Jewish people and the nation of Israel by Hamas," read the statement.

But that reality can't explain why 77% of the faces at the Appleton Ave. Walmart are African

Most of the Black customers are Milwaukeeans. Ironically, they travel out of their way to get to G-town, not because that store has better bargains, but instead because they feel safer.

The Walmart on Capitol Drive has a history of daytime robberies. Along with its sister store on Brown Deer, is reportedly on the list of locations that might be closed because of excessive losses from coordinated shoplifting.

That's why, we assume, the Miltown and, most recently, the Silver Springs locations were closed.

In fact, the primary reason for Milwaukee becoming an entertainment and department store desert (outside of downtown and the Third Ward) is related to our city's cultural image, exasperated by nation-leading poverty.
