There's an old saying: 'Revenge is a dish best served cold...'

And cold...glacial...is how former Republican president and current GOP candidate Donald Trump and his conserva-

When Andi Elliott completed an internship at Community Advocates as part of the University of Wisconsin-Milwaukee School of Social Work requirements, she was offered a position with the organization.

She never imagined that 32 years later she not only would still be working there, but she is running the agency as its CEO and President.

"I thought I'd be at Community Advocates for two to three years, but I found the work so rewarding that I stayed. My tenure here has fulfilled my need and desire to serve," said

vocates has provided basic needs, advocacy and services to low-income, at-risk individuals

and families in the Milwaukee

Over the years, the organization has expanded its services to include the Women's Center. At the heart of its mission is its goal to reduce poverty in Milwaukee

Community Advocates provides health care advocacy, case management and protective payee services, homelessness prevention, energy assistance, disability advocacy services, and housing/case management services for individuals who are homeless and also have chronic mental illness.

With a rich history of fostering and creating partnerships. Community Advocates regularly collaborates with other organizations to help solve problems and challenges.

Community Advocates is also one of only a handful of agencies that accepts clients on a walk-in basis.

The organization delivers its services using a wraparound approach in which clients work in partnership with staff to help them achieve their individual

issues should call Community Advocates first before taking any actions.

For example, if tenants are behind in rent and they connect with the Department of Neighborhood Services first, once landlords are notified, they can start the eviction process.



It took Pulitzer Prizewinning journalist Cara Fitzpatrick five years of extensive research on 'public education' to reach a conclusion I could have provided seconds after she began her project: the country is moving away from a public school system to a

system of public schools. And the public, and particularly minority children in failing 'government' schools, will be the beneficiaries.

The author of 'The Death of Public Schools,' Fitzpatrick, discussed the history of educational options, specifically school choice and charters, during a lecture at Marquette University re-

Her presentation was sponsored by the Lubar Center and moderated by noted education reporter and Luber senior fellow Alan Borsuk.

The book's title is misleading in that it doesn't foretell the demise of 'government-operated' schools.

Instead, she surmised, the nation is moving away from the stagnant, one-size-fits-all paradigm that has shortchanged urban and low-income children to a system that provides various educational options.

The steady growth of school choice has forced a reassessment of how we define 'public.'

I have long maintained that 'non-government' schools that receive most of their funds from 'our' taxes are public schools.

Fitzpatrick did not cross that line. However, she revealed a majority of Americans---and an overwhelming majority of lowincome and African Americans—support vouchers in one form or another.

While she did not elaborate during the Marquette lecture, in another forum, Fitzpatrick touched on the roots of the Democratic Party and teacher union opposition to school choice, a paradigm in which the needs of the students are secondary to that

of adults...especially teacher security.

While opponents of school choice have used rhetorical 'okie doke' to convince the public that vouchers are rooted in a racist agenda, proponents and stakeholders offer alternative genesis stories that paint an entirely different picture.

She mentioned the efforts of Nobel prize winner Milton Friedman's proposal for a universal voucher program in 1955 in which parents would be allowed to attend schools of their choice with a voucher.

The nationally recognized economist posited that parents, versus 'educrats,' know what's best for their children.

Fitzpatrick also mentioned the advocacy of Milwaukee Catholic Priest Virgil Blum, founder of the Center for Educational Freedom, who called for a national voucher program during that era.

Fitzpatrick's revelation conflicts with that of Chicago Teacher Union President Stacy Davis Gates, who has come under criticism recently for sending her son to a private school while lobbying against school choice in that educationally distressed city.

Facing criticism for her blatant hypocrisy, David Gates tried to explain her 'choice' by asserting the union opposed school choice because it was conceived by racist southerners following the infamous Brown vs. Board decision of 1954.


She said vouchers were to be used to escape 'integrated' schools.

In a recent television interview, David Gates repeatedly justified her opposition to vouchers based solely on their Southern origins to escape the ramifications of the Brown vs Board decision, which paved the way for school desegregation.

The irony of the Chicago union official's explanation was that the 'racists' in question were actually Southern Democrats.

Today, their political descendants have joined teachers' unions to undermine the program and block the schoolhouse

In her presentation, Fitzpatrick opined that the teacher's unions have largely failed to undermine the school choice program both legally and politically primarily because the majority of Americans—and overwhelming support by Black and low income—support educational

Fitzpatrick and I also agree on why the teachers union's disingenuous and hypocritical opposition has failed to move the public relations needle: Not only have unions been unable to offer mechanisms to improve the quality of education in urban America or close the racial academic achievement gap, they have stood in opposition to every significant reform proposed to address the failing status quo.

The pandemic also put the state and local teachers unions in the hot seat as they refused to

open classrooms to in-person schooling long after suburban districts and private schools par-

ticipated in the choice program. Parents were outraged, and the virtual education template effectively cost the majority of MPS students a full year of scholarship.

She acknowledged that opposition provided a negative "backlash," which continues to reverberate today.

While Fitzpatrick's research provides a comprehensive picture of the origins and benefits of school choice, her presentation lacked a human face.

Equally important, she did not secure an opportunity to interview the late Polly Williams, the author of Milwaukee's program, which has grown into the largest in the country.

Nor did she include a history of Black Milwaukee's decadesment school system---Milwaukee Public Schools (MPS).

City to No Longer **Collect Holiday Trees Curbside: Additional Drop Sites Offered**

The City of Milwaukee Department of Public Works (DPW) is modifying its management of discarded cut Christmas trees this holiday season in order to comply with a changed state requirement.

Historically, Milwaukee residents have been encouraged to take trees to the Drop Off Centers to be managed along with yard waste but have also had the option to dispose curbside as a bulky item collected by garbage crews.

The Wisconsin Department of Natural Resources (DNR) recently revisited its longstanding interpretation that previously deemed Christmas trees as a household decoration.

Instead, the DNR has clarified that it now considers holiday trees to be yard waste and thus subject to the State's yard waste landfill ban.

Communities are expected to manage them ac-

The City of Milwaukee provides the opportunity

to drop off yard waste year-round through its Drop Off Centers. Seasonal brush collection does not operate from December through March, so residents will be required to drop off their discarded trees or make other arrangements instead of receiving a curbside collection option from the City.

Artificial trees will still be collected curbside at the garbage collection point.

New this holiday season, DPW will provide additional temporary locations for residents to drop off cut Christmas trees to supplement the two Drop Off Centers.

The temporary sites will be open from January

11th to 15th, 2024. Please note that staff will not be on-site to assist with unloading trees or placing them in the collection area. All decorations must be removed. Trees col-

Much of Trump's and his allies' retribution' can be found in a plan that has been dubbed, 'Project 2025,' which is comprised of 75 groups in a collaboration organized by the Heritage Foundation.

According to Wikipedia, Project 2025 is a plan to reshape the executive branch of the United States federal government in the event of a Republican victory (Trump or no Trump) in the 2024 U.S. presidential election.

But, the plan is crafted to support the agenda of Trump.

The Heritage Foundation is an activist American conservative think tank based in Washington, D.C.

Founded in 1973, it took a leading role in the conservative movement in the 1980s during the presidency of Ronald Reagan, whose policies were taken from Heritage Foundation studies, including its 'Mandate for

Called "the manifesto of the Reagan revolution," Mandate for Leadership is a series of books published by the Foundation that are guidelines for reducing the size and scope of the federal government through specific policy recommendations.

In total, Project 2025 runs to more than 900 pages, with contributions from over 30 authors.

More than 50 conservative-leaning campaign groups, think tanks, educational institutions and publications are listed on its advisory board, including the Claremont Institute, Young America's Foundation and the Defense of Freedom Institute.

Project 2025 leans heavily on what legal scholars refer to as a 'unitary executive theory,' which suggests that Congress cannot limit the president's control of the executive branch

But critics of that theory, like Columbia University law professor Peter Strauss, believe that this way of thinking is a fundamentally misguided—and limited—interpretation of the Constitution.

"The Constitution can only properly be understood as making the president the overseer of the government that Congress creates, not its commander," Strauss said.

"The president is the commander of the military, but the power explicitly defined for him over ordinary

domestic government is much less."

Ultimately, the fear is that applying the unitary executive theory in this way would usher in a return of a political spoils system and lead to the development of an autocracy, in which one ruler has absolute power.

The Project 2025 team that put the new mandate together was created and led by Paul Dans, director of the Heritage Foundation.

The plan includes draft executive orders that would deploy the U.S. military domestically under the 'Insurrection Act,' according to a person involved in those conversations and internal communications reviewed by the Washington Post.

Last updated in 1871, the Act authorizes the president to deploy the military for domestic law enforce-

Acting like Robin Hood in reverse, Trump wants to rob funding from programs that help those in the greatest need to fund massive tax cuts for the rich, who already are paying less than their fair share thanks in part to tax cuts he signed as president.

To cite just a few of many other examples, based on what Trump has indicated he wants to do:

Trump wants to end civil service job protections for many career federal employees so he can replace them with political appointees willing to do whatever he orders. About 18% of the nearly 2 million federal civilian employees are Black.

The former president wants to slash environmental regulations that protect our health and protect us against climate change, and instead increase domestic oil, natural gas and coal production.

Women's reproductive rights could be further eroded following decisions by even more Trump appointees to the Supreme Court.

This is just a partial list.

Surprisingly, Trump holds narrow leads (often within the margin of error) over Biden in polls. A lot can change, of course, but the race will be won or lost on the margin in several key battleground states.

Even more surprisingly, Trump is doing better among Black voters in early polling than he did in the 2016 and 2020 presidential races. A series of New York Times polls in November found that 22% of Black voters in six battleground states said they would vote for Trump for president. That's a lot less than the 71% support Biden received in the

polls, but more than the 12% of the Black vote Trump received in 2020. Why is Trump doing so well?

The former president is a first-class con artist and reality TV star. He's a great entertainer and knows how to capture public attention like no one else. Scandals that would force any other politician into retirement only make Trump stronger with his base in the Republican Party.

The media are so used to Trump lying and making outrageous comments that they don't adequately expose the craziness of what he says. At the same time, reporters examine every word that Biden utters under a microscope for the slightest imperfection.

One of Biden's biggest weaknesses is that he is 81, and Trump keeps harping on that to portray Biden as senile, feeble and incapable of governing. This is a blatant lie. I've seen Biden up close and personal as well as on TV, and I know many of the people who work with him. He's mentally sharp and has extraordinary knowledge and unparalleled experience that make him an outstanding president.

At 77, Trump is almost the same age as Biden. If you watch him as he rants and raves while rattling off his many grievances, it's clear that he's the candidate clearly past him prime and unfit to be president again. He cares only about basking in fame, enriching himself, and now escaping prosecution and a possible prison sentence by becoming president again.

The American people must open their eyes, remember the bad old days under Trump, learn about his plans for the future, and reject his effort to lead us to another four years of his chaotic, uninformed, in-

Dressing up for the doctor: Many people of color say it's a must!

A new survey of patients that reaffirms the prevalence of racial discrimination in the U.S. health system.

Many people from racial and ethnic minority groups brace themselves for insults and judgments before medical appointments, according to a new survey of patients that reaffirms the prevalence of racial discrimination in the U.S. health sys-

The KFF survey of nearly 6,300 patients who have had care in the past three years found that about 55% of Black adults feel they have to be very careful about their appearance to be treated fairly by doctors and other health providers. Nearly half of American Indian, Alaska Native, and Hispanic patients feel similarly, as do about 4 in 10 Asian patients.

By comparison, 29% of white people surveyed said they worried about their appearance before appointments.

"In 2023, the notion that any person must prepare for discrimination is sad on one hand and angering on the other," Burgess Harrison, ex-

ecutive director of the National Minority Health Association, wrote in an email. "The stress that this causes, in addition to whatever health issue involved, is crazy."

Discrimination has long been a concern for both patients and health providers in the U.S., where racial disparities in health outcomes are vast and particularly unfavorable toward Black people.

A 30-year-old Hispanic man in Illinois who responded to the KFF survey told researchers he wears clothes

to health care appointments with the logo of the university where he works. He noticed, he said, that when they know he is a professor, health care providers listen to him more intently and involve him more in care decisions.

A 44-year-old Asian woman in California told the researchers that her white male doctors ignored her concerns about breathing issues, telling her she "was probably just thinking too hard about breathing." She was later diagnosed with asthma.

The two respondents were not identified in the study.

The survey offers "a way to actually quantify what those experiences are with racism and discrimination, and the multitude of ways they then impact people's lives," said Samantha Artiga, director of KFF's racial equity and health policy program.

"For folks who have been following these issues for a long time, the findings are not unexpected," she said.

Other findings:

A third of adults reported at least one of several negative experiences with a health care provider in the past three years, such as a professional assuming something about them without asking, or suggesting they were to blame for a health problem.

Nearly a quarter of Black adults, 19% of Alaska Native and Native American adults, 15% of Hispanic adults, and 11% of Asian adults said they believed they endured negative treatment because of their race or
