TOGETHER WE ARE THE DREAM:

Unpacking Dr. King's Dream - Equality to Economic Justice, Are We There Yet?

to speak at a Martin Luther King Jr. celebration in North Georgia. The theme was "Together We are the Dream," and, when I first heard it, it felt good.

That's the ideal. We need to be Dr. King's dream.

But I became confused. The topic didn't sit right with me. "Together We are the Dream" made me uncomfortable.

So, I asked myself, what was Dr. King's dream anyway?
In August of 1963, at the

March on Washington, he said:
"I have a dream that one day
this nation will rise up and live
out the true meaning of its
creed: We hold these truths to
be self-evident, that all men are
created equal... that every hill
and mountain shall be made
low... and the glory of the Lord

shall be revealed, and all flesh shall see it together."

Well, there it is! That should answer my question.

But are we there yet? Everyone knows that Dr. King gave his most famous speech at the March on Washington.

What we often overlook is that the March was actually called the "March on Washington for JOBS and Freedom."

The point of the March was to demand equal access to employment for all.

Dr. King wasn't using metaphors and rhetoric in his speech just to make us feel warm inside. Dr. King wasn't just talking about social justice and the right to sit at a lunch counter. Martin was talking about MONEY.

When Dr. King shared his dream, he wasn't just talking

about the ability to use the water fountain or sit on the bus; he was talking about the right to rise out of poverty, to get a good job, and to buy a house.

It is much easier – cleaner –

to remember King's narrative as

one that begins with the Montgomery Bus Boycott and ends, victoriously, with the passage of the Civil Rights Act in 1964 and the Voting Rights Act of 1965.

This is what made him a hero

This is what made him a hero to all of us. But his career as a theologian and activist is much more nuanced.

It was when he began to speak about economic injustice that it cost him his life.

So, are we together? Since the March in 1963, have we become the Dream?

The U.S. FDA recently issued a ruling on menthol cigarettes that prohibits the manufacture and sale of menthol cigarettes in the United States, an action research estimates found could save up to 654,000 lives, including more than 238,000 Black Lives over the course of 40 years.

The ruling is a step towards righting the historic wrongs of the tobacco industry against African American communities, which it targeted for decades with its deadly menthol products. But, as also evidenced throughout history, the tobacco industry does not plan to go down without a fight. It's wielding its many resources to wage a campaign of misinformation related to the menthol ban, including that it will result in the "over policing of the Black community. In other words, "targeting."

It's downright shameless that an industry which still targets the Black community, is warning those same communities that they in fact, will be targeted when menthols are removed from the market. No one should ever mistake the tobacco industry as a trusted messenger.

The successful campaign they wielded to push menthols in Black communities resulted in tobacco being a major contributor to the three leading causes of death for African Americans: heart disease, cancer, and stroke, with 45,000 dying each year from smoking-related deaths.

The truth is, the FDA has said that it can't and won't enforce the ban against individuals who smoke or possess menthols. Saying the ban will result in over-policing is an example of the tobacco industry exploiting real issues in the community related to police brutality and mass incarceration. The fact of the matter is that the menthol ban will save countless lives, including those of our friends, loved ones, and future generations.

During his short life, **Dr. Martin** Luther King Jr. stepped on all kinds of powerful toes in his fight for civil rights, and he was a courageous and determined leader who refused to let prison or violence sway his end mission. He also never lost sight of the fact that civil rights—addressing racial and economic injustice—were inextricable from peace.

As the leader of the Southern Christian Leadership Conference (SCLC), King led a nonviolent movement to abolish the triple evils crippling American society: racism, poverty, and militarism.

Associates said he believed those forces were contrary to God's will for humanity and that they could only be opposed by a religious vision of nonviolent social change.

In April of 1967, King spoke publicly against the war in Vietnam.

Today, as the nation observes Dr. Martin Luther King Jr. Day, civil rights activists, including those who knew the slain leader, offered their thoughts on what his position might be on conflicts in the Middle East and Russia and on the twice-impeached and four-times indicted former President Donald Trump.

"At the March on Washington in 1964, Dr. King talked about Alabama Gov. George Wallace having his lips dripping with interposition and nullification," said the Rev. Peter Johnson, who began working for the Congress of Racial Equality in Plaquemine, La., and later was recruited by Andrew Young to work for King in the Southern Christian Leadership Conference in Atlanta.

"What's the difference between George Wallace and Donald Trump? You're not going to hear Trump publicly say the n-word, that's the only difference," Johnson remarked.

"King would easily have seen that Trump is a bigot in the true sense of the word who actually believes he is superior to people of color."

Johnson and others said the

"[Israel's Prime Minister] Benjamin Netanyahu is on the wrong side of history," legendary civil rights leader the

Rev. Jesse Jackson told the Black Press. "What led up to Oct. 7 (when Hamas attacked Israel) is the issue, not what happened on Oct. 7." Jackson, like he said King would have, decried the mass killings taking place in the Middle East and the war strategy occurring in Ukraine.

"Those captured," Jackson demanded, "should be allowed to go home under the supervision of the United Nations and anyone tried should be done so in the World Court."

Jackson noted that King spoke of a deeper malady in American society. His view was that presidential administrations have been embroiling themselves in conflicts across the globe for the wrong reasons.

"Dr. King was outspokenly anti-war and anti-racism," said Rev. Mark Thompson, a civil rights leader who recently joined the National Newspaper Publishers Association as the trade association's global digital transformation director. "There's no question King would oppose the war in Ukraine and seek diplomatic solutions. I believe he would also call for a ceasefire in Gaza."

Thompson added that the reason for King's cancellation of a pilgrimage to the Holy Land in 1967—one year before his assassination—suggests King had an evolving posture on the Israel-Palestine question. "In canceling the pilgrimage during the Six-Day War, King said, 'I just think that if I go, the Arab world, and of course African and Asia for that matter, would interpret this as endorsing everything that Israel has done, and I do have questions of doubt," Thompson said.

"I believe his posture on Congress's dysfunction would be consistent with the words he used to describe segregationist intransigence in his 'I Have a Dream' speech—interposition and nullification," Thompson declared.

tize your children by calling them out of their

...I've been hearing that term for several years, yet I still need clarification about what it is, who issues it, and what losing it means.

To lose your Black card, I assume, is akin to being tarred and feathered or being labeled an 'Uncle Tom' or 'Aunt Jemimah'.

I'm only guessing because my 'card' has never been threatened since I'm among fellow warriors wearing armor forged in the furnace of civil rights, the Black Empowerment Movement, and cultural advocacy.

My marching shoes are bronzed from too many miles of marching, and my head is covered with a Kufi representing my DNA discovered Motherland tribe, the Mende of Sierra Leone—by way of Nigeria and Kemet.

As such, I don't know what 'punishment' is

appropriate for Neckbones who jeopardize their 'Blackness' by their disregard and disrespect for Black institutions, criminal activity, and cultural impotence. The punishment may include losing pig-

ment, which implies Michael Jackson betrayed our trust when he had his skin lightened. Maybe Barack Obama possesses a caramel card since his mother is white and he was raised in that world.

Does being 'bi-racial' (ethnicity is more appropriate) mean you have only partial rhythm, love county music, and feel comfortable participating in Polka line dancing?

Of course, I'm merely speculating since there's nothing in print about the criteria---a Brothahood/Sistahood Bible--or an annual melanin test.

One confusing reference about losing your 'Black card' is announced during the daily promo for the 'DT and Telly' early morning talk show on the Truth, 101.7.

In that oft-repeated commercial, DT (Denise Thomas) suggests her co-host, Telly (Hughes), is at risk of losing his ('Black Card') based on his response or reaction to her questions.

The promotion suggests if your philosophy or grasp of a topic is outside the box or does not adhere to the Black cultural status quo, you can lose your pigmentation, authenticity, or cultural membership.

The commercial got me thinking that in the world of 'Neckbonology,' you can lose your Black Card by 'acting white.'

That ridiculous affront represents the dis-



ingenuous proposition that if you speak 'proper' English, improve yourself academically and professionally, and act with civility, you are not 'Black.'

Based on that 'Willie Lynch' slave syndrome, which is advanced by community crabs (bottom barrel feeders), there are also degrees of Blackness based on geography, attire, and social status.

If you wear a business suit instead of designer jeans situated six to 10 inches below where the jeans normally rest around the waste, you are not 'Black enough.' Similarly, if you don't smoke weed, you go to church, and have membership in a reading club, you're more chocolate than Black. Moving on up, or over, like the Jeffersons makes you suspect and a traitor to the cause of Black dysfunctionality.

I assume that means the closer you live to dilapidated houses, near a drug dealer, and across the street from an unemployed 'urban terrorist' who somehow can afford to put \$5,000 rims on his \$800 used 'hoopty' (car), the Blacker you are.

I guess that toxic assumption means the higher the weeds on your dirty lawn, the Blacker you are. And each KFC chicken bone found on your dirt lawn is a merit point.

Sarcasm is my middle name, but I am not being entirely facetious when I note many equate 'Blackness' with dysfunctionality. For them---'Neckbones' with minds chained to slavery--- being Black means poor grammar, vulgarity, and an absence of morals, mores, and values.

If I could engineer a Black Card guidebook, it would take on a different color (pun intended), based on the age-old motto that not all skin folk are kin folk, and many of us continue to wear slave chains around our brains, if not our wrists and ankles.

I don't think you should lose your black card because of ignorance or being victimized by educational apartheid. You can, however, lose 'brownie' points if you don't push your children to excel, reach their potential, or seek help if you can't provide adequate guidance.

That process would be enhanced if you stopped using double negatives, adding an extra 'ed/did' at the end of words like "I liked-did it," and refrained from using profanity around your kids.

I would raise the interest rate on your Black Card if you (as a Black woman) refer to yourself as a 'bitch' (b-word) or 'nigger'/'nigga' (n-word).

The Black Card Bureau will be notified if you don't see the harm in throwing your drive-through garbage out your car window, driving through funeral possessions, or disregarding stop signs and lights.

Urban terrorists and reckless drivers need not apply for a card.

Your card should be suspended indefinitely if you don't attend parent-teacher conferences for your high school child who reads at a fourth-grade level, you don't monitor your child(ren's) homework, nor motivate them for success in life.

You likewise lose your card if you don't vote in a local, state, and national election, trauma-

names ('dumb heffer,' 'little nigra' (n-word), or fail to discipline them.

Likewise, you are responsible if your child starts school without knowing how to count, recite the alphabet, or identify primary colors. You, thus, should have your card suspended until you take parenting classes.

Your Black Card would be cast into the lake or sewer if you smoke weed In front of, or with, your offspring, accept stolen (or expensive) gifts from them, or close your eyes when they leave your house with a gun in their laylowing pants.

The same categorization applies to those who take pride in their ignorance, sisters who only see their lives through the prisms of single motherhood, or 'sperm donors' who think being a father is showing up at a birthday party with a \$300 pair of tennis shoes for a six-month-old.

Of course, another side of the 'depigmentation' paradigm must be more transparent.

Most Black 'gatekeepers' would declare Texas state Representative Wesley Hunt, a Black Republican who is campaigning for Donald Trump, a sellout and thus has lost his 'Black Card.'

That's a sticky proposition in that merely being Republican in a two-party system in which neither party prioritizes Black empowerment is disingenuous at best.

It also sparks the question of whether President Joe Biden can determine who can possess a Black Card, as he did with talk show host 'Charlemaine Da God' before the 2020 election?

If you recall, Biden asserted Black folks who didn't vote for him are not truly Black, and their Black Card will be repossessed by the IRS or FBI.

Through my Black Nationalist lens, we will never achieve our goals if we continue blindly following either party and dismiss the reality that we must break the political chains and start our own political party. Nor will we reach the mountaintop if we continue down this path of cultural dysfunction and social chaos.

In other words, even the good brothers and sisters are not entirely 'Black.'

The bottom line is most of us could use some cultural Opzelura---the pigmentation cream being advertised on late-night television--because we all fall short in one area or another with our 'Blackness'.

(continued from page 2) get a callback for a job opportunity than a black applicant.

- In 2019, black homeownership was at about 40% while white homeownership was at 73%.
- In 2019, the wealthiest ten men in the United States added \$347 billion to their net worth while eight million more people fell below the poverty line.
- In 2022, women earned only eighty-two cents for every dollar that a man made.
- The federal minimum wage has been \$7.25 since 2009! Fortunately, twenty-five states are raising the minimum wage this year. There's a little more togetherness.

There are bright spots in the data, but we are not yet together, and we cannot yet say that we are the Dream.

King's focus on economic justice challenged the foundation of the American economic system. He argued for a rethinking of how the American economy works.

For example, today Dr. King would have supported innovation like the AmeriCorps program, which creates government-funded jobs that

enhance the social order, or the Universal Basic Income programs that cities such as Rochester, NY, and Durham, NC, are piloting.

King wanted to give every American the opportunity to earn a living and contribute to this nation through the dignity of their work.

The complete interpretation of King's dream includes not only the idea that one day "little black boys and black girls will be able to join hands with little white boys and white girls as sisters and brothers" but also that those same young adults will have a level playing field when it comes to accessing opportunity and creating stable lives for their families.

King not only wanted equal justice under the law; he wanted equal prosperity under the law too. Martin wanted jobs AND freedom!

In this regard, we are not together.

So how do we come together

to become the Dream? Today Dr. King would remind us that black and white is not the problem, poverty is.

He would remind Christians that Muslims and Jews aren't the problem and insist that only if we are together can we become the Dream.

He would remind us that
American ideals and values
must be made available to all
of us. That's the only way that
we'll ever be able to say that
Together We are the Dream.



OPINION: Today's conservatives would have vilified the real Martin Luther King Jr. for fighting for everything they hate. BY MICHAEL HARRIOT

On June 2, 1959, 30year-old Morehouse alumnus Martin Luther King Jr. returned to his alma mater to give a keynote that would have today's Republicans bursting into a puddle of white tears.

Although Dr. King was already known as one of America's most gifted preachers, he eschewed his sermonic style to construct an address that didn't contain a single

Instead, he leaned heavily on a colloquialism that was well-known in the community in which he served. Nearly three years before writer William E. Kelly's New York Times article on a "negro idiom" exposed white America to the term, King debuted an early version of a speech that he would give more frequently than any

"[T]he great question facing us today is whether we will remain awake through this worldshaking revolution and achieve the new mental attitudes which the situations and conditions demand," explained the young minister. "...

This is particularly true for those of us who are emerging from the yoke of oppression as a result of the present revolution. If we allow ourselves to be content with sheer mediocrity, we will be sleeping through the at a time when we should be fully awake."

While King liked the "Remaining Awake Through a Great Revolution" speech so much that he recorded it as an album, Ron De-Santis would have banned it for making white people uncomfort-

The Florida governor would've probably felt personally attacked when King said, "Let nobody fool you, all of the loud noises that we hear today in terms of 'nullification' and 'interposition' and "massive resistance' are merely the death groans from a dying system."

King's fight against "the perpetrators of the evil system that existed so long" would have been outlawed by DeSantis' lawyers, who defined "woke" as "the belief there are systemic injustices in American society and the need to address them." What kind of person would blame white people for institutional racism?

Nikki Haley would've likely called King a "Democratic plant" if she heard the 1965 version that mentioned 1619 and slavery.

Christopher Rufo would've labeled King a communist for the rendition of the speech because it sounded a lot like critical race

Even moderate Republicans (if they actually exist) would have condemned King for believing in the myth of systemic racism and calling for reparations. And, of course, King was always bringing up America's past.

"America must hear about its sins because we will never understand what is happening in this country today without understanding that we are now reaping the harvest of terrible evil planted by seeds centuries ago," King explained. "Yes we were given emancipation but no land to make it meaningful.

And you know what? At that same time, America was giving away millions of acres of land in the West and the Midwest.

It was said the nation was willing to undergird its white peasants from Europe with an economic

Yet it would not do it for those who had been in the land, brought here in chains for 244 years so emancipation for the negro was freedom to hunger."

Only a race-baiter would say something like this:

"In their relations with Negroes, white people discovered that they had rejected the very center of their own ethical professions. They could not face the triumph of their lesser instincts and simultaneously have peace within.

"And so, to gain it, they rationalized—insisting that the unfortunate Negro, being less than human, deserved and even enjoyed second class status...

"White men soon came to forget that the Southern social culture and all its institutions had been organized to perpetuate this rationalization. They observed a caste system and quickly were conditioned to believe that its social results, which they had created, actually reflected the Negro's innate and true nature."

— "Our Struggle," April 1956

Today, as Americans honor America's most celebrated civil rights icon by twisting him into a series of conveniently comfortable aphorisms, we must remember that white Americans disliked King as much as they currently dislike CRT, DEI, BLM and all of the Marxist, anti-white three-letter cusswords that white America has redefined.

A 1964 poll revealed that a majority of white New Yorkers felt that the civil rights movement had 'gone too far."

A 1965 Gallup poll found that 85% of Americans believed that communists were involved in the civil rights movement. By 1966, only 35% of white Americans believed that King "helped the negro cause," while 50% believed he was "hurting" it.

King wouldn't be surprised by a June 2023 CBS poll that found most white Americans want to abolish affirmative action programs. That's exactly why he said: "We must also realize that privileged groups never give up their privileges voluntarily.

If we are victimized with the feeling that we can sit down comfortably by the wayside and wait for the white man to voluntarily give us our justly deserved freedom, we will be the victims of a dangerous illusion, which can only end up in tragic disillusion."

When Operation Breadbasket suggested an early version of affirmative action to "negotiate a more equitable employment practice," conservatives would have called it

reverse racism.

He surely would've been met with the phrase "not all white people ..." when he said: "He who passively accepts evil is as much involved in it as he who helps to perpetrate it.

"He who accepts evil without protesting against it is really cooperating with it."

They would've hated that guy. Four days before a white suprem-

acist snuffed out the life of the man who the Christian right had turned into a communist, un-American boogeyman, King decided to sprinkle a few Bible verses into his trusty speech and gave it one more shot.

In the last Sunday sermon he would ever preach, King gave the most complete version of "Remaining Awake Through a Revolution." It was longer than "I Have a

Dream" and the "Mountaintop" speeches combined. King explained that battling in-

justice would cause some Americans to lash out against those fighting to live in a free country.

"I say to you that our goal is

freedom, and I believe we are going to get there because however much she strays away from it, the goal of America is freedom,'

"King preached, before revealing the reason why he believed conservatives' beta version of the anti-woke movement was doomed.

"Before the Pilgrim fathers landed at Plymouth, we were here. Before Jefferson etched across the pages of history the majestic words of the Declaration of Independence, we were here.

"Before the beautiful words of the "Star Spangled Banner" were written, we were here. For more than two centuries our forebearers labored here without wages.

"They made cotton king, and they built the homes of their masters in the midst of the most humiliating and oppressive con-

"And yet out of a bottomless vitality, they continued to grow and develop. If the inexpressible cruelties of slavery couldn't stop us, the opposition that we now face will surely fail.

"We're going to win our freedom

And so, however dark it is, however deep the angry feelings are, and however violent explosions are, I can still sing "We Shall Over-

We shall overcome because Carlyle is right—"No lie can live forever.' We shall overcome because Wil-

liam Cullen Bryant is right— "Truth, crushed to earth, will rise again."
