## Three Black U.S. Army reservists killed in drone attack near Syrian border

Three Black American reservists from the 926th Engineer Brigade, based at Fort Moore, Georgia, lost their lives in a drone attack on a U.S. base near the Jordan-Syria border. Pentagon Deputy Press Secretary

Sabrina Singh identified the fallen soldiers as Sgt. William Jerome Rivers, 46, of Carrollton, Georgia; Spc. Kennedy Ladon Sanders, 24, of Waycross, Georgia; and Spc. Breonna Alexsondria Moffett, 23, of Savannah, Georgia.

The tragedy occurred at the logistics support base at Tower 22 of the Jordanian Defense Network, where approximately 350 U.S. Army and Air Force personnel are stationed. That base plays a crucial role in providing support

for the coalition's efforts against ISIS, according to Central Command.

The attack marks the third drone strike on the outpost in the past six months, with the first two occurring in the latter half of the previous year being unsuccessful. Lt. Gen. Jody Daniels, chief of the Army Reserve

and commanding general of the U.S. Army Reserve Command, said the murders of the three Black reservists cut deeply.

The U.S. government has determined that Iran was responsible for the attack, prompting President Joe Biden to vow a response. "There will be a response," Biden declared.

"We will never forget what Sergeant Rivers and his fellow fallen soldiers, Spc. Kennedy Ladon Sanders and Spc. Breonna Alexsondria Moffett, gave for our nation. May their memory live on in our continued service to our military families."

Sanders' parents shared that she volunteered for deployment to experience different parts of the world. With a history of military service in the family, Sanders had previously deployed to Djibouti and later volunteered for Kuwait, including a stint in Jordan near the Syrian border.

Rivers enlisted in the Army Reserve in 2011 as an interior electrician, according to the U.S. Army Reserve Command Public Affairs

He served "with courage, honor, and a deep sense of duty, embodying

the best of New Jersey and our nation," said Sen. Cory Booker (D-N.J.). "His death is a profound loss to his family, friends, colleagues, and our entire country, and a reminder of the heavy debt we owe to our military families for their sacrifice."

Each week seems to bring a fresh headline featuring a dog attack, stirring public debate and concern.

This trend has led authorities in recent years to implement breed-specific legislation, with measures that often include bans or severe restrictions on certain breeds, notably pit bulls, rottweilers, dobermans, and other large breeds.

These laws have sparked a counter-argument among large breed enthusiasts who contend that it's not the dogs that are inherently dangerous, but rather the training and treatment they receive from their owners.

In response to this debate, movements advocating for responsible dog ownership have gained momentum across the country, presenting a humane alternative to breed-specific

A California personal injury law firm, Bisnar Chase, undertook a comprehensive study to examine this contentious issue.

Their goal was to gauge whether public skepticism is directed more towards the socalled 'dangerous' breeds or the owners who may fail to provide proper training.

They surveyed 3,000 people,

asking them to reflect on their personal encounters and identify the dog breed owners in Wisconsin they find least trustworthy.

Public Perception Rankings: The Breeds and Their Owners

**#1 Pit Bulls:** Topping the list, Pit Bull owners are perceived as the least trustworthy in Wisconsin, a stigma fueled by media portrayals and controversial headlines.

However, advocates argue that pit bulls can be among the most loyal and affectionate breeds when raised in a loving environment.

**#2 Rottweilers:** The second least trusted dog owners are those who own rottweilers. Owners of this German breed are often met with skepticism.

Despite the breed's capacity for loyalty and guardianship, the imposing nature of rottweilers can be intimidating if not paired with rigorous and consistent training.

**#3 Wolf-Hybrids:** Landing in 3rd place are owners of wolf-hybrids.

Known for their close genetic ties to wild wolves, these canine owners face skepticism due to the unpredictable nature often associated with these animals.

The debate continues on whether their wild instincts can be entirely domesticated.

#4 German Shepherds:

German Shepherds are fourth on the list among Wisconsinites, which may surprise some

given their esteemed role in

police and service work. Nevertheless, the breed's strong protective instincts can be misinterpreted as aggression, highlighting the need for thorough training and socialization.

#5 Bullmastiffs: Known for their strength and protective nature, Bullmastiffs can be gentle giants under the guidance of a firm, caring owner.

#6 Siberian Huskies: Taking the sixth spot, Siberian Husky owners often face trust issues from the public, largely due to the breed's independent nature and resemblance to wolves.

Owners must actively work to channel the breed's energy and intelligence in positive ways.

**#7 Doberman Pinschers:** In the seventh position, Doberman Pinschers and their owners are often viewed warily.

Historically bred for protection, these dogs can exhibit a powerful presence that demands an owner who is committed to their disciplined training.

**#8 Boxers:** At eighth, boxer owners are often perceived as having their hands full managing the high energy and playful antics of their pets.

While boxers are generally friendly, their boisterous behavior requires dedicated training to manage effectively in public spaces.

**Photo courtesy of Google** #9 Akitas: Akitas carry a noble stature and a reserved temperament, and while they can be fiercely loyal, they require an owner who understands the nuances of the breed to prevent aggressive tenden-

cies. #10 Alaskan Malamutes: Similar to Siberian huskies in their thick fur and robust build, Alaskan Malamute owners are challenged to meet their high exercise needs, often a point of contention for those unfamiliar with the breed.



## **DHS** Encourages Pregnant Wisconsinites to **Get RSV Vaccine**

Vaccine can protect babies from serious illness

With cases of Respiratory Syncytial Virus (RSV) rising across Wisconsin, the Department of Health Services (DHS) is urging pregnant Wisconsinites to get the vaccine to protect their baby from the virus.

As of January 10 there have been 1,402 people in Wisconsin hospitalized with RSV this season, 580 of those are children

The RSV vaccine Abrysvo can be given to people who are pregnant between 32 weeks and 36 weeks and 6 days of pregnancy and provides protection for newborns until they are 6 months old.

The vaccine was approved for use in 2023 and is safe and effective. People who are pregnant should ask their health care provider if they can get the vaccine.

"This RSV vaccine provides protection to the infant for the first six months after they are born," said DHS Respiratory Disease Epidemiologist Tom Haupt. "That provides the baby protection at a time when they could be vulnerable to serious illness."

A different option to protect infants is a monoclonal antibody shot (nirsevimab). Children under 8 months of age can receive nirsevimab, but it is important to know that nirsevimab is currently in limited supply.

This is why it is especially important for people who are pregnant to get the RSV vaccine, which is readily available, to ensure their infants are protected.

The RSV vaccine is also available to all adults aged 60 and older. There are two RSV vaccines available for this age group: Arexvy and Abrysvo. Both vaccines are safe and effective.

Aging and older adults, individuals who are pregnant, and new parents should contact their health care provider to determine it RSV vaccination or preventive treatment is recommended for them or their infant.

In addition to the RSV vaccine, DHS urges everyone 6 months and older to get the flu vaccine and updated COVID-19 vaccine.

This is especially important for people who are at greater risk of becoming seriously ill, this includes those who are pregnant, age 65 and older, and those with chronic health conditions. Wisconsinites can find locations offering the flu and COVID-19 vaccine by visiting vaccines.gov or calling 211 or 877-947-2211.

Besides vaccines, there are steps we can all take to help stop the spread of germs and viruses:

- Wash your hands often with soap and water for 20 seconds.
- Avoid touching your nose, eyes, and mouth.
- Stay home and away from others if you feel sick.
- Avoid being around others who are sick or have respiratory illness symptoms.
- Cover your nose and mouth when you cough or sneeze and encourage children to do the same.
- Wear a high-quality mask around others to prevent the spread of respiratory illnesses.

My heart skipped a beat when I received the press release announcing state Senator Lena Taylor had been appointed by the governor to fill a vacancy on the Milwaukee Circuit Courts.

The heart palpitation wasn't rooted in a lack of appreciation; I was elated that a sister of Lena's talents, perspectives, and commitment to social justice would serve the people as a jurist.

But my elation was tempered with a sense of anxiety with the realization that we have simultaneously lost one of the most influential voices in our Black political circle.

Lena was 'the' spark plug, the tree shaker at both the state and local level. She is/was a forceful advocate who frequently—and to the dismay of the political status quo—brings to mind the Robert F. Kennedy quote that posits: 'instead of asking why, ask why

Lena was also a thorn in the side of the state Democratic Party's status quo, initially prompting me to question Governor Tony Evers' 'true' motivation in making the appointment.

Was it to diversify the courts with a qualified African American jurist? Or was it to remove the prickly needle in the butt of the Democratic Missionary Machine network?

Some believe-myself included---that Evers followed the stratagem used by Milwaukee Mayor Chevy Johnson when he appointed his top critic, Ashanti Hamilton, to a position outside the political arena.

While Lena hasn't targeted the governor as much---at least not publicly—she has not been as civil with other members of the Madison Missionary Mob (MMM or 'M3'). As history has repeatedly advised, challenging the 'great white hopes' by putting our interests before their agenda will generally result in a significant 'backlash' (pun intended).

We should never forget what the MMMs did to the late Black Nationalist and fiery state Rep. Polly Williams for daring to challenge educational apartheid and, thus, the control of the teachers' union over the Dem Party.

Polly took on the role of Harriet Tubman, not only in hue and mission, but fighting the same Democrats who, 70 years ago, literally and figuratively blocked the schoolhouse door. Check your history; those were Southernfried 'Demo-rats'!

They did everything but tar and feather Polly as she exposed her party's 'true' agenda.

S.C., professed his love for Donald Trump while stumping in New Hampshire, Black leaders say the Republican Party's highest-ranking Black man is an embarrassment to the Af

rican American community.

"There are few moments in my life I've been more embarrassed than to watch Tim Scott," the Rev. Al Sharpton said on MSNBC of Scott's remarks at a Tuesday night Trump campaign event. He added, "It was humiliating to watch what Tim Scott did as a sitting

After giving brief remarks at the victory rally, Scott interrupted Trump when the former president and leading 2024 Republican candidate jabbed at his remaining opponent, Nikki Haley, the former South Carolina governor who appointed Scott to the Senate in 2012.

"You must really hate her," Trump said after pointing out the irony that Scott endorsed him over Haley despite that appointment and their South Carolina connection. The senator quickly jumped to the mic to respond, saying with a wide smile, "I just love you."

Sharpton said, "It's not a good day in my life to watch him do that." The civil rights activist continued, "We fought to see people like him, Black, become a high elected in the South.

do Donald Trump," said Sharpton, who does not personally align with Scott's politics. "But to do it in such a way that is so humiliating was troubling."

Seawright, who serves as an adviser to longtime Rep. James Clyburn, D-S.C., said that when the senator had a chance during Trump's presidency to "strongly disagree on issues that matter to our community" or "highlight where there has to be some separation from white supremacy, white nationalism, Christian white nationalism, bigotry, and hate," Scott "didn't take the oppor-

"If you love Trump, then that means you love Trumpism and all the things that come along with Trump," he argued. "Those things don't align historically with those who look like us."

He added, "At some point, values have to matter." Angela Angel, senior adviser at Black Lives Matter PAC, said of Scott: "All skinfolk ain't kinfolk."

"Tim Scott has denied that systemic racism exists, bragged about increasing police funding, and downplayed the impacts of slavery on Black Americans," she

told the Grio. "His latest shuck and jive should come as no surprise. He has clearly shown us who he is.'

Seawright agreed with Sharpton that, as a conservative Republican, Scott has the right to have differing political beliefs. However, he said the senator's latest actions may leave many questioning "where his head and heart really are."

"Tim Scott has enough political cache. He doesn't need to do all that he is doing for the former president. In particular, it's a slap in the face to the former governor [Haley] because he would not be in the U.S. Senate without her," explained the political strategist.

As Trump has demonstrated in his attacks on fellow Republicans who disagree with him, Seawright noted that for the former president, "Loyalty is a one-way

"Trump is OK with Tim Scott as long as Tim Scott is OK with Trump," he contended. "The minute there is a half a degree of separation, then Trump will back the Trump bus up and roll it over Tim Scott like he's done everyone else who has been loyal to him."

After quickly endorsing Trump upon ending his own presidential campaign, Scott ignited chatter that he could be tapped by the Trump campaign to be the former president's vice presidential running mate. Days later, Scott, once a notorious bachelor, announced that he was engaged to marry his girlfriend, Mindy Noce, who only recently had been known publicly.

Seawright predicted that if Scott were on the Republican ticket with Trump, this recent clip of him declaring his love for the former president would become campaign "material" for the Biden-Harris reelection campaign.

He added, "If Tim Scott is on the ticket with the former president as a nominee, I certainly think that not only that clip, but his positions, like a national abortion ban, will become an opportunity for folks to be educated about where he stands."


