BLACK VETS TAP INTO THER 'CHI' WITH THE **SOLDIER TO CIVILIAN** SUNDAY WELLNESS' PROGRAM ATTHE SHERMAN PHOENIX

I was a bit diffident about participating in the Solider to Civilian Sunday Wellness program at the Sherman Phoenix.

While I had agreed to write an article about the health and wellness program geared toward Black veterans, I was cautious about the benefits of chair yoga, breathing relaxation, and healthy food sampling.

You could say I've been there and done that.

I took slow movement and chair aerobics at the Veteran's Administration, and with 40 years of martial arts under my belt--which included breathing exercises to tap into your 'chi'--I thought I knew

We call breathing exercises by another name, but the premise is similar, although we used it in a different application.

But moments into my observations on a bright Sunday afternoon at the Phoenix, watching a dozen Black veterans of varying ages sitting in a fraternal circle, my hesitancy quickly evaporated.

Within 30 minutes, I was hooked.

Maybe it was the sobering voice of group leaders Alahna Taylor and Dr. Robinson or the relaxing atmosphere created by Camille Mays, who operated the singing bowls.

Then again, it could be the sense of comradery among the participants, who ranged from young to mature. Each veteran was a member of a lifelong fraternity of men and women who have often served in horrid conditions or life-threatening scenarios.

This unique brother/sisterhood makes relatives and acquaintances and creates shared memories that transcend time and circumstances. The fraternity of soldiers, sailors, airmen, and Marines is a unique bonding experience that often requires spiritual as well as physical exorcisms.

Given the title, I had mistakenly assumed the participants would be younger vets, many of whom suffer from PTSD or related anxieties born of military experiences, particularly those encountered by war.

Instead, the participants covered a wide range of ages and shared experiences.

As a Vietnam vet, I found it easy to tune into the vibrations of that wave link only military veterans can find on the dial, making it all the easier to appreciate the health session.

PTSD (Post-Traumatic Stress Disease -or Disorder) is incurred when soldiers are placed in positions of witnessing or participating in deadly conflict. But that trauma is often doubted by Black military, who also face racism during their service and discrimination when they return home.

The military is a microcosm of America; in fact, racism is alive and well within military structures, as is blatant sex-

One of the benefits of programs like Wellness Sunday is that it affords African American veterans an opportunity to express themselves—to vent with people who can relate to their unique experiences.

Those shared experiences formed the foundation of the project, explained Taylor, owner of Earth Angel Studios and one of the two 'instructors' for the sessions.

"My studio focuses on nutrition, breathing, and relaxation," she explained, adding the singing bowls therapy, which allows participants to block out the world around them as they focus on themselves.

Mayes provides soothing vibrations through her orchestration of the 'singing bowls,' a technique that entails circling various-sized bowls with an instrument to create different

Mayes said coordinated vibrations are considered a therapeutic form of music used by dozens of cultures but under different names.

She was first introduced to the concept "as therapy for my

son" but has seen the relaxation process expand throughout the community for different audiences. "Still, there are only a handful of (musicians) in our community, but the system is growing," she explained.

Taylor elaborated, explaining that different relaxation techniques have similar impacts. "Color represents a similar process used for relaxation."

At the session I attended, which was led by Robinson, who moved among the circle, encouraging participants to "tap into" themselves and "allow the energy to flow to your muscles," a sense of calm came over the circle, feeding veterans both physically and spiritually.

Ambrose, a breathing instructor for a Black male cancer support group coordinated by the Medical College of Wisconsin, led the team in breathing exercises.

He unexpectedly allowed me to show the different techniques we used in the marital arts. They were easily adapt-

Taylor is also a certified breathing specialist and focuses on chair yoga.

Dr. Stacia Thompson, executive director of Sherman Phoenix, lamented during a telephone conversation that

the Soldier to Civilians platform comfortably fits into the hub's network of programs.

The program is funded by the State Veteran's Foundation for one year.

The foundation offers numerous veterans programs, but this may be one of a handful designed explicitly for Black

The next session is at 1 p.m. on March 17. Chef Nunu will provide a healthy meal.

Trust me, I attended as a journalist but will return as a stressed-out vet.

Sales from vehicles to be illegal along stretch of W. Capitol Dr. starting March 16



Legislation approved last month by the Common Council banning sales from parked vehicles on both sides of W. Capitol Dr. from N. 76th St. west to the city limits takes effect on March 16.

Alderman Lamont Westmoreland, who sponsored the file that was approved by the Council on February 27, said the ban will affect anyone selling food, clothing, or other items from parked vehicles along W. Capitol Dr. in the affected area.

Alderman Westmoreland said the impacted stretch of W. Capitol – located within the 5th Aldermanic District – has traffic safety issues, as well as cleanliness concerns.

"The ban is needed as I continue to work on reducing the amount of litter scattered throughout the city, address parking issues and obstructed vision for motorists to reduce the potential of accidents, as well as eliminate the disruption of walk-in business for our brick and mortar businesses that are along this stretch," he said.

Alderman Westmoreland said he is looking for an alternative location for the food trucks and other peddlers who have frequented the affected stretch of W. Capitol.

"I am studying alternative locations where these operators can flourish, but safety and cleaning up our city is first and foremost.

Vehicles that are selling items along that stretch of Capitol Drive have increasingly affected the quality of life for Milwaukeeans who live in the area, work in the area and operate businesses in the area, and that's why I needed to take decisive action (with the ban)," he said.

Soon, anyone of menstruating age who needs birth control will be able to grab it from the family planning aisle of their local drugstore without a prescription and for less than \$50.

On Monday, the drug maker Perrigo announced that the FDA has approved its product Opill to become the first birth control pill available in stores and online without a prescription in the U.S. when it hits shelves later this month.

According to the release, the progestin-only daily oral contraceptive will be available in drug stores in multiple quantities, including one-month supplies for



\$19.99 and three-month supplies for \$49.99 in stores, and up to six-month supplies for \$89.99 online.

"The availability of an oral contraceptive without a pre-

scription is a truly groundbreaking milestone in reproductive health," Melissa Kottke, an obstetriciangynecologist in Atlanta, said in the release. She added, "Progestinonly pills have been a trusted contraceptive option for decades, yet obtaining a prescription for birth control

# How a colorblind health care system results in Black

OPINION: Inequities in health care — from devices that don't consider darker skin tones to our exclusions from trials and studies — require that we ask questions at every level of our health care system to avoid unnecessary deaths.

Editor's note: The following article is an op-ed, and the views expressed are the author's own.

If you're Black and have ever had a vitamin D test, chances are you've been diagnosed as Vitamin D deficient. And chances are your diagnosis was wrong.

Understanding why so many of us are misdiagnosed re-

quires a broader understanding of the evolution of our health care system and the diagnostic tools it relies on.

You've probably heard about the Tuskegee experiment where the cure for syphilis was withheld from Black men for decades so doctors could study the effects of the untreated disease.

You may also know of the

controversy surrounding the testing of contraception techniques on Puerto Rican women.

These and similar incidents are often cited as catalysts for the distrust Black and Latino communities have for the health care system and our ultimately low enrollment in clinical studies and trials.

However, our exclusion from studies and trials creates a twofold issue. Not only does a patient miss out on the potential outcomes from more advanced treatment options, but our relative exclusion from studies also means we are not adequately represented — or ultimately factored — in the development process for diagnostic tests and treatments; creating opportunities for tests and treatments that are less than optimally effective for Black and brown demographics.

Siemens Healthineers took this issue head-on a few years ago when reviewing its test for preeclampsia.

A team reviewed the study data for that test and discov-

ered that while preeclampsia far disproportionately impacts Black mothers, the population for the study used to substantiate the test's effectiveness was predominantly white. Siemens conducted a new study with a more representative sample and ultimately improved the design and effectiveness of the test for the patients who needed it most.

Which brings me back to your Vitamin D diagnosis. A 2013 study in the New England Journal of Medicine high-(continued on page 8)

pills creates unnecessary barriers for many. Creating additional opportunities for contraceptive access is critical in helping people reach their reproductive goals."

Opill, like many forms of other birth control, is 98% effective when taken as directed, placing it among the most effective forms of birth control available. However, it is not without its risks. Birth control, in general, can come with risks, including the small chance of developing blood clots, especially when the method contains both estrogen and the synthetic hormone progestin.

With Opill being progestin-only, the risk of developing blood clots is lower, thus potentially making it a safer option for those with that concern.

The daily pill should take full effect 48 hours after the first dose. Any potential side

effects could include cramping, headaches, and bloating.

Perrigo officials clarify in the release that Opill is not an emergency contraceptive, like Plan B, and will not prevent pregnancy when used after unprotected sex.

When nearly half of all pregnancies in the U.S. are unplanned, and as more states move to ban vital reproductive health options, Opill hitting the shelves has the potential to impact reproductive health for many.

Perrigo officials said in the release,

"Those who face barriers to initiating use of effective methods and continuing consistent use once started can benefit the most from Opill."

Despite Opill not requiring a prescription, those interested and with further questions should seek the advice of a medical professional.

### Menthol Ban Decision: Data, Not Bias, Should Guide the Way

Having more than three decades of law enforcement experience, I've witnessed the pendulum of justice swing, often disproportionately affecting African Americans. Whether it's addressing sentencing disparities, mass incarceration, or excessive use of force, African Americans bear the brunt of policies resulting in adverse outcomes.

### RACIAL IMPACT STUDY

Before enacting policies with far-reaching consequences, it's essential to conduct racial impact assessments. These assessments show how proposed actions may affect different racial and ethnic groups. Armed with this knowledge, legislators can take steps to mitigate disparities in communities of color.

We are far from being a color-blind society. Racial diversity is the acknowledgment and celebration of differences between racial groups. Diversity recognizes and values differences within as well as between racial identities.

The proposed ban on menthol-flavored cigarettes exemplifies this disparity. While not a ban on cigarettes in general, it specifically targets menthol cigarettes, which are preferred by 81 percent of African American smokers. Such a ban would disproportionately affect African American smokers based solely on their flavor preferences.

To be clear, I am not advocating for smoking, as scientific evidence outlines its health risks. However, I'm advocating for fairness in policy administration regarding cigarettes favored by African American smokers. Menthol, an additive in these cigarettes, lacks evidence linking it to cancer. In fact, menthol is present in various everyday products like breath fresheners, candy, and cough drops, none of which face calls for bans.

Procedural justice is about fairness and transparency of the process by which decisions are made. The core principles of procedural justice include being fair in processes, transparent and trustworthy, making unbiased decisions, and allowing citizens to express their views.

If a law or regulation adversely impacts one racial group, then it is imperative that a racial impact assessment be conducted.

President Obama initiated The President's Task Force on 21st-Century Policing and reported that a positive relationship between law enforcement and civilians is "key to the stability of our communities and the safe and effective delivery of policing services." The pillar of focus here is Building Trust and Legitimacy.

### UNINTENDED CONSEQUENCES OF BAD POLICIES

Historically, in the United States, despite good intent, bans and prohibitions have not worked. The Eighteenth Amendment to the U.S. Constitution declared the production, transport, and sale of intoxicating liquors illegal. The Volstead Act of 1920 provided federal enforcement to investigate the prohibition of the manufacture, sale, or transportation of intoxicating liquors, including beer, wine, and alcohol. Yet,

speakeasy joints and moonshines became prevalent throughout the time of prohibition. Unregulated alcohol became readily available as criminal organizations found ways to manufacture, transport, and sell their illegal products. Consequently, the 18th Amendment was repealed by the 21st Amendment in 1933.

Bad policies, with unintended consequences, have been commonplace in the African American community. In the 1980s and 1990s, under both President Reagan and President Clinton, laws were passed that led to mass incarceration of mostly African Americans and Hispanics. Their crime bills encouraged incarnation, as Congress passed minimum mandatory sentence guidelines, which led to significant mass incarceration.


The crack cocaine versus powder cocaine sentencing disparity resulted in African Americans being sentenced to incredibly lengthy terms of imprisonment compared to their white counterparts who were engaged in powder cocaine use and sales. Although it requires powder cocaine to make crack cocaine and crack cocaine was cheaper, the sentence difference was 100 times greater for crack cocaine than for

powder cocaine. Possession of 5 grams of crack cocaine yielded a 5-year federal sentence, while 500 grams of powder cocaine was required for a similar sentence.

In 1986, before the enactment of federal mandatory minimum sentencing for crack cocaine offenses, the average federal drug sentence for African Americans was 11% higher than for whites. Four years later, the average federal drug sentence for African Americans was 49% higher. African Americans make up 13% of the population but constitute 37% of the prison inmate population.

Addressing issues like tobacco and drug use requires evidence-based approaches and harm reduction strategies, not criminalization. Instead of banning menthol cigarettes, efforts should focus on education, treatment options, and counseling opportunities to support individuals in making healthier choices.

Addressing systemic disparities requires a multifaceted approach rooted in fairness, transparency, and evidence-based solutions. We must strive for policies that promote equity and justice for all communities.



(continued from page 4) lighted a very similar deficiency in the majority of the world's Vitamin D tests, while a 2018 U.S. National Institutes of Health-sponsored expert panel looked at the vitamin D paradox in Black Americans and whether Vitamin D supplements were necessary or even safe — leaving you with questionable medical guidance

If you aren't already, you should be wondering how many more of your lab results fall into this category. How many false positives, or worse, false negatives have you systematically received?

But the problem extends beyond your lab results. In 2022, Apple was sued for its watch's poor pulse oximeter performance with darker skin tones. In this case, Apple reacted to suit with an update to algorithm training sets, augmenting them with a full spectrum of skin pigments, resulting in a better-performing feature for their broad demographic of users. (It should be noted that at the end of 2023, an ITC patent infringement ruling led Apple to remove the pulse oximeter feature from some watch

Unfortunately, we're not always so lucky. What was a great health equity story for Apple, is an alarming story for our nation's hospitals and patients of color. In 2020 during the height of the COVID-19 pandemic, we lost nearly 1,000 people a day in my home state of New York, and Black patients were twice as likely to die once admitted than their white counterparts. At that time, pulse oximeters — the same type of device Apple corrected — were a key device in alerting clinicians that an ICU patient was in distress. The sad truth is that most of those faulty pulse oximeters resulted in delayed or withheld treatments for the Black and Hispanic dying fingers they were attached to every day.

This leads us to one sobering question that we sadly still cannot answer with certainty. How many of those Black and Hispanic patients among those 1,000 per day are dead because the pulse oximeters used to monitor them underperformed because of their darker hues? And how many could be alive if we did something in 2013 or in the 1970s

when we first learned skin pigment could throw off readings?

If the questions leave you with a pit in your stomach (they should), then we should ask these questions at every level of our health care system. Clinicians and hospitals should ask their device manufacturers how they address the effectiveness of their products for the patient demographics they serve. Manufacturers should search the research literature and review study protocols from a modern lens to see if redesigns are necessary. And patients should have honest discussions with their physicians about their concerns.

At moderate levels, no one really suffers from taking Vitamin D supplements. But for every Vitamin D, there is a preeclampsia or a pulse oximeter. If you're like me, you'd rather not wait for the next COVID-19 to highlight the criticality of health equity with unnecessary death.
