

"No matter how people may feel about certain things, crime is down. Crime is down," declared Milwaukee Police Chief Jeffrey Norman during a recent Milwaukee Press Club 'Newsmaker Luncheon' hosted by the Milwaukee Press Club and

WisPolitics.com.

The chief ran down the stats, noting from 2021 to 2022, there was a 15% reduction overall in 'part one crimes' such as homicides, and a six percent reduction in violent crimes.

From 2022 to 2023, there was a nine percent reduction in part one crimes, and a two percent reduction in violent crimes.

But Norman stressed efforts to keep those numbers down don't just fall on the shoulders of police, especially when it comes to youth violence.


"We want the public to know you have a responsibility in this public safety, and we mean it," he told a panel of journalists and audience members at the luncheon, held at the Newsroom Pub, 137 E. Wells St.

The chief acknowledged the uptick in youth crime, but says it's nothing compared to the city's adult criminals, especially those on the roads.

"The biggest drivers of a lot of our speeding and reckless driving (are people) between the ages of 20 and 31," Norman said.

Noting the MPD has partnerships with community organizations to target and interact with young people, such as the Police Athletic League (PAL), the chief made it clear the community also has to do its part to help.

"I'll say this with all types of sincerity. Shame on you if you have not put yourself into the game of this work. There are no bystanders."



Norman also touched on more cost-effective ways to reduce access to guns. "Having that particular conversation and helping with our business community, with the residents. Don't leave your weapons inside your vehicle."

As to securing this July's Republican National Convention, Norman said he is committed to making sure the city will be safe during the RNC. However, he stressed the department needs more funding to pay for the officers putting in the work.

According to Wispolitics, the department is pushing to boost the amount to \$75 million. During the luncheon, Norman said the \$50 million federal security grants provided for cities to host the RNC and the Democratic National Convention for the last 20 years "is not appropriate for the challenges that we have in this day and age."



unanimous passage of MISSING AND MURDERED AFRICAN AMERICAN WOMEN AND GIRLS legislation from senate committee

Editor's Note: This statement from the office of state Rep. Shelia Stubbs, released March 11, has been partially edited for content and length.

Recently, the Senate Committee on Mental Health, Substance Abuse Prevention, Children and Families voted unanimously to pass Senate Bill 568 that will create a task force on missing and murdered African American

women and girls. In the March 6 MCJ edition, we reported (in the article titled: 'Senator blocks task force on missing and murdered African American women and girls,' that Republican state Sen. Duey Strobel of Saukville, who chairs the committee overseeing the legislation, blocked it.

He noted in the article that of the 204 missing persons in Wisconsin listed on the Na-

tional Missing and Identified Persons System, the majority are men.

He added he had a difficult time legislating in a way that government to prioritize justice based on a victims race or gender. Representative Shelia Stubbs, a democrat representing Madison and the lead author of the bill, released the following statement:

Howard University Students Leave Lasting Impact on MKE Community!

For the seventh consecutive year, Howard University has selected the campus of Holy Redeemer Institutional Church of God in Christ as one its Howard University Day of Service (HUDOS) locations.

As part of its commitment to public service, HU students travel the world providing community services to 25 cities internationally.

Since 2017, more than 45 students have chosen Holy Redeemer each year. On Friday, March 8, 60 HU students were in Milwaukee to implant inspiration and foster a collective mindset of the historical and cultural significance of the preservation the

President Joe Biden awards grant to Milwaukee to transform 6th Street into complete street



A Complete 6th Street A TRANSFORMATIVE INVESTMENT FROM NATIONAL AVENUE TO NORTH AVENUE

PROJECT OVERVIEW

The Complete 6th Street project will reconnect several of Milwaukee's historic and diverse communities that have been negatively affected for decades by the impacts of urban renewal and highway construction

The project will transform 2.6 miles of 6th Street from National Avenue to North Avenue, connecting southside neighborhoods like Walker's Point through downtown to northside neighborhoods like Hillside and Halyard Park.

A transformed 6th Street will include safe, dedicated infrastructure for people walking, biking, and taking transit as well as green infrastructure that will provide much needed tree canopy and increased green space.

Informed by extensive, upcoming engagement, the project's design will connect underserved communities through a people-centered corridor that offers cost-effective and climate-friendly mobility options and improves quality of life.

The City of Milwaukee was awarded \$36.56M of Neighborhood Access and Equity (NAE) Capital Construction Grant funding Department of Transportation for transformative, community-driven project.

into a "complete street." In a statement, council members—council President José G. Pérez, alderman Robert J. Bauman and alderwoman Milele A.

Coggsm—thanked the president for recognizing the project, which aims to connect neighboring communities and downtown resources through comfortable, affordable, safe, and sustainable modes of transportation, and a transformed street that enhances

the character of the unique

communities along the corri-

"The 'Complete Streets program' integrates people and places by making it safe, enjoyable, and convenient to walk, bike, take transit, or simply experience our streets and public spaces – no matter one's age or ability," the council's statement read. "The 6th Street project will include a variety of amenities such as enhanced pedestrian crossings, narrowed streets, physically separated bike lanes where feasible, tree-lined medians, an enhanced tree canopy, and more.

"Perhaps most importantly, this project will work to undo the decades of negative impacts from previous highway construction that prioritized car traffic over the experiences of people who live, walk, work, and shop along the corridor."


Unsettled is an intense multi-generational novel set in racially and politically turbulent Philadelphia about a mother fighting for her sanity and survival.

It's probably of no consequence to most Black Milwaukeeans.

Still, a Germantown referendum calling for a tax increase to support the hiring of four new police officers foretells a cultural shift that will undoubtedly have local ramifications.

The referendum notice addresses a 'shortage' of officers to address ever-increasing calls for 'low-level' crimes.

But suppose you read between the lines, or talk to residents. In that case, the 'real' rationale behind the referendum is an increase in crime, specifically related to drugs and retail

As you assess the referendum, consider that the Germantown population has not grown significantly and, in fact, has been capped by legislative decree to maintain a small community-urban/rural-paradigm. What is different is the flood of Neckbone 'visitors' to the area.

Moreover, the 'stress' on policing is a relatively recent phenomenon that coincides with the introduction of retail favored by Black Milwaukeeans,

including the nearest and only movie chain. Marcus Theater --- there are no movie theaters in central city Milwaukee, even though Black Milwaukeeans disproportionately make up their audience.

I frequented that theater but was taken aback to notice it is the only movie outlet with armed sheriff's deputies patrolling inside.

Looking at their stoic faces, I wouldn't be surprised if they searched our popcorn for guns and our overpriced hot dogs for

Also, a court-ordered bus line from Milwaukee to Germantown was created to allow easy access to suburban jobs (since discontinued). It opened the door for a steady flow of Black folks to the suburb.

To be more specific, hundreds of Black Milwaukeeans bypass several of the chain stores (including the Brown Deer location, which witnessed a shooting recently) to spend their dollars (or steal the goods) from the Germantown Wal-

guards have been added, and men's underwear has been put under lock and key.

Yes, that's correct, UNDER-WEAR!...Seriously!

I guess the young thugs who wear their pants under their butt cheeks have to display clear drawers to attract their prey ... Bless their souls.

To be honest, I'm sick and tired of making excuses for the conduct of those who subscribe to the 'Culture of Poverty.' I'm ticked with trying to explain that the subculture doesn't represent the whole, our majority.

I get a break because of my appearance—either wearing a Vietnam veteran's hat in the suburbs or allowing my gray hair to flow in the windwhich disrupts my Flo.

I learned years ago that veterans have a 'get out of jail free card' because we served. Gray means—at least to White folk—that you have earned a level of respect. We survived.

My sons, however, are still followed at many outlying scription (profile)' of the Neckbones who create the chaos.

I taught them not to speed, to keep their license plates up to date, and not to play loud rap music when driving through the burbs.

But that only sometimes works.

And rightly or wrongly, they have been taught to give respect only when it is given. That could lead to WWIII with a racist cop.

Whether you accept it or not, we will all end up paying for the new taxes in some manner. shape or form.

Race relations will suffer. Prejudices will be substanti-

All of us will be suspects until proven innocent. The 'Black card' will be taxed.

Suppose any of that's essential to you. In that case, we can expect a 'backlash' that will fuel hostile relationships that even Biden can't resolve. If it doesn't matter to you, assume it's business as usual.

But don't make the mistake of assuming you can leave the sanctity of the 'hood' without the 'Big Bad Germantown Police Wolf' potentially taking a bite out of you 'as-the-worldturns.' Hotep.

Waves of Opportunity

It's a relatively mild February morning, but Lake Michigan still has that cold look to it.

Carter doesn't see the cold. She sees an opportunity. Opportunity drives Carter as she oversees the Port's \$6.7 million budget and nearly 500 acres.

It's a big piece of land, stretching from the steps of the Milwaukee Art Museum, south past the Lake Express Ferry building, and

west underneath I-794 to Jones Island.

The Port operates as a landlord with tenants that include Cargill Salt and Kinder Morgan. Carter says, "It's daunting, but that's where it's important to remember there's a team."

And Carter is all about teamservice as administrator in For- work. She listens and brainstorms with staff and community leaders This Black History Month we to improve and attract more trains with the backdrop of her historic appointment.

"It's encouraging but also somewhat discouraging, right? Because in 2023 we shouldn't still be having that conversation. But the encouraging part is it allows other young people who look like me who come from the same community that I come from to know that it's possible."

Early Days

This 1995 Marshall High School graduate came from humble beginnings. She grew up in Milwaukee's Washington Park neighborhood, raised mostly by her grandmother Granny Mae. Granny Mae died in 2020 at the age of 96. Carter says she was a great woman who lived a great

"I think the greatest gift she gave me, was introducing me to faith, which is the foundation I stand on for everything."

Carter says faith guides her at shore of Lake Michigan in 1835. it's about what she should say in 2017 overseeing finances and bechallenging situations.

Port of Call

One of the biggest surprises and challenges is getting the word out that Milwaukee has a port, even though the first commercial vessel called on the west

came Port Director six years later.

Carter says, "When I was apwere like 'congratulations, this is great,' but they had no idea we had a Port."

And now, Carter is on a mission to change that by getting the word out about what the Port does and can offer businesses.

Cruising has increased the port's profile by breaking records in 2022 with nearly 14,000 visitors.

WASHINGTON (AP) — Lawmakers, meet your latest lobbyists: online influencers from Tik-Tok.

On Tuesday, some influencers began a two-day advocacy event in support of TikTok, which arranged their trip ahead of a House floor

vote on the legislation on Wednesday.

But unlike a similar lobbying event the company put together last March when talks of a TikTok ban reached a fever pitch, this year's effort appeared more rushed as the company scrambles to counter the legislation, which advanced rapidly on Capitol Hill.

"If they ban it, I don't know what it will do" to the business, Summer Lucille, a Tik-Tok content creator with 1.4 million followers who is visiting Washington this week, said in an interview arranged by the platform. "It will be

devastating." The legislation is drawing unusual support in Congress.

In an unusual showing of bipartisanship, a House panel unanimously approved the measure last week. President Joe Biden has said he will sign the legislation if lawmakers pass it. But it's unclear what will happen in the Senate, where several bills aimed at banning TikTok have stalled.

The legislation faces other roadblocks. Former president and current presidential candidate Donald Trump, who holds sway over both House and Senate Republicans, has

voiced opposition to the bill, saying it would empower Meta-owned Facebook, which he continues to lambast over his 2020 election loss. The bill also faces pushback from some progressive lawmakers in the House as well as civil liberties groups who argue it infringes on the First Amend-

TikTok could be banned if ByteDance, the parent company, doesn't sell its stakes in the platform and other applications it owns within six months of the bill's enact-

The fight over the platform takes place as U.S.-China relations have shifted to that of strategic rivalry, especially in areas such as advanced technologies and data security, seen as essential to each country's economic prowess and national security. The shift, which started during the Trump years and has continued under Biden, has placed restrictions on export of advanced technologies and outflow of U.S. monies to China, as well as access to the U.S. market by certain Chinese businesses.

The Biden administration also has cited human rights concerns in blacklisting a number of Chinese companies accused of assisting the state surveillance campaign against ethnic minorities. TikTok isn't short on lobby-

ists. Its Beijing-based parent company ByteDance has a strong lobbying apparatus in Washington that includes dozens of lobbyists from well-known consulting and legal firms as well as influential insiders, such as former members of Congress and exaides to powerful lawmakers, according to the Foundation for Defense of Democracies.

TikTok CEO Shou Zi Chew will also be in Washington this week and plans to meet with lawmakers, according to a company spokesperson who said Chew's visit was previously scheduled.Influencers descend on Washington.

But influencers, who have big followings on social media and can share personal stories of how the platform boosted their businesses — or simply gave them a voice are still perhaps one of the most powerful tools the company has in its arsenal.

A TikTok spokesperson said dozens of influencers will attend the two-day event, including some who came last year. The spokesperson did not immediately respond to questions about how many new people would be attending this year's lobbying blitz. The company is briefing them ahead of meetings with their representatives and media interviews.

Lucille runs a plus-sized boutique in Charlotte, North Carolina, that she says has seen a substantial surge in revenue because of her Tik-Tok page. The 34-year-old began making TikTok content focusing on plus-sized fashion in March 2022, more than a decade after she started her business. She quickly amassed thousands of followers after posting a ninesecond video about her boutique.

Because of her popularity on the platform, her business has more online exposure and customers, some of whom have visited from as far as

JT Laybourne, an influencer who also came to Washington, said he joined TikTok in early 2019 after getting some negative comments on videos he posted on Instagram while singing in the car with his children.

Laybourne, who lives in Salt Lake City, Utah, said he was attracted to the shortform video platform because it was easy to create videos that contained music. Like Lucille, he quickly gained traction on the app. He says he also received more support from TikTok users, who reacted positively to content he produced on love and positiv-

Laybourne says the community he built on the platform rallied around his family when he had to undergo heart surgery in 2020. Following the surgery, he said he used the platform to help raise \$1 million for the American Heart Association in less than two years. His family now run an apparel company that gets most of its traffic from Tik-Tok.

"I will fight tooth-and-nail for this app," he said.

But whether the opposition the company is mounting through lobbyists or influencers will be enough to derail the bill is yet to be seen. On Tuesday, House lawmakers received a briefing on national security concerns regarding TikTok from the FBI. Justice Department and intelligence officials.

I say that a lot in my writing because a lot of my writing highlights the many ways in which (some) white people trip over themselves to co-opt and flat-out steal ideas, phrases, content, dances, music, and anything else Black people have. It is a founding principle of this country; it began with the enslavement and forced labor/wage theft of Black people in the 1600s.

These days, it takes on forms both big and "small" (small is doing a lot, from commercial ad campaigns for skincare companies to Keith Olbermann running the phrase "Bye, Felicia" into the ground to the author who gets a huge book contract writing stories about predominantly Black characters using stereotypical Black tropes — and it's later revealed she's a white woman (she tried to explain herself, but

Marjorie Taylor Greene showing up to the State of the Union address on Thursday evening wearing full MAGA regalia and a T-shirt with "Say Her Name" emblazoned across the front is the latest example of white people going too far when it comes to stealing things from Black people. #SayHerName was coined in

2015 by Kimberlé Crenshaw co-founder and executive director of the African American Policy Institute. Crenshaw, who is a civil rights activist and law professor, coined the phrase after the "mysterious" death of Sandra Bland a Black woman motorist who died under suspicious circumstances
