Evers signs "PRINCE Act" to expand AMBER Alert system for missing kids

Two members of the Milwaukee Common Council praised Wisconsin Gov. Tony Evers for signing the Protection and Recovery Involving Non-located Children Endangered (PRINCE) Act into law, which addresses gaps in the state's Amber Alert system.

"What happened to Prince McCree last year was a tragedy, and in the future we believe these new alerts have the potential to save lives when children are reported missing," read a joint statement by Aldermen Mark Chambers, Jr. and Khalif Rainey.

"The new system will allow an alert to be sent out if a child is under the age of 10, or for children up to the age of 18 if they

He participated in youth sports in the Sherman Park Community, as well as at Pius XI High School and at Marian University where he earned his Social Work degree. He served as a social worker for at risk youth in Milwaukee, and then as a curriculum specialist.

He went on to earn his BS degree in Education and his Educational Leadership Degree, both from Marian University.

Ernie enjoyed both teaching and coaching. He served as a mentor for college students and as a soccer coach for generations of youth in Milwaukee. He also coached soccer for two years at Cardinal

Stritch University,

Ernie initiated the "Paul Sanchez Memorial Alumni Soccer Tournament" through Marian University in honor of a classmate and teammate who died unexpectedly.

He served as a Director for the Mulberry Garden Youth Program, and supported America Scores Milwaukee Soccer Cup.

Ernie has earned a number of awards over his many years of service, most recently the Sr. Judith Schmidt Core Values Alumni

Award at Marian University.

Ernie will be greatly missed by his family, colleagues, students and life-long friends.

Ernie had an incredible way of integrating his many groups of friends from various places and situations in his life into one cohesive and ever-expanding whole.

Those who knew or worked with Ernie, played with Ernie, and loved Ernie often used just two words to describe him: Ernie was a "gentle soul!"

Ernie spent his early life with many foster families, people whose faith traditions and practices spanned a number of religions.

Ernie's spiritual philosophy can be summed up in this simple Scriptural reading, "Choose you this day Whom ye shall serve...but as for me and my home, we will serve the Lord." Joshua 24-15.

Wisconsin will replace FoodShare aid when outages spoil food, but filing requests isn't easy!

Bureaucratic hurdles and a lack of awareness mean few FoodShare/SNAP recipients are reimbursed for spoiled food following power outages and other misfortunes.

Food doesn't last long in Leisa Winston's home, where she takes care of nine grandchildren.

"Every day after school, it's somebody (saying), 'Granny, I'm hungry. Granny, you got something sweet?" Winston said.

The Milwaukee retiree relies on food assistance to stock her kitchen with some of her grandkids' favorites.

But feeding everyone got tougher in January

Evers recently signed the act at the Hawley Environmental School in Milwaukee, which was attended by Prince McCree, the namesake of the bill.

It was Prince's tragic disappearance last year, and death (along with Lily Peters in Chippewa Falls in 2022), that inspired Prince's neighbor, state Sen. LaTonya Johnson (D-Milwaukee), to champion and pass (with the assistance of state Sen. Jesse James) Senate Bill (SB) 981 to enhance the Amber Alert sys-

tem.

The PRINCE Act ensures authorities in future missing child cases have expanded resources to issue quicker and more robust alert notices to the public, hopefully ensuring

kids are able to be quickly located and returned home safely in the future.

According to AMBER Alert

Wisconsin, to issue an AMBER Alert, a child must be 17 years of age or younger, in danger of serious bodily harm or death, and the initiating agency must have enough descriptive information about the child, the suspect and/or the suspect vehicle to believe an immediate broadcast alert will help locate the child.

"The idea of having your child go missing is something no parent ever wants to imagine or, heaven forbid, experience firsthand," said Evers at

Burleigh St. where Dr. Carter lived and opened his pharmacy in 1968, a time when there were few Black residents in the neighborhood and fewer Black

doctors in the city. Remembered fondly for sporting a bowtie and white lab coat, the late Dr. Carter was a trusted physician, herbalist, and a fixture in Milwaukee's Black Com-





and freezer to spoil.

The family survived the next two weeks on peanut butter and jelly sandwiches, hot dogs and bologna, Winston said. She told the kids: "It might not be a steak dinner, but your little tummies are full."

She couldn't afford fresh milk or meat until she got additional funds through FoodShare, Wisconsin's food aid program for low-income people.

The federal government funds FoodShare through its Supplemental Nutrition Assistance Program, or SNAP. It allows states to replace funds for households that lose food to misfortunes like refrigerator malfunctions, power outages or flooding.

But many aid recipients don't know that's an option, local food assistance experts say.

Those who are aware face what advocates call unnecessary hurdles. They include requirements in Wisconsin and most states that recipients hand-sign a verification of loss form. That means people like Winston who lack access to a home printer must pay for transportation to an office that has one.

That may help explain why only 6% of the estimated 127,500 SNAP households the state health department identified as potentially affected by Wisconsin's January outages applied for replacement benefits, according to state data obtained by WPR and Wisconsin Watch.

That's what happened in January, giving Wisconsin residents about a month to document their food loss after the storm.

Winston filed her replacement benefit form as soon as she could, and she waited about two weeks for replacement benefits to show up on the QUEST card, which she uses to purchase food.

Feeding America, a national food bank network with multiple Wisconsin offices, recommends printing, signing and then uploading the form as the fastest way to get benefits under the current system.

How other states handle SNAP replacement requests Had Winston lived in one of at least nine other states, she could have completed a simple online form without worrying about phone hold times or bus fares, according to a WPR and Wisconsin Watch analysis of the request process in 50 states. Seven additional states regularly accept someone's voice over the phone as a signature. In most cases, Wisconsin offers neither.

The Wisconsin Department of Health Services says states need federal approval to change signature requirements.

The United States Department of Agriculture oversees SNAP. In 2016, it sent a memo to regional SNAP directors to clarify that, for initial applications and recertifications, "any electronic means of conducting the SNAP certification process may be suitable for electronic signatures," including over the telephone. It said "state agencies may not fully realize the methods available" to improve efficiency.

That memo, however, did not give guidance on replacement benefit

won't know they can ask for replacement aid.

SNAP agencies nationwide struggle to draw attention to the option, Cundari said.

While local SNAP offices have information about replacement benefits on posters or pamphlets, clients are less likely to visit offices today, Cundari said.

The information gap affects more than just replacement benefits. Local agencies often struggle to get the word out about other SNAP program forms and requirements, Cundari said, adding that she's seen few solutions to the problem.

After major outages, Wisconsin's health department emails community partners about the reimbursements and posts information on its updates page, Miller said.

The reimbursement form asks recipients how and when their food was destroyed and how much it was worth. It asks for proof of the loss, such as a letter from a utility confirming the outage.

But the state already has enough information about each FoodShare household to know who likely needs assistance after major outages, Hunger Task Force CEO Sherrie Tussler said.

"They should just use (their databases) to approve and support people who are in trouble rather than putting them through some kind of unnatural gauntlet of paperwork," Tussler added.

States can get USDA approval to automatically reimburse recipients in some situations. It requires proof that more than 50% of a defined area, like a county, city or zip code, lost power for at least four hours.

Normally, states issue automatic replacements only during declared disasters, but that isn't a requirement.

At least 19 states have issued mass replacement benefits 47 times in the last five years, a WPR and Wisconsin Watch analysis found.

Wisconsin hasn't issued mass replacement benefits in at least 15 years, but only one disaster during that period potentially caused food loss, Miller said: a January 2020 storm that ravaged lakeshore communities in Kenosha, Racine and Milwaukee counties.

But the state has issued Disaster SNAP benefits to help those affected by significant events, Miller said. Under Disaster SNAP, Food-Share recipients can receive supplemental benefits.

Climate change adds urgency

Midwest SNAP agencies have not traditionally focused much on disaster preparation compared to agencies in more disaster-prone states, particularly in the South, Cundari said.

Southern states "just have this philosophy of very much like not if we have a disaster, but when, and our Midwest states are not there yet," Cundari said.

That has begun to change in the aftermath of the derecho that walloped much of the Midwest in 2020. Food aid officials know severe weather is becoming more frequent in the region, and they are strategizing ahead of future disasters. Learning from policies in southern states can help, Cundari added.

"With climate change, these storms are becoming as detrimental to households as the hurricanes that you'll see in Florida."

SIDEBAR: How to get help accessing (and replacing) FoodShare benefits

......

Nearly 26,000 FoodShare households in Wisconsin received \$3.1 million in replacement benefits between December 2022 and November 2023. That's far less than the up to \$34 million in food that FoodShare households potentially lost from January's storm alone, according to a state estimate.

Such barriers may grow more consequential as climate change drives more extreme weather in Wisconsin and other states. The number of weather-related power outages nationwide increased by more than 75% during 2011-2021 compared to the previous decade.

Wisconsin is gradually moving to simplify FoodShare replacement requests. It plans to join at least nine other states in allowing applicants to electronically sign replacement aid forms.

But although Oklahoma updated its process in a matter of days, the Wisconsin Department of Health Services, which rolled out digital signature options for other forms a decade ago, doesn't plan to accept online signatures for FoodShare replacement until October after the state's typical tornado season.

The delay means FoodShare recipients may still face reimbursement challenges this summer if severe storms knock out power.

Over the past decade, six of Wisconsin's seven federally declared natural disasters happened between June and September.

Challenging process for requesting FoodShare replacement funds

Winston had used FoodShare for less than a year before the January storm. She didn't learn about replacement benefits until her friend saw a news report about how Hunger Task Force was helping affected residents.

Upon calling the anti-hunger nonprofit, Winston learned she could request funds to buy fresh milk and meat before her usual monthly benefits were set to reload — a "blessing," she said.

"I never knew all these resources are here to help people. There's really, really a need," Winston said.

Determined to keep her family fed, she said she spent her last two dollars taking the bus to a Hunger Task Force office to sign the form by hand.

The Wisconsin Department of Health Services, at the time, temporarily accepted signatures over the phone, but outside groups like Hunger Task Force are not authorized to accept phone signatures.

FoodShare recipients who call the state health department after major outages often experience long hold times, a Hunger Task Force spokesperson said. Residents typically have little time to waste in seeking to replenish their food supplies. The window to request replacement funds is 10 days after the event that triggered the misfortune, unless the state requests an extension from the federal government. forms.

A spokesperson for the Midwest Regional Office of the USDA's Food and Nutrition Service said states still need a federal waiver to roll out digital signatures on replacement benefit forms.

But Oklahoma and Tennessee's SNAP agencies told Wisconsin Watch and WPR they did not need federal permission to make their changes.

Following a major ice storm in October 2020, Oklahoma Human Services added online signature options for replacement benefits within 10 days — allowing applicants to submit required forms over their phones, a spokesperson said.

SNAP agencies in California, Florida, Kansas, Kentucky, Mississippi, Missouri, North Dakota and Tennessee also confirmed they accept electronic signatures for reimbursement forms.

Wisconsin plans to remove signature barriers for FoodShare replacement requests

Wisconsin's health department applied last September for a waiver, which USDA approved two months later.

"The current method of electronically signing for applications and renewals has been effectively used by all agencies in Wisconsin for over 10 years," the agency wrote in its request. "All workers are thoroughly familiar with and comfortable using this method of collecting signatures."

That includes within the initial FoodShare application process, where applicants can submit digital signatures to the state's website or app or sign over the phone. The health department will use similar digital signature options for the replacement benefit form.

Despite having expanded signature options for other forms, the state's target date for implementing new digital signature options for replacement forms isn't until October 2024.

"DHS understands that providing telephonic or electronic signatures is more convenient for members, which is why we continue to pursue these options while making sure that we meet federal requirements," spokesperson Jennifer Miller told WPR and Wisconsin Watch in an email. "Doing this requires changes to documents, systems, and processes."

The delay gives the health department and local SNAP agencies time to transition without disrupting recipients' benefits, Miller added.

Signature changes shouldn't make the request process any less secure, said Melissa Cundari, the Midwest regional SNAP director. Every state regularly reports replacement benefit figures to the USDA, allowing the agency to act if it notices any anomalies.

It was a temporary departure from reality --- spending Sunday dinner with people who cooked with grease, knew the lyrics of 1960s R&B, greeted each other as 'brother' and 'sister,' and read books---novels, the Bible, and newspapers -- daily.

The honored guest was in her mid-90s, and having achieved that millstone was worthy of the hugs and kisses she received from each guest in turn.

It was about respecting the elderly, seniority, and wisdom---an African, and formerly African American, tradition.

That's why those of us who grew up in the shadow of Black nuclear families and Africentric culture stood up when she did.

She was an anchor of the family circle and offered a prayer for our continued blessings, the hope that none in attendance would forget where they came from, the importance of extended family, and the desire that none would step from under God's shadow.

The prayer was followed by group hugs and thanksgiving as the aroma of greens, string beans, turkey, ham, dressing, potato salad, mashed potatoes, and various desserts overwhelmed us.

It was like a scene from a Tyler Perry movie, with a guest appearance from a 'MaDear' clone complete with a flowing wig, heavy makeup, and a thunderous voice.

Every family has at least one; ours was adorned in a tight dress, boobs busting out, and eyelashes extending four or five inches to catch the rain, snow, or glaring sunlight.

She kept the young folks engaged, as the seniors were served first!

Three generations followed the seniors. Only two women wore European wigs that touched their kneecaps, and while there were fake eyelashes aplenty, none were so long as to block out Monday's solar eclipse.

Two little boys wore white shirts, both with clip-on ties. They were sharp, a reminiscence of my youth when we wore our one (Sunday) suit and Buster Brown shoes.

No 'hoochie mama' outfits, and I saw only one pierced navel or 'tramp stamp.' And that sister's hue made it impossible to figure out what the design designated. (I have yet—for the life of me—to

figure out why dark-skinned folks sport tattoos you can't see).

Now that I think of it, there were no gold teeth---permanent or temporary-nor tattooed faces, although a couple of sisters had imprints of past relationships on their necks. Guess they have to find someone with a similar name to make the tattoo relevant.

In totality, it was a refreshing departure from the realities of the streets and made me wonder if one of the elder's funeral possessions

would be interrupted when a punk

or punkette callously drove through their motorcade prossessional, or worse still, fired off their stolen pistols during the internment.

The world outside the family room where we gathered was much different than the world most of the diners were brought up in.

Back in the day, we prized clean, litter-free neighborhoods. And neighbors who involved themselves in the upbringing of the 'village children.'

Much of the discussion among the older diners was about the 'old community,' when families consisted of a father, mother, and children—a nuclear concept that has become rarer and rarer in central cities around the country.

Often a grandparent who watched the children when parents worked felt safe and could be seen sitting on the porch, occasionally chastising a child for getting too

loud or running across their manicured lawn.

It was about a community where people mowed their lawns and erected signs that said 'Keep off the grass' (the kind you grow for beautification).

Dinner conversations focused on those (not so) good ole days of segregated neighborhoods, schools, and churches. Was that man seen coming out of Helen's house at midnight a relative or a...

It was an era when Black folks jeopardized health and welfare to cast their votes versus complaining or making excuses.

It centered around illiterate migrants from the south doing any and everything to ensure their children did not suffer from the fate assigned to the ignorant.

I grew up in a community where there were more virgins than the other way around.

An epoch where we had 'hoes,' and 'bastards' and teen pregnancy was the exception instead of the rule.

It was a time when mothers taught their daughters the 'quarter' rule---put it between your knees and don't let it drop until you're (continued on page 8)

It was a prehistoric period when the rare pregnant teen disappeared 'down south', and men were more fearful of shotgun weddings than machine gun drivebyes.

The Black population was small in the 1960s and 1970s, but the poverty rate was minuscule compared to today (two-parent household income was higher), as was home ownership, which was nonexistent in the suburbs because of housing covenants.

Rent parties were familiar and provided an example of a village as a cultural paradigm.

Most Black children, one generation removed from southern 'speech and custom,' spoke proper English, wrote intelligently legible script, and even learned cursive. This could be because our teachers didn't grade on intent but instead corrected bad grammar and stopped us from saying, 'I ain't got no,' using double negatives. Instead we were taught how to navigate proper subject/verb agreement.

I'm not suggesting things were better back in the day. Police were an occupying and racist army, our schools were underfunded, and the laws—from housing covenants to racial standards---would not allow Black residents to file a complaint against police if we were not property owners, which only a tiny percentage were.

'Sundown' rules applied not only to the suburbs but to middle-class neighborhoods in the city as well.

National celebrities---from Henry Aaron to Sammy Davis, Jr.---had to stay at the preacher's house because they weren't allowed to get a room at downtown hotels, or in the case of Sammy, wasn't allowed to stay at the hotel he was performing at on the lakefront.

But those racist paradigms were offset by positive, cultural, and familial paradigms---some out of necessity, or equally fruitful, out of comfort— stayed with people who appreciated them.

Legalized segregation meant Black doctors, nurses, lawyers, professional athletes, and entertainers were our neighbors. Teachers visited our homes to deliver homework, and many also served as Sunday School teachers.

We were po' versus poor, and the difference meant we learned instead and despite.

Nonetheless, we walked with shoulders high and eyes ablaze instead of cast downward. We called white men 'mister' instead of boss or sir. We were taught to be Black and proud, and 'niggeritude' was an evil expression, not a compliment.

I left the dinner with a smile and a tearful heart because I remembered the good as well as the bad. The village died sometime during the 1970s when Daddy moved out and Uncle Sam moved in. Black unity imploded when someone told us we had reached the mountaintop, only to slide back down into the swamp.

My belly was full, and my spirit rejoiced. Maybe in was those collard greens and the sweet potato casserole. **Hotep.**
