Black voters, who helped power Joe Biden to the White House, expressed a mix of hope and worry recently over his exit from the presidential race and the prospect of Vice President Kamala Harris becoming the Democratic nominee.

A key Democratic constituency, Black voters were among Biden's most steadfast supporters, even as calls for him to quit grew. But as much pride as many Black Americans feel about the possibility of Harris, who is of Black and Indian descent, becoming president, the upending of the race has some voters feeling scared.

"I felt like we were doomed," said Brianna Smith, a 24-year-old school counselor from Decatur, Georgia, recounting her reaction to Biden's announcement. "I don't see America actually accepting the fact that a Black woman is running for president."

reminiscent of 2008, when Barack Obama sought the presidency alongside Biden, the vice presidential candidate. Millions of Black people were proud of Obama's candidacy even as they feared he wouldn't be accepted by Americans

Cyria Adams, a 37-year-old hairstylist from The apprehension of some Black voters was Smyrna, Georgia, called Biden's decision

"heartbreaking." As speculation spread last week that the president might withdraw, she prayed it was just a rumor.

"I'm nervous. I'm really nervous," Adams

Biden's support of Harris and the immediate coalescing of other party leaders around her makes her the prohibitive favorite to replace him at the top of the presidential ticket. But in interviews in Atlanta, where voters helped flip Georgia for Democrats four years ago, some Black voters were nervous.

"People really don't like women, especially Black women," said Mary Jameson, 46. "If a white woman can't win, how can a Black woman win?"

Carrington Jackson, a 23-year-old chiropractic student from Marietta, Georgia, said she immediately felt fearful when Biden dropped out.

Though she believes Harris is a great candidate, she worries about her facing not only the popularity of the GOP nominee, former President Donald Trump, but the prejudices of the American public.

"With me being a Black woman, I understand that she's at the intersection of sexism and racism," Jackson said. "I think now that's going to be a whole other battle, as well as competing against Donald Trump's supporters."

An AP-NORC Center for Public Affairs Research poll fielded prior to Biden's announcement Sunday found about 6 in 10 Democrats believe Harris would do well as president.

More broadly, among all adults, the poll showed skepticism of Harris, with only 3 in 10 Americans saying she would do well as president.

Cancer Center.

She works closely with the community, her team and a community advisory board to identify and respond to health care concerns that impact cancer prevention and treatment.

"I could not do anything without community insight and support. Collaborating with residents and other community resources leads to the development of programming that is relevant and responsive to community needs," she said.

Debra and her sister were adopted by James and Evelyn Davis, when Debra was only three months old. Her dad was a teacher and guidance counselor for MPS and her mother was a stay-at-home mom, who later returned to school, earning a master's degree in psychotherapy. In fact, she and Debra attended UWM at the same time.

Though her parents are now deceased, Debra is grateful for the love, nurturing and wise counsel she received from both.

"Evelyn Davis was my best friend and continues to be the angel on my shoulders. She taught me how to show up authentically as myself; how to value every moment and the importance of treating everyone with respect."

"I also loved the way my father instilled in me a positive image of myself. When I was young, he encouraged my sister and I to walk into a room thinking about the one thing we were better at than anyone else in the room. If we couldn't think of anything, he said we needed to understand that God called us into that room for a purpose. This has been important advice throughout my career. I often find myself in rooms with researchers and doctors who are regarded as experts in their fields. At those times, I remember that I am in the room because of what I bring to the table," said Debra.

Among her mentors are individuals who have long worked in the healthcare industry, including Dr. Patricia McManus, Dr. Sandra Underwood, and Jestene McCord (deceased). Her husband, children and grandchildren remain a constant source of inspiration and support.

"They keep me rooted, grounded, involved and engaged. They are in my ear. I'm so grateful that I have had them in my life and on my journey," she said.

Debra also teaches part-time at Concordia Uni-

"I love facilitating learning for those who will hopefully replace me one day. I enjoy creating

tools and materials to teach individuals at any level. People learn differently and I'm really fascinated by how culture plays a role in how we approach learning. How I present information determines how that information is used. There is no one size fits all," she said.

Debra sometimes collaborates with individuals from the community to deliver health education.

"Culturally, African Americans are story tellers but I don't presume I should always be the one to tell the story. For example, I work with three incredible African American men who are prostate cancer survivors who train other men about prostate cancer. When they enter a room with other men they don't need me there," she said.

Debra is concerned about the holistic health of the community—spirit, mind and body. She also works to encourage others to address the post-COVID trauma that people are facing, particularly youth.

"If one member of the community is ill, it impacts an entire family, which then impacts the whole community. We must put a priority on our health. Our mental health (e.g., depression) also impacts the entire family. The trauma our community goes through is at a pandemic state. We have children going to school, walking past crime scenes or who heard gunshots the night before. We have school shootings that we have to be worried about. How can you be there for students if you have to worry about all the doors being locked? In one of our MPS schools, seventy percent of the students are unhoused. Some of our kids may go to a shelter for food and rest at night. Understanding the impact of our environment beginning with childhood allows us to understand how to begin

"When we heal, we can learn – as we learn, we can build our wealth, improve our environment and take better care of ourselves. Without our health, we are not able to have this impact. Health is wealth – they are tied together," she said.

I would like to be remembered fondly as we do of our elders, like Mildred and Reuben Harpole. I want to have a footprint like that of Vivian King or Dr. Joan Prince. I want people to know that I did something positive; that I was a support and that I was helpful," said Debra.

There is, indeed, a reason you are in the room, Debra, and the community is grateful that you are there, advocating for and educating our community.



I erroneously assumed a Black vendor occupying an ideal spot to sell her goods (t-shirts and Donald Trump memorabilia) directly across the street from the Hyatt Hotel during the RNC convention was a local resident.

But when I asked, she quickly dismissed that assumption and asked why there was a dearth of local merchants at the event.

"Can't understand Milwaukee (Black) folks. I heard the convention will bring in a quarter billion dollars, but all of it is gonna go to White people and a few local villagers (Black) who took advantage," she said.

Sad. Sad. Sad. Another golden opportunity was wasted.

That was among the significant observations. The only Black Milwaukeeans who got a splice of the pie were Black hotel valets, bartenders, and temporary security guards.

Given that Milwaukee is now recognized as Chocolate City,' I mistakenly assumed convention coordinators---city politicians-- would ensure we would get a piece of the pie. But again, we didn't even get crumbs.

Other observations:

Conventioneers primarily ate downtown, at select restaurants organized by state parties, or from tourist guides, none of which mentioned Black attractions—the Holocaust Museum, the Black Historical Society, or Bronzeville.

To be honest, few Black businesses---particularly restaurants---advertised their services or uniqueness. And as I heard, they were discouraged from traveling behind the security perimeter to the central city.

I contacted the Black Holocaust Museum, considered the premier local attraction, only to discover that they decided to close during the

Jamila Benson of the Wisconsin Black Historical Society/Museum said she didn't see an uptick from the convention.

a beautiful sister approached me at Saint Kate's as I was waiting for transportation. I asked why she was at the convention, and instead of mentioning Trump or the conservative agenda, she responded, "Business."

IHop boondoggle. I need help explaining why. Officials hoped to see record (which isn't high) ridership, enough to justify the high price of the investment. It didn't happen. What does that say about the boondoggle?

...One of the most interesting---and defining—moments of the convention came not from a speaker but from a segment of the Tory Lowe radio show on Wednesday.

The Truth radio platform covered the entire convention, the Panther Arena, one of three convention sites.

I was at the Hyatt, waiting for an interview, and decided to tap the Truth radio station on my phone. Tory, a well-known community ad-

vocate whose destain for President Biden sparked his decision to endorse Trump, was interviewing local entrepreneur Shana Gray, who has become a celebrity of the Republican Party since switching parties from her lifelong Democratic Party affiliation.

The owner of Gray Jett Café--a veggie restaurant--explained that she turned to Democratic leadership and Black officials for help as her business floundered during the pandemic. The city and state were sitting on billions but did little to nothing to help starving Black companies.

Her frustration was mentioned on a radio program, which Trump's inner circle heard. To her surprise, they reached out, asking how they could assist. Obviously, they exploited her, having her

speak at forums about her disappointment. And to her surprise, liberal Democrats charged her with treason and invoked the Fugitive

Speaking on Lowe's program, she revealed she was the subject of a vicious, racially tainted attack.

"They said they were willing to listen," and I took advantage. The racist taunts from liberals were overwhelming; they threatened boycotts of her business and wanted to run her out of town. Surprisingly, they never addressed the underlying issue.

Everywhere I went, they were polite and happy. Maybe it was because they assumed I was a Black Republican or because I wore a Black Vietnam Veteran's ball cap.

Whites throughout the country generally say 'thanks for your service' when I wear one of several caps daily. I view those hats as my 'get out of jail free card...'-Hotep.

awarded child support, doesn't necessarily mean you end up getting it. About 7 in 10 custodial parents (69.8 percent) who were supposed to receive child support in 2017 received at least some payments. The aggregate amount of child support that was supposed to have been received in 2017 was \$30 billion; 62.2 percent of that amount was actually re-

States and tribes have several tools for enforcing child support orders, like income withholding.

Accessing federal and state tax refunds is also an important tool. Appropriate enforcement is a crucial part of our efforts to ensure that families and children actually get the child support they are entitled to, including through intercepting federal tax refunds, when necessary.

Currently, only state child support collection agencies and their contractors can access the offset program that authorizes the Department of the Treasury to withhold from tax refunds amounts owed for past due child support payments.

Tribes were excluded even though at least 61 out of the 574 federally recognized tribes run child support programs. Denying Tribes the ability to directly request that tax refunds be garnished for child support, as states can

do, is a direct affront to Tribal sovereignty, and continues to hamper their ability to use their child support enforcement tool. This legislation before us today would provide a long overdue and permanent statutory fix which tells our tribes, we respect your sovereignty and your ability to have the same authority as states to help ensure that families and children get the support they are entitled

It's important to recognize that this bill also advances a fix for states that use contractors to operate enforcement pieces of their child support programs. Many states have IRS audit findings related to the unauthorized disclosure of federal tax information to contractors- audit findings that are currently suspended so that the States that use contractors can temporarily continue to operate their pro-

Given that State programs have come to rely on access to this information, we have a duty to ensure that these child support payments continue to flow to families that need them – while ensuring that confidential taxpayer information remains safeguarded.

At the end of the day, we must remember the greatest beneficiaries of our action today will be the children. I am grateful that this legislation has garnered strong bipartisan support and will continue to work to get it enacted expeditiously."

The Protecting America's Children by Strengthening Families Act (H.R. 9076) is a bipartisan reauthorization of Title IV-B pro-

"I am grateful to the Chairman and Ranking Member for including provisions of standalone bills. H.R. 9076 includes provisions from my Preventing Child Welfare Entry Caused by Poverty Act (H.R. 8813),

which I introduced with Chairman Smith, that would allow child welfare agencies to deploy short term resources under the existing Title IV-B program to address the acute needs of families living in poverty that might otherwise lead to investigations for neglect.

"This includes resources to address housing, food insecurity, or other concrete needs that may help prevent families from being separated. These provisions also require states to have policies in place to ensure that simply living in poverty, absent abuse or neglect, is not a reason on its own to separate children from their parents."

"I have long championed efforts to revise policies in order to prevent the needless and traumatic separations of children from their families. Instead of separating families solely because of poverty, we need to ensure we can connect families with the resources they need to remain whole. The inclusion of these provisions builds toward that goal and help struggling families with emergency support when they need it most."

H.R. 9076 also includes the provisions of my Youth and Family Engagement in Child Welfare Act and would require states to consult with youth and families with lived experience in child welfare services when developing their state child welfare plans that they must develop to receive federal funding.

"I am also thrilled that we are moving to lift up those with lived experiences and ensure their voices are reflected in our state and federal child welfare policies. These efforts are how we can ensure the child welfare system is truly meeting the needs of some of our most vulnerable children."

H.R. 9076 passed committee unanimously and now heads for consideration in the full House.
