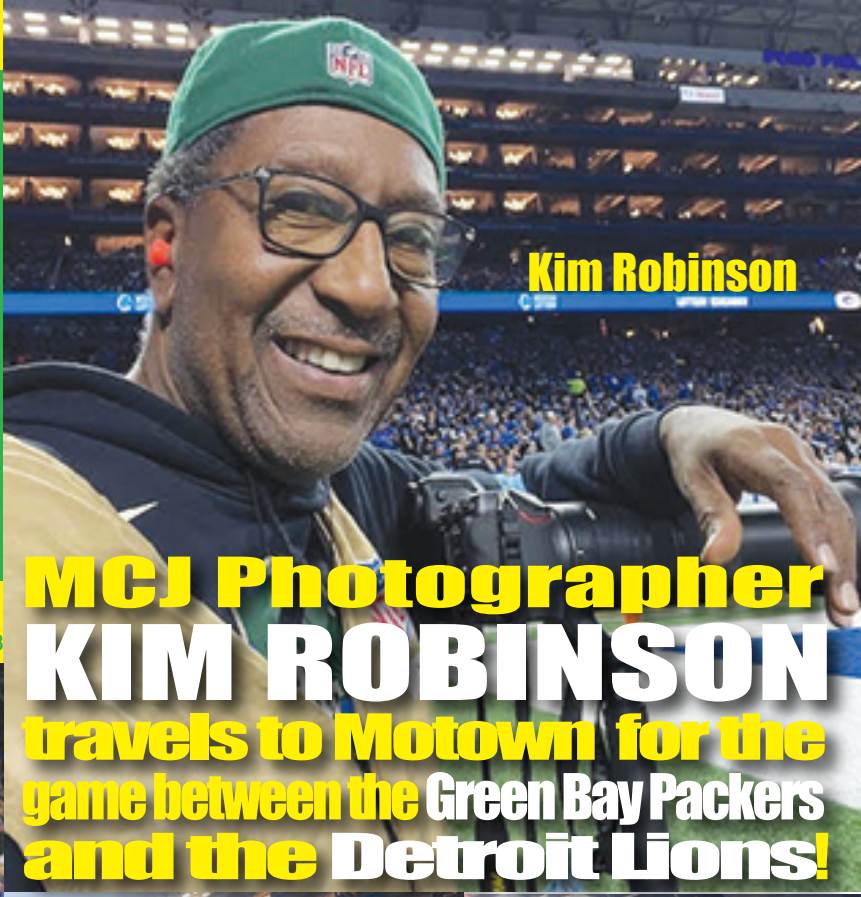

The Green Bay Packers were a “close, but no cigar” as they lost a tight one to the Detroit Lions, 34 to 31 at Ford Field in Detroit recently. The Lions lead the North Division and are a favorite to reach the Super Bowl. Both quarterbacks—Green Bay’s Jordan Love and Detroit’s Jared Goff—and their respective teams went back and forth the whole game, with the Lions getting in the ‘last word’ short-to-speak, kicking a winning field goal in the last seconds of the game. 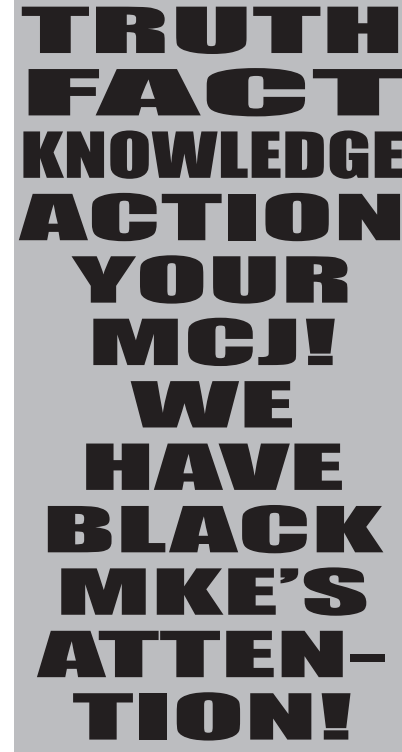
