When Leading Voices of Color Are a Threat to Corporate Strategy

First off, they made Auntie cry.

Once again, corporate America shows us how little it values diversity when it becomes inconvenient. MSNBC, in its latest misstep, has done what no one knew was coming: canceled The Reid-Out, Joy Reid's much-needed platform that gave voice to Black Lives Matter, immigrant rights, and, let's not forget, a progressive take on global crises like Gaza. This is not a simple shake-up due to ratings.

No, this is about corporate convenience—about putting an end to the voices that dare disrupt the comfortable, whitewashed narrative that so many in the media love to peddle. This is MSNBC rolling back its own DEI.

Joy Reid's departure surprises me despite the network's recent behavior. Reid's unapologetic advocacy and tireless pursuit of racial and social justice made her a star among those who refuse to let America's sins slide unnoticed.

But, apparently, MSNBC's new leadership, led by Rebecca Kutler, has other priorities: appeasing the white demographic and cozying up to a Republican-leaning audience. You're expendable if you're an anchor of color speaking truth to power. You're no longer "fresh" enough.

The 'Rebrand' That Is, Quite Frankly, a Whitewash
It's not just Reid. No, the axe came for Ayman Mohyeldin, Jonathan Capehart, and Katie Phang as well. But don't worry, folks—these anchors of color aren't out of a job entirely.

No, no. They'll be moved to smaller, less visible time slots—indeed, a consolation prize when your face no longer fits the corporate "vision."

Capehart and Mohyeldin are being placed in lesser roles on

 the network as though they're some consolation prize for an audience no longer interested in watching a few Brown faces tell the truth.

MSNBC claims the cuts are all about ratings. But let's be honest: they've been playing the ratings game for years, and in that game, voices like Reid's are always on the chopping block.

The network is simply making a strategic decision to cater to a broader audience that's more comfortable hearing a message that doesn't challenge their biases.

The decision to cancel The ReidOut is not because of low ratings—it's because Reid's unapologetically progressive stance was becoming too much of a threat to the establishment's carefully curated narratives that cater to white moderate ears.

The Expendability of Black Women Anchors at MSNBC

MSNBC's recent decisions to part ways with prominent Black women anchors—Joy Reid, Melissa Harris-Perry, and Tiffany Cross—underscore a troubling pattern: the network tends to elevate Black Women's voices when convenient and discard them when their perspectives challenge the status quo.

Melissa Harris-Perry: A Brief Resurgence

In 2012, I was brought on to host a weekend morning show, Melissa Harris-Perry, which gained acclaim for its in-depth discussions on race, politics, and culture and was my favorite news show ever.

However, in 2016, after a public dispute over the preemption of her show for political coverage, Harris-Perry departed from MSNBC. She expressed frustration over the network's treatment, stating, "I am not a token, mammy, or little brown bobblehead."

Tiffany Cross: A Sudden Exit

Tiffany D. Cross joined MSNBC in 2020, hosting The Cross Connection, a Saturday morning show that provided a platform for discussions on race and politics that quickly became my new favorite show.

In November 2022, just

days before the midterm elections, MSNBC informed Cross that her contract would not be renewed.

Cross expressed disappointment, stating, "I am disheartened to learn of MSNBC's decision to cancel my show... With a rapidly changing media landscape, I look forward to maintaining a platform that continues to reflect the changing demographics of the country."

Joy Reid: The Unceremonious Ending to a Trailblazing Career

Joy Reid, MSNBC's first Black female primetime anchor, made history with The ReidOut, a groundbreaking show that aired from 2020 until its abrupt cancellation in February 2025.

In a move that has drawn intense backlash, Reid and her staff learned of the cancellation not through the network but from social media—just one day before their final show.

This lack of communication not only underscored the network's disregard for the contributions of its Black hosts but also highlighted the expendability of voices that challenge the mainstream narrative.

The decision to ax Reid's show, alongside others hosted by anchors of color, has sparked outrage across the media world.

Fellow MSNBC host Rachel Maddow, a longtime anchor at the network, publicly condemned the cancellation on her show last night, calling it "worse than bad" and "indefensible."

The criticism reflects personal disappointment and underscores the collective

betrayal felt by Reid's supporters, who see her departure as part of a larger, troubling trend of sidelining Black voices in favor of a more palatable, corporate-friendly image.

A Pattern of Discarding Black Women's Voices

The departures of Harris-Perry, Cross, and Reid highlight a recurring issue: MSNBC's pattern of sidelining Black women anchors when their perspectives challenge the network's corporate interests or the broader media landscape.

This trend reflects a broader discomfort within corporate media with voices that demand accountability and represent marginalized communities.

Removing these anchors is not merely a reshuffling of talent but a systematic flippancy in how mainstream media has treated Black women.

As MSNBC continues to make these decisions, it is imperative to call this what it is: a DEI rollback just like Meta and Target.

This isn't just a reluctance to embrace the full spectrum of voices that reflect the diverse experiences of the American populace.

The Reckoning: Time for a Boycott of MSNBC?

Let's be clear about something: MSNBC has shown us exactly where its allegiance lies—white, centrist America.

And that's fine if that's the audience they want to cater to, but let's not pretend this is some progressive beacon of truth and change.

MSNBC has spent years wrapping itself in the mantle of liberal ideals, only to discard the very voices that

challenged the status quo when it became inconvenient.

The anchors it has fired or quieted—Reid, Mohyeldin, Capehart, Phang—were pushing boundaries, telling the stories that needed to be heard.

And now they've been thrown away, not even afforded the dignity of a proper farewell. So here's a thought: it's time to #boycott.

If MSNBC were genuinely committed to social change, it would stand by those who dared to rock the boat. But it has chosen comfort over progress.

It has decided that a smooth-running, safe corporate machine is more important than representing the objective, raw, uncomfortable truths that Black voices bring to the table.

And that, my friends, is precisely why it's time to pull the plug on this network.

Boycotting MSNBC isn't just an act of protest—it's a statement.

It's a statement that we won't keep playing nice while corporate media erases the voices that matter.

It's a rejection of the same old corporate nonsense that allows white supremacy to thrive unchecked.

When Black people in media speak truth to power, they should be celebrated, not discarded.

But MSNBC has made it clear: their comfort zone is more important than the truth. So, why should we keep supporting that?

This isn't just about Reid's departure but the broader message that MSNBC is sending.

The network's desperate need to appeal to a wider, whiter, less confrontational audience is now apparent.

They've chosen to protect their brand and profit margins rather than stand by the people representing real, progressive change. That's not just disappointing—it's downright offensive.

So yes, Reid's exit is a loss—but the real question is, why are we still giving these networks the benefit of the doubt?

Why should we keep tuning in to a station that silences the voices demanding accountability, the voices that refuse to be quiet when the world needs to hear them most?

The boycott is the only answer because it's time we make it clear: if MSNBC keeps pushing out the people who matter, then I'm not sticking around to be their audience. Let's take our power back. #Blaxit
